Set the spectrum analyzer span to include the block edge frequency (704, 716, 824, 849, 1710 and 1755, 1850 and 1910MHz)

Set a marker to point the corresponding band edge frequency in each test case.

Set display line at -13 dBm

Set resolution bandwidth to at least 1% of emission bandwidth.
