

5.1. METROLOGICAL TRACEABILITY

6. EQUIPMENT UNDER TEST

6.1. DESCRIPTION OF EUT

The Apple iPhone is a smartphone with cellular GSM, GPRS, EGPRS, UMTS, LTE, 5G NR1, IEEE 802.11a/b/g/n/ac/ax, Bluetooth (BT), Ultra-Wideband (UWB), GPS, NFC, NB UNII, 802.15.4, 802.15.4ab-NB and MSS technologies. The rechargeable battery is not user accessible.

Testing was performed on the parent model and is used to support the application for the parent and variants identified in this report based on the test plan submitted and approved via KDB inquiry by the FCC and by ISED-Canada.

6.2. MAXIMUM OUTPUT POWER

EIRP/ERP TEST PROCEDURE

GT = gain of the transmitting antenna, in dBd (ERP) or dBi (EIRP);

LC = signal attenuation in the connecting cable between the transmitter and antenna, in dB.

For devices utilizing multiple antennas, KDB 662911 provides guidance for determining the effective array transmit antenna gain term to be used in the above equation.

6.5. WORST-CASE CONFIGURATION AND MODE

The EUT was investigated in three orthogonal orientations X/Y/Z on all ANT 1, ANT2, ANT3 and ANT4 antennas to determine the worst-case orientation. The following table exhibits the worst-case orientation for different frequency bands. The full tests of the EUT have made upon the orientations that shown in the table below.

Based on average conducted output power measurement investigations. The worst-case is Ant1 with the highest power. Therefore, Ant 1 was used to perform all conducted tests.

The worst-case scenario for all measurements as followed:

- GSM GPRS
- GSM EGPRS
- WCDMA REL 99
- WCDMA HSDPA

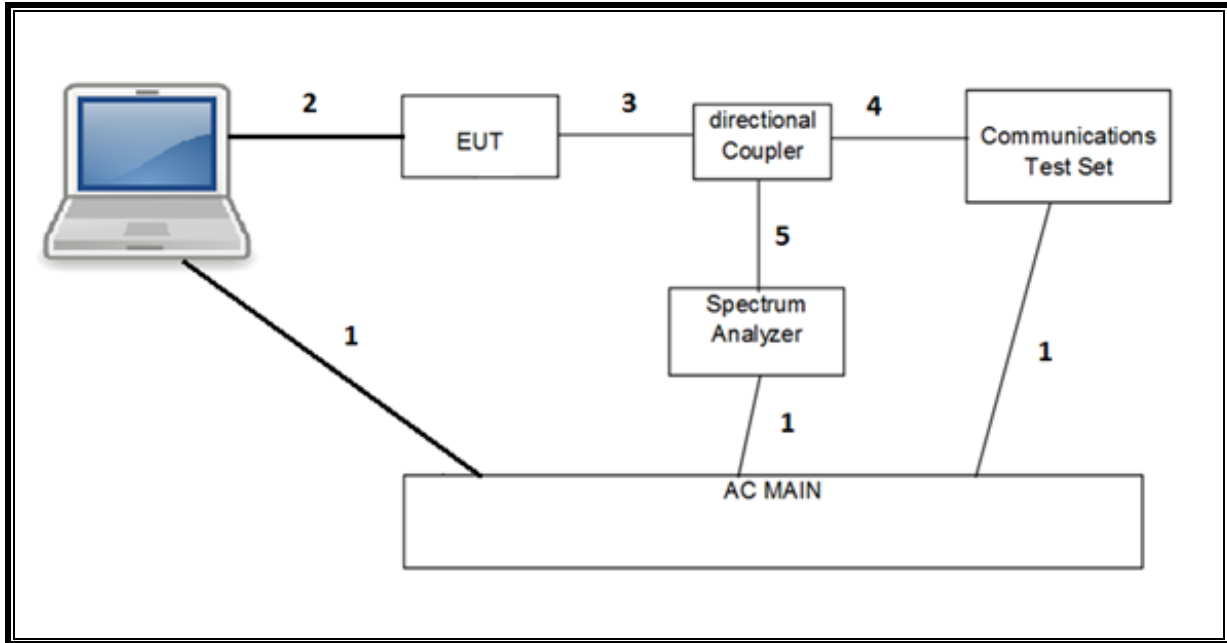
Radiated spurious emissions were investigated from 9kHz to 30MHz, 30MHz-1GHz and above 18GHz. There were no emissions found with less than 20dB of margin from 9kHz to 30MHz, 30MHz-1GHz and above 18GHz.

For simultaneous transmission of multiple channels in the 2.4GHz/5GH WLAN, UWB, and Cellular bands, tests were conducted for various configurations having the highest power, least separation in frequencies and widest operation bandwidths. No noticeable new emission was found.

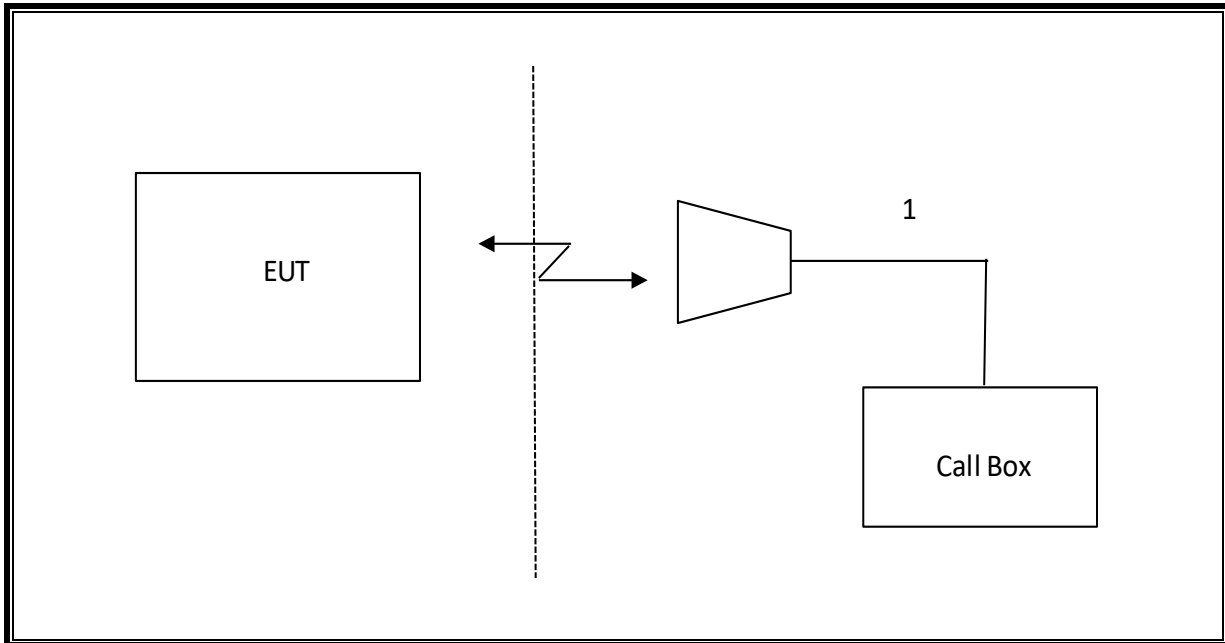

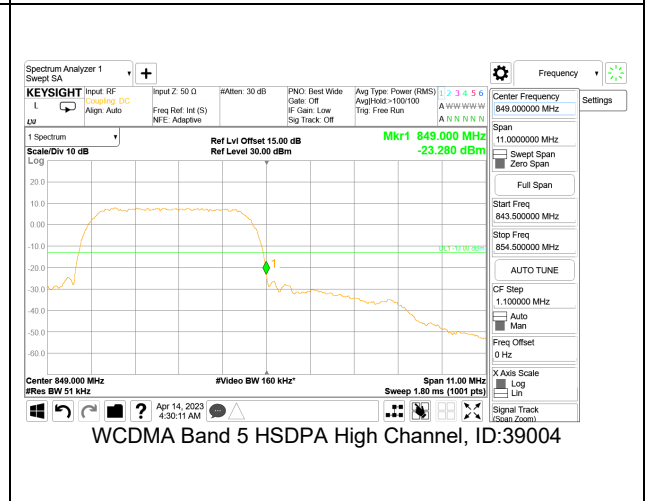
WCDMA Band 5 Rel 99 Low Channel, ID:39004



WCDMA Band 5 Rel 99 High Channel, ID:39004

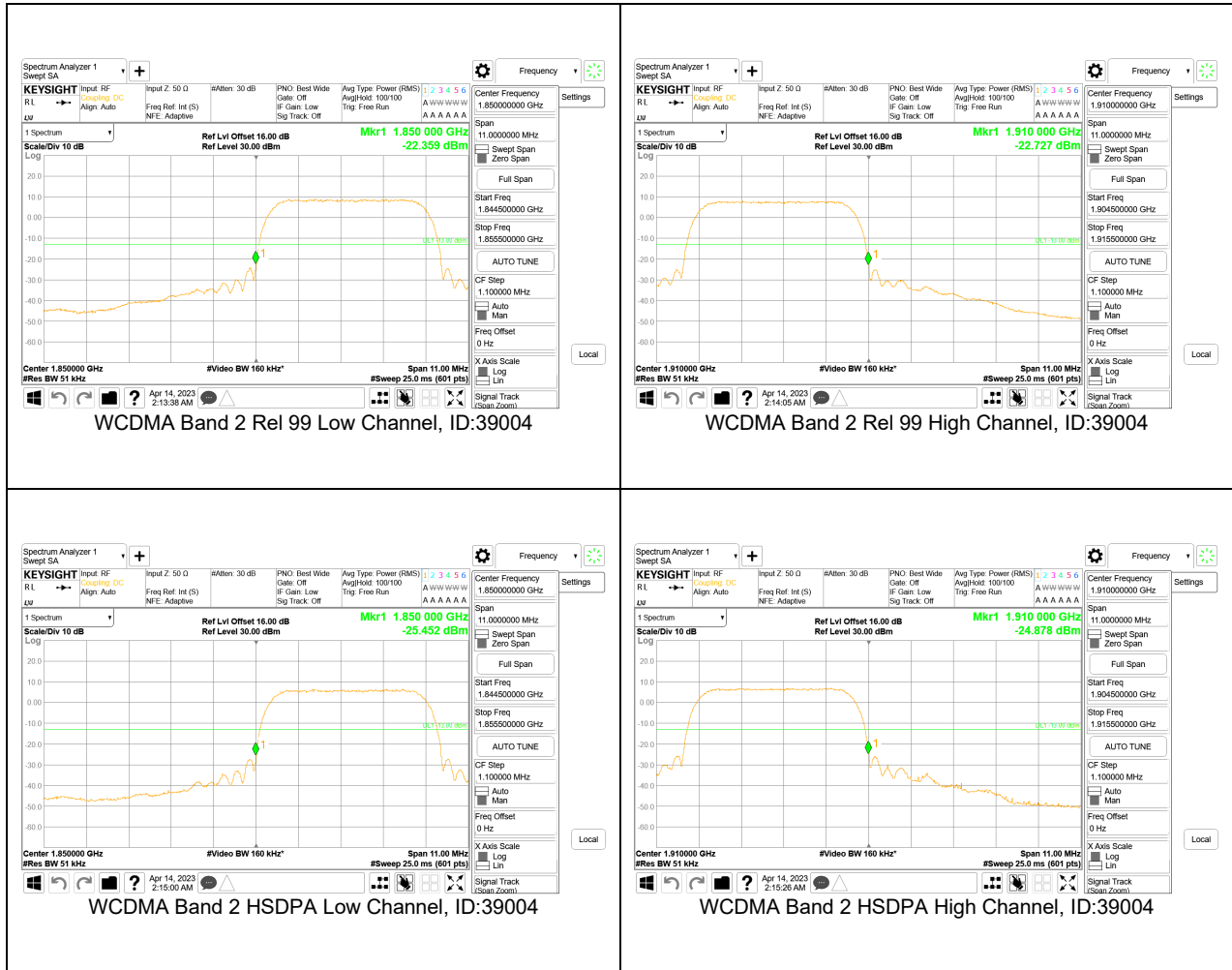


WCDMA Band 5 HSDPA Low Channel, ID:39004

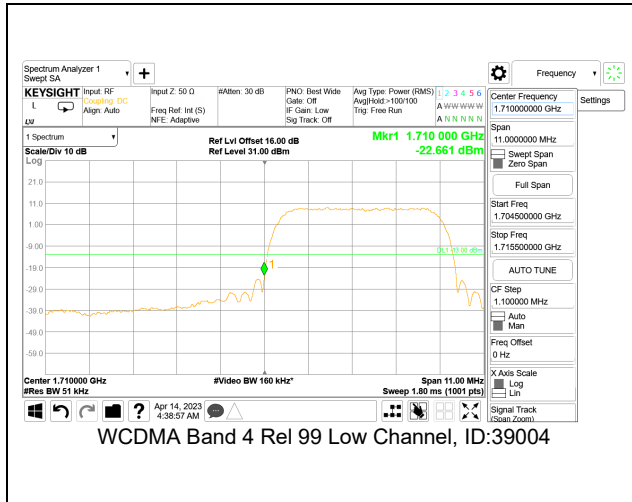

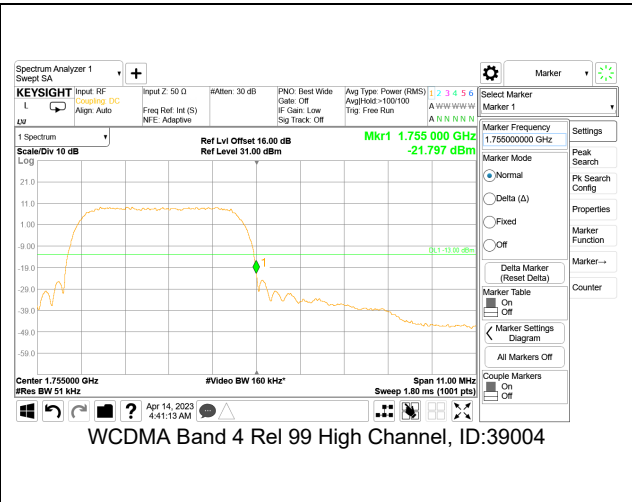

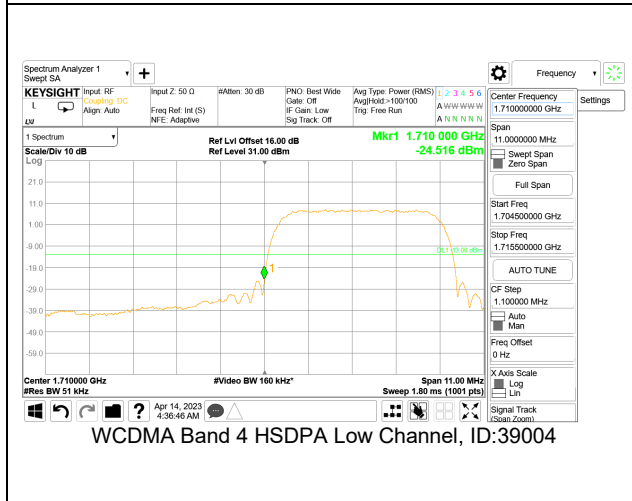

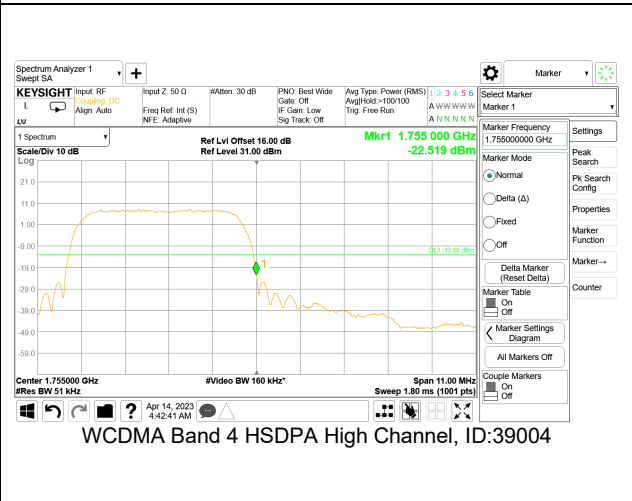

The minimum permissible attenuation level of any spurious emissions is $43 + 10 \log (P)$ dB where transmitting power (P) in Watts.

The minimum permissible attenuation level of any spurious emissions is $43 + 10 \log (P)$ dB where transmitting power (P) in Watts.

TEST PROCEDURE

The RF output of the transmitter was connected to a spectrum analyzer through a calibrated coaxial cable. Sufficient scans were taken to show the out-of-band Emissions, if any, up to 10th harmonic. Multiple sweeps were recorded in maximum hold mode using a peak detector to ensure that the worst-case emissions were caught.

For each out of band emissions measurement:

- Set display line at -13 dBm
- Set RBW & VBW to 100 kHz for the measurement below 1 GHz, and 1 MHz for the measurement above 1 GHz.
(NOTE: Worst case set RBW/VBW to 1MHz/3MHz)
