4. DECISION RULES AND MEASUREMENT UNCERTAINTY

4.1. METROLOGICAL TRACEABILITY

All test and measuring equipment utilized to perform the tests documented in this report are calibrated on a regular basis, with a maximum time between calibrations of one year or the manufacturers' recommendation, whichever is less, and where applicable is traceable to recognized national standards.

4.2. DECISION RULES

The Decision Rule is based on Simple Acceptance in accordance with ISO Guide 98-4:2012 Clause 8.2. (Measurement uncertainty is not taken into account when stating conformity with a specified requirement.)

4.3. MEASUREMENT UNCERTAINTY

Where relevant, the following measurement uncertainty levels have been estimated for tests performed on the apparatus:

4.4. MEASURING INSTRUMENT CALIBRATION

The measuring equipment utilized to perform the tests documented in this report has been calibrated in accordance with the manufacturer's recommendations, and is traceable to recognized national standards.

5. EQUIPMENT UNDER TEST

5.1. DESCRIPTION OF EUT

The Apple iPhone is a smartphone with cellular GSM, GPRS, EGPRS, WCDMA, LTE, 5GNR1, 5GNR2, IEEE 802.11a/b/g/n/ac/ax/be, Bluetooth (BT), Ultra-Wideband (UWB), Global Positioning System (GPS), Near-Field Communication (NFC), Narrow-Band (NB) UNII, 802.15.4, 802.15.4ab-Narrow Band (NB), Wireless Power Transfer (WPT) and Mobile Satellite Service (MSS) technologies. The rechargeable battery is not user accessible. This device is not user-serviceable and requires special tools to disassemble.



7. END USER DEVICE ADDITIONAL REQUIREMENT

7.1. **TEST REQUIREMENT**

FCC Part 96.47

- (a) End User Devices may operate only if they can positively receive and decode an authorization signal transmitted by a CBSD, including the frequencies and power limits for their operation.
- (1) An End User Device must discontinue operations, change frequencies, or change its operational power level within 10 seconds of receiving instructions from its associated CBSD.

8. TEST PROCEDURE AND EUT CONFIGURATION

KDB 940660 D01 Part 96 CBRS v03, WINNF-TS-0122 V1.0.2

Additional requirements are required to End-User Device n48 device base on CBSD protocol. During the test, the EUT and its companion certified CBSD (FCC ID: 0) device communicate with each other via air. Plots are captured and measurements are done over the air, in which the path loss is not accounted for the correction of the output power.

- a) Setup Sercom with 3625MHz and power level 17 dBm/MHz
- b) Enable n48 service from admin control panel

- d) Disable n48 service from admin control panel and check EUT stop transmission within 10s.

Configuration 2

- a) Setup Sercom with 3670MHz and power level 12 dBm/MHz
- b) Enable n48 service from admin control panel
- c) Check EUT Transmitter Frequency and power
- d) Disable n48 service from admin control panel and check EUT stop transmission within 10s.
