2. TEST METHODOLOGY

The tests documented in this report were performed in accordance with FCC CFR 47 Part 2, FCC CFR 47 Part 15, FCC 06-96, FCC KDB 789033, ANSI C63.10-2009, RSS-GEN Issue 3, and RSS-210 Issue 8.

3. FACILITIES AND ACCREDITATION

The test sites and measurement facilities used to collect data are located at 47173 Benicia Street, Fremont, California, USA.

4. CALIBRATION AND UNCERTAINTY

4.1. MEASURING INSTRUMENT CALIBRATION

The measuring equipment utilized to perform the tests documented in this report has been calibrated in accordance with the manufacturer's recommendations, and is traceable to recognized national standards.

4.2. SAMPLE CALCULATION

Where relevant, the following sample calculation is provided:

Field Strength (dBuV/m) = Measured Voltage (dBuV) + Antenna Factor (dB/m) + Cable Loss (dB) – Preamp Gain (dB) 36.5 dBuV + 18.7 dB/m + 0.6 dB – 26.9 dB = 28.9 dBuV/m

Note 1: This is the level at the input of the receiver assuming a 0 dBi receive antenna Note 2: Throughout these test procedures an additional 1 dB has been added to the amplitude of the test transmission waveforms to account for variations in measurement equipment. This will ensure that the test signal is at or above the detection threshold level to trigger a DFS response.

The instant that the *Channel Move Time* and the *Channel Closing Transmission Time* begins is as follows:

For the Short pulse radar Test Signals this instant is the end of the *Burst*.

For the Frequency Hopping radar Test Signal, this instant is the end of the last radar burst generated.

For the Long Pulse radar Test Signal this instant is the end of the 12 second period defining the radar transmission.

The Channel Closing Transmission Time is comprised of 200 milliseconds starting at the beginning of the Channel Move Time plus any additional intermittent control signals required to facilitate channel changes (an aggregate of approximately 60 milliseconds) during the remainder of the 10 second period. The aggregate duration of control signals will not count quiet periods in between transmissions.



5.1.2. TEST AND MEASUREMENT SYSTEM

RADIATED METHOD SYSTEM BLOCK DIAGRAM



SYSTEM OVERVIEW

The short pulse and long pulse signal generating system utilizes the NTIA software. The Vector Signal Generator has been validated by the NTIA. The hopping signal generating system utilizes the CCS simulated hopping method and system, which has been validated by the DoD, FCC and NTIA. The software selects waveform parameters from within the bounds of the signal type on a random basis using uniform distribution.

The short pulse types 2, 3 and 4, and the long pulse type 5 parameters are randomized at runtime.

The hopping type 6 pulse parameters are fixed while the hopping sequence is based on the August 2005 NTIA Hopping Frequency List. The initial starting point randomized at run-time and each subsequent starting point is incremented by 475. Each frequency in the 100-length segment is compared to the boundaries of the EUT Detection Bandwidth and the software creates a hopping burst pattern in accordance with Section 7.4.1.3 Method #2 Simulated Frequency Hopping Radar Waveform Generating Subsystem of FCC 06-96 APPENDIX. The frequency of the signal generator is incremented in 1 MHz steps from F_L to F_H for each successive trial. This incremental sequence is repeated as required to generate a minimum of 30 total trials and to maintain a uniform frequency distribution over the entire Detection Bandwidth.

The signal monitoring equipment consists of a spectrum analyzer. The aggregate ON time is calculated by multiplying the number of bins above a threshold during a particular observation period by the dwell time per bin, with the analyzer set to peak detection and max hold.

SYSTEM CALIBRATION

A 50-ohm load is connected in place of the spectrum analyzer, and the spectrum analyzer is connected to a horn antenna via a coaxial cable, with the reference level offset set to (horn antenna gain – coaxial cable loss). The signal generator is set to CW mode. The amplitude of the signal generator is adjusted to yield a level of –64 dBm as measured on the spectrum analyzer.

Without changing any of the instrument settings, the spectrum analyzer is reconnected to the Common port of the Spectrum Analyzer Combiner/Divider. The Reference Level Offset of the spectrum analyzer is adjusted so that the displayed amplitude of the signal is –64 dBm.

The spectrum analyzer displays the level of the signal generator as received at the antenna ports of the Master Device. The interference detection threshold may be varied from the calibrated value of –64 dBm and the spectrum analyzer will still indicate the level as received by the Master Device.

ADJUSTMENT OF DISPLAYED TRAFFIC LEVEL

A link is established between the Master and Slave and the distance between the units is adjusted as needed to provide a suitable received level at the Master and Slave devices. The video test file is streamed to generate WLAN traffic. The monitoring antenna is adjusted so that the WLAN traffic level, as displayed on the spectrum analyzer, is at lower amplitude than the radar detection threshold.



RADIATED METHOD EUT TEST SETUP





5.1.4. DESCRIPTION OF EUT

The EUT operates over the 5250-5350 MHz and 5470-5725 MHz ranges.

The EUT is a Slave Device without Radar Detection.

The highest power level within these bands is 22.35 dBm EIRP in the 5250-5350 MHz band and 21.41 dBm EIRP in the 5470-5725 MHz band.

The only antenna assembly utilized with the EUT has a gain of 4.63 dBi in the 5250-5350 MHz band and 4.51 dBi in the 5470-5725 MHz band.

The rated output power of the Master unit is > 23dBm (EIRP). Therefore the required interference threshold level is -64 dBm. After correction for procedural adjustments, the required radiated threshold at the antenna port is -64 + 1 = -63 dBm.

The calibrated radiated DFS Detection Threshold level is set to -64 dBm. The tested level is lower than the required level hence it provides margin to the limit.

The EUT uses one transmitter/receiver chain connected to an antenna to perform radiated tests.

In the client mode, WLAN traffic is generated by streaming the video file TestFile.mp2 "6 ½ Magic Hours" from the Master to the Slave in full motion video mode using Safari web browser. In the Client-to-Client Communications mode, WLAN traffic is generated by streaming the video file TestFile.mp2 "6 ½ Magic Hours" from the Master, to the Slave, and mirror to the peer slave device in full motion video mode using Safari web browser.

TPC is not required since the maximum EIRP is less than 500 mW (27 dBm).

The EUT utilizes the 802.11a/n architecture. Two nominal channel bandwidths of 20 MHz and 40 MHz are implemented in standard client mode.

One nominal channel bandwidth of 20 MHz is implemented in Client-to-Client Communications mode.

The software installed in the EUT is IOS (Build 10A378).

UNIFORM CHANNEL SPREADING

This requirement is not applicable to Slave radio devices.

OVERVIEW OF MASTER DEVICE WITH RESPECT TO §15.407 (h) REQUIREMENTS

The Master Device is a Cisco Access Point, FCC ID: LDK102061. The minimum antenna gain for the Master Device is 3.5 dBi.

The rated output power of the Master unit is > 23dBm (EIRP). Therefore the required interference threshold level is -64 dBm. After correction for procedural adjustments, the required radiated threshold at the antenna port is -64 + 1 = -63 dBm.

The calibrated radiated DFS Detection Threshold level is set to –64 dBm. The tested level is lower than the required level hence it provides margin to the limit.








CHANNEL CLOSING TIME




AGGREGATE CHANNEL CLOSING TRANSMISSION TIME






CHANNEL CLOSING TIME




AGGREGATE CHANNEL CLOSING TRANSMISSION TIME








CHANNEL CLOSING TIME
