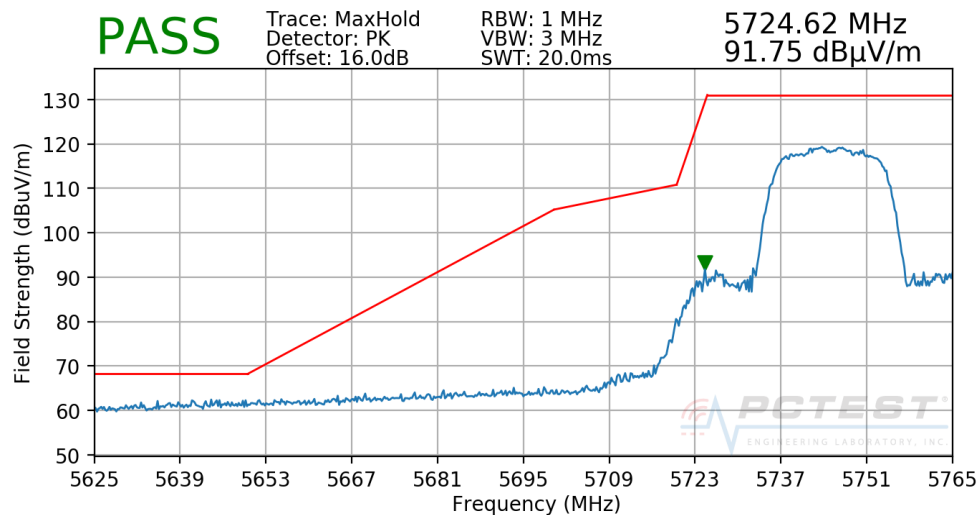

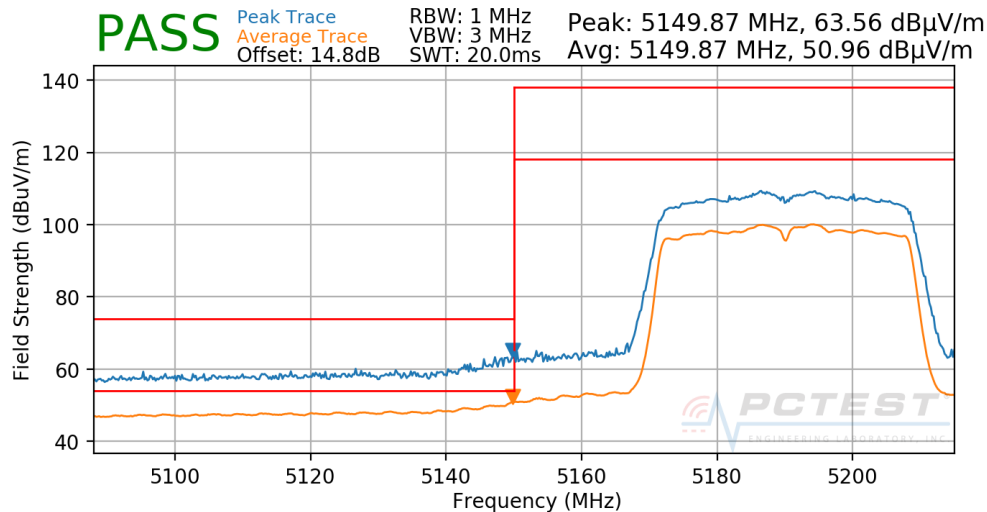

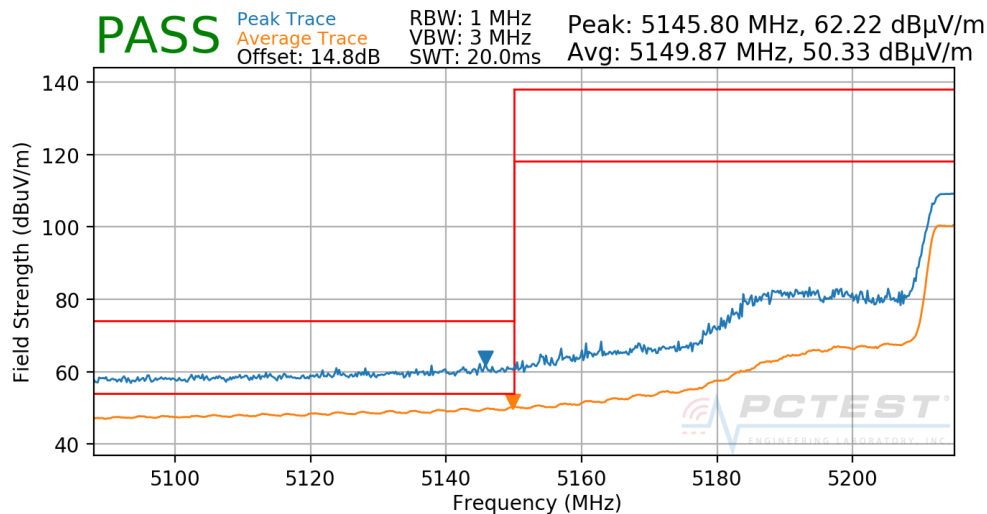

Plot 7-236. Radiated Lower Band Edge Plot SISO CORE1 (UNII Band 1)

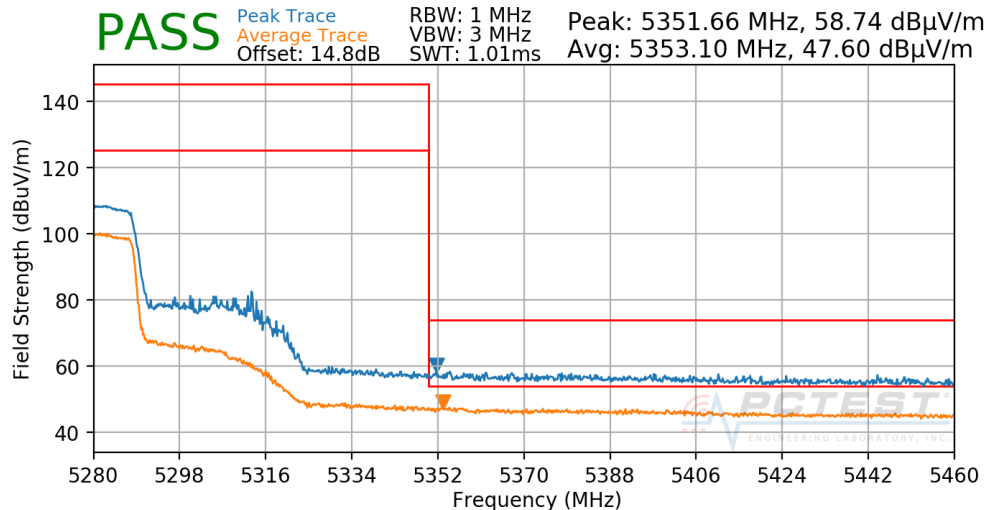

Plot 7-237. Radiated Lower Band Edge Plot SISO CORE1 (UNII Band 1)

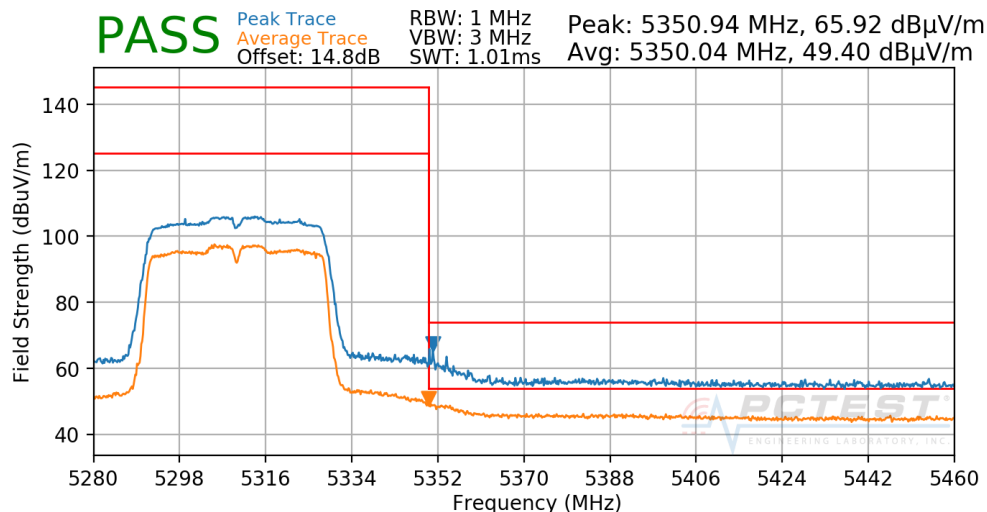

Plot 7-238. Radiated Upper Band Edge Plot SISO CORE1 (UNII Band 2A)

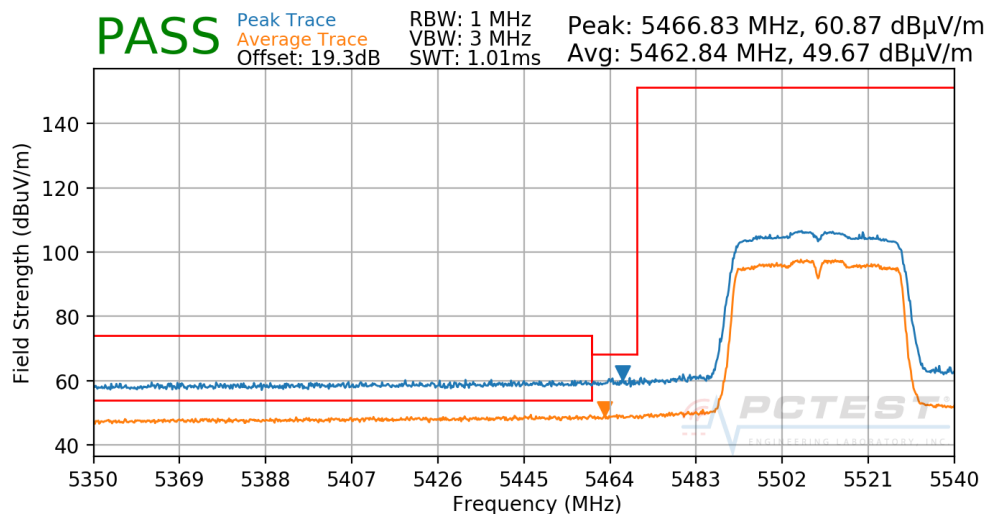

Plot 7-239. Radiated Upper Band Edge Plot SISO CORE1 (UNII Band 2A)

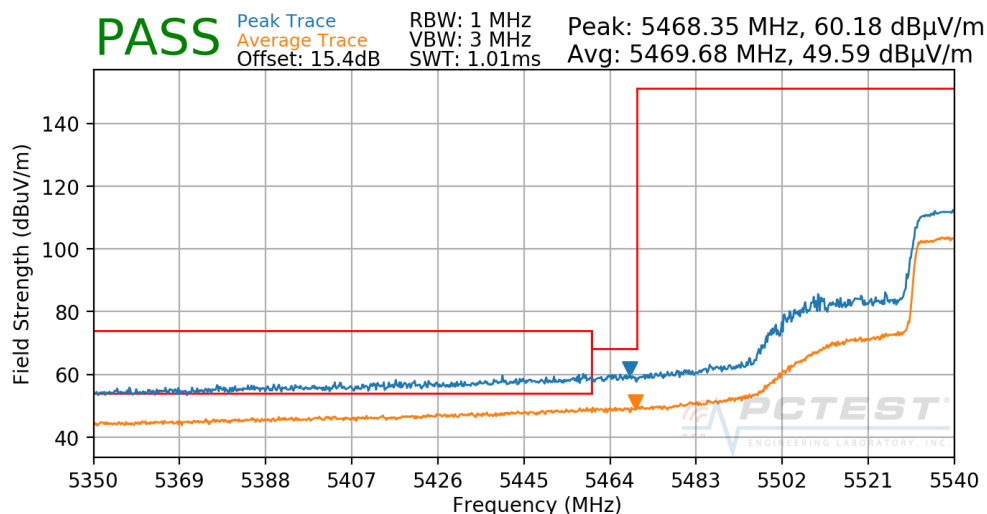

Plot 7-240. Radiated Lower Band Edge Plot SISO CORE1 (UNII Band 2C)

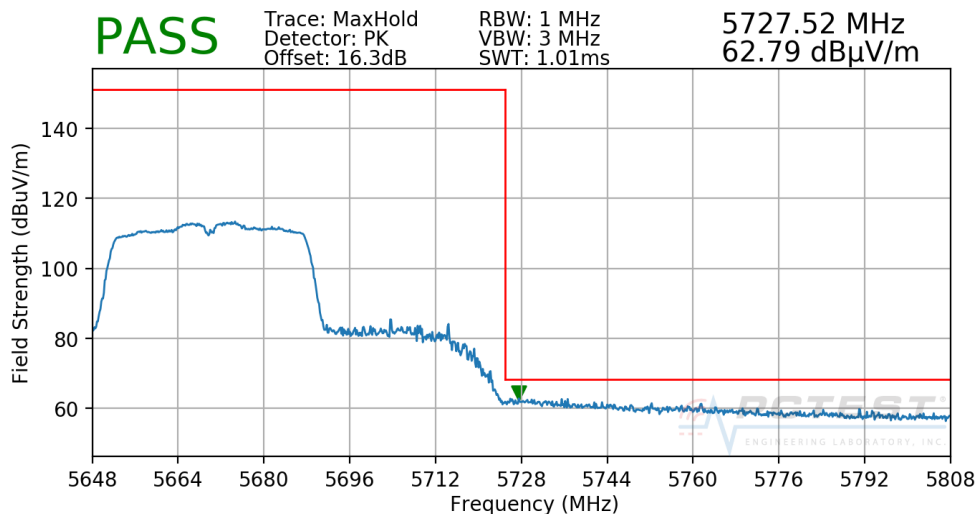

Plot 7-241. Radiated Upper Band Edge Plot SISO CORE1 (Peak - UNII Band 2C)

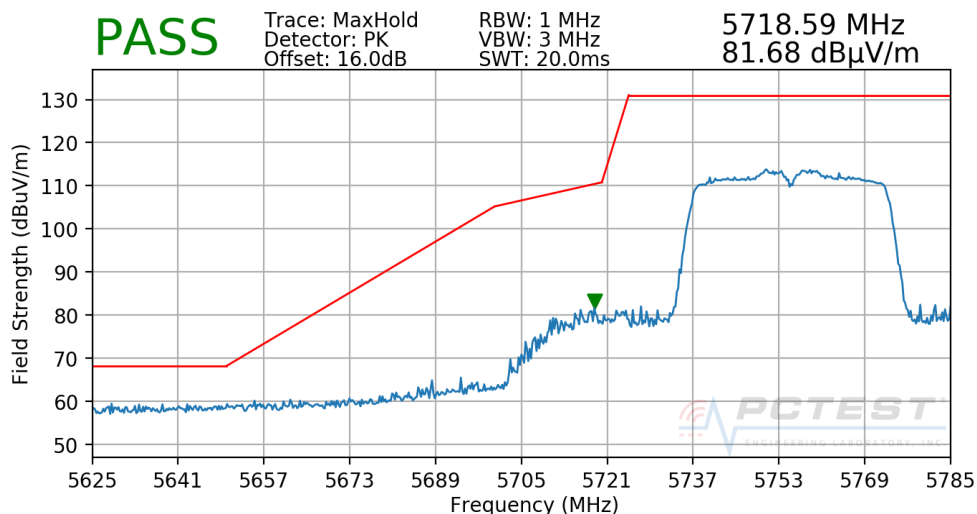

Plot 7-242. Radiated Upper Band Edge Plot SISO CORE1 (Peak - UNII Band 2C)

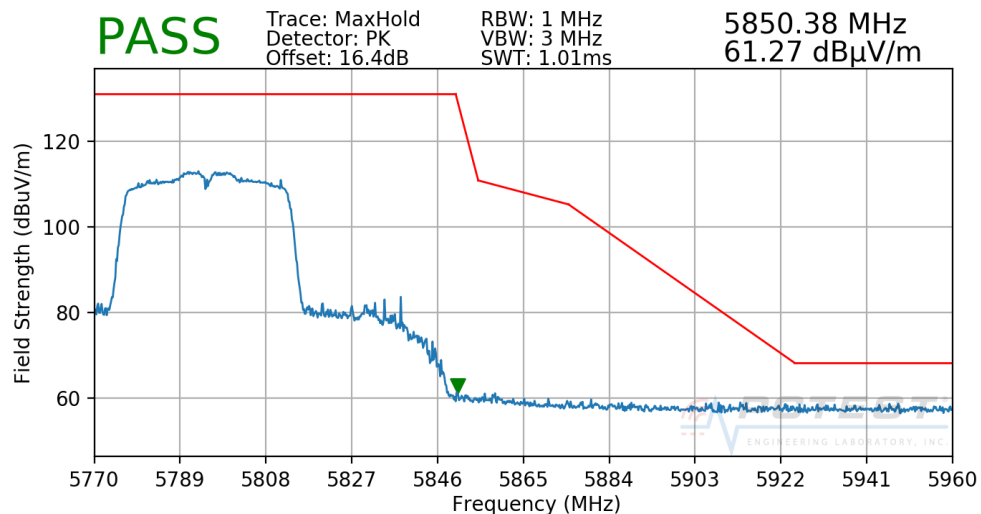

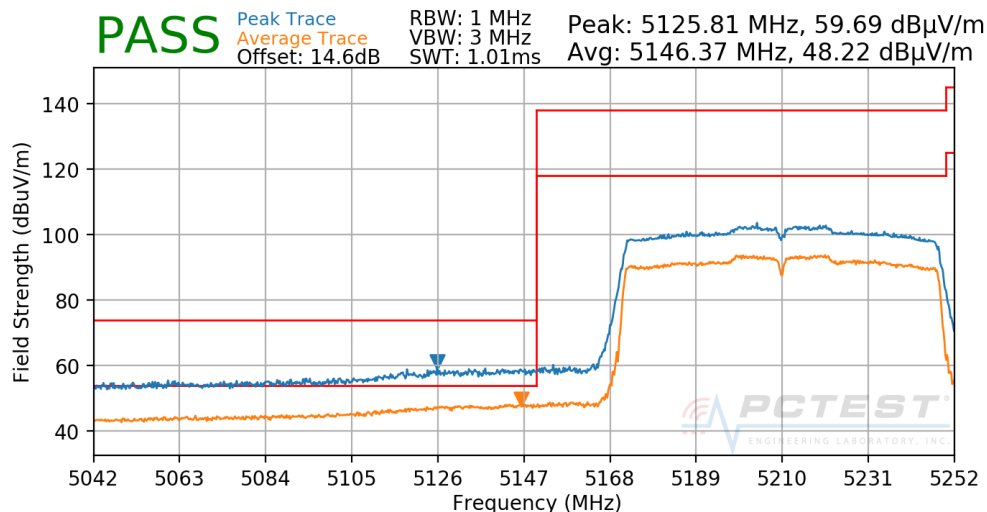
Plot 7-244. Radiated Upper Band Edge Plot SISO CORE1 (Peak – UNII Band 3)

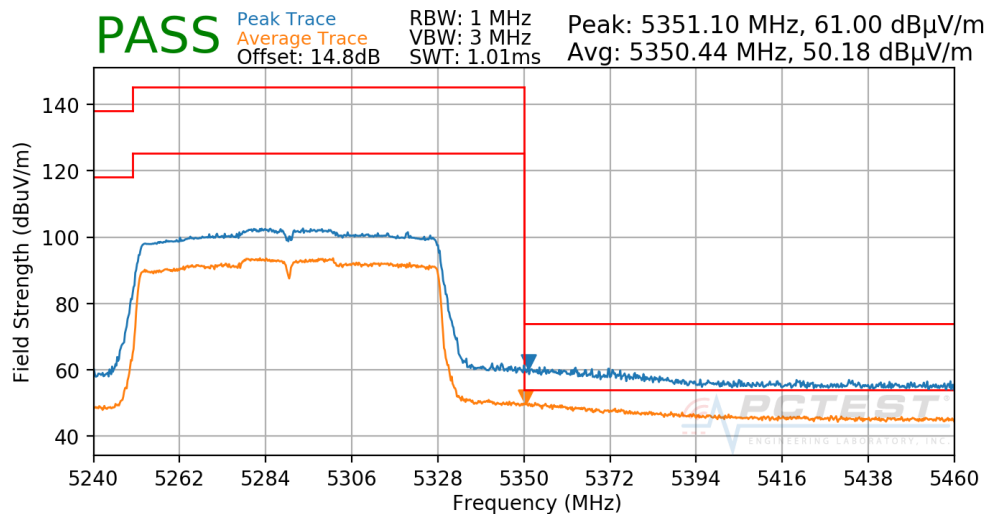

Plot 7-245. Radiated Lower Band Edge Plot SISO CORE1 (UNII Band 1)

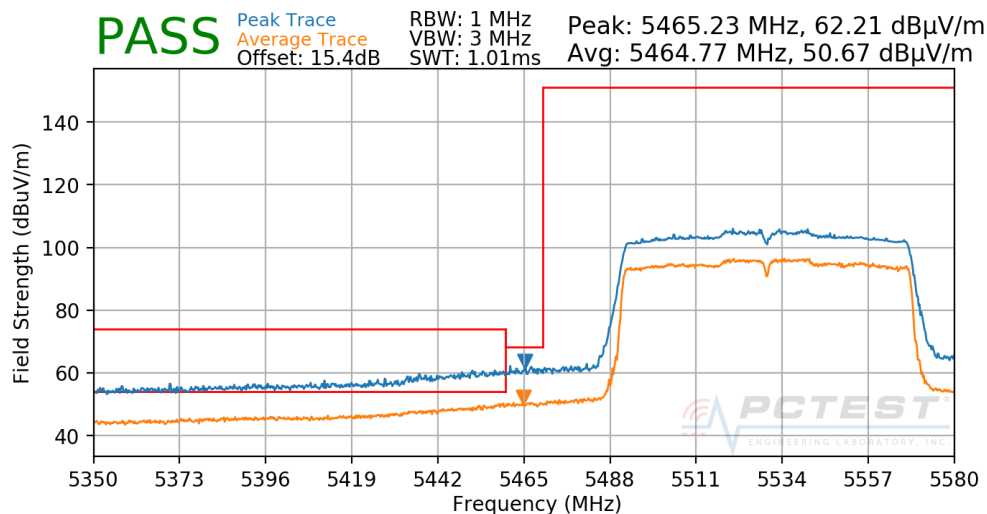

Plot 7-246. Radiated Upper Band Edge Plot SISO CORE1 (UNII Band 2A)

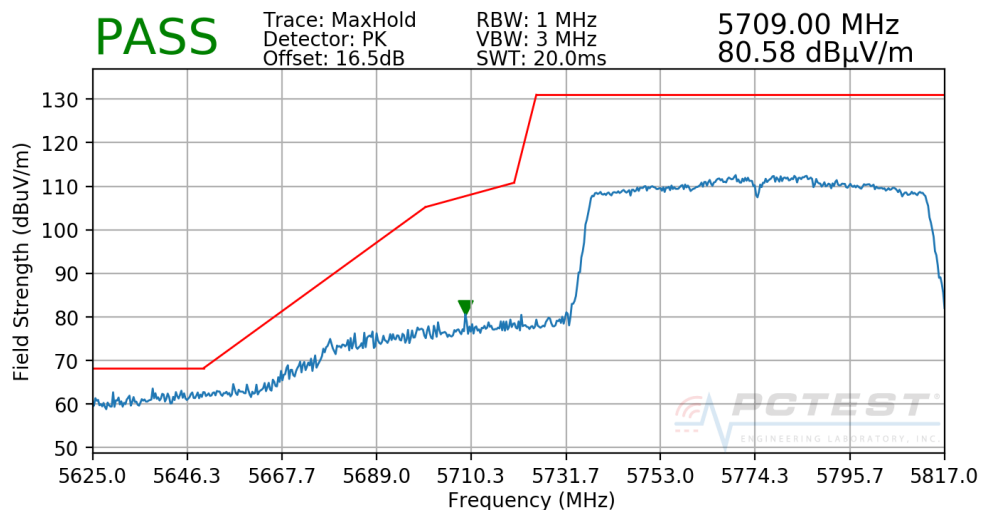

Plot 7-247. Radiated Lower Band Edge Plot SISO CORE1 (UNII Band 2C)

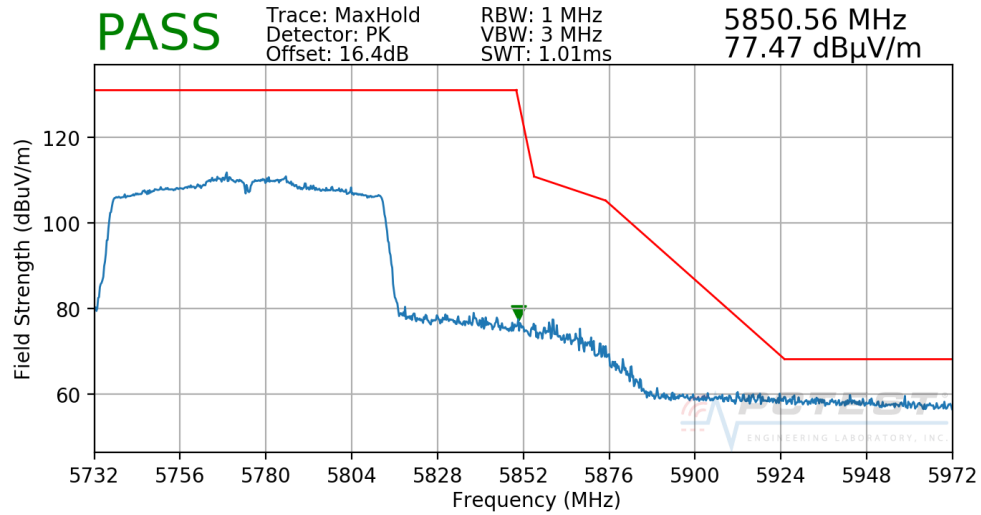

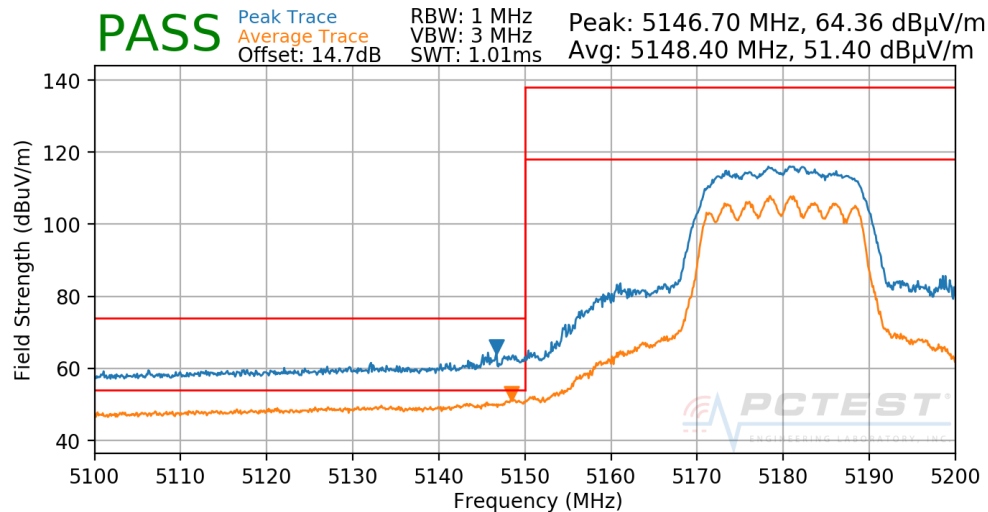
Plot 7-249. Radiated Upper Band Edge Plot SISO CORE1 (Peak – UNII Band 3)

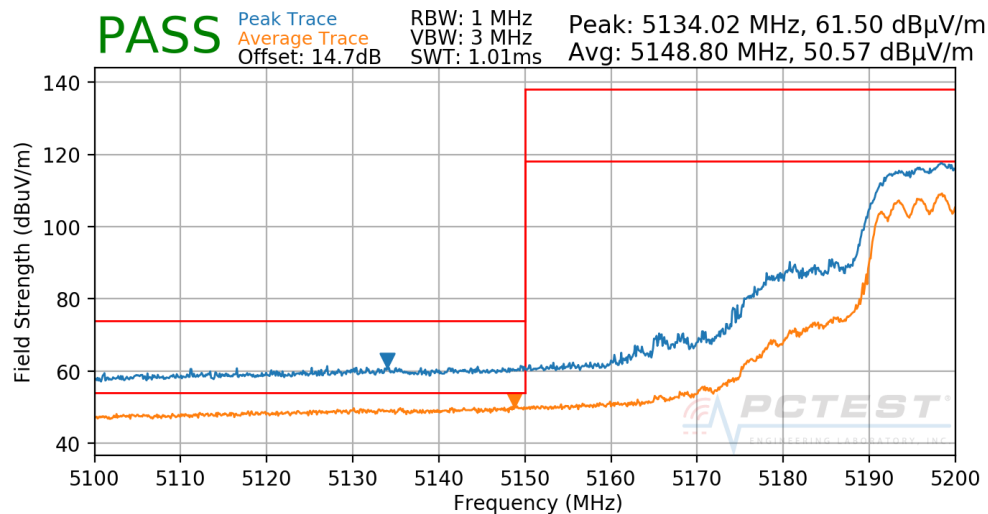

Plot 7-250. Radiated Lower Band Edge Plot CDD (UNII Band 1)

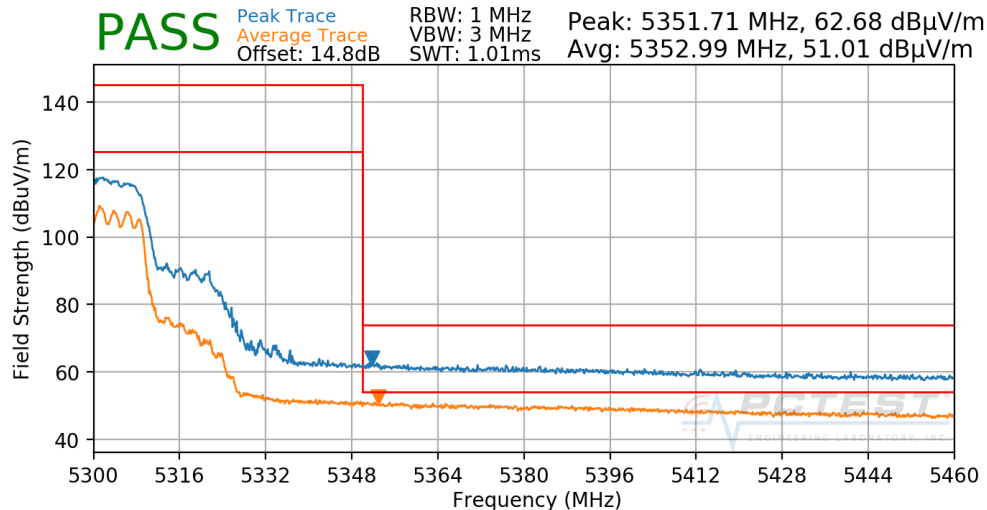

Plot 7-251. Radiated Lower Band Edge Plot CDD (UNII Band 1)

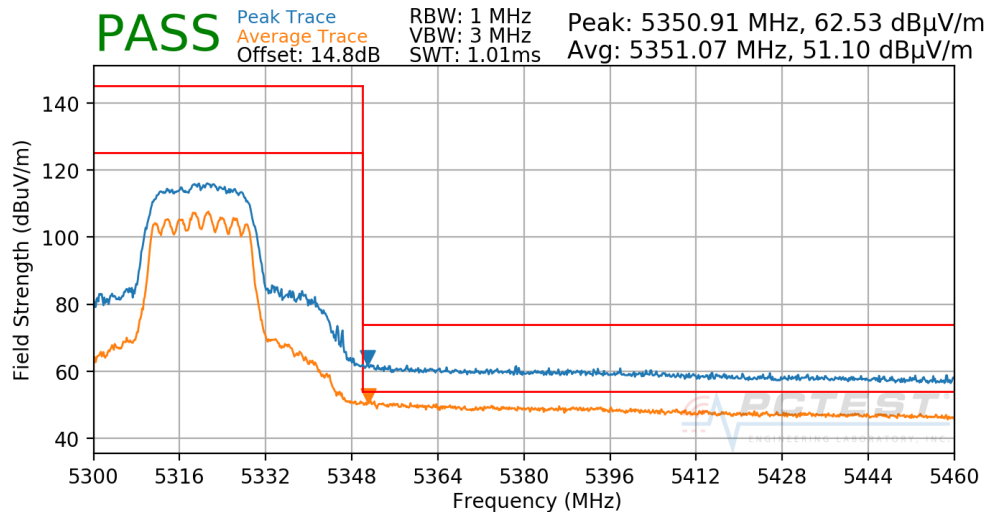

Plot 7-252. Radiated Upper Band Edge Plot CDD (UNII Band 2A)

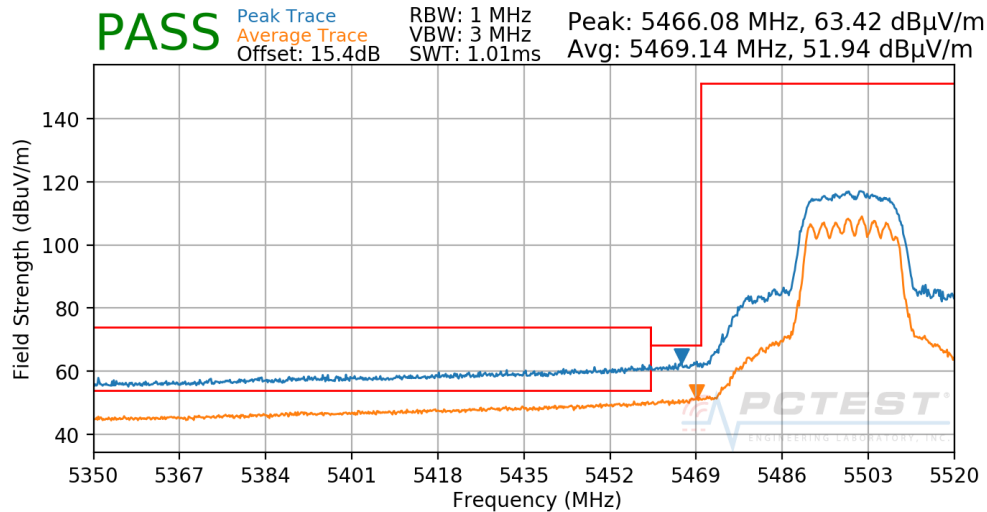

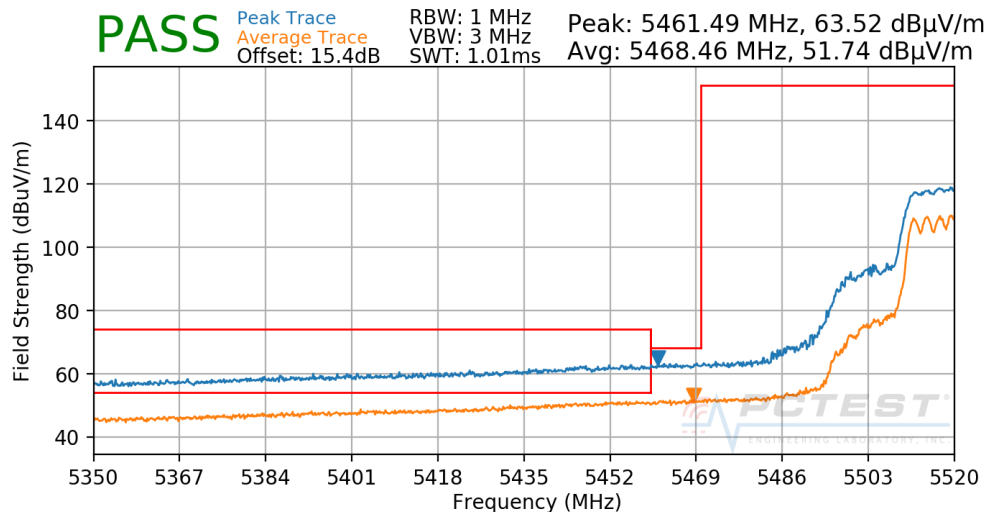

Plot 7-254. Radiated Lower Band Edge Plot CDD (UNII Band 2C)

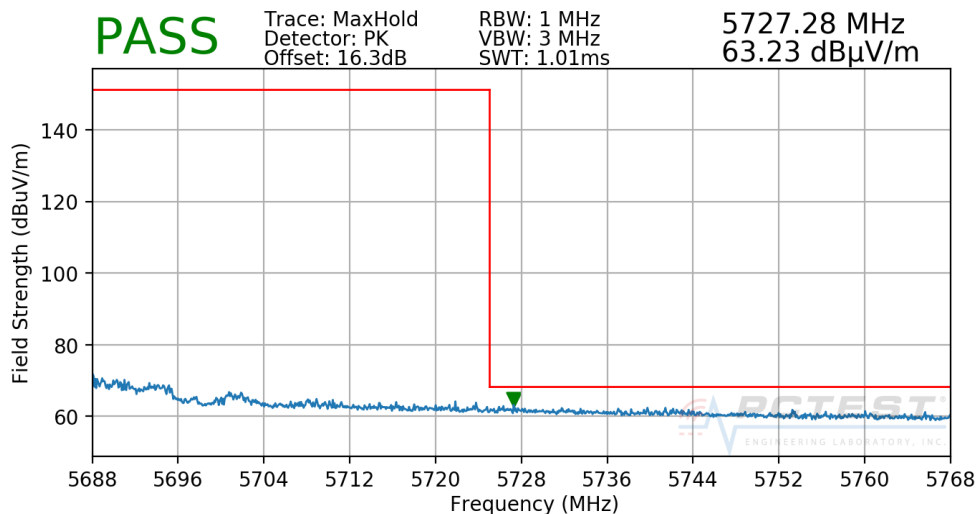

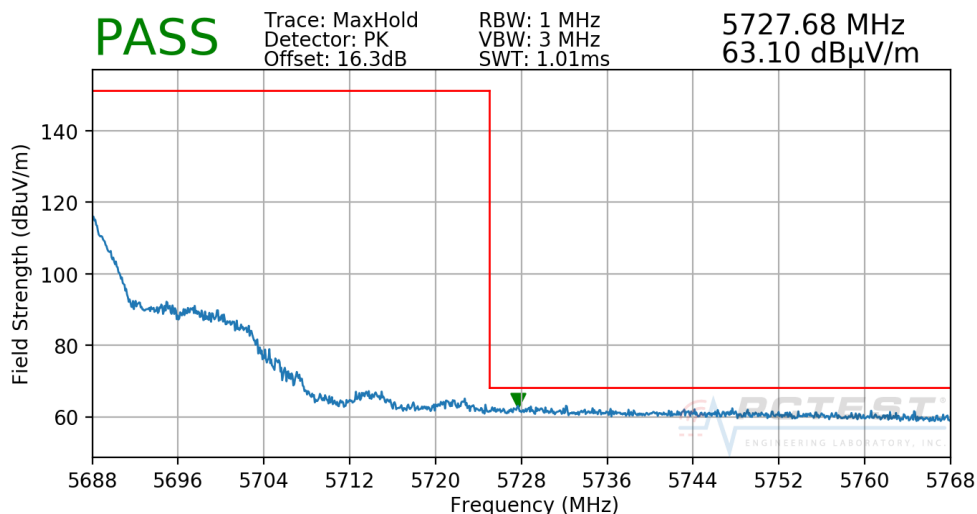

Plot 7-256. Radiated Upper Band Edge Plot CDD (Peak – UNII Band 2C)

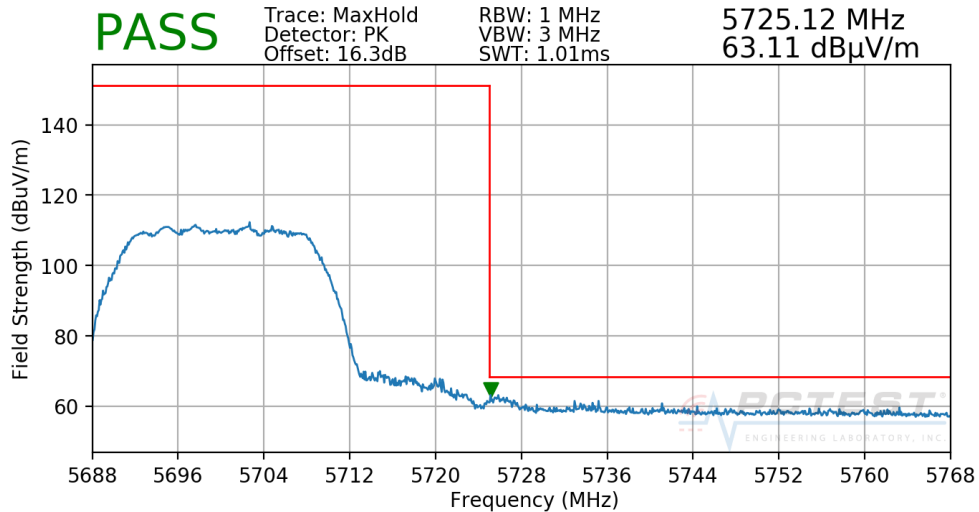

Plot 7-257. Radiated Upper Band Edge Plot CDD (Peak – UNII Band 2C)

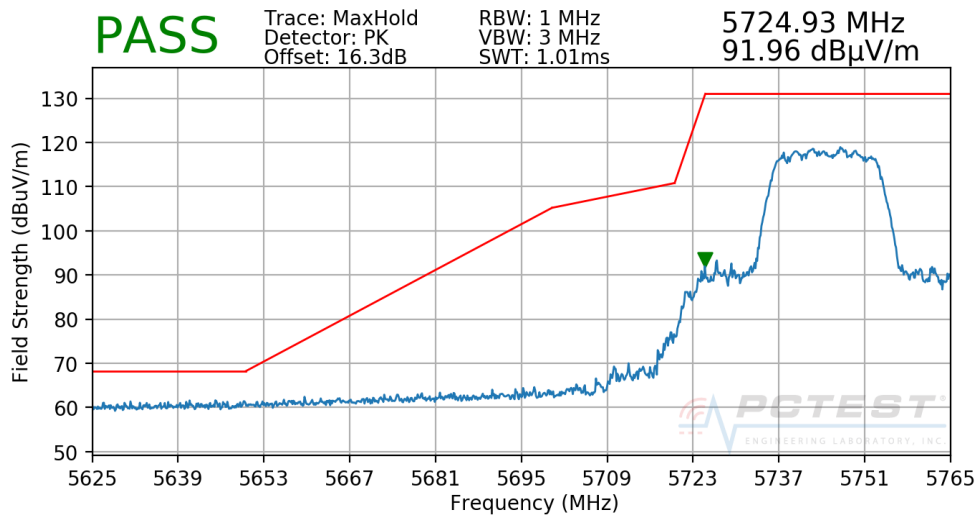

Plot 7-258. Radiated Upper Band Edge Plot CDD (Peak – UNII Band 2C)

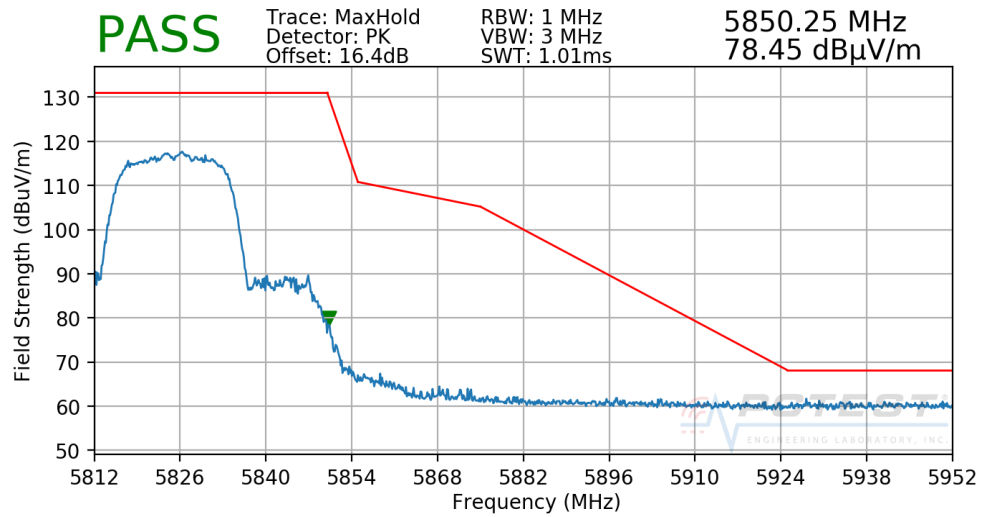

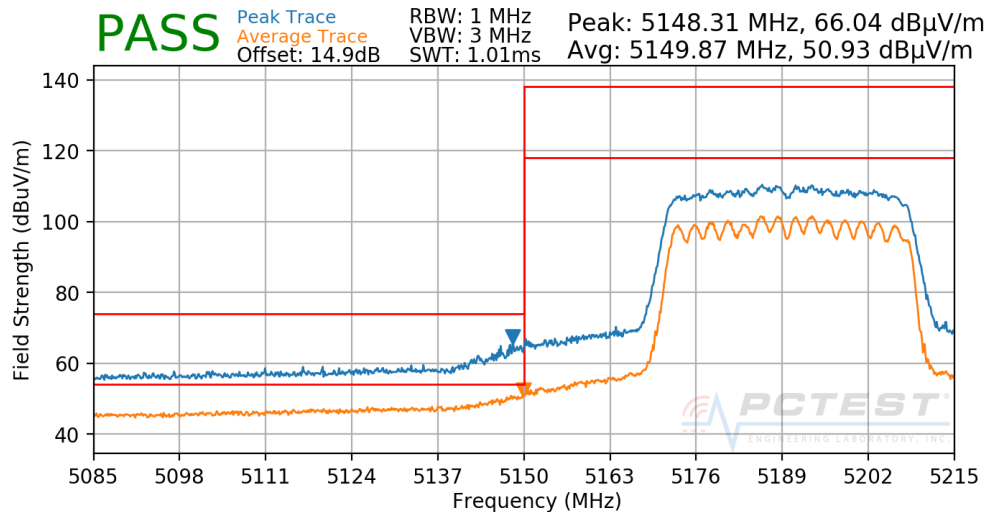
Plot 7-260. Radiated Upper Band Edge Plot CDD (Peak – UNII Band 3)

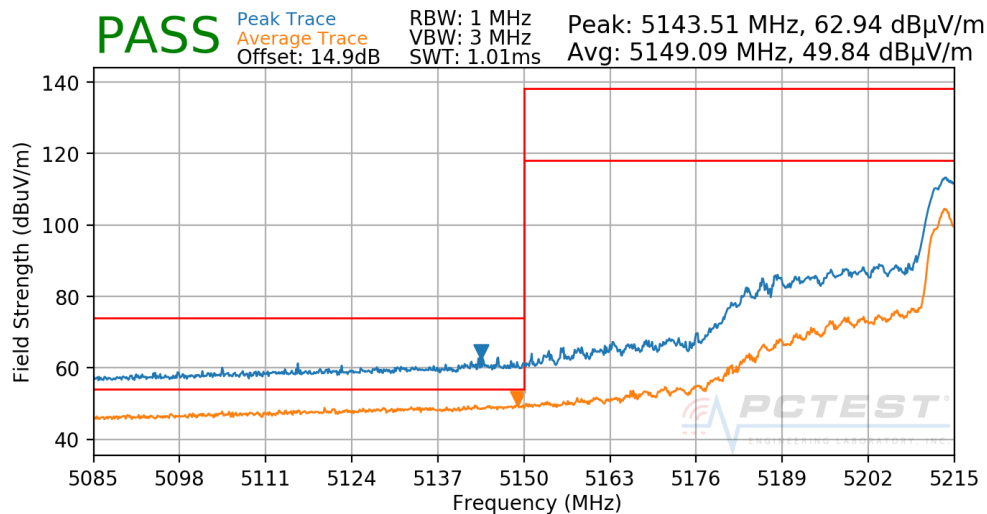

Plot 7-261. Radiated Lower Band Edge Plot CDD (UNII Band 1)

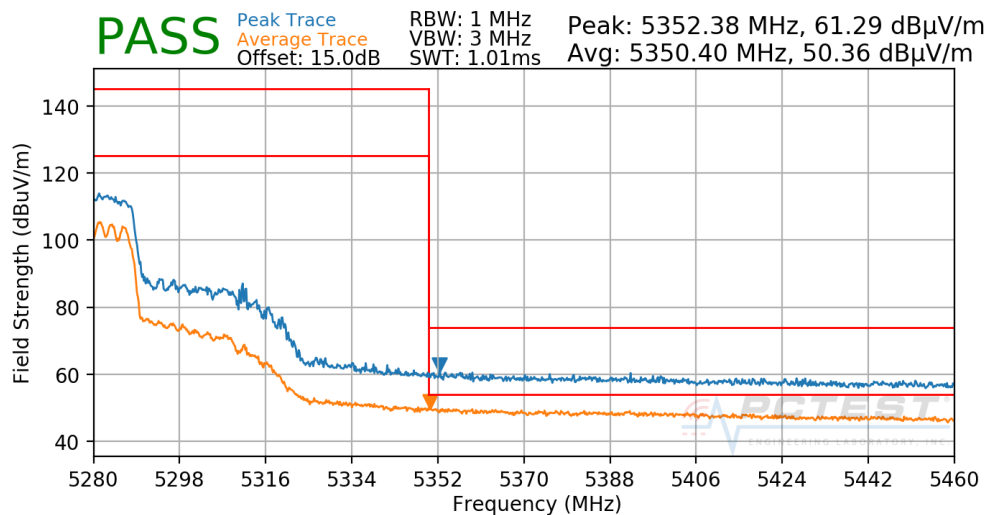

Plot 7-262. Radiated Lower Band Edge Plot CDD (UNII Band 1)

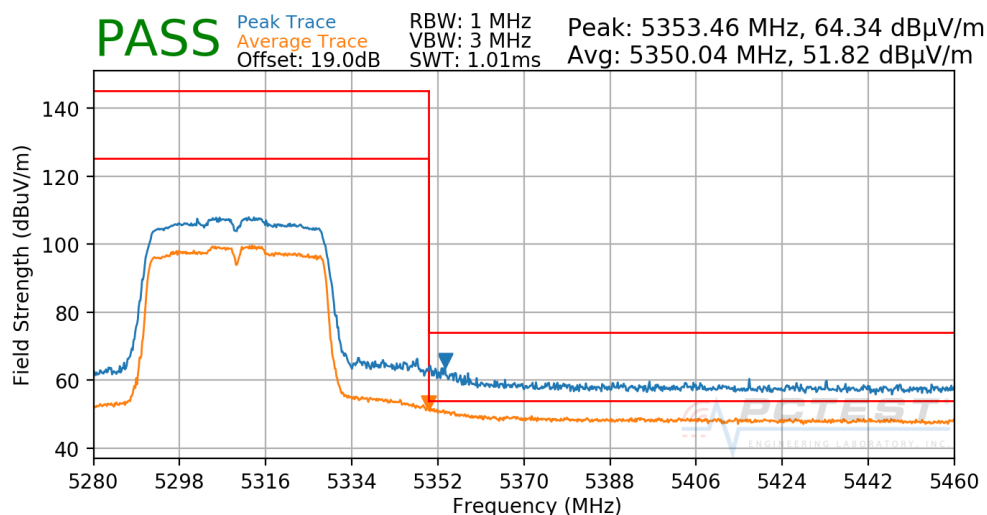

Plot 7-263. Radiated Upper Band Edge Plot CDD (UNII Band 2A)

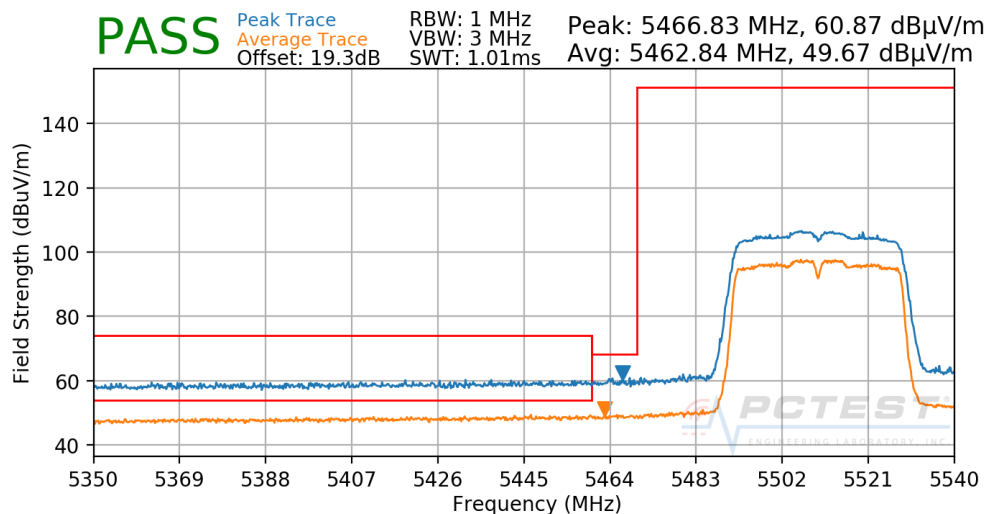

Plot 7-264. Radiated Upper Band Edge Plot CDD (UNII Band 2A)

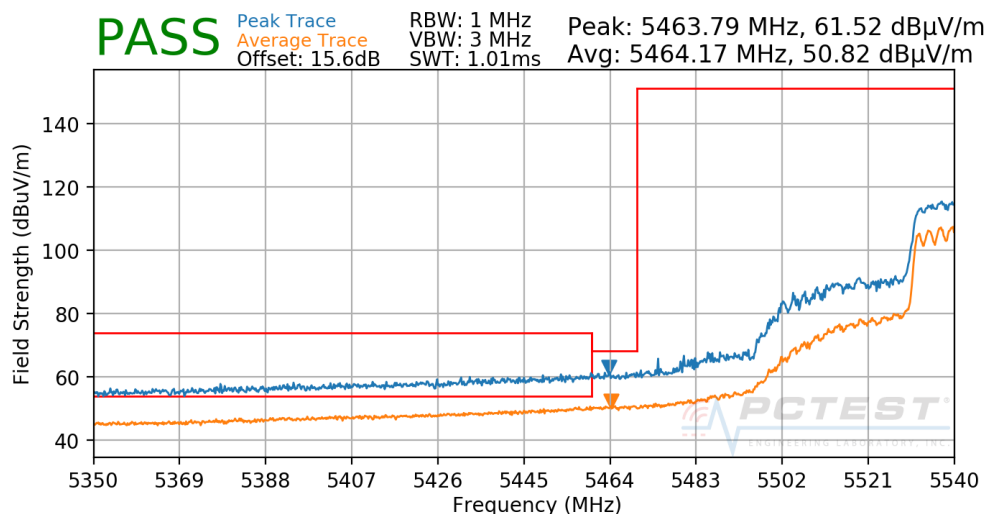

Plot 7-265. Radiated Lower Band Edge Plot CDD (UNII Band 2C)

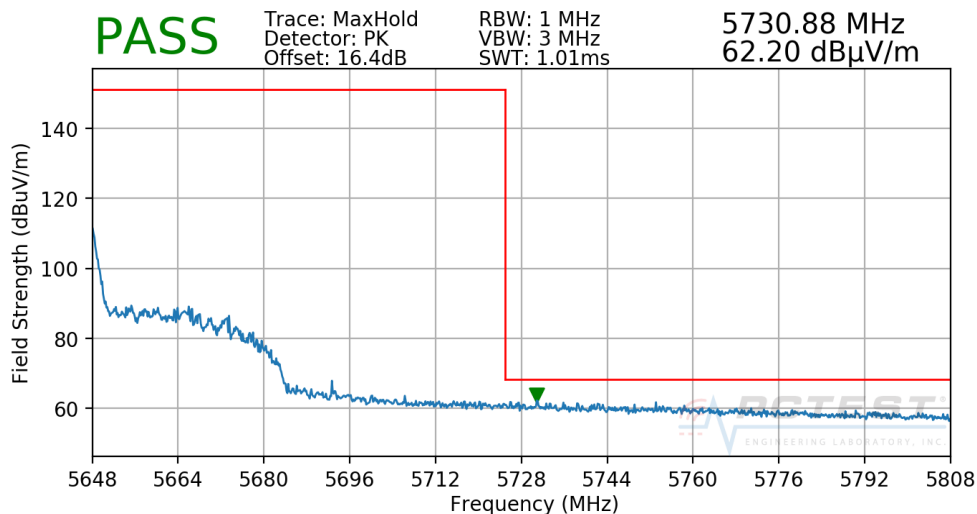

Plot 7-266. Radiated Lower Band Edge Plot CDD (Peak - UNII Band 2C)

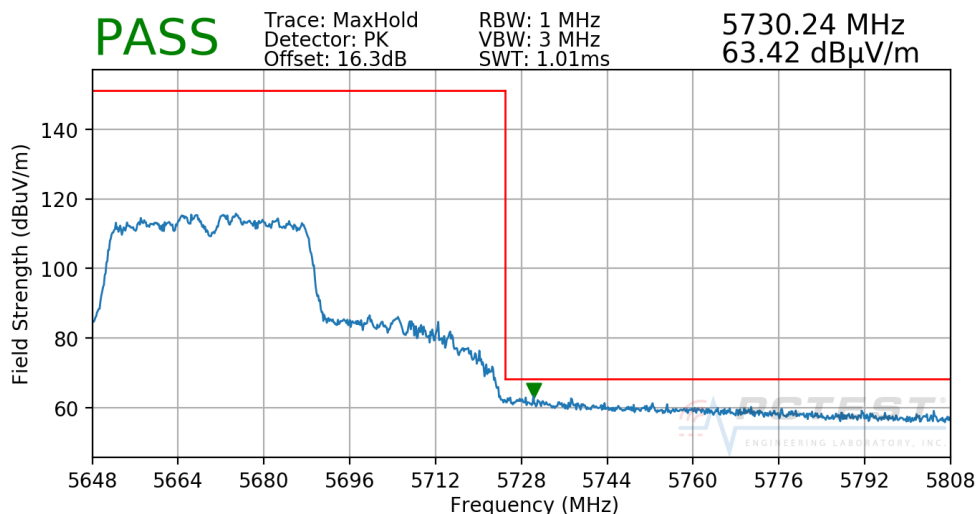

Plot 7-267. Radiated Upper Band Edge Plot CDD (Peak - UNII Band 2C)

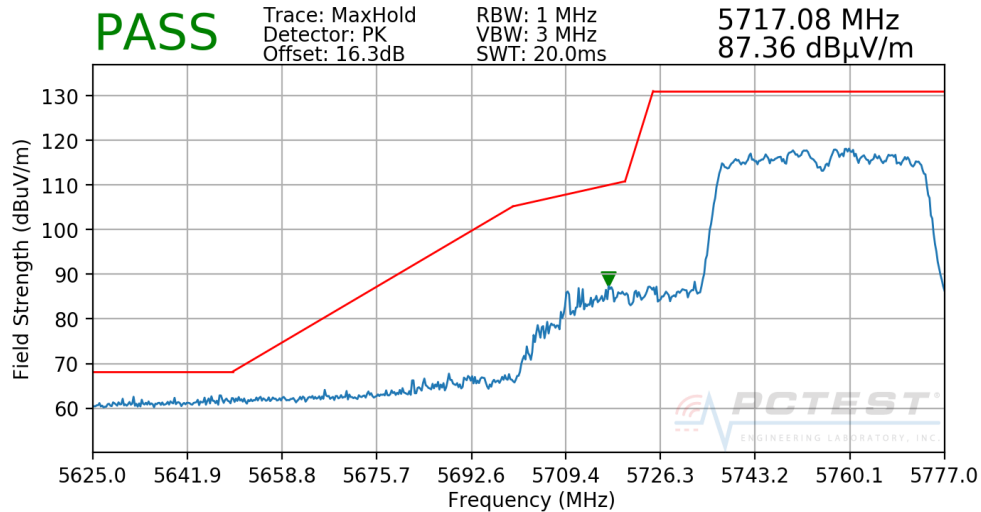

Plot 7-268. Radiated Upper Band Edge Plot CDD (Peak - UNII Band 2C)

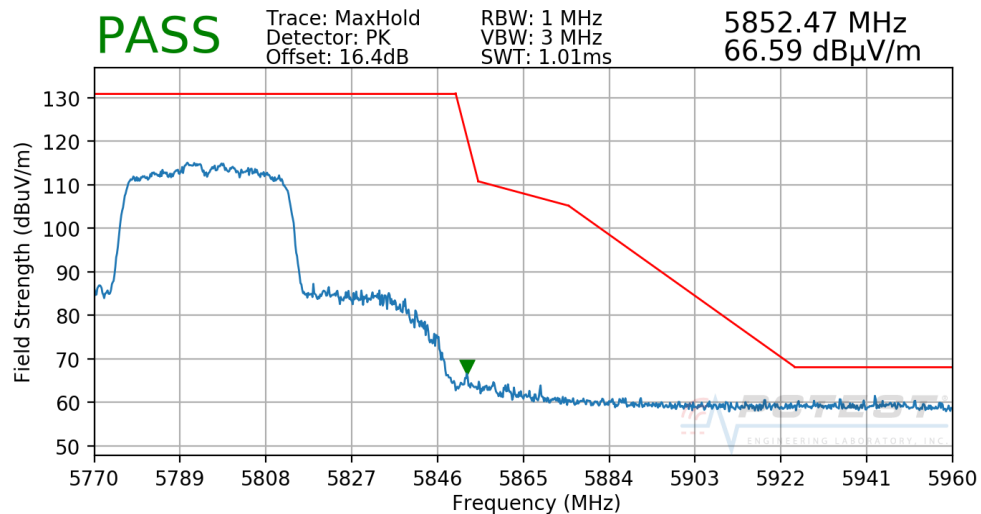

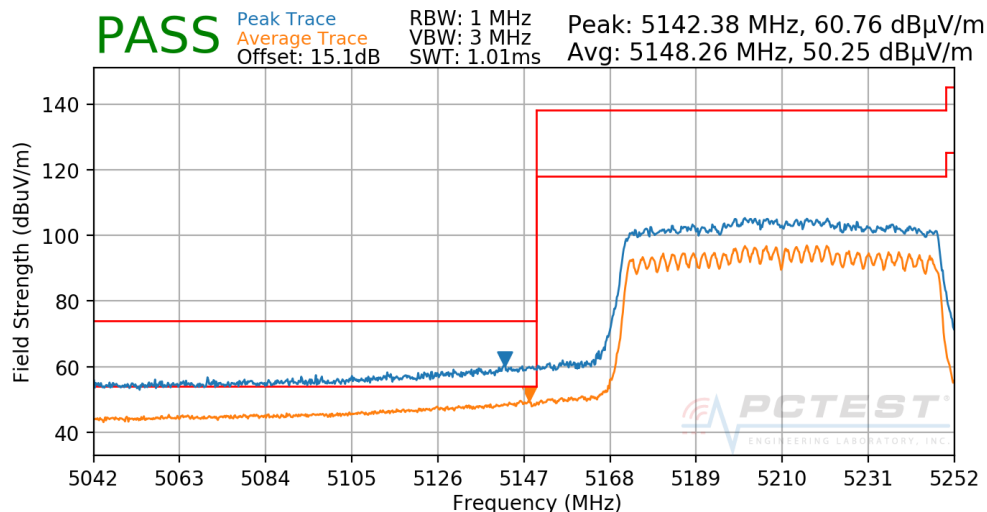

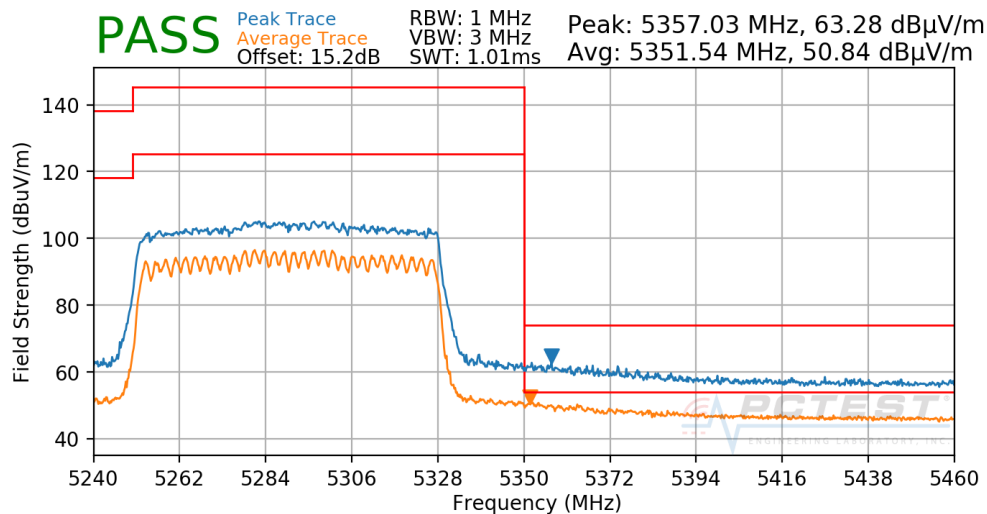

Plot 7-271. Radiated Lower Band Edge Plot CDD (UNII Band 1)

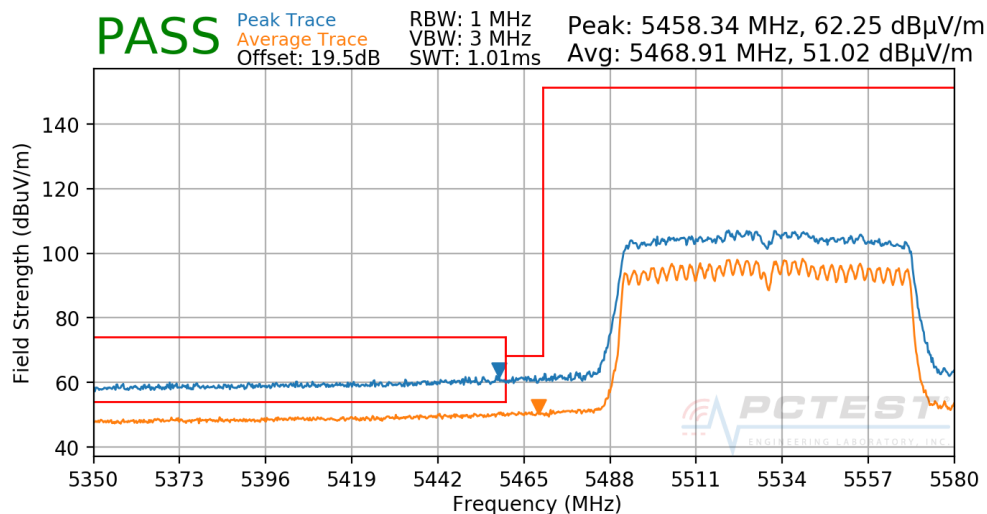

Plot 7-272. Radiated Upper Band Edge Plot CDD (UNII Band 2A)

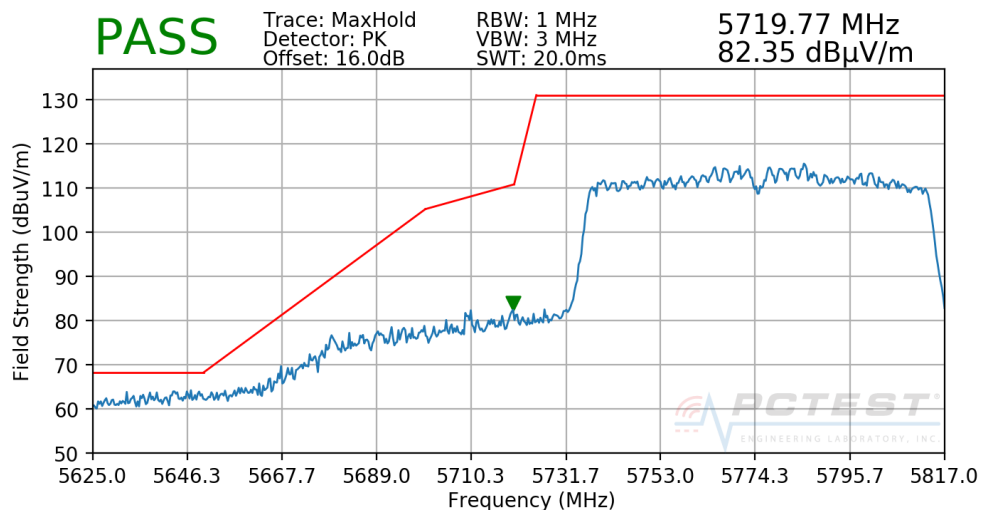

Plot 7-273. Radiated Lower Band Edge Plot CDD (UNII Band 2C)

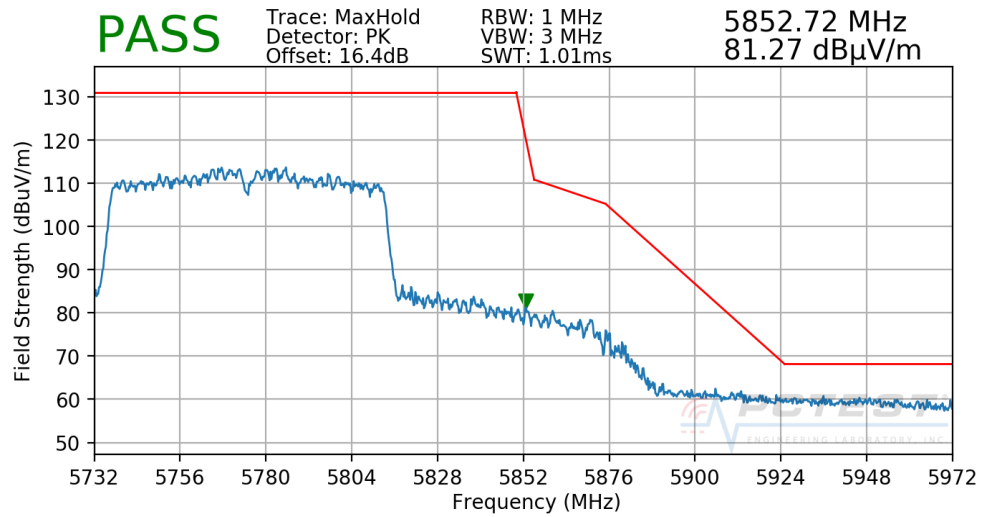

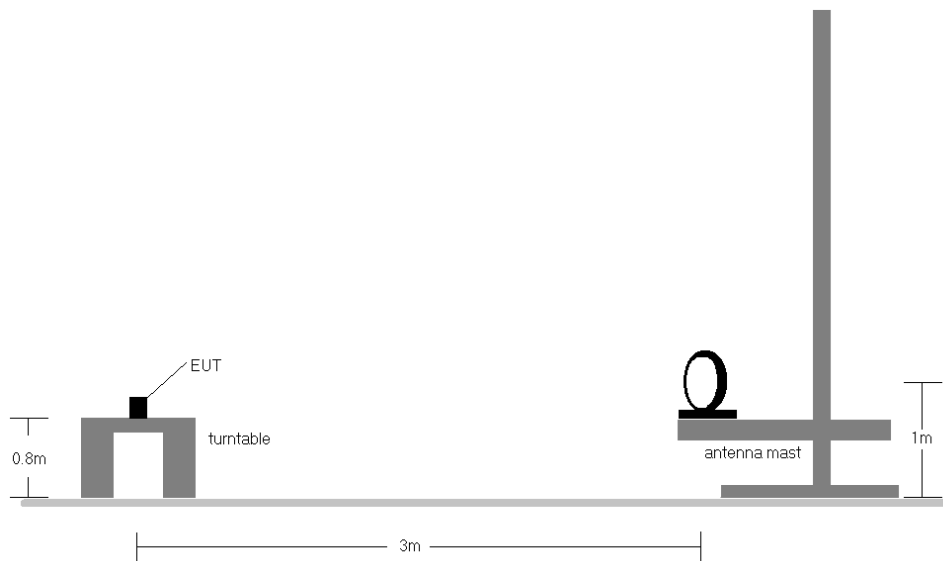


Figure 7-6. Radiated Test Setup < 30MHz

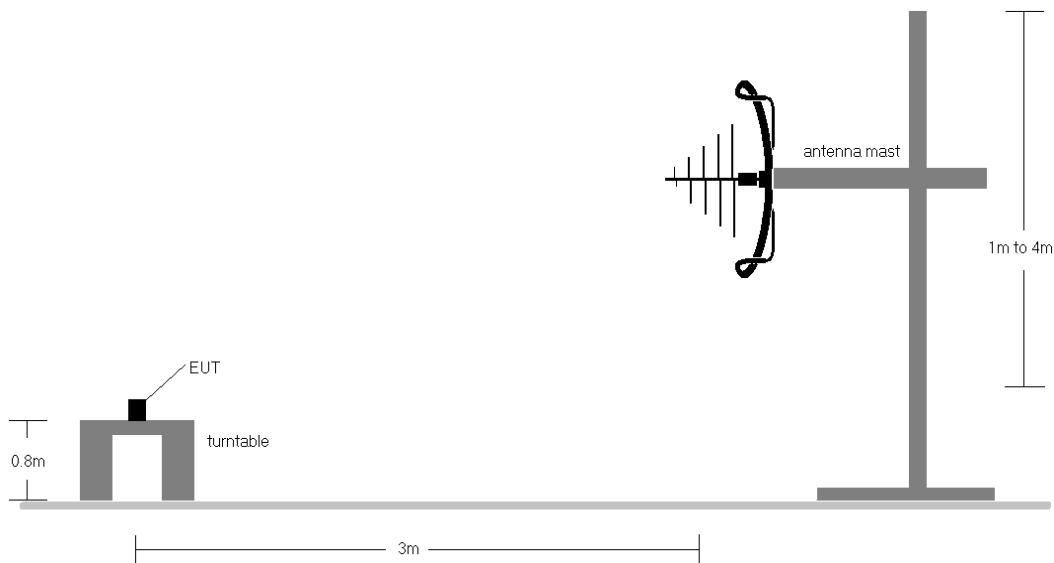


Figure 7-7. Radiated Test Setup < 1GHz

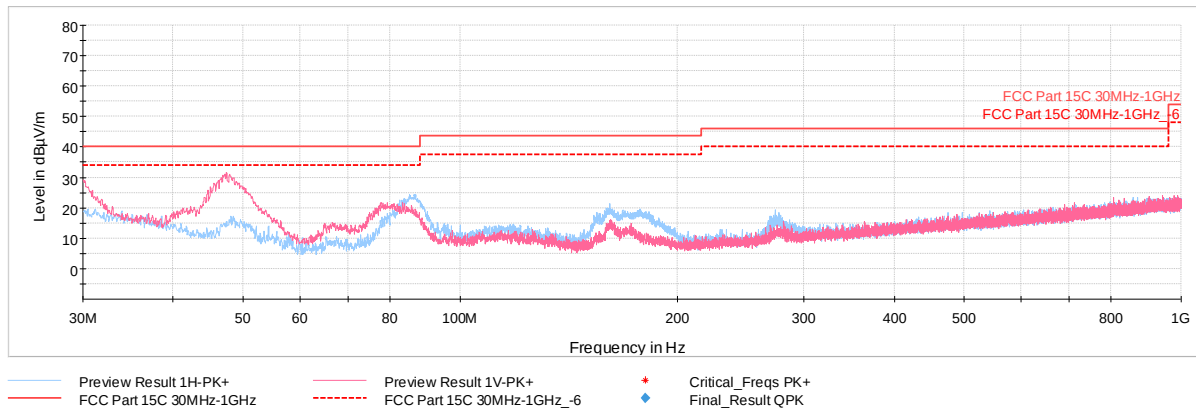

1. All emissions lying in restricted bands specified in §15.205 and RSS-Gen (8.10) are below the limit shown in Table 7-72.
2. The broadband receive antenna is manipulated through vertical and horizontal polarizations during the tests. The EUT is manipulated through three orthogonal planes.

All AC line conducted spurious emissions are measured with a receiver connected to a grounded LISN while the EUT is operating at its maximum duty cycle, at maximum power, and at the appropriate frequencies. All data rates and modes were investigated for conducted spurious emissions. Only the conducted emissions of the configuration that produced the worst case emissions are reported in this section.

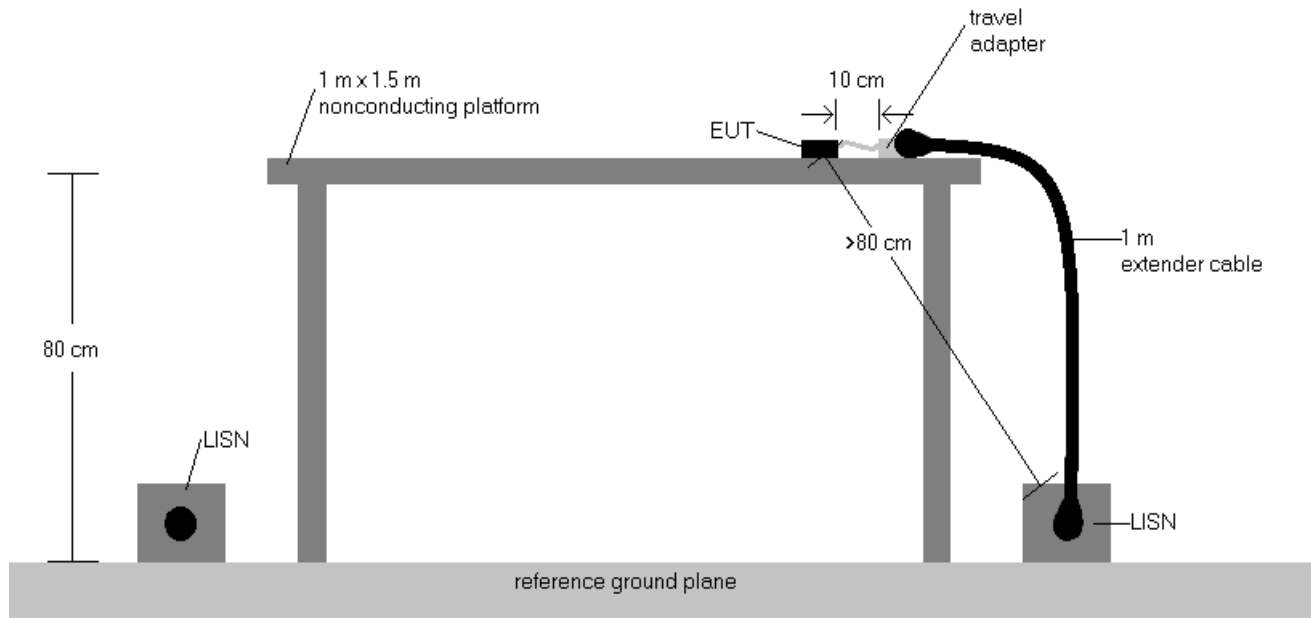
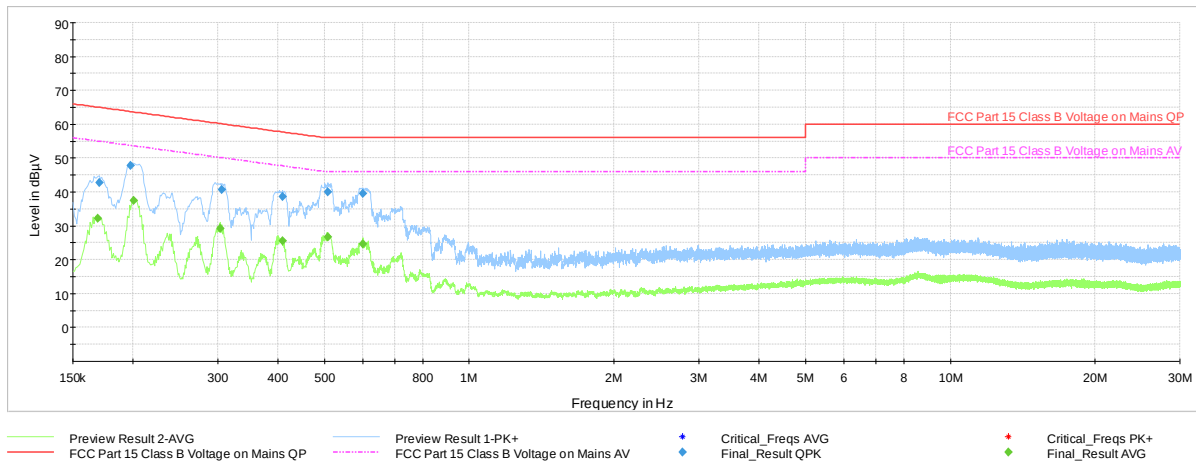


Figure 7-8. Test Instrument & Measurement Setup

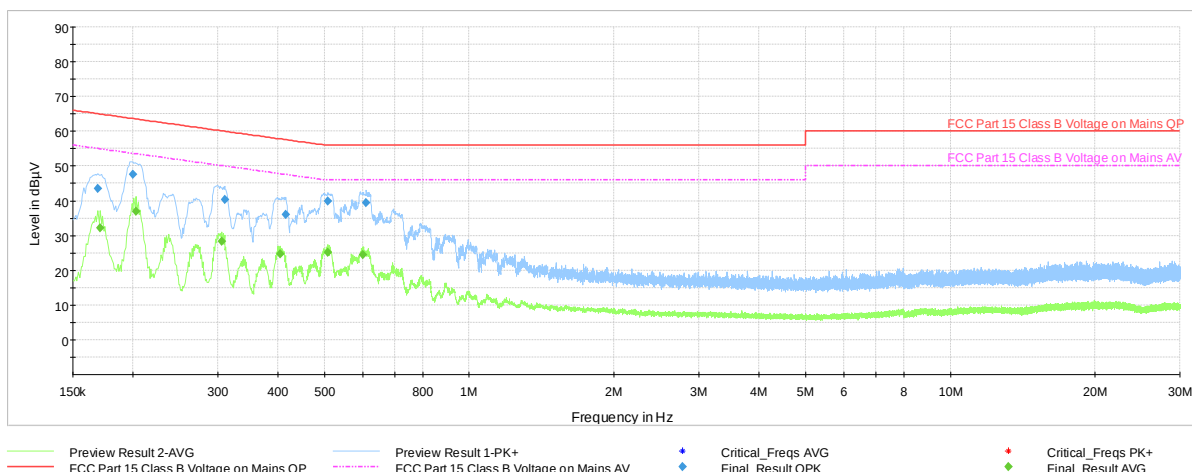


Plot 7-277. Line Conducted Plot with 802.11n UNII Band 1 (L1)
