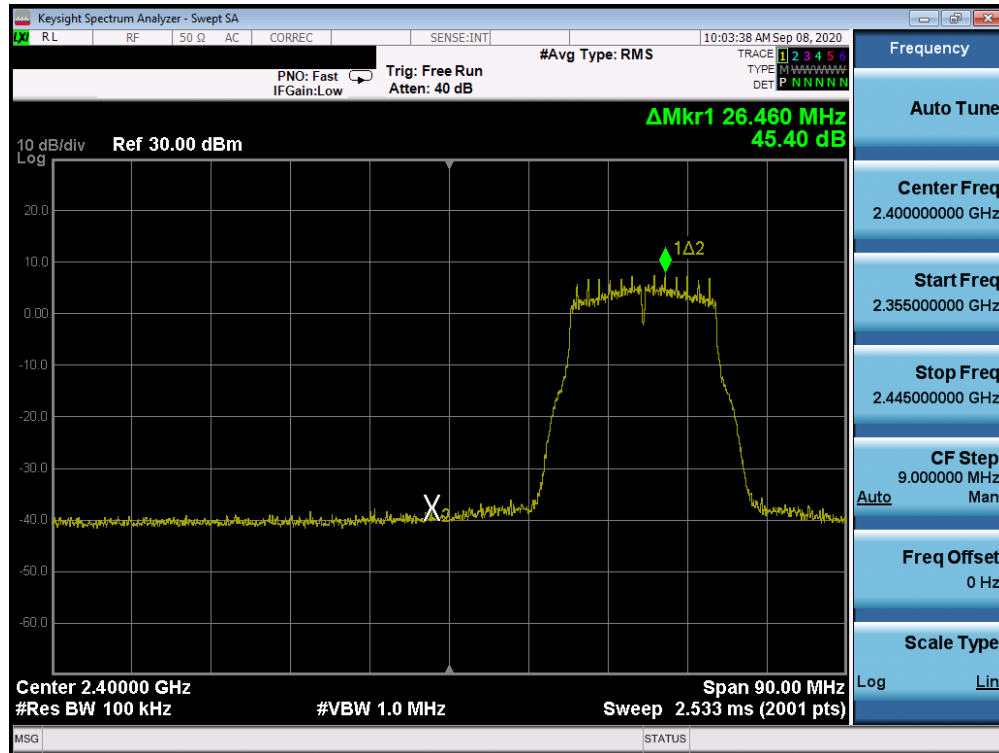
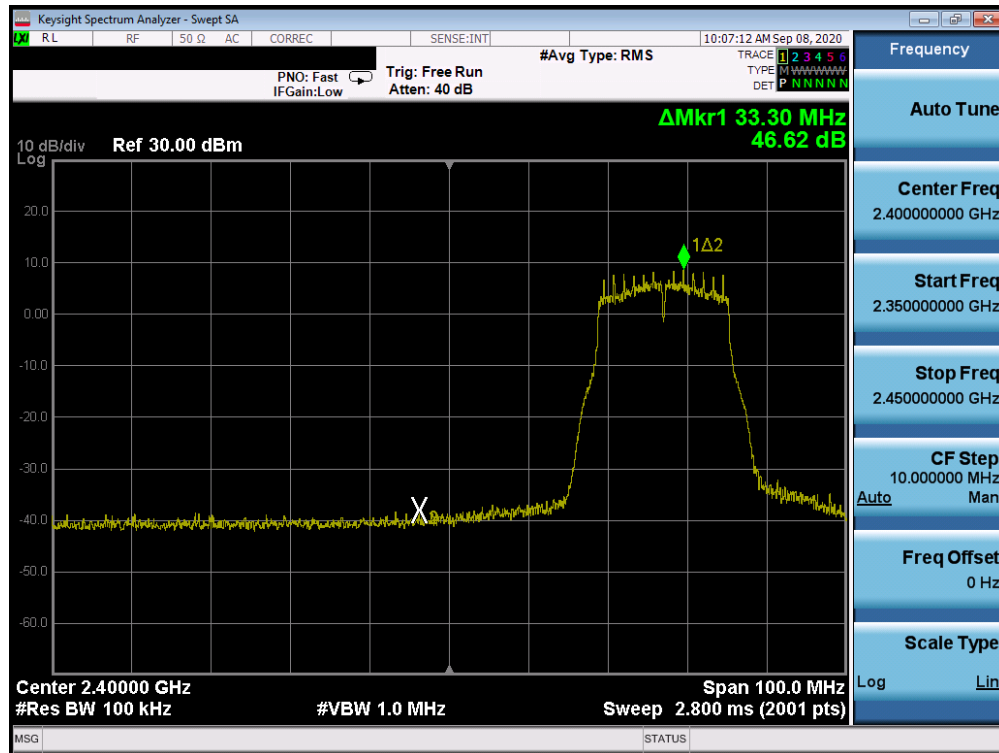


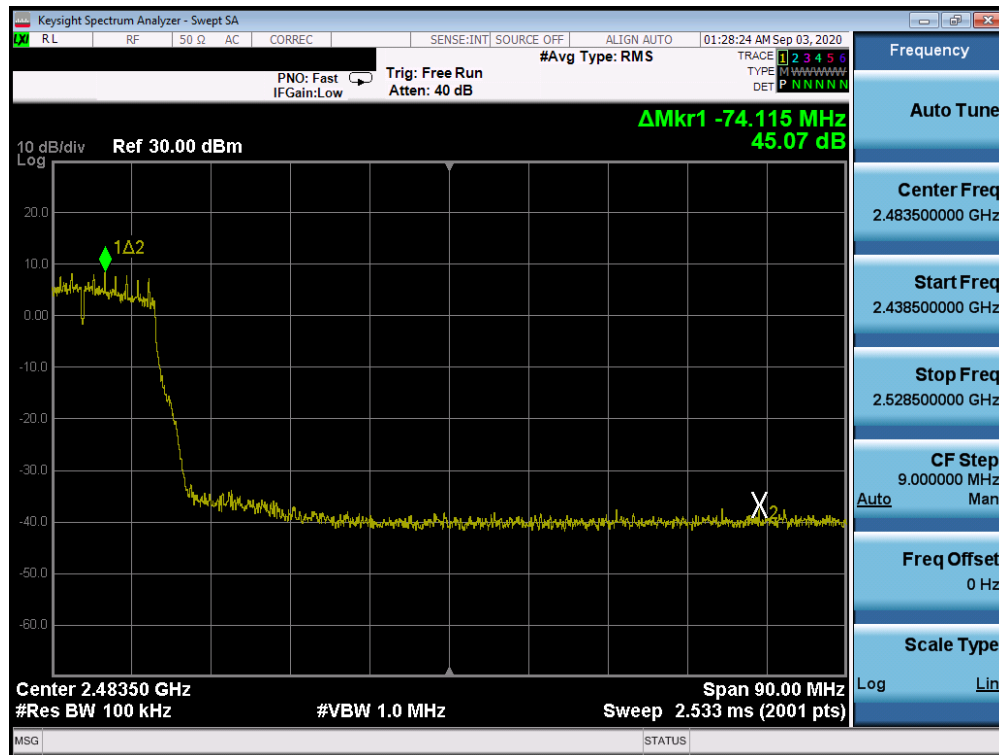


Plot 7-85. Band Edge Plot ANT 1a (802.11g– Ch. 3)

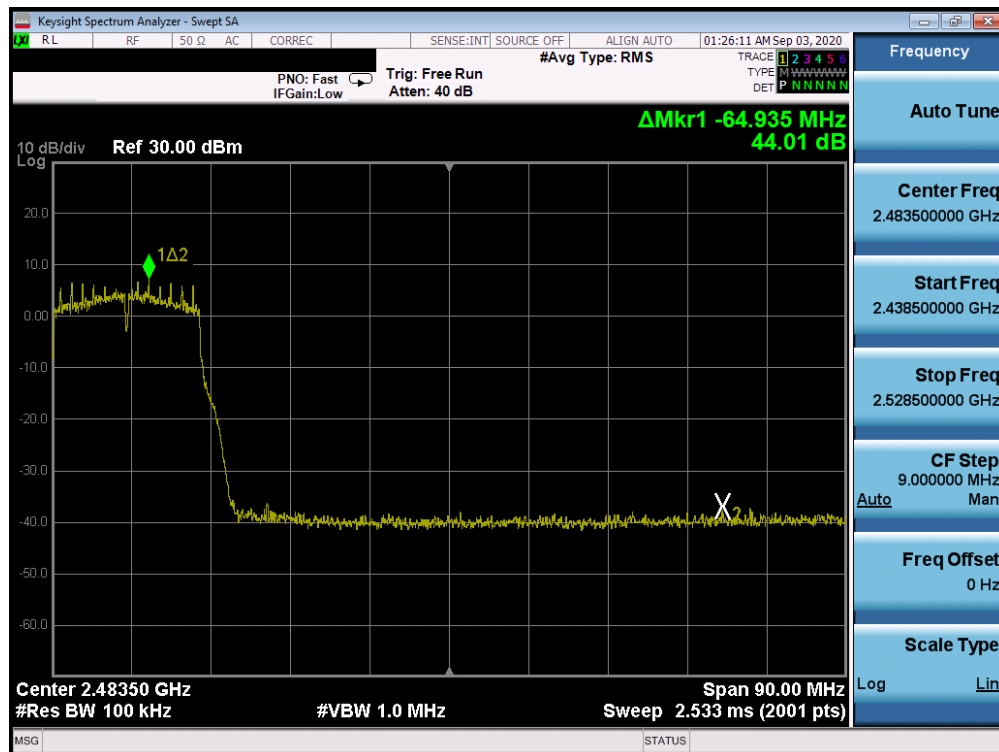


Plot 7-86. Band Edge Plot ANT 1a (802.11g– Ch. 4)

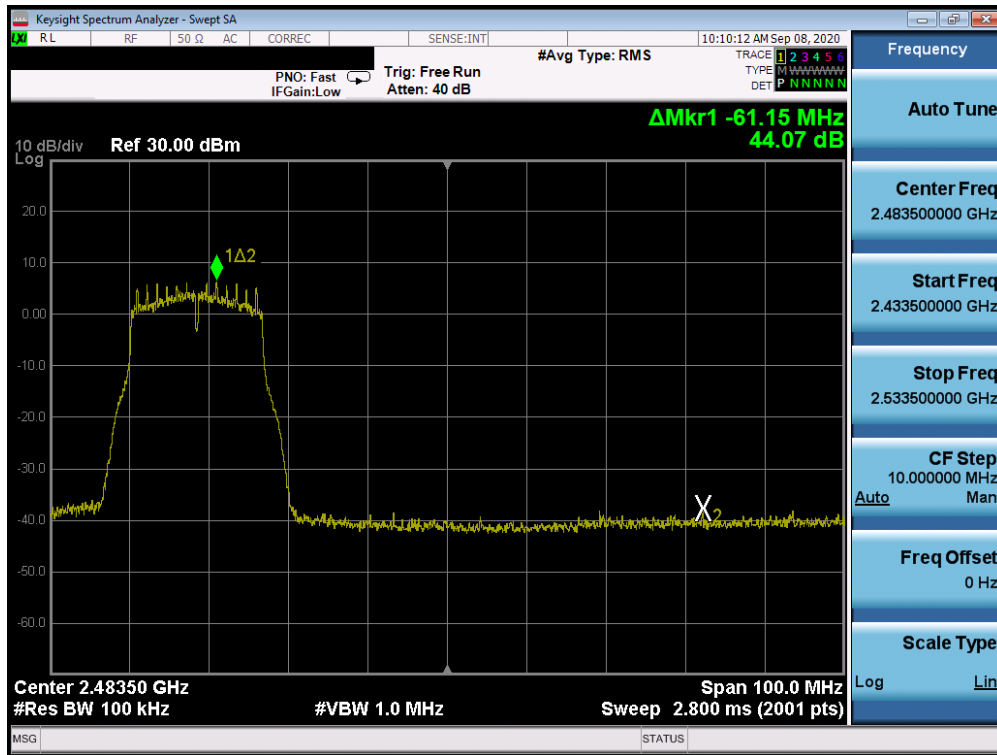


Plot 7-87. Band Edge Plot ANT 1a (802.11g – Ch. 7)

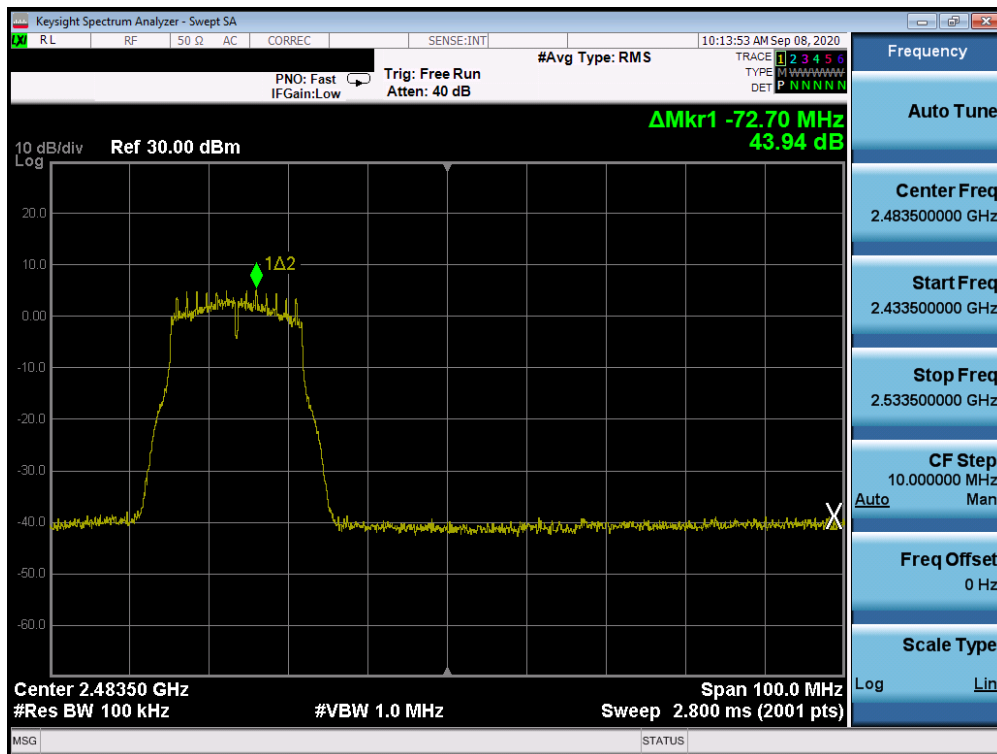


Plot 7-88. Band Edge Plot ANT 1a (802.11g – Ch. 8)

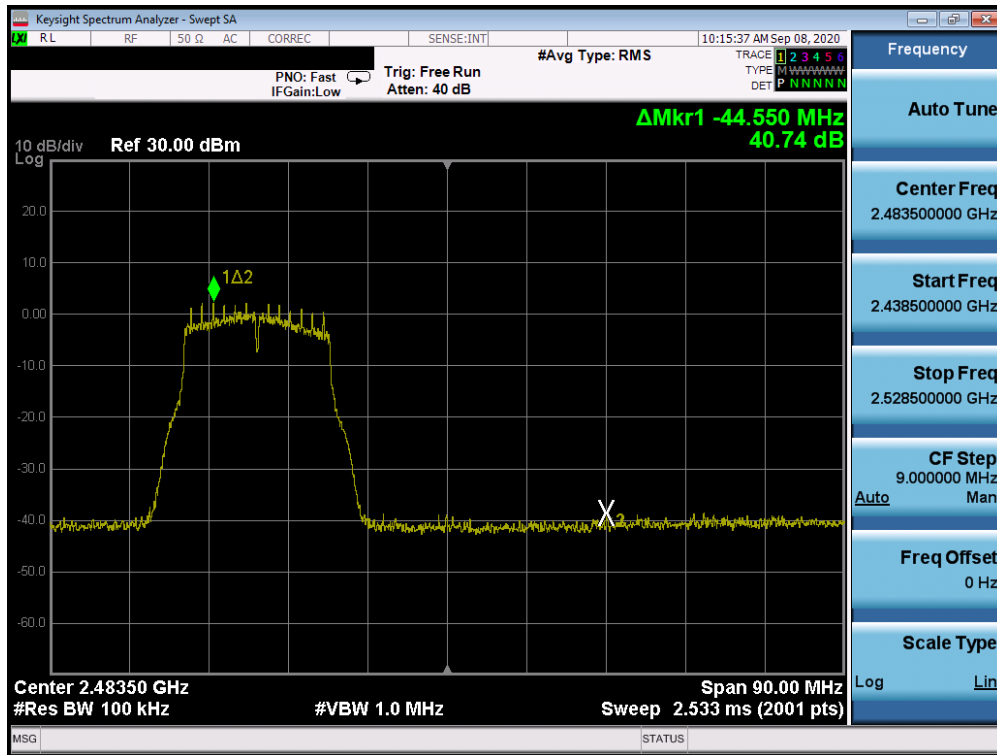


Plot 7-89. Band Edge Plot ANT 1a (802.11g – Ch. 9)

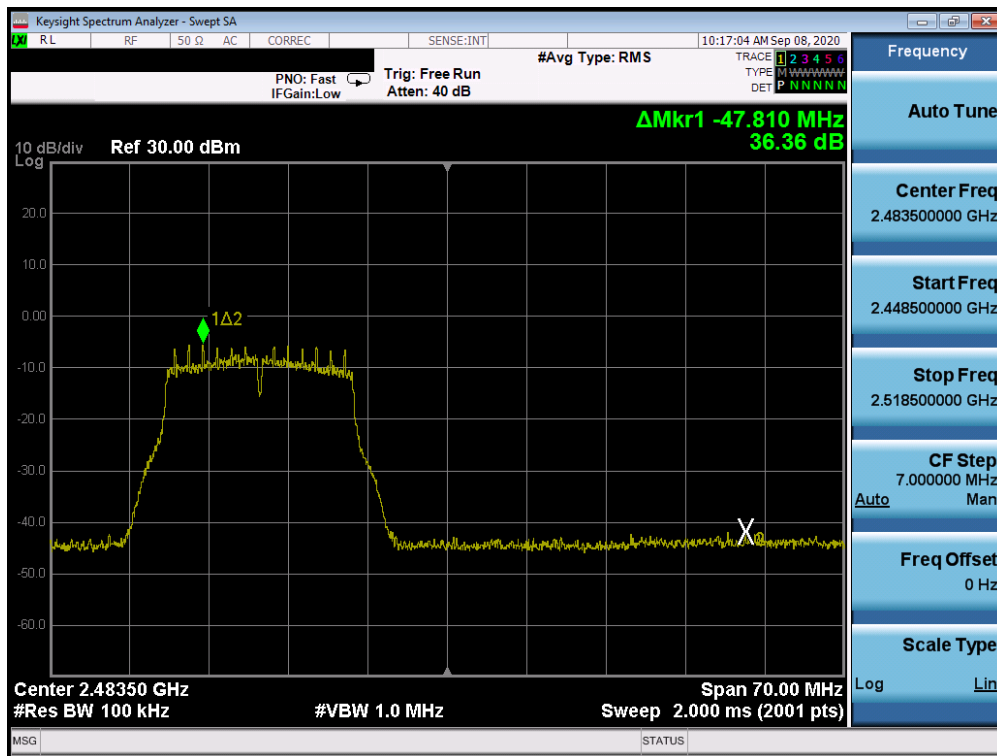


Plot 7-90. Band Edge Plot ANT 1a (802.11g – Ch. 10)

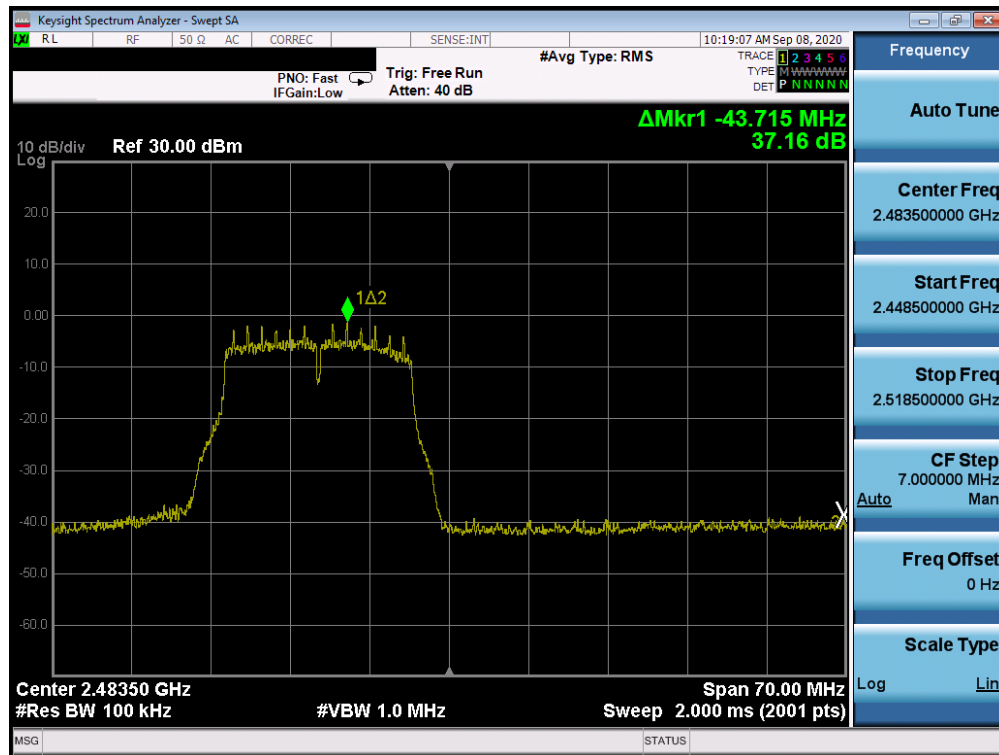


Plot 7-91. Band Edge Plot ANT 1a (802.11g - Ch. 11)

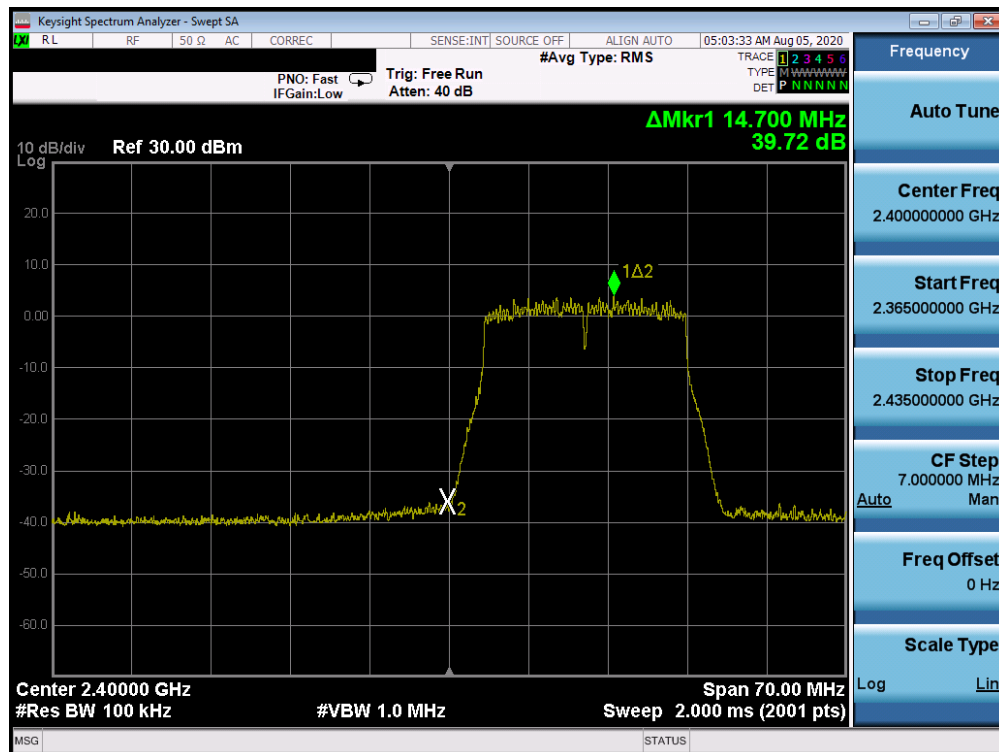


Plot 7-92. Band Edge Plot ANT 1a (802.11g - Ch. 12)

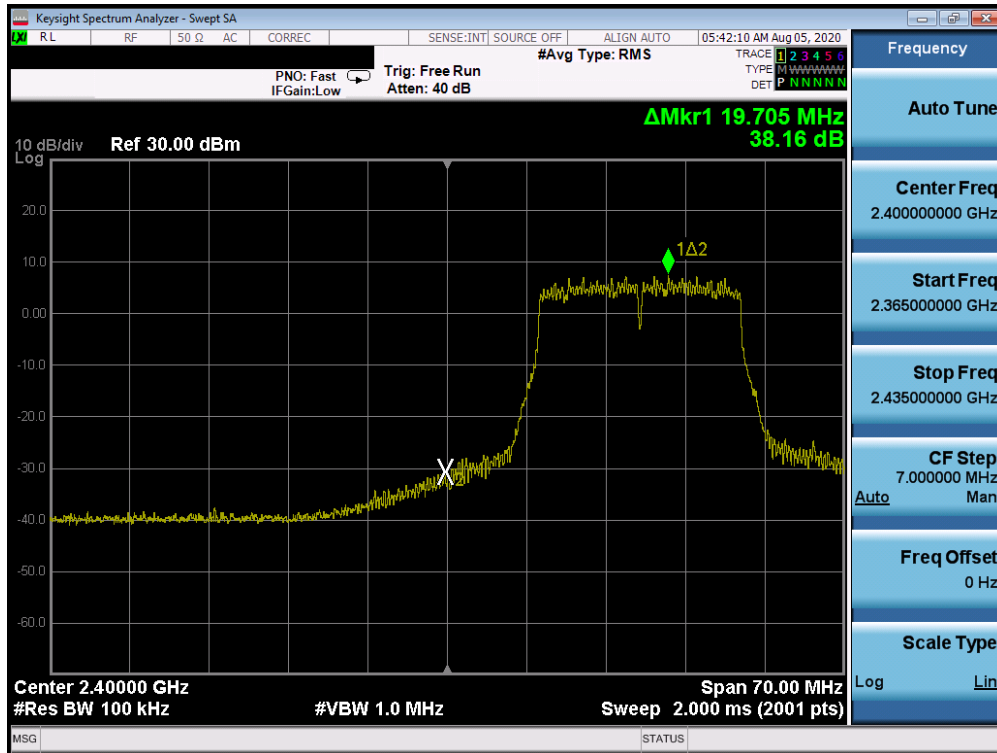


Plot 7-93. Band Edge Plot ANT 1a (802.11g - Ch. 13)

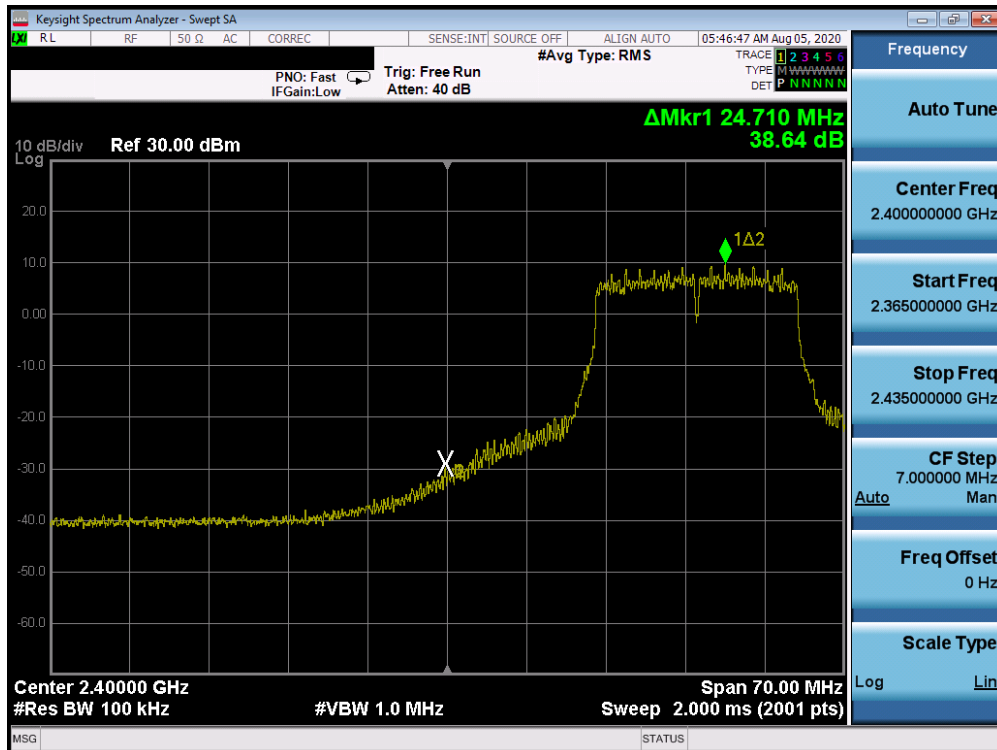


Plot 7-94. Band Edge Plot ANT 1a (802.11n (2.4GHz) - Ch. 1)

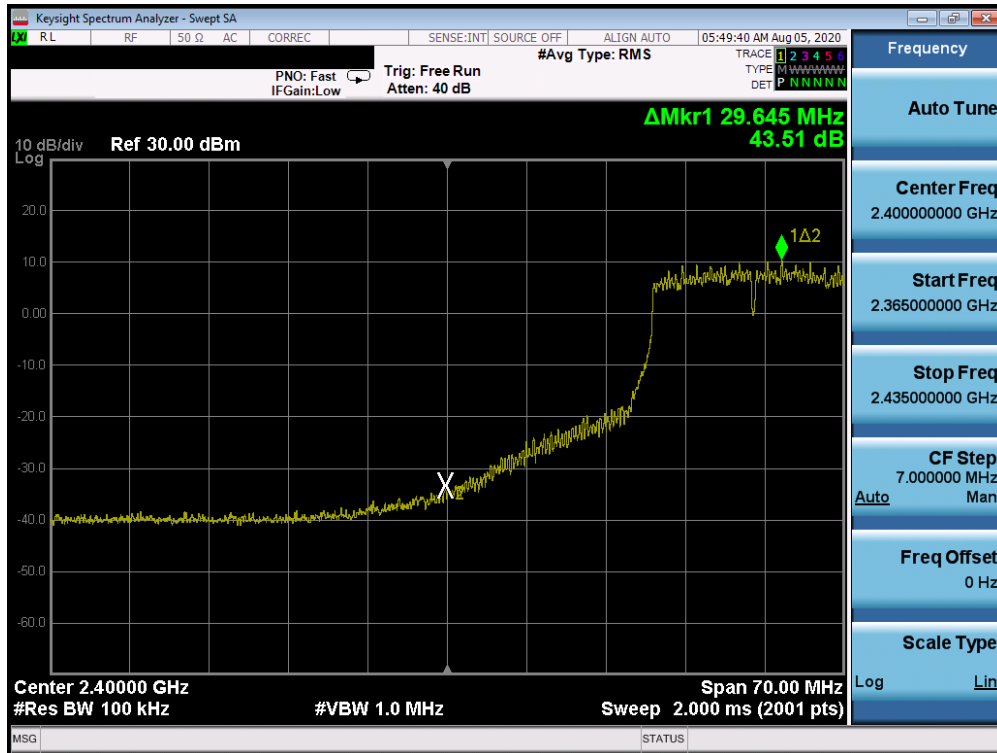


Plot 7-95. Band Edge Plot ANT 1a (802.11n (2.4GHz) - Ch. 2)

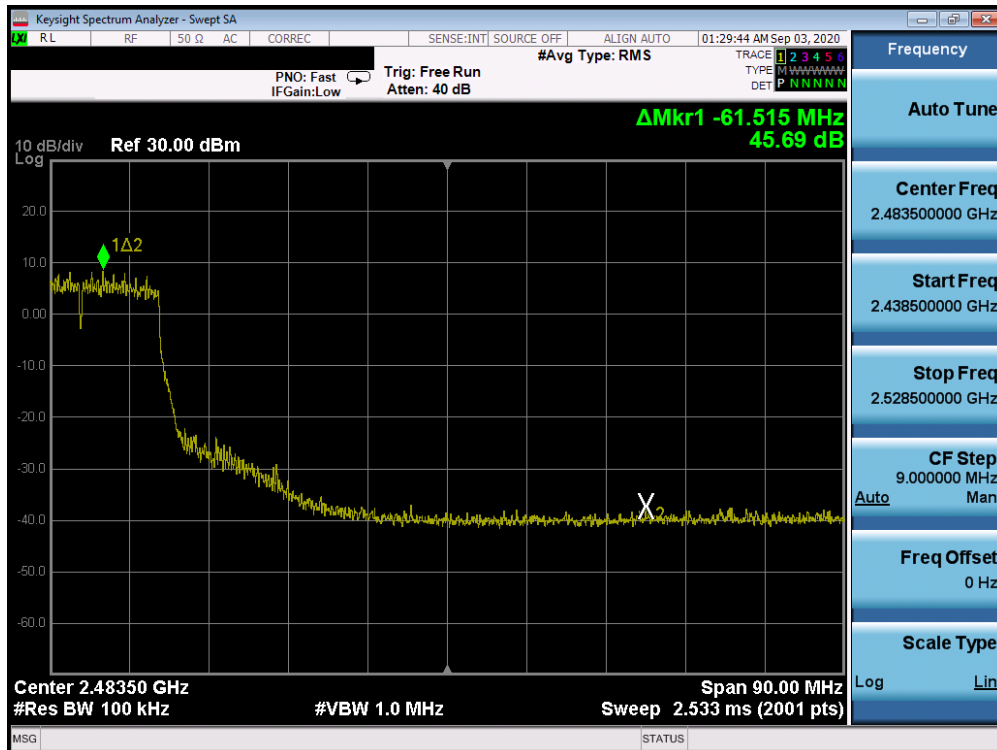


Plot 7-96. Band Edge Plot ANT 1a (802.11n (2.4GHz) - Ch. 3)

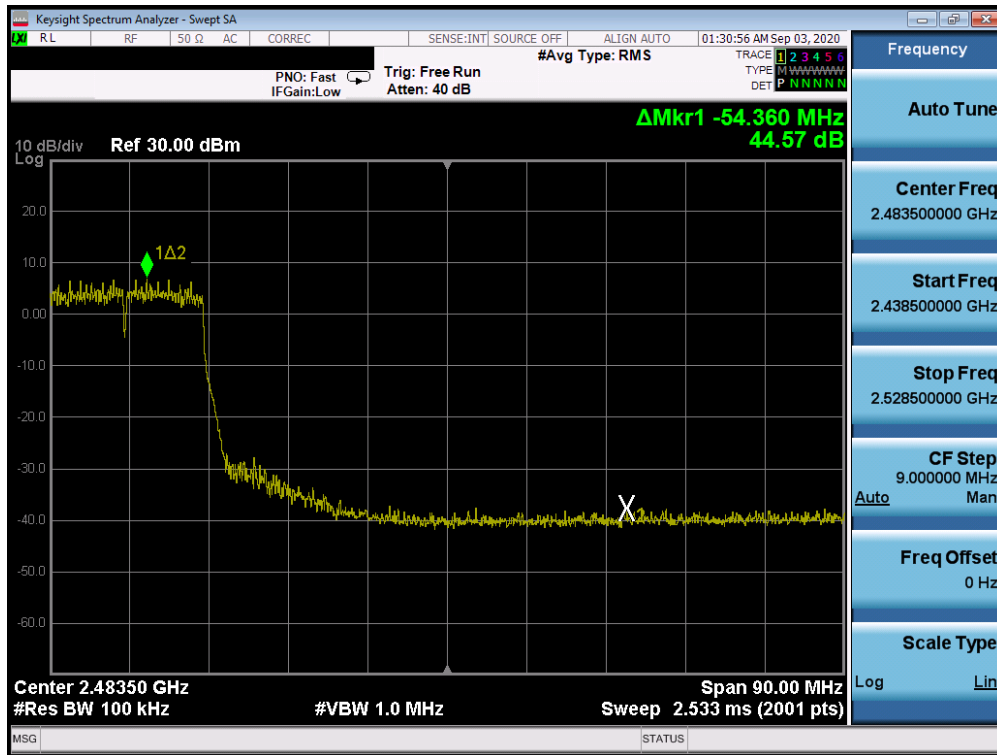


Plot 7-97. Band Edge Plot ANT 1a (802.11n (2.4GHz) – Ch. 4)

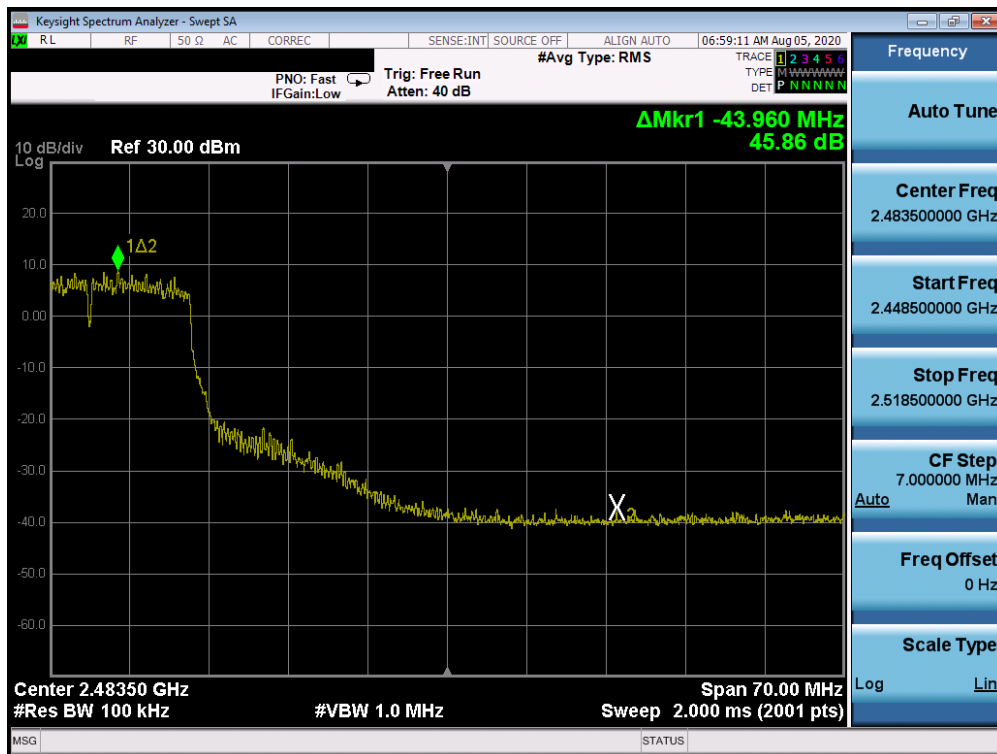


Plot 7-98. Band Edge Plot ANT 1a (802.11n (2.4GHz) – Ch. 7)

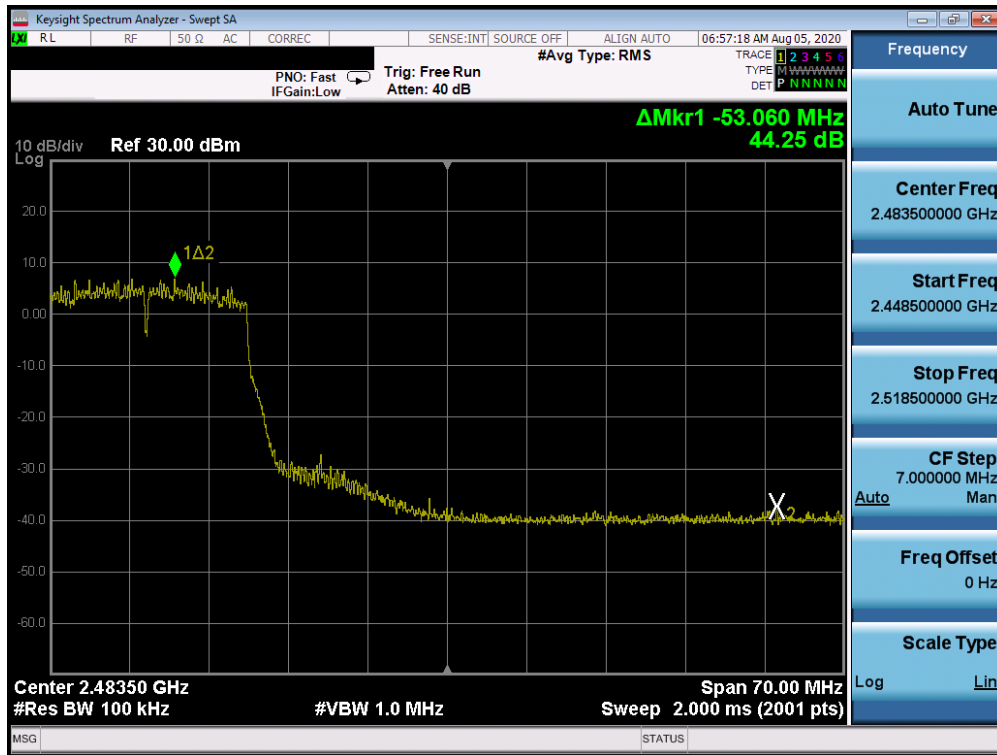


Plot 7-99. Band Edge Plot ANT 1a (802.11n (2.4GHz) - Ch. 8)

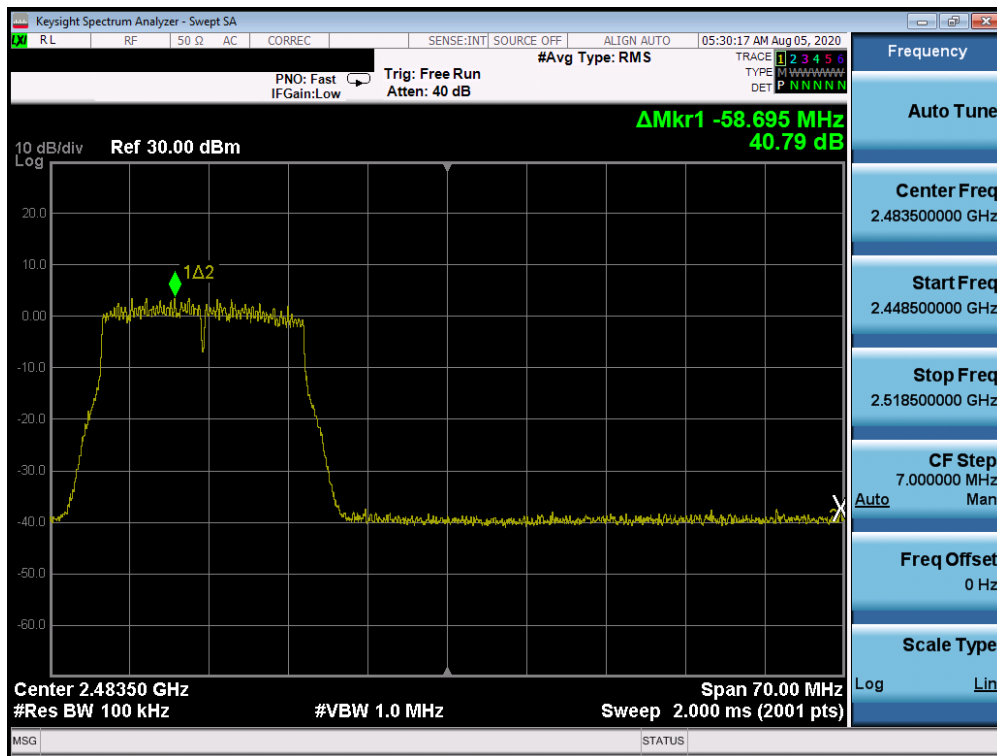


Plot 7-100. Band Edge Plot ANT 1a (802.11n (2.4GHz) - Ch. 9)

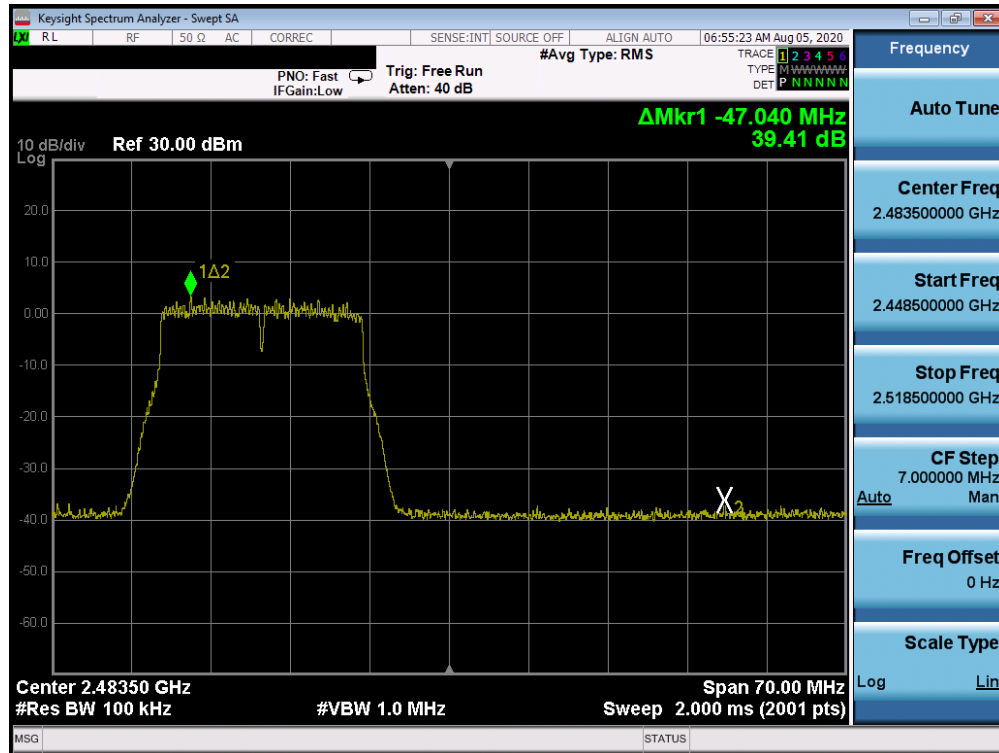


Plot 7-101. Band Edge Plot ANT 1a (802.11n (2.4GHz) - Ch. 10)

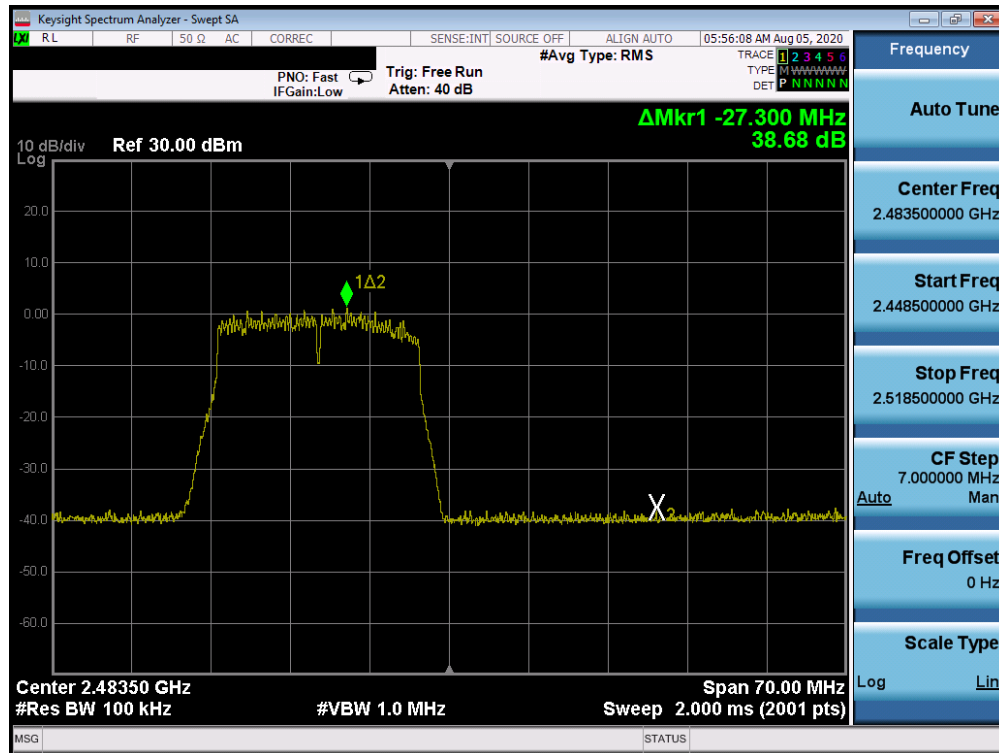


Plot 7-102. Band Edge Plot ANT 1a (802.11n (2.4GHz) - Ch. 11)

7.6 Conducted Spurious Emissions

§15.247(d); RSS-247 [5.5]

Test Overview and Limit

All out of band emissions are measured with a spectrum analyzer connected to the antenna terminal of the EUT while the EUT is operating at its maximum duty cycle, at maximum power, and at the appropriate frequencies. All data rates were investigated to determine the worst case configuration. For the following out of band conducted spurious emissions plots, the EUT was investigated in all available data rates for “b”, “g”, “n” modes. The worst case spurious emissions for the 2.4GHz band were found while transmitting in “b” mode at 1 Mbps and are shown in the plots below.

The limit for out-of-band spurious emissions at the band edge is 20dB below the fundamental emission level, as determined from the in-band power measurement of the DTS channel performed in a 100kHz bandwidth per the procedure in Section 11.1 of ANSI C63.10-2013 and KDB 558074 D01 v05r02.

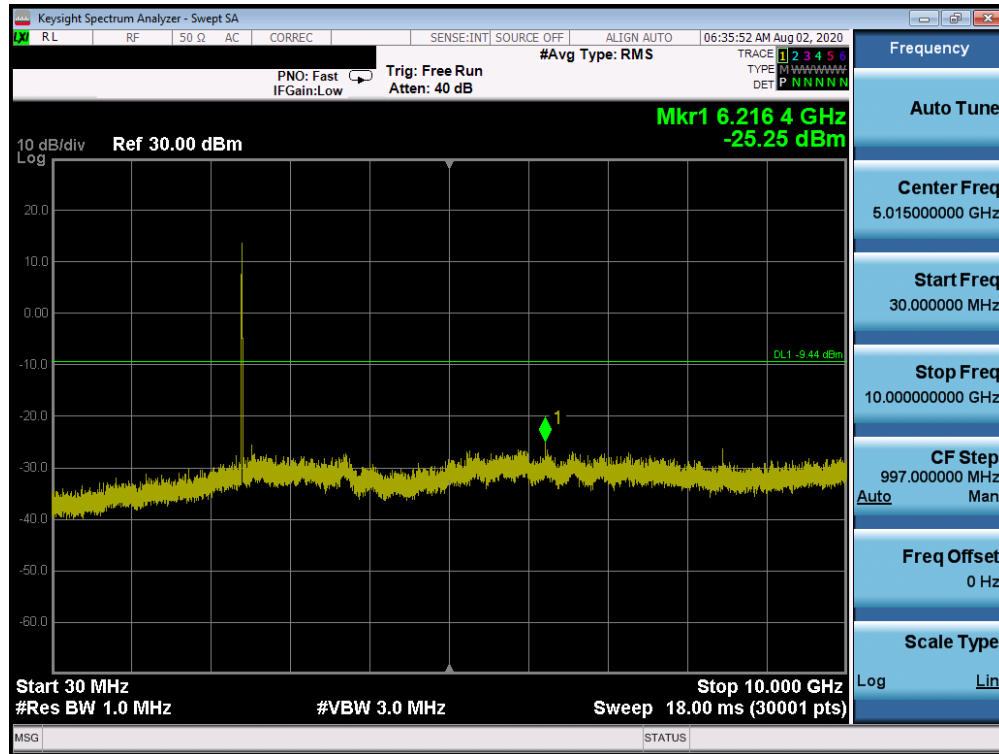

Test Notes

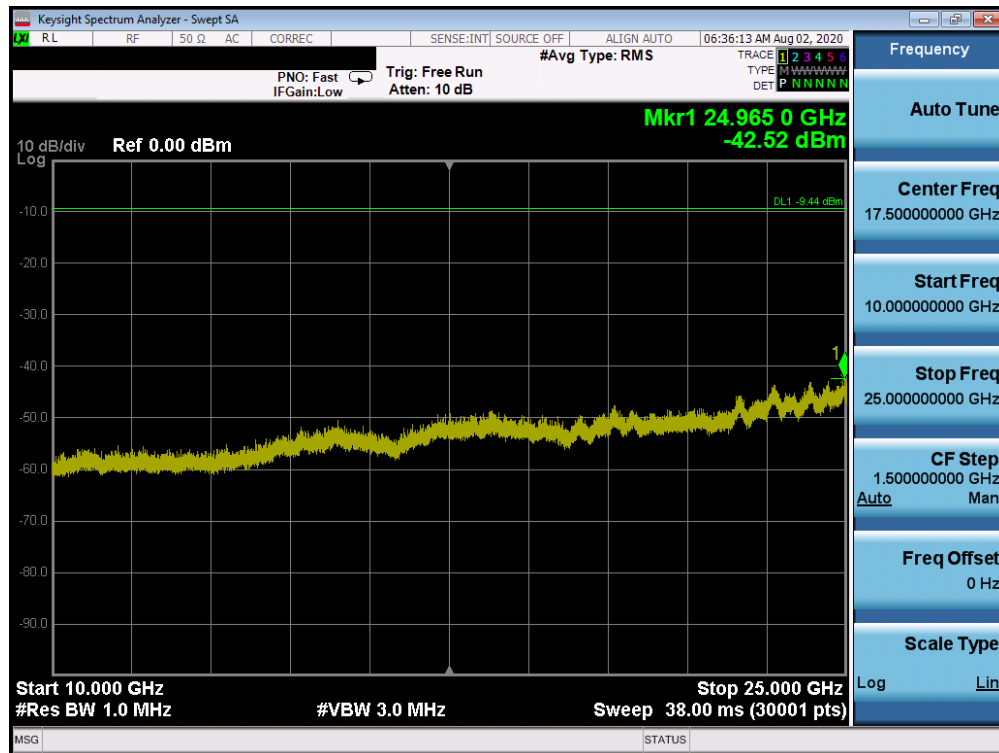
1. RBW was set to 1MHz rather than 100kHz in order to increase the measurement speed.
2. The display line shown in the following plots denotes the limit at 20dB below the fundamental emission level measured in a 100kHz bandwidth. However, since the traces in the following plots are measured with a 1MHz RBW, the display line may not necessarily appear to be 20dB below the level of the fundamental in a 1MHz bandwidth.
3. For plots showing conducted spurious emissions near the limit, the frequencies were investigated with a reduced RBW to ensure that no emissions were present.
4. The conducted spurious emissions were measured to relative limits. Therefore, in accordance with ANSI C63.10-2013 and KDB 662911 D01 v02r01 Section E)3)b), it was unnecessary to show compliance through the summation of test results of the individual outputs.
5. All antenna configurations were investigated and only the worst case is reported.
6. Following data were re-used from model A2324 per Data Re-use KDB guidance defined by the FCC.

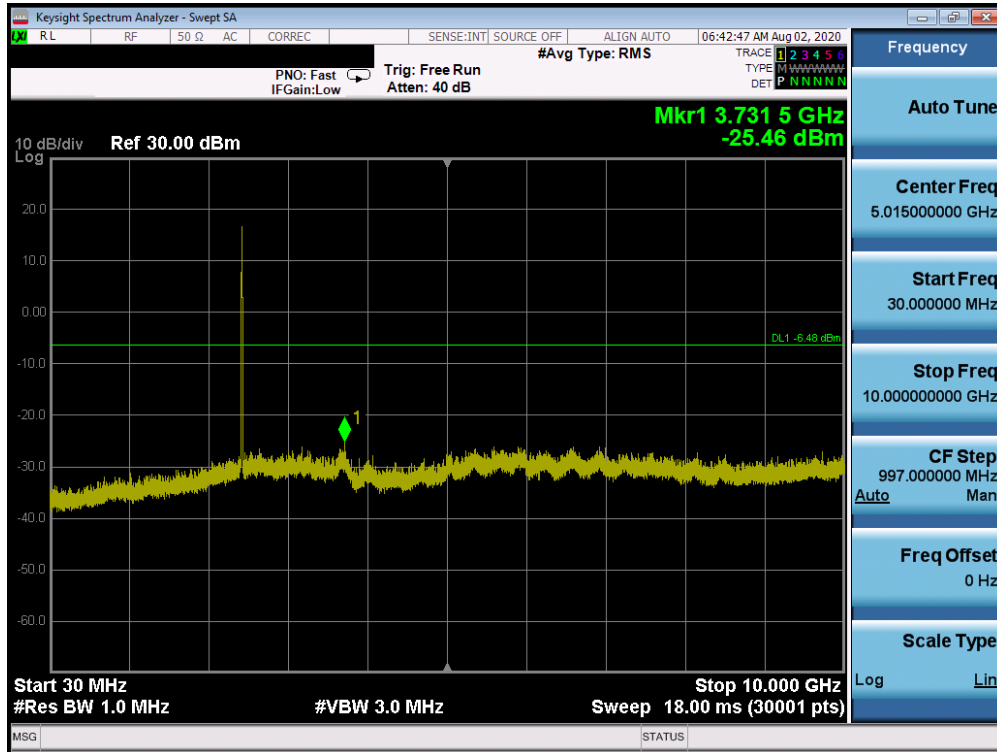


Plot 7-105. Conducted Spurious Plot ANT 3a (802.11b – Ch. 1)

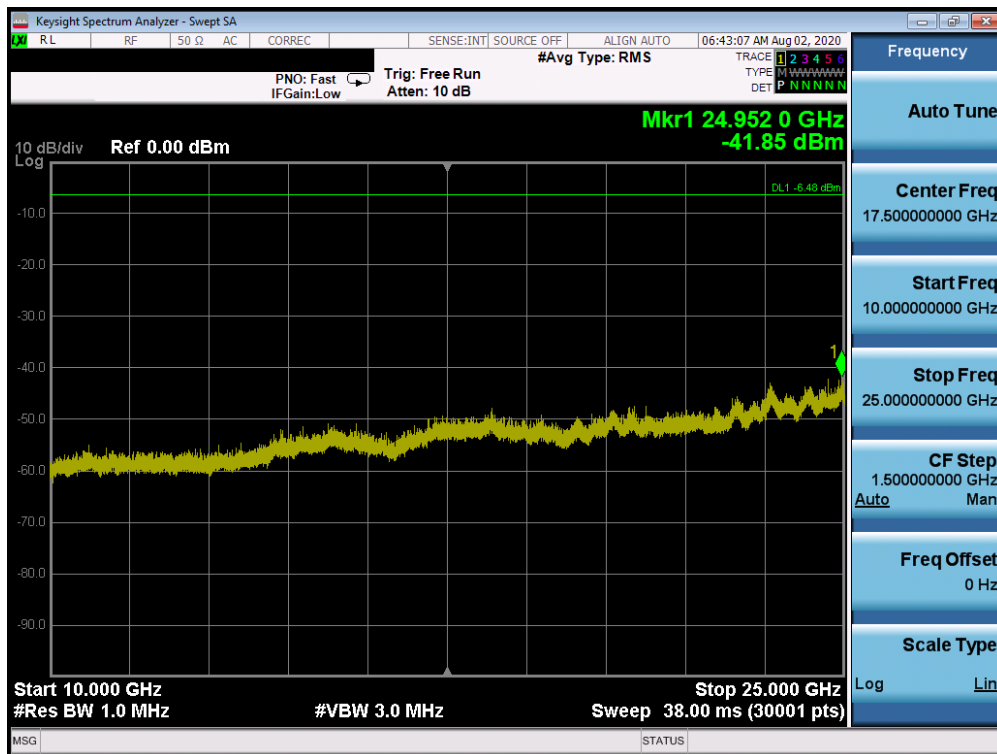


Plot 7-106. Conducted Spurious Plot ANT 3a (802.11b – Ch. 1)

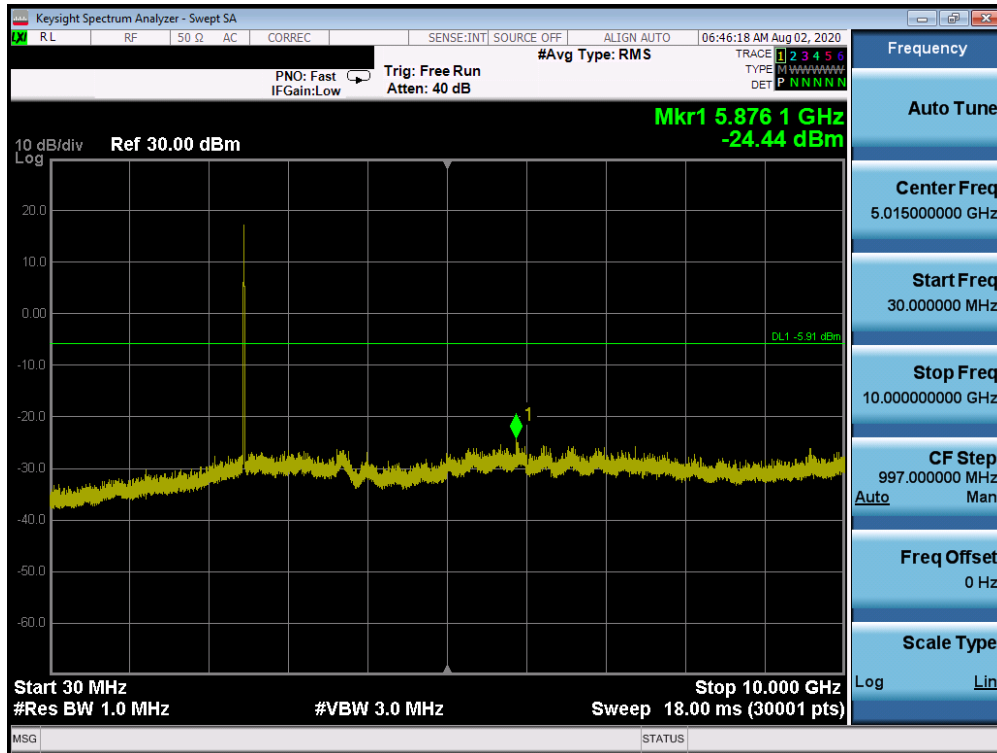


Plot 7-107. Conducted Spurious Plot ANT 3a (802.11b – Ch. 6)

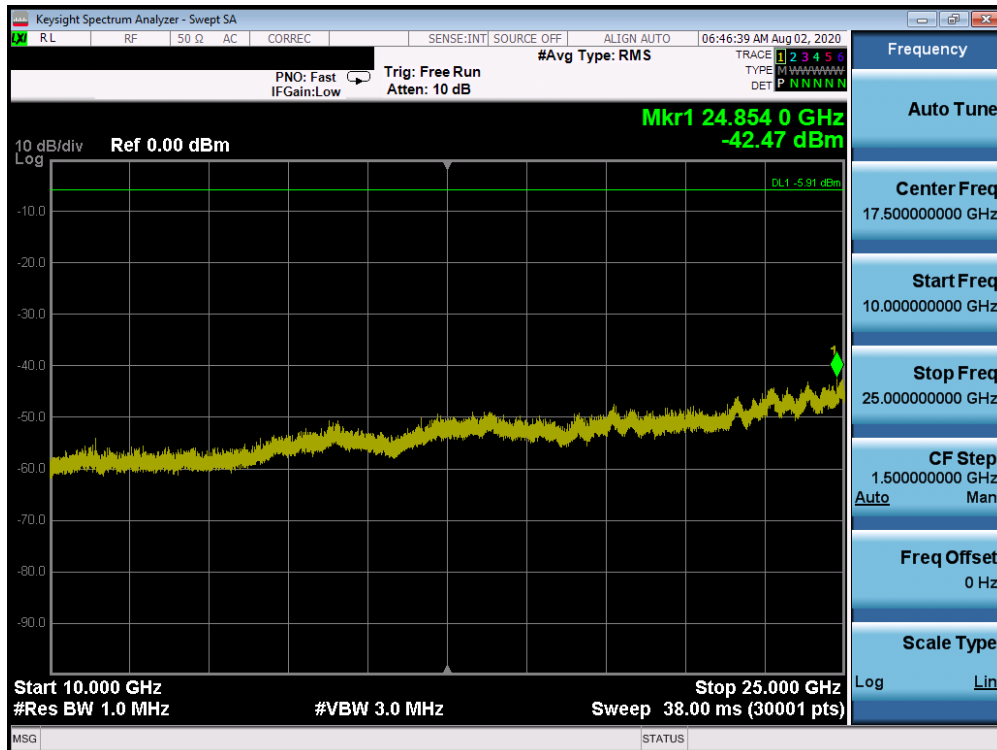


Plot 7-108. Conducted Spurious Plot ANT 3a (802.11b – Ch. 6)

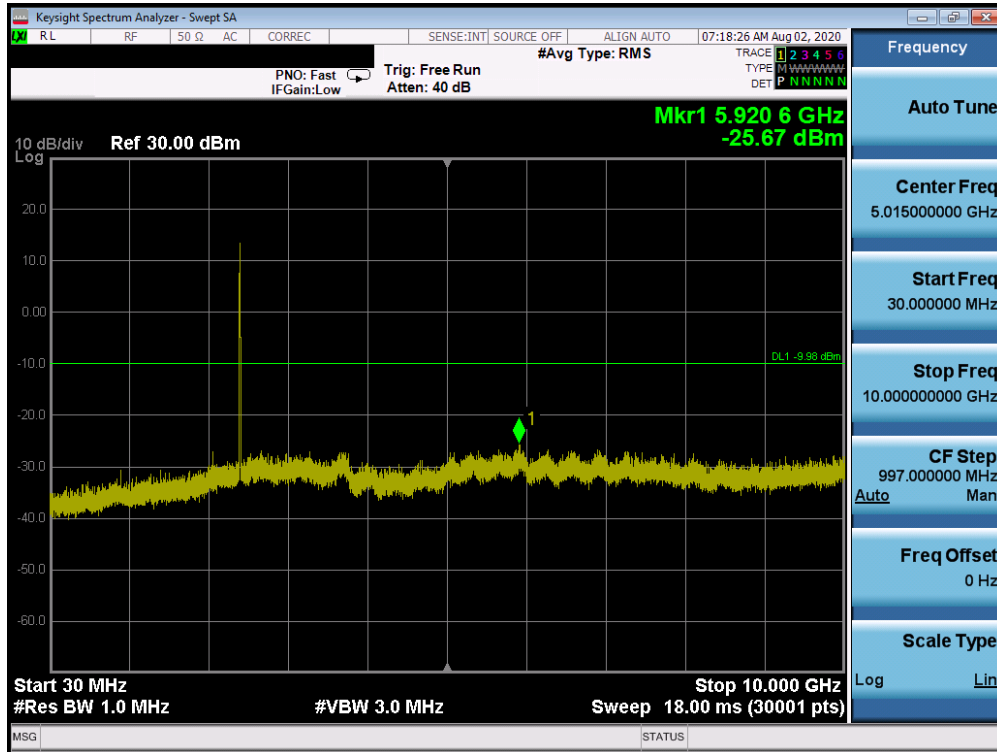
Plot 7-109. Conducted Spurious Plot ANT 3a (802.11b – Ch. 11)



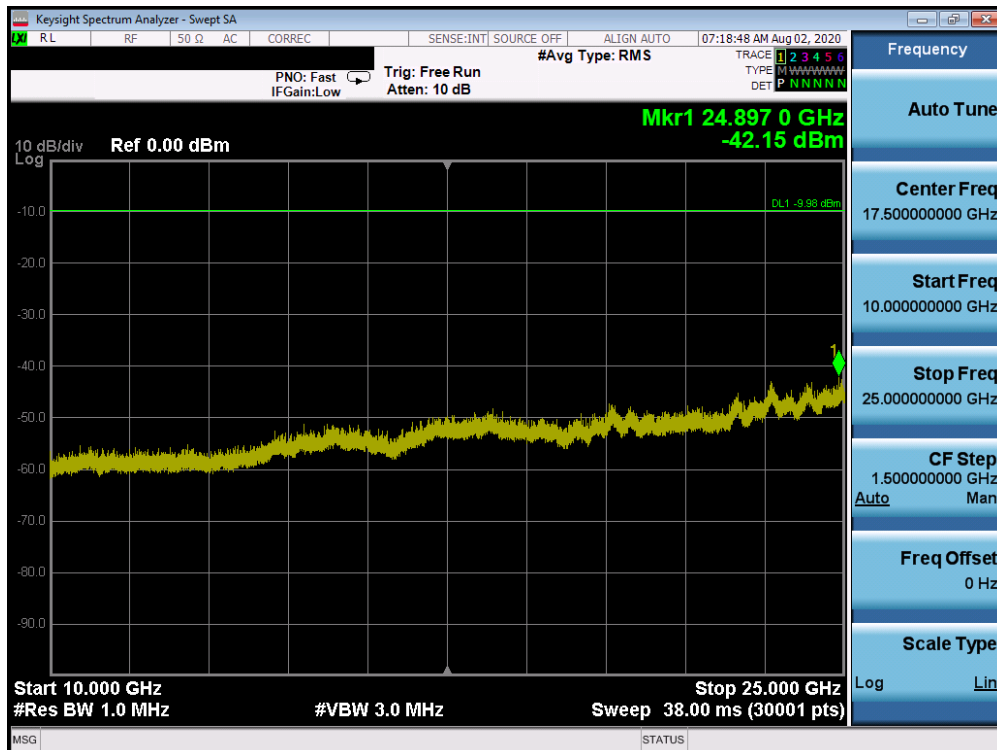

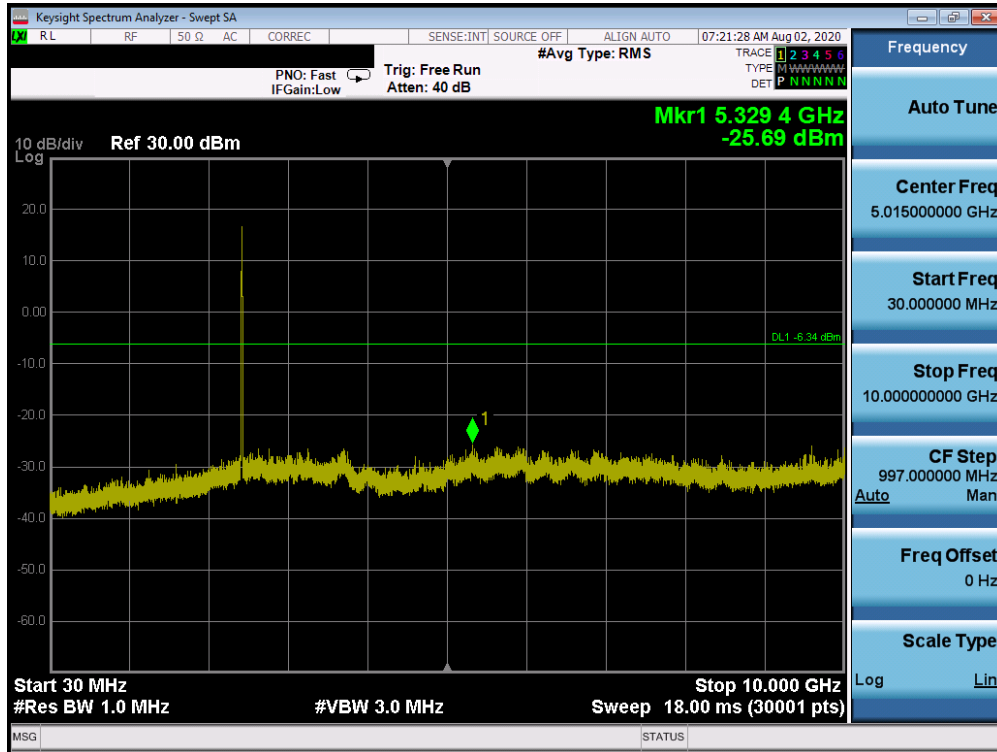


Plot 7-111. Conducted Spurious Plot ANT 1a (802.11b – Ch. 1)

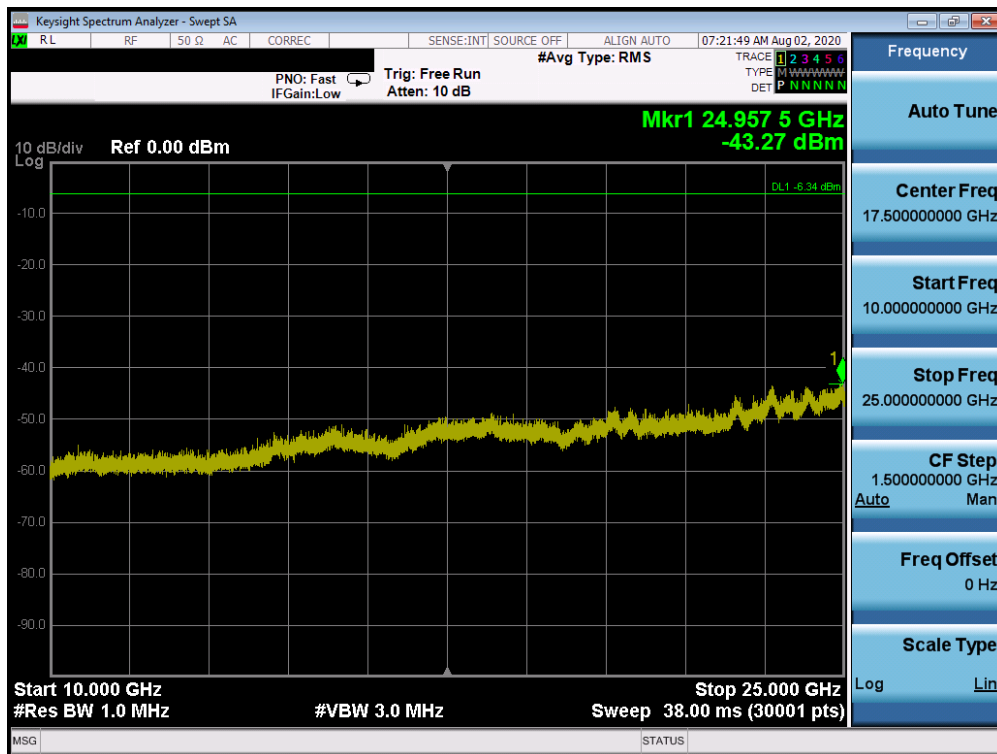


Plot 7-112. Conducted Spurious Plot ANT 1a (802.11b – Ch. 1)

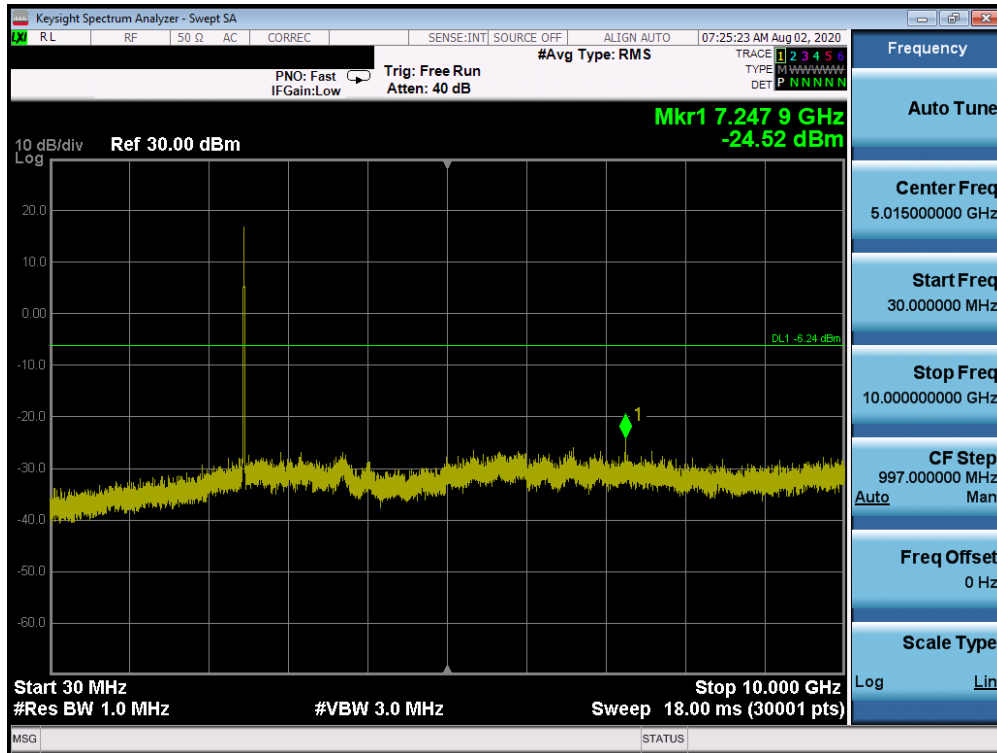


Plot 7-113. Conducted Spurious Plot ANT 1a (802.11b – Ch. 6)

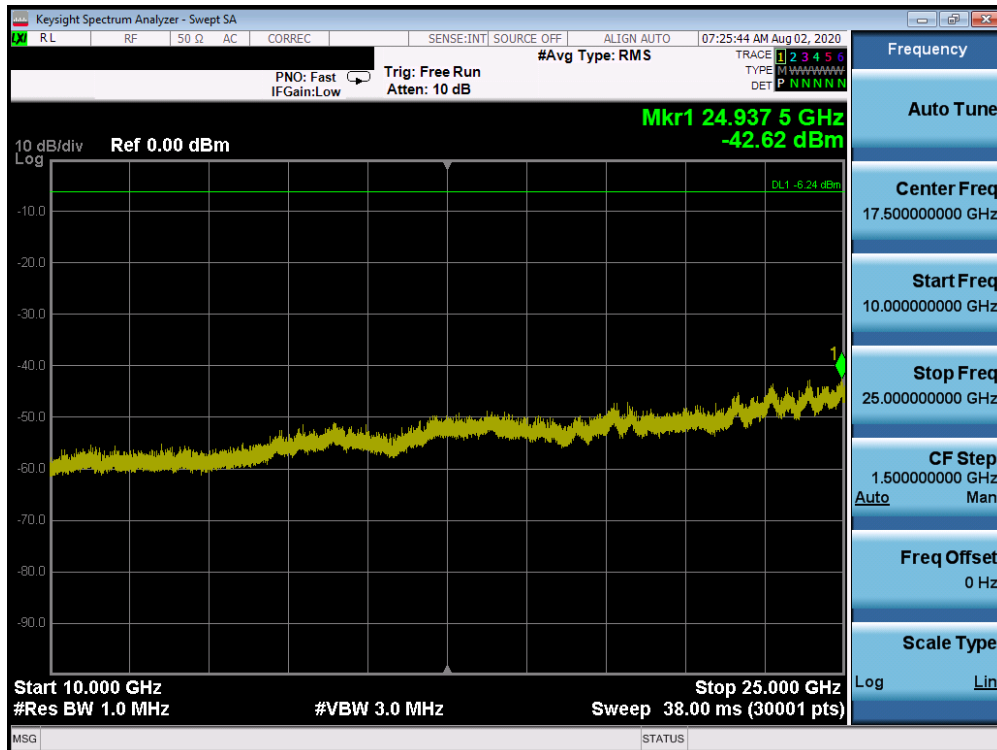


Plot 7-114. Conducted Spurious Plot ANT 1a (802.11b – Ch. 6)

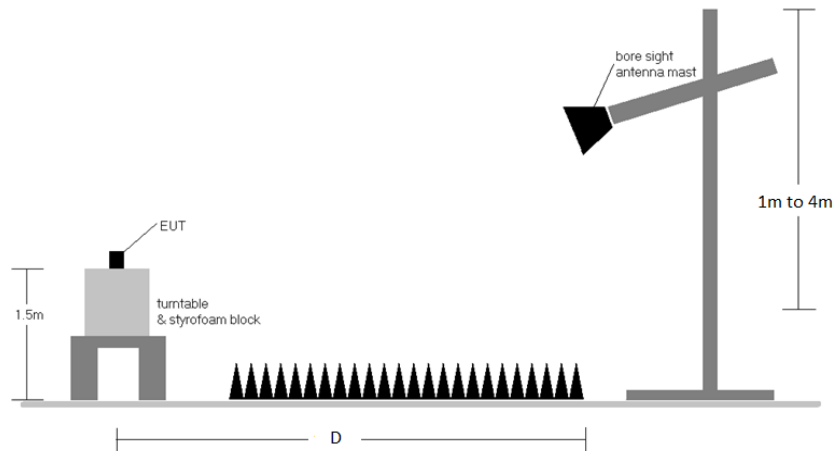


Figure 7-6. Radiated Measurement Setup

Test Notes

1. The optional test procedures for antenna port conducted measurements of unwanted emissions per the guidance of KDB 558074 D01 v05r02 were not used to evaluate this device for compliance to radiated limits. All Radiated Spurious Emissions levels were measured in a radiated test setup.
2. All emissions lying in restricted bands specified in Section 15.205 and Section 8.10 of RSS-Gen are below the limit shown in Table 7-15.
3. The antenna is manipulated through typical positions, polarity and length during the tests. The EUT is manipulated through three orthogonal planes.
4. This unit was tested with its standard battery.
5. The spectrum is measured from 9kHz to the 10th harmonic of the fundamental frequency of the transmitter using CISPR quasi peak detector below 1GHz. Above 1 GHz, average and peak measurements were taken using linearly polarized horn antennas.
6. D is the measurement test distance and emissions 1-18GHz were measured at a 3 meters test distance while emissions above 18GHz were measured at a 1 meter test distance with the application of a distance correction factor.
7. The wide spectrum spurious emissions plots shown on the following pages are used only for the purpose of emission identification. Any emissions found to be within 20dB of the limit are fully investigated and the results are shown in this section.
8. The "-" shown in the following RSE tables are used to denote a noise floor measurement.
9. All antenna configurations were investigated and only the worst case is reported.
10. The unit was tested with all possible modes and only the highest emission is reported.
11. Spot-check testing of the following data was performed and confirmed to be within guidance per Data Re-use KDB defined by the FCC.

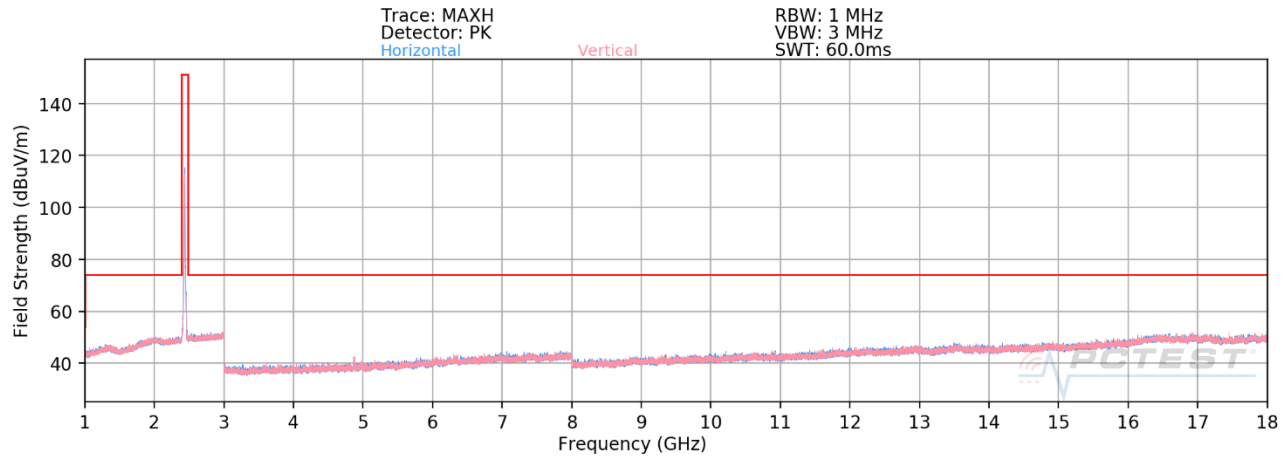

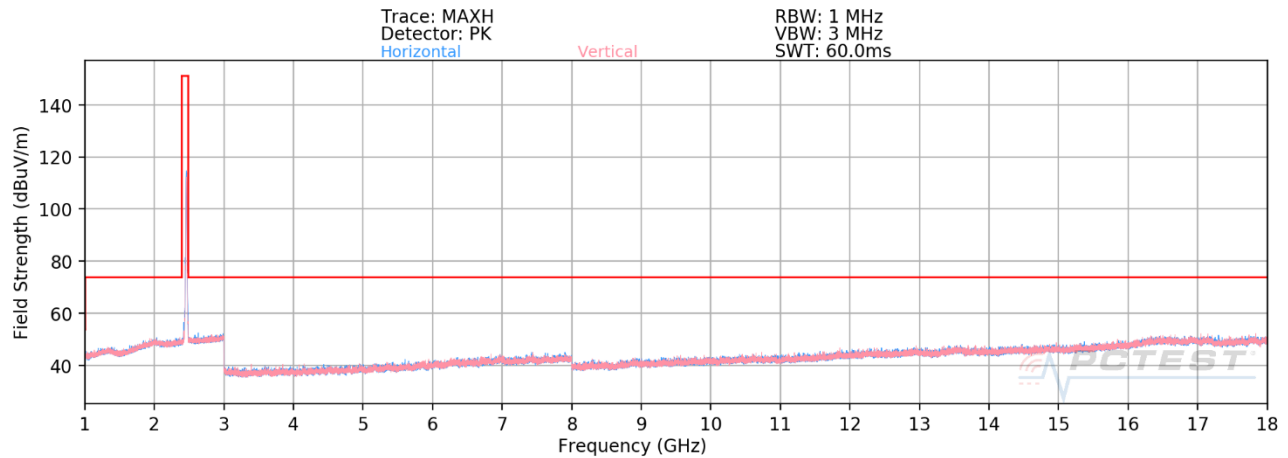

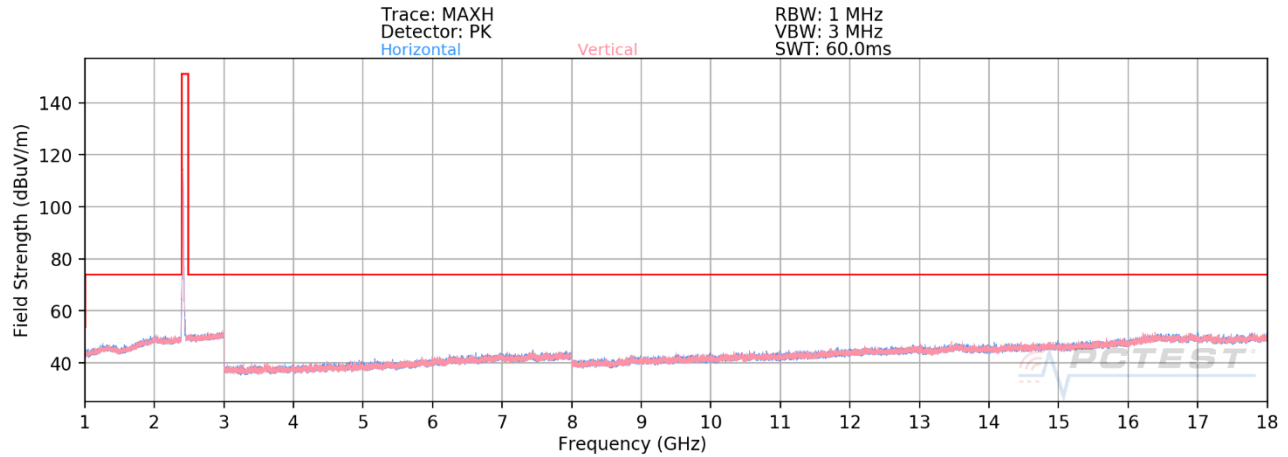

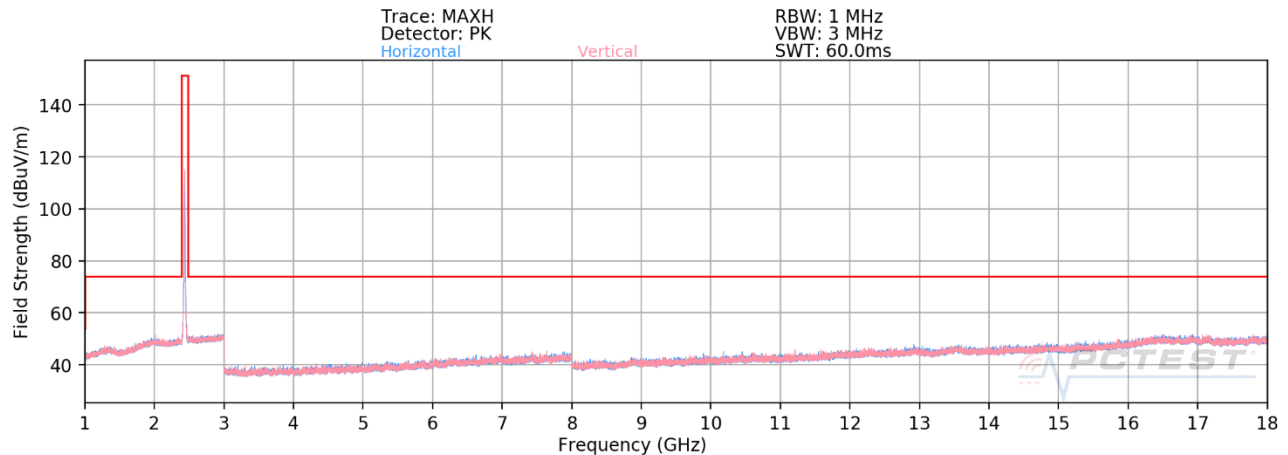

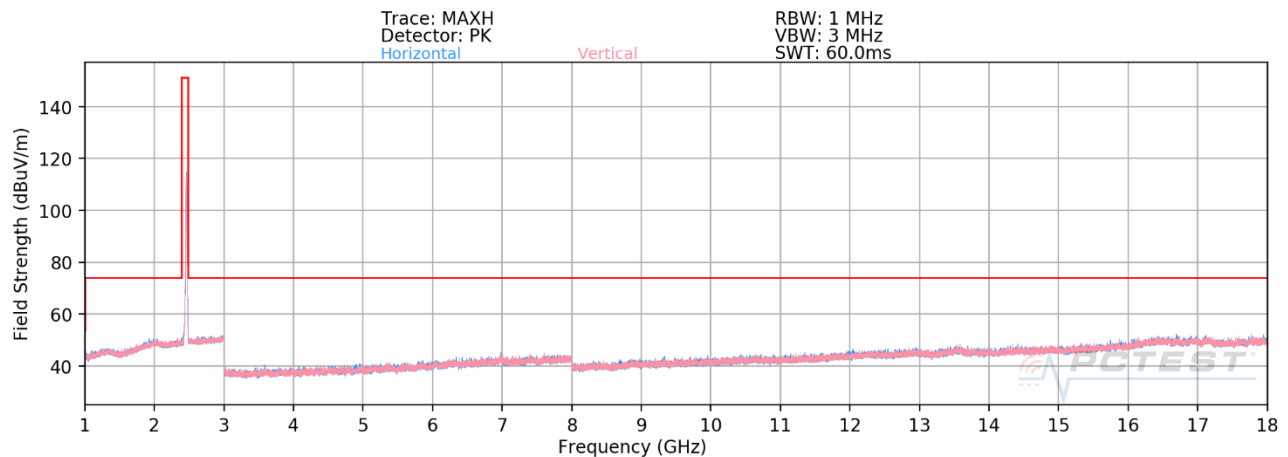

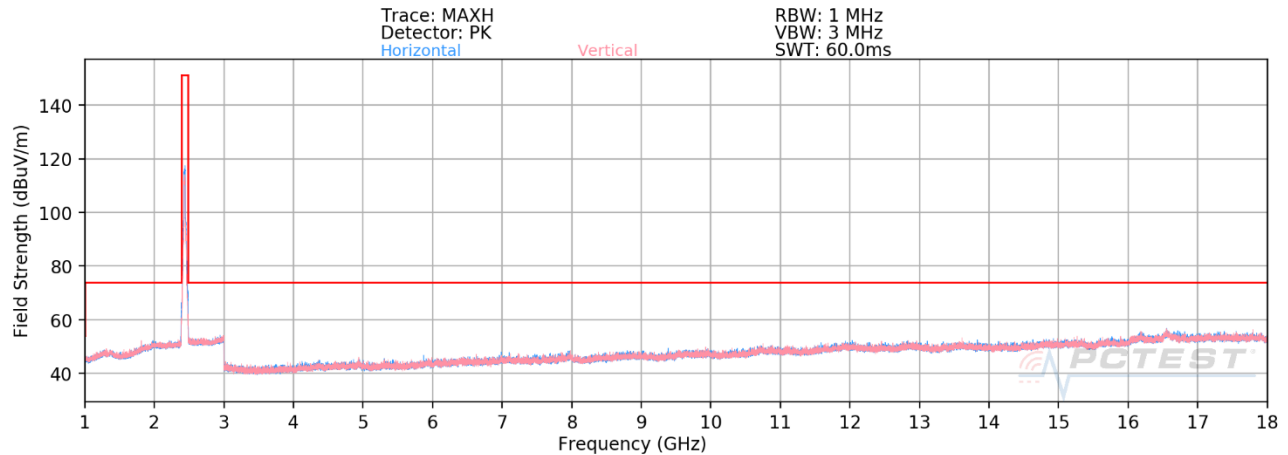

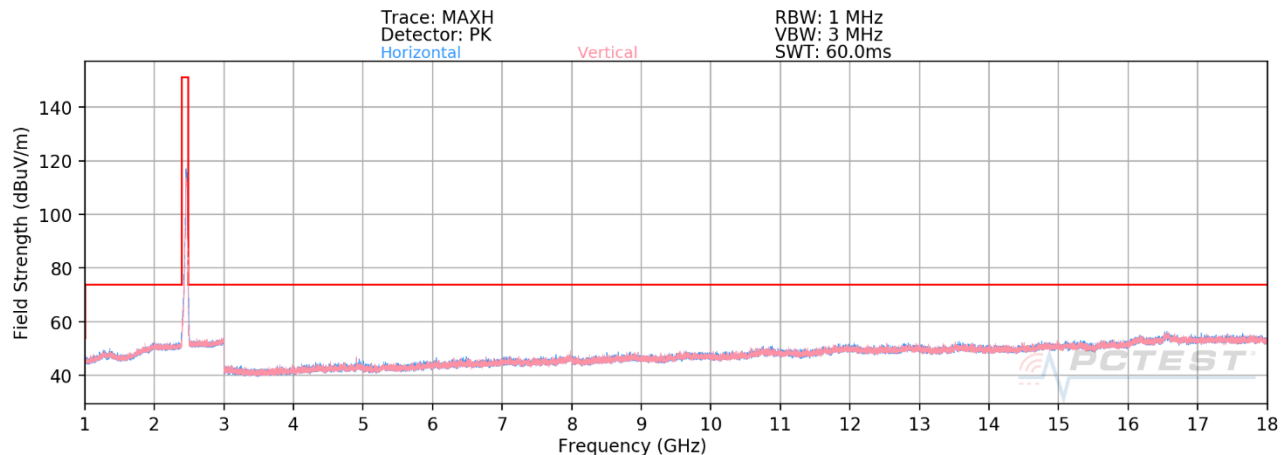

Plot 7-124. Radiated Spurious Emissions above 1GHz CDD (802.11n – Ch. 6)

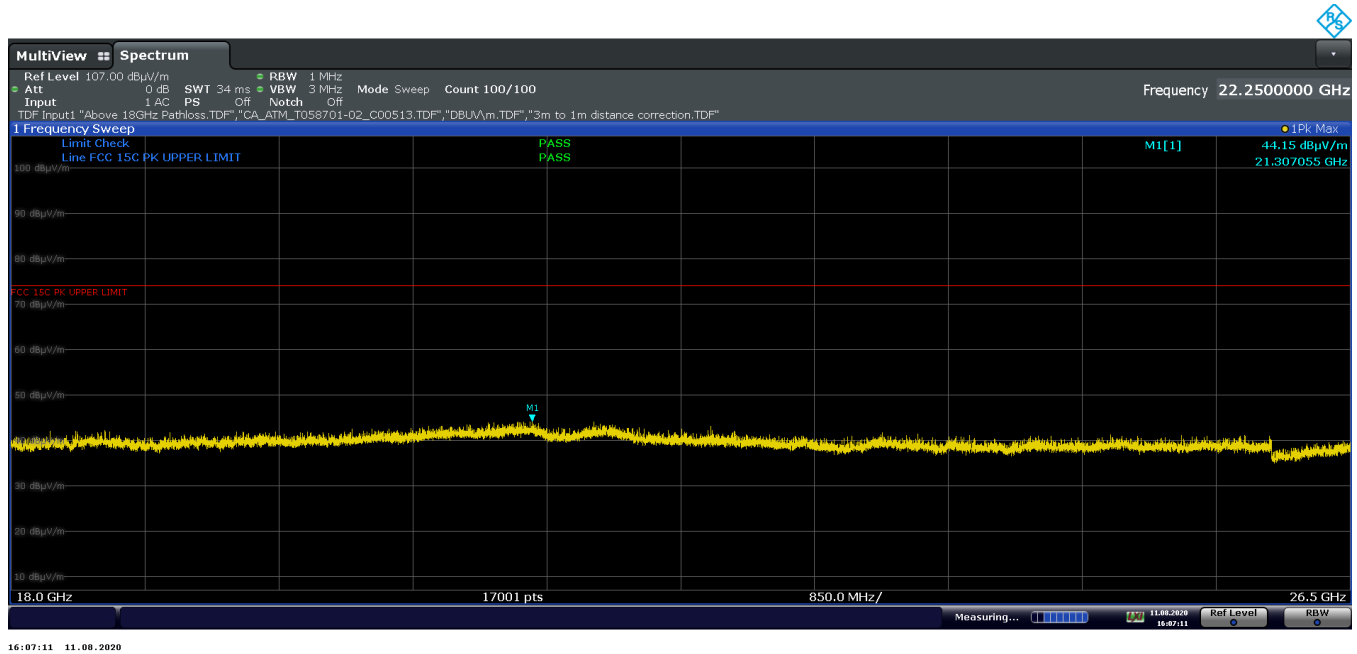


Plot 7-125. Radiated Spurious Emissions above 1GHz CDD (802.11n – Ch. 11)

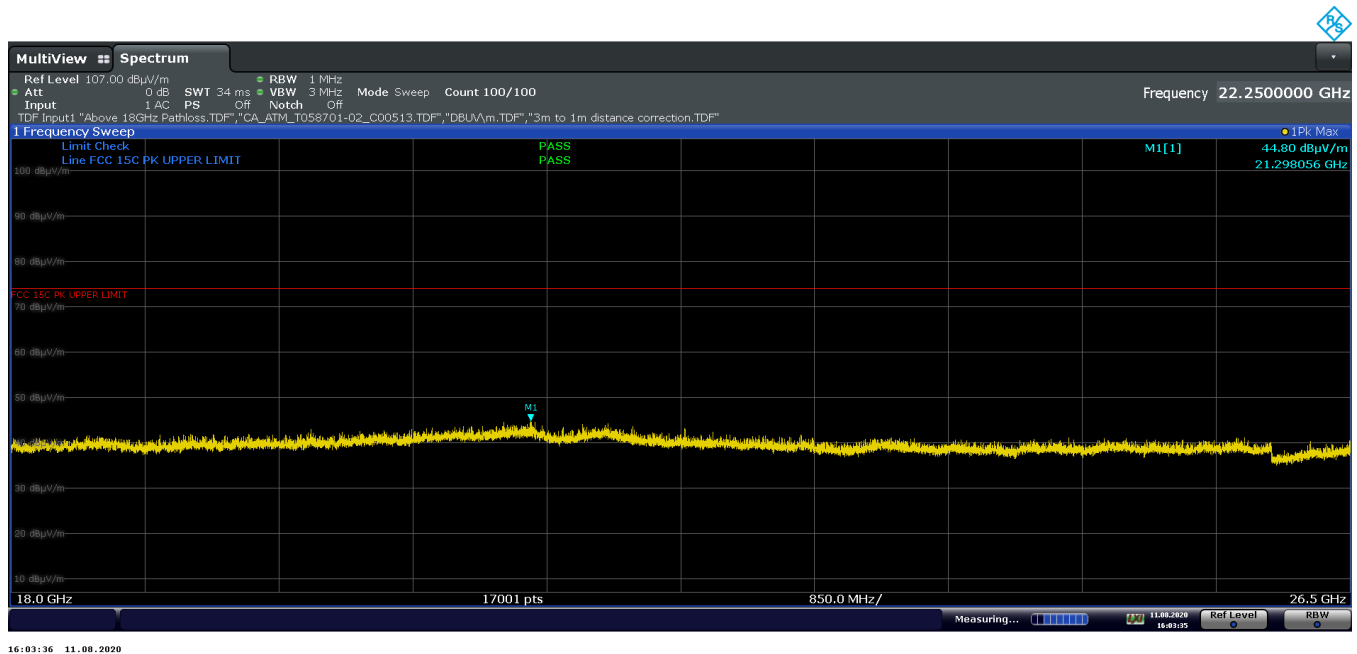

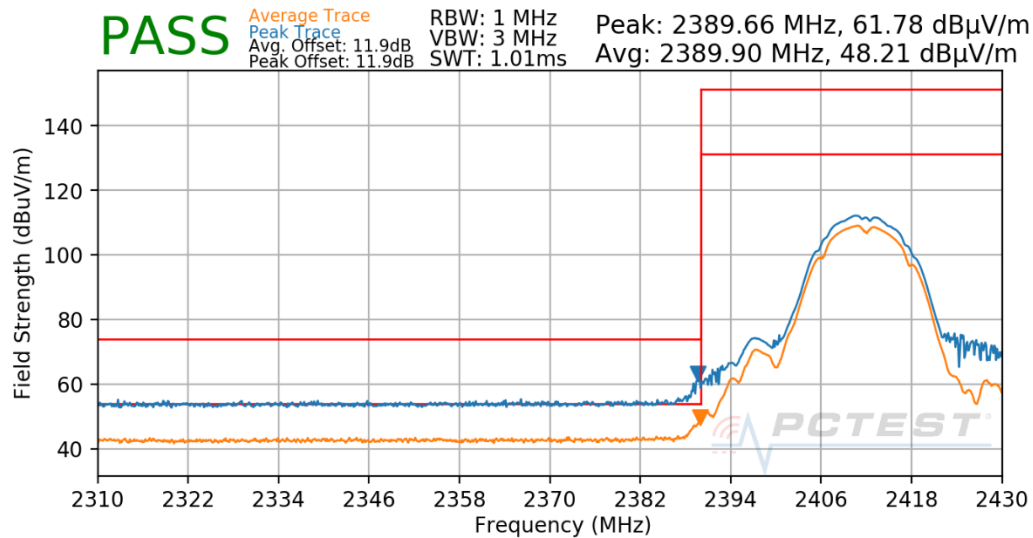

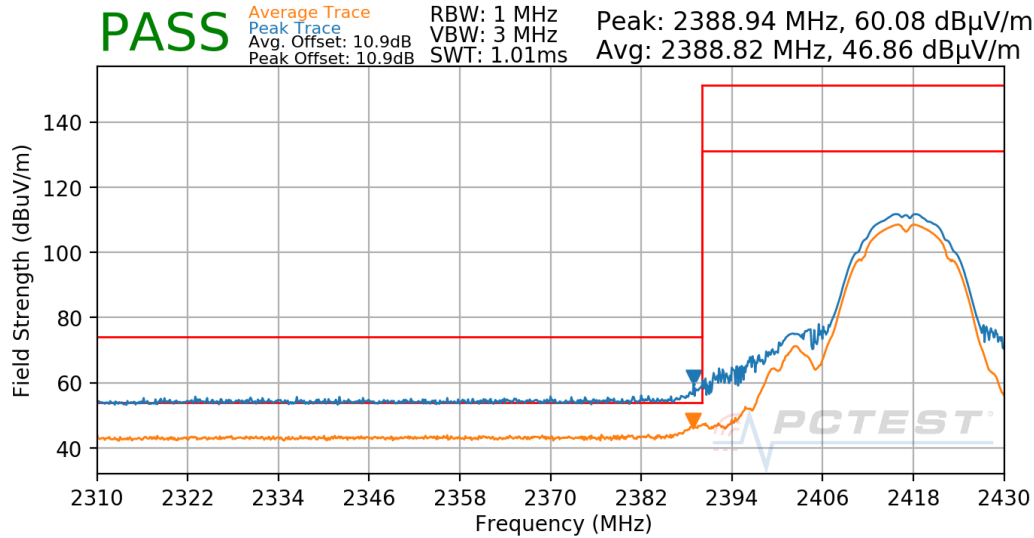

Plot 7-128. Radiated Restricted Lower Band Edge Measurement ANT 3a

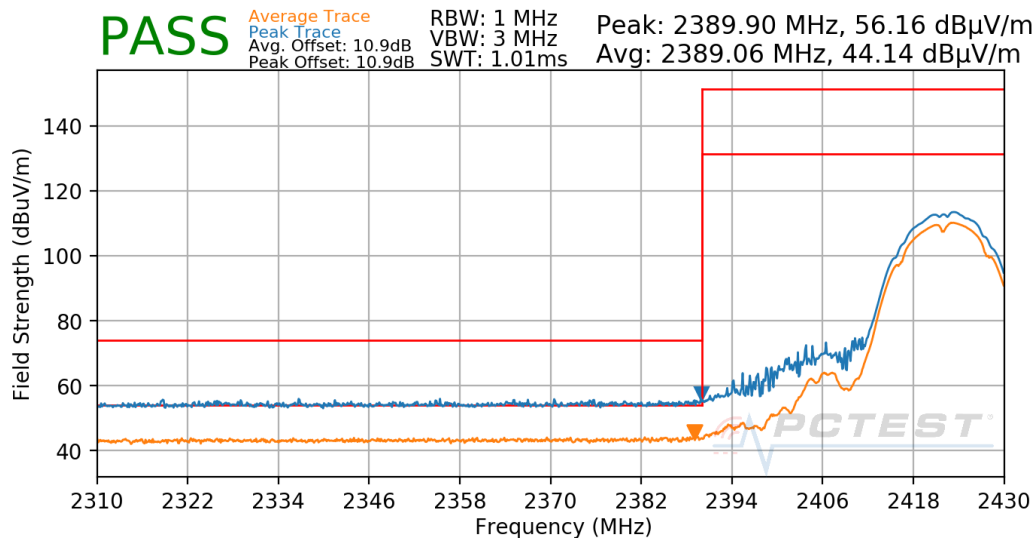

Plot 7-129. Radiated Restricted Lower Band Edge Measurement ANT 3a

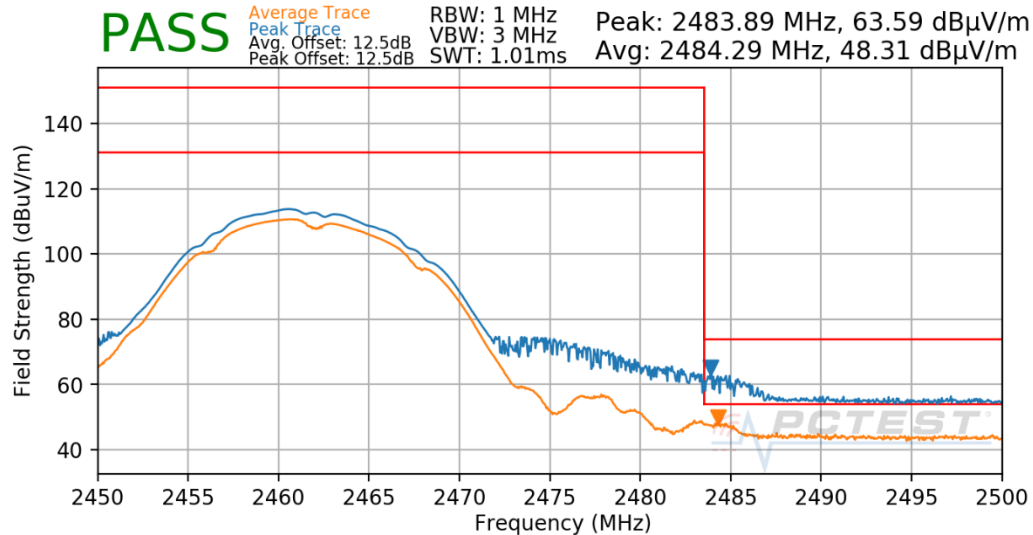

Plot 7-130. Radiated Restricted Lower Band Edge Measurement ANT 3a

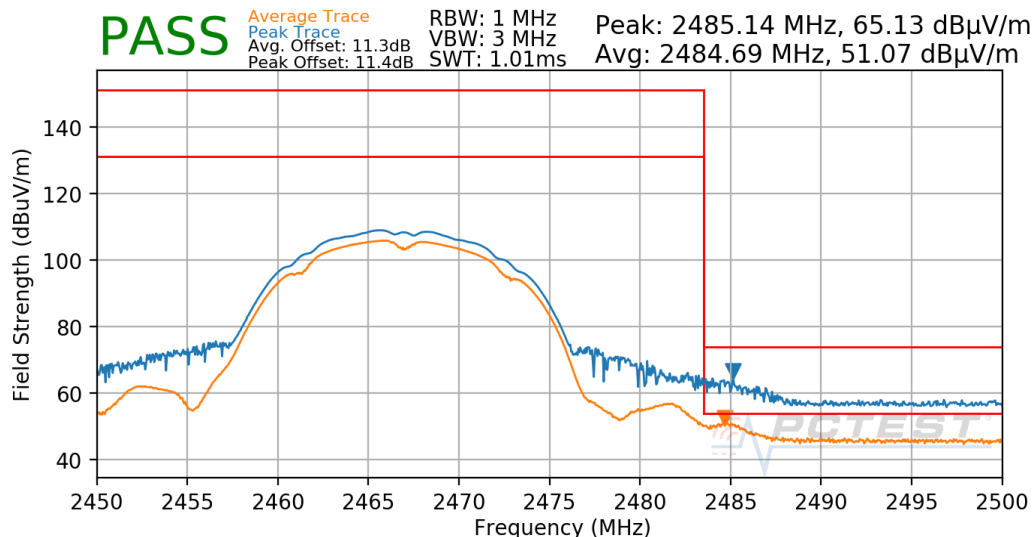

Plot 7-131. Radiated Restricted Upper Band Edge Measurement ANT 3a

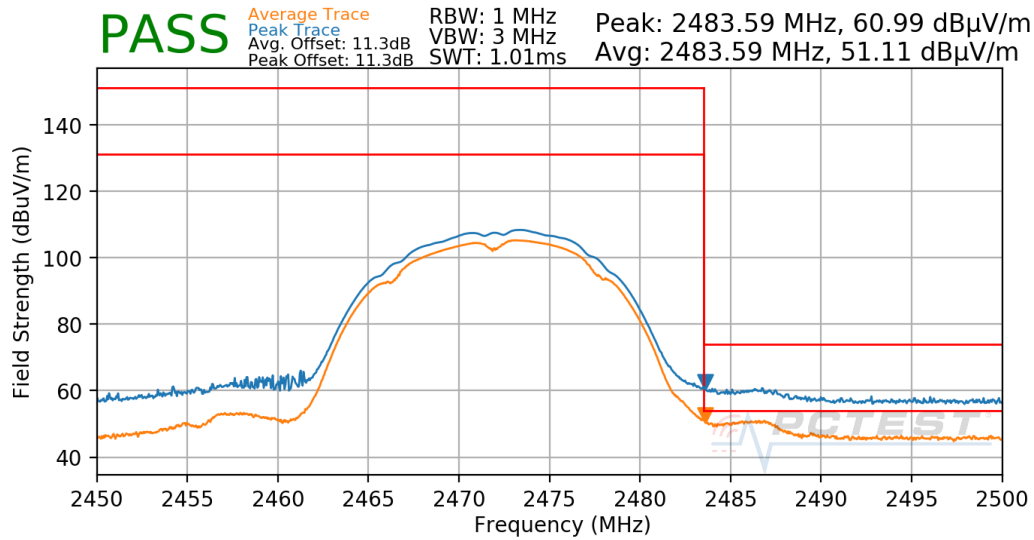

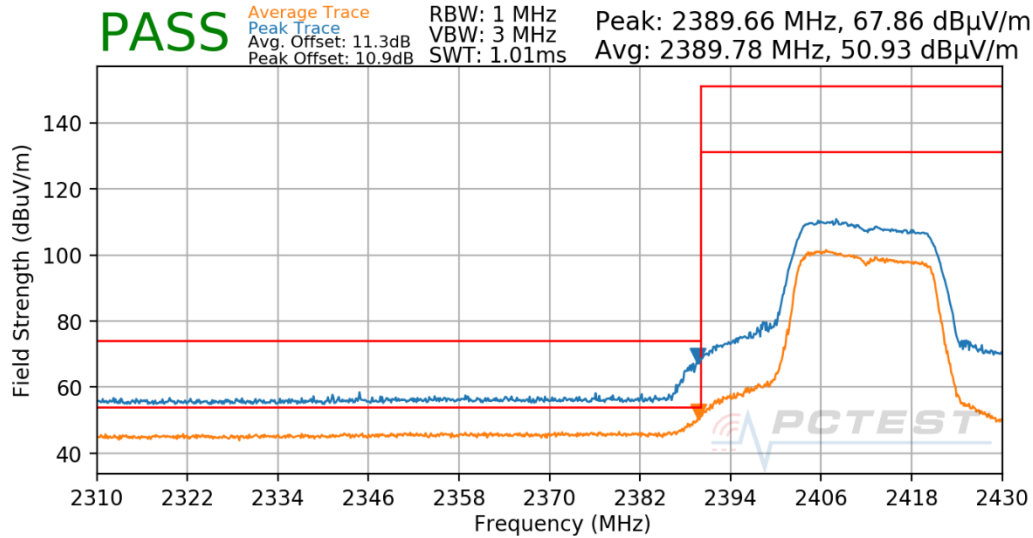

Plot 7-133. Radiated Restricted Upper Band Edge Measurement ANT 3a

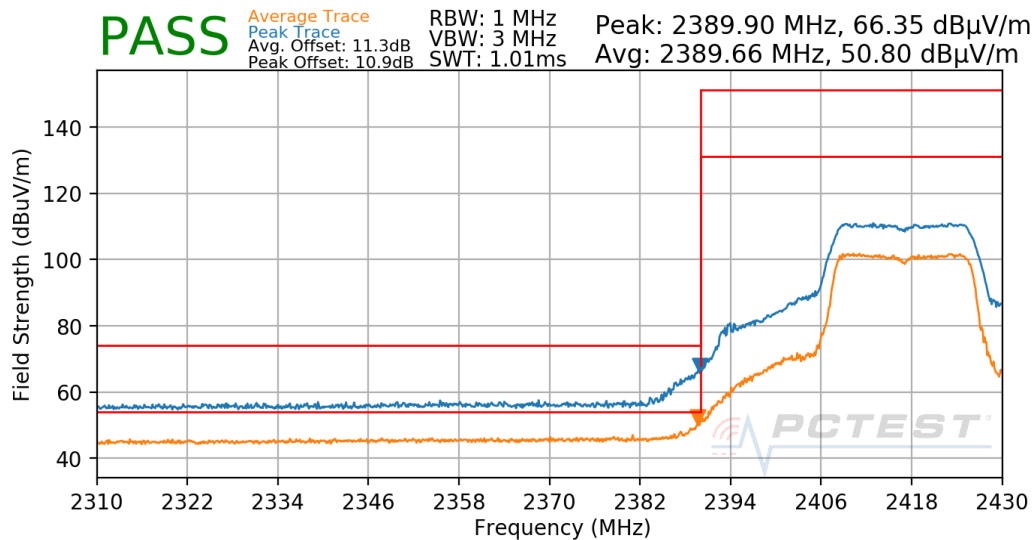

Plot 7-134. Radiated Restricted Lower Band Edge Measurement ANT 3a

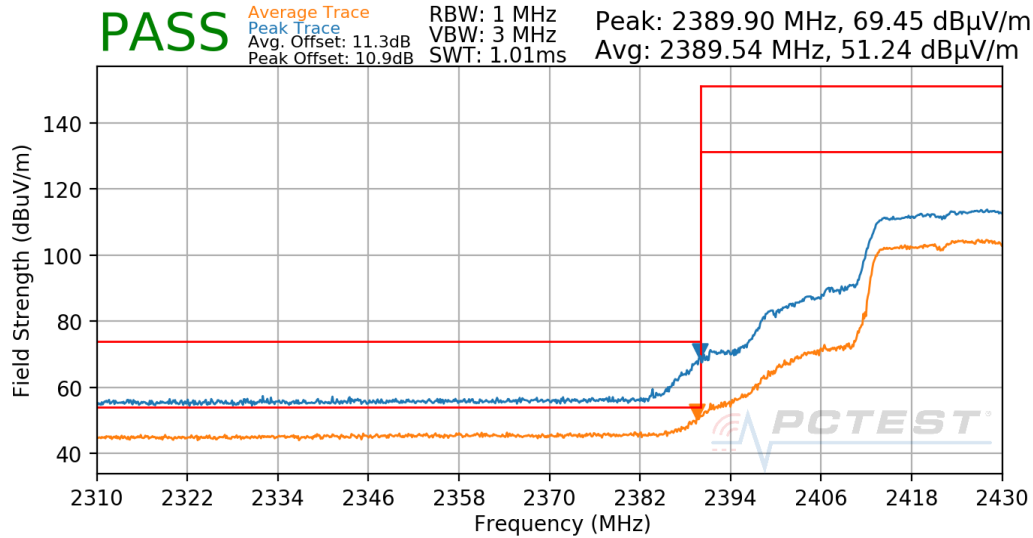

Plot 7-135. Radiated Restricted Lower Band Edge Measurement ANT 3a

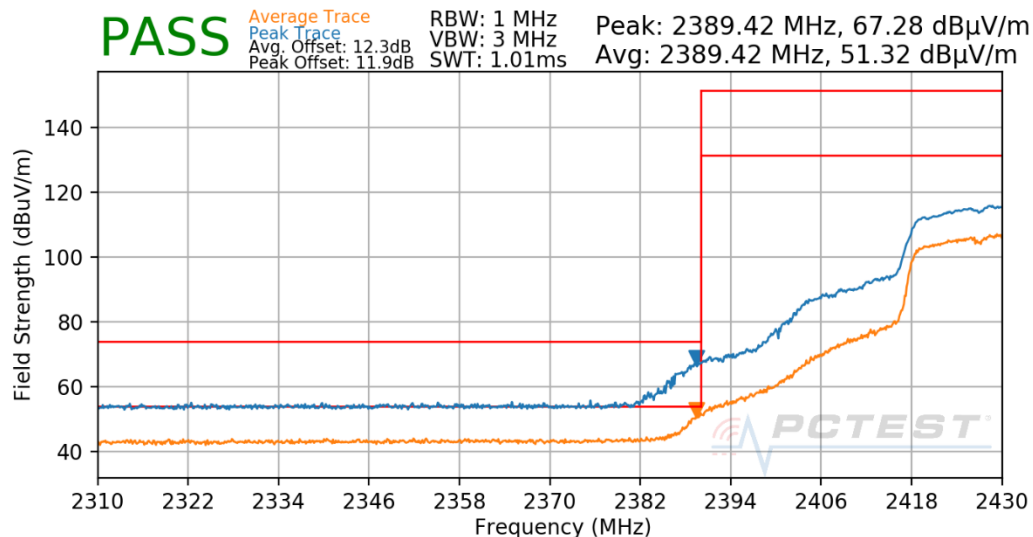

Plot 7-136. Radiated Restricted Lower Band Edge Measurement ANT 3a

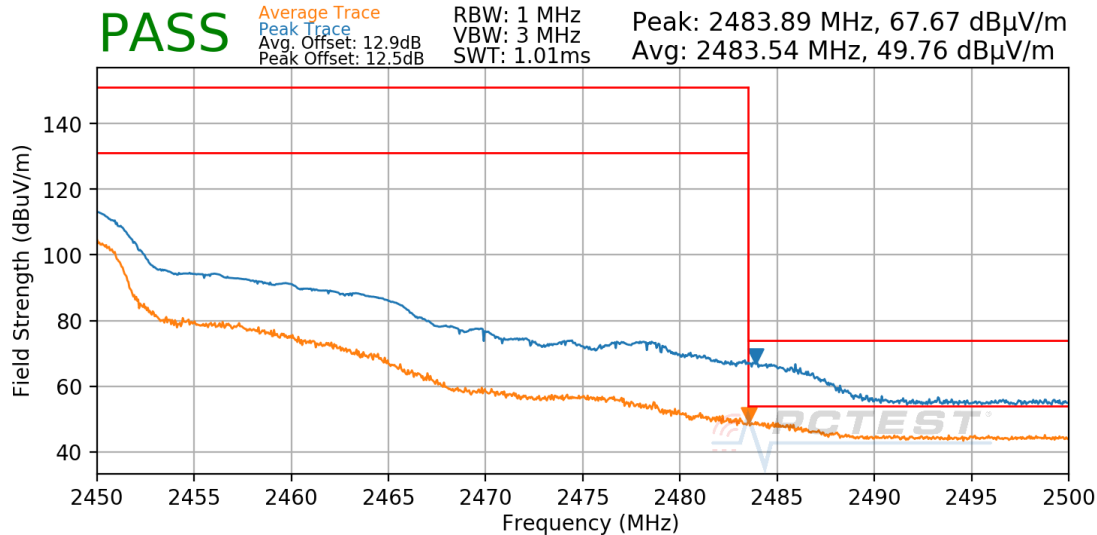

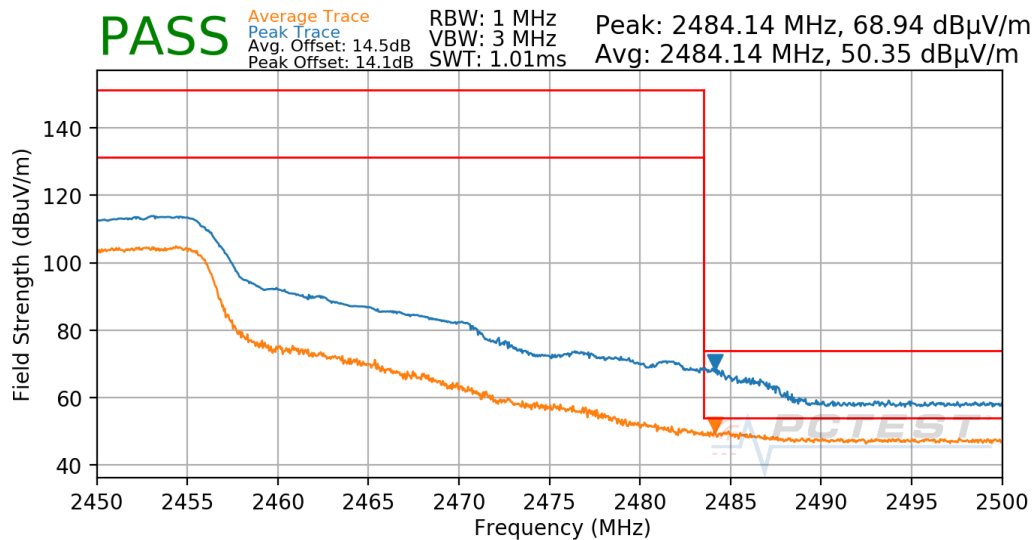

Plot 7-138. Radiated Restricted Upper Band Edge Measurement ANT 3a

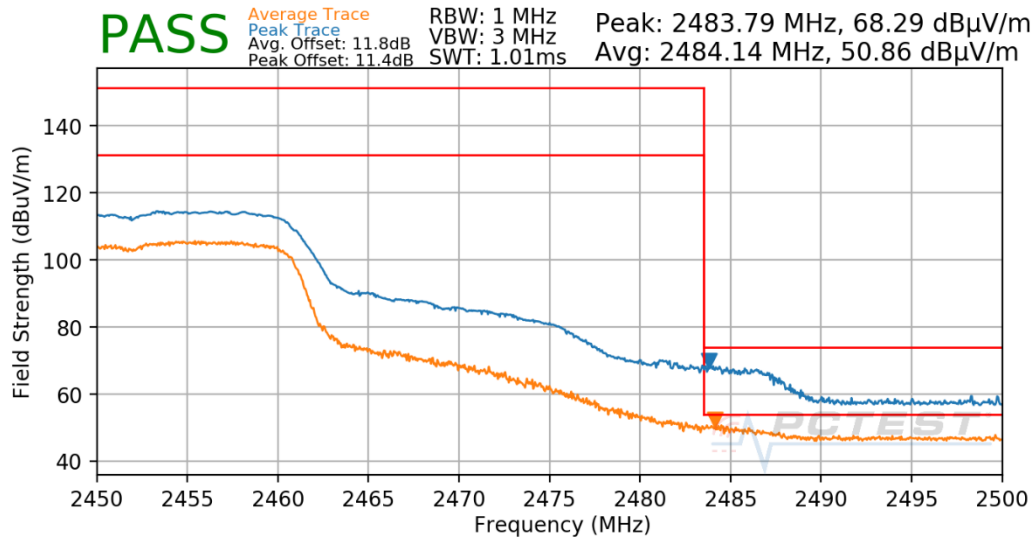

Plot 7-139. Radiated Restricted Upper Band Edge Measurement ANT 3a

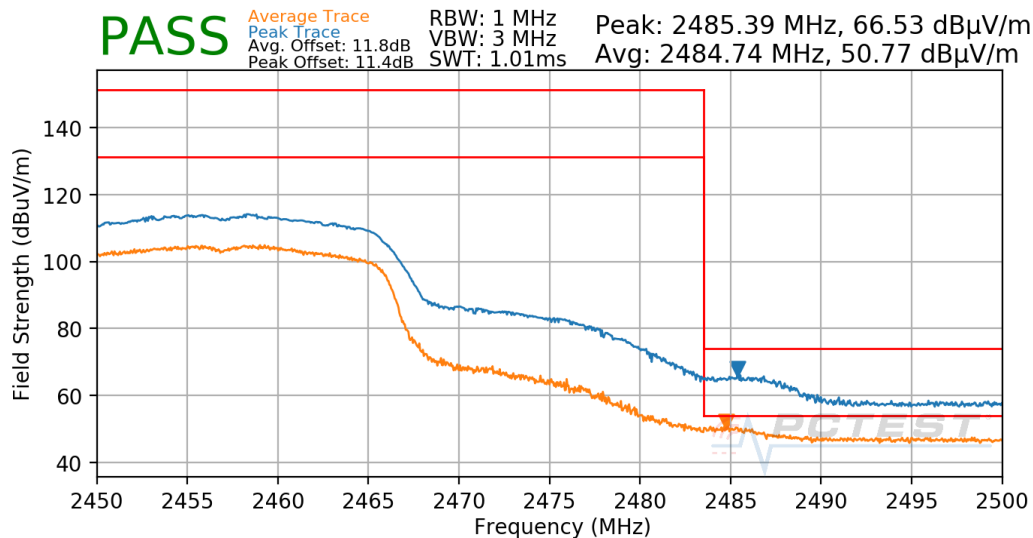

Plot 7-140. Radiated Restricted Upper Band Edge Measurement ANT 3a

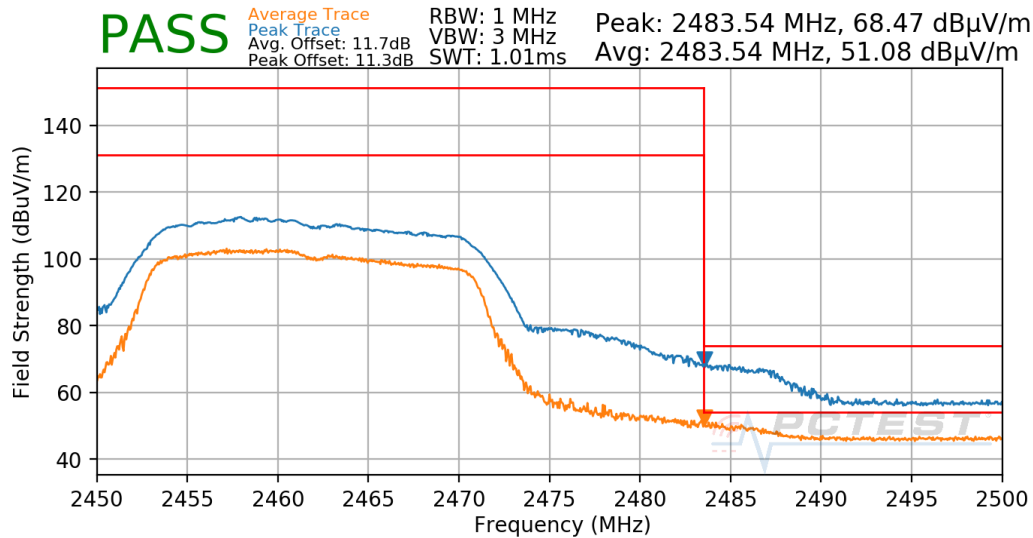

Plot 7-141. Radiated Restricted Upper Band Edge Measurement ANT 3a

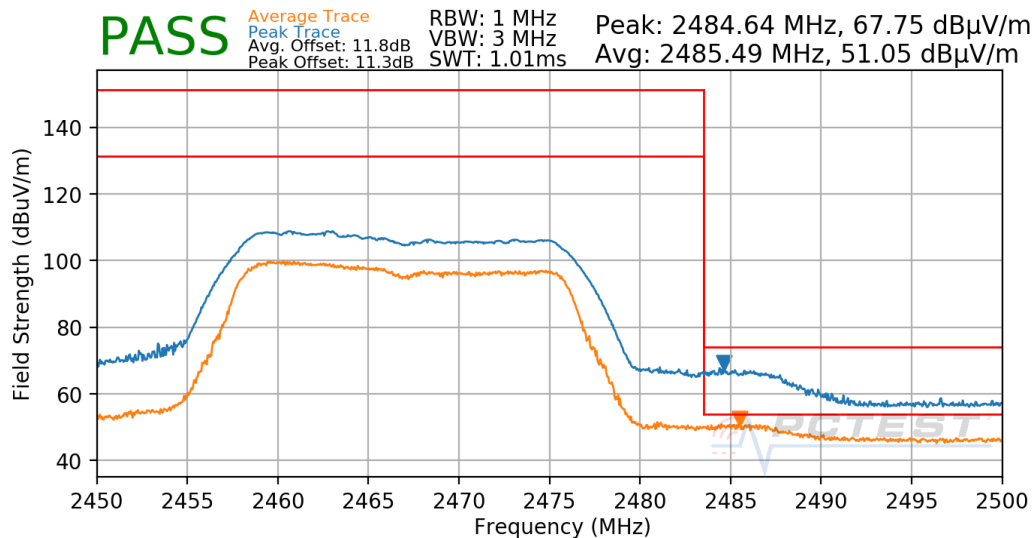

Plot 7-142. Radiated Restricted Upper Band Edge Measurement ANT 3a

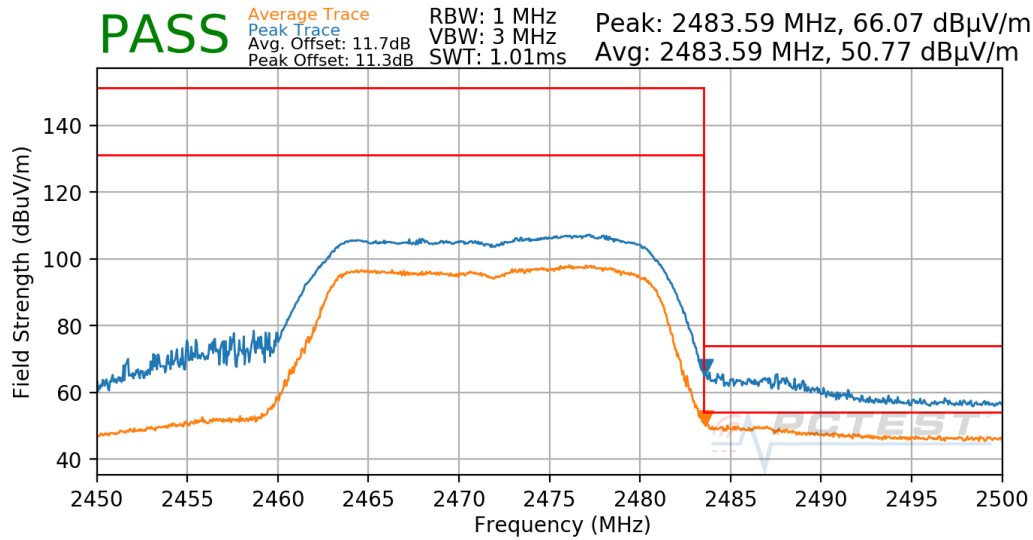

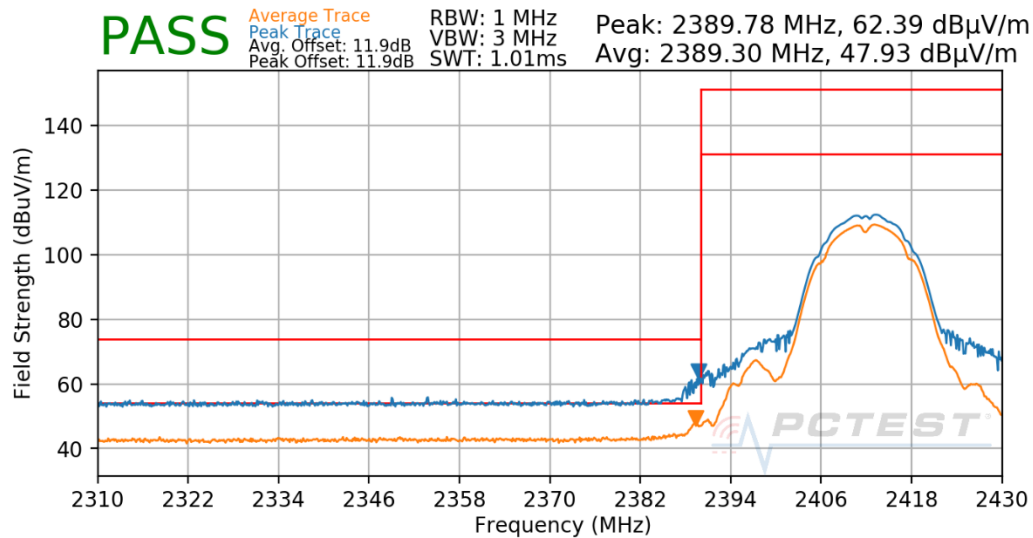
