4. CALIBRATION AND UNCERTAINTY

4.1. MEASURING INSTRUMENT CALIBRATION

The measuring equipment utilized to perform the tests documented in this report has been calibrated in accordance with the manufacturer's recommendations, and is traceable to recognized national standards.

5. EQUIPMENT UNDER TEST

5.1. DESCRIPTION OF EUT

The Equipment Under Test is a mobile phone with GSM, GPRS, EGPRS, UMTS, LTE and TD-SCDMA technologies. It also supports IEEE 802.11a/b/g/n/ac, Bluetooth®, GPS and NFC. The device has a built-in inductive charging receiver which is not user accessible. The rechargeable battery is not user accessible.

5.2. MAXIMUM OUTPUT POWER

EIRP/ERP TEST PROCEDURE

ANSI C63.26:2015

KDB 971168 Section 5.6

$$\text{ERP/EIRP} = \text{PMeas} + \text{GT} - \text{LC}$$

where: ERP/EIRP = effective or equivalent radiated power, respectively (expressed in the same units as PMeas, typically dBW or dBm);

PMeas = measured transmitter output power or PSD, in dBm or dBW;

GT = gain of the transmitting antenna, in dBd (ERP) or dBi (EIRP);

LC = signal attenuation in the connecting cable between the transmitter and antenna, in dB.

For devices utilizing multiple antennas, KDB 662911 provides guidance for determining the effective array transmit antenna gain term to be used in the above equation.

5.4. SOFTWARE AND FIRMWARE

The EUT firmware installed during testing was version 00.34.09.

5.5. WORST-CASE CONFIGURATION AND MODE

The worst-case is EUT on the highest power. Based on Average Power measurement investigations, the following modes should be considered as worst-case scenario for all other measurements.

Worst-case modes:

- GSM GPRS
- GSM EGPRS
- UMTS REL 99
- UMTS HSDPA

The EUT was investigated in three orthogonal orientations X/Y/Z on both LAT 1 and UAT 1 antennas. For LAT 1 antenna, it was determined that Y (Landscape) orientation was worst-case orientation for cell band, secondary band; X (Flatbed) orientation for PCS band without AC/DC adapter, headphones, or laptop. For UAT 1 antenna, it was determined that X (Flatbed) orientation was worst-case orientation for all bands without AC/DC adapter, headphones, or laptop.

Radiated spurious emissions were investigated below 30MHz, 30MHz-1GHz and above 1GHz. There were no emissions found on below 30MHz and 30MHz-1GHz.

For simultaneous transmission of multiple channels in the 2.4GHz and Cellular bands, tests were conducted for various configurations having the highest power, least separation in frequencies and widest operation bandwidths. No noticeable new emission was found.

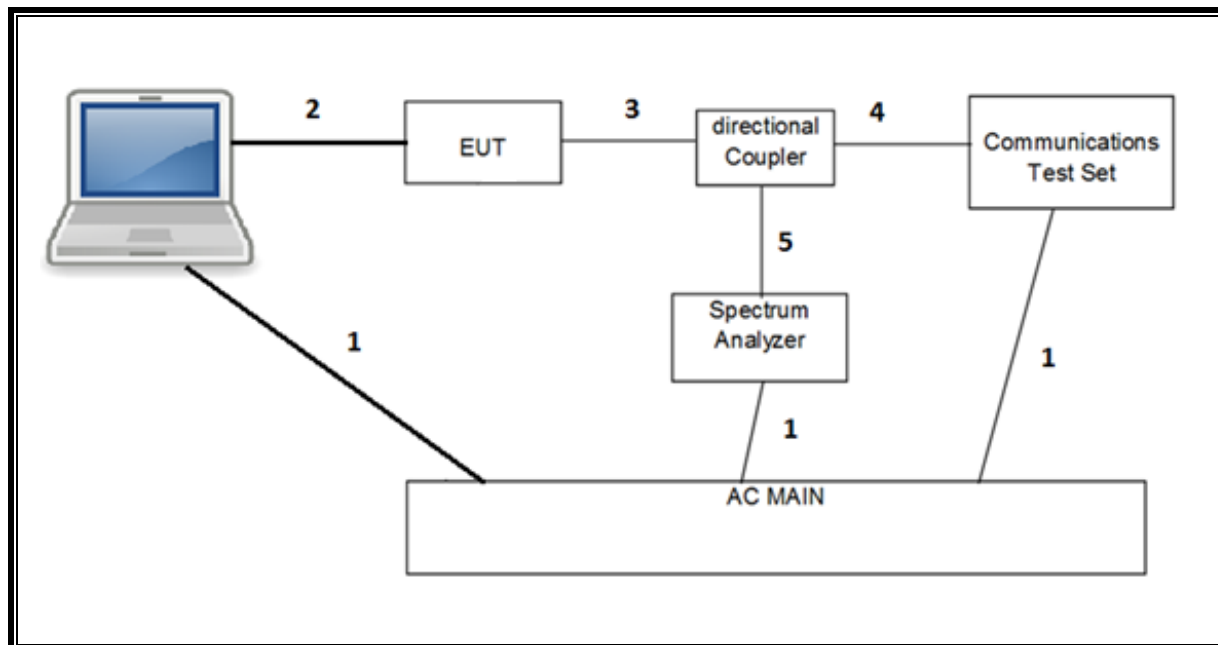

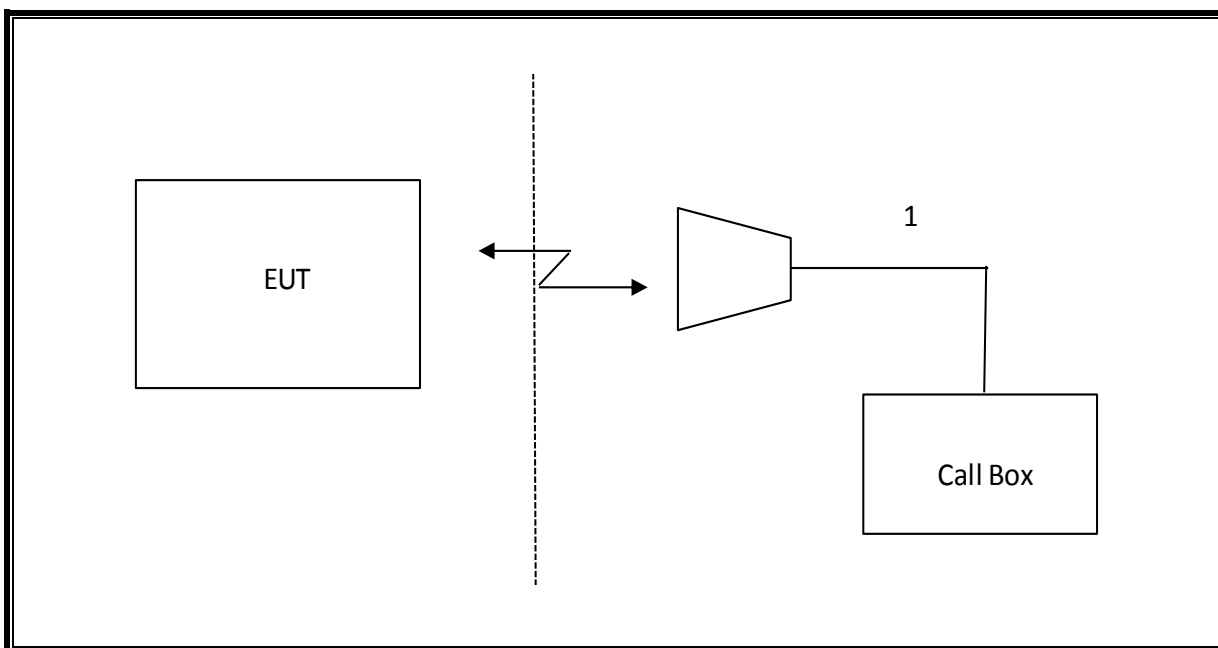

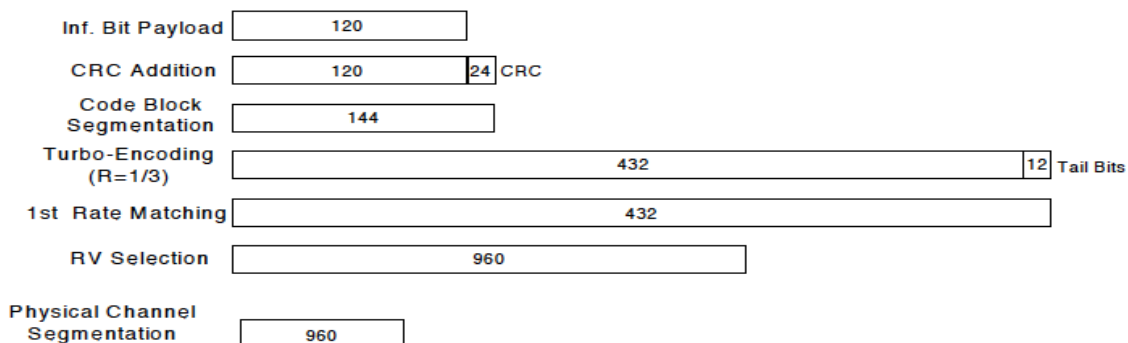


Figure C.8.19: Coding rate for Fixed reference Channel H-Set 12 (QPSK)

The temperature is increased by 10 degrees, allowed to stabilize and soak, and then the measurement is repeated. This is repeated until $+50^{\circ}\text{C}$ is reached.

Frequency Stability vs Voltage:

The peak frequency error is recorded (worst-case).
