### 3. DESCRIPTION OF TEST MODES

The EUT is a Wireless-N Router w 3G+Modem & Voice.

The RF chipset is manufactured by Ralink technology, corp.

The antenna peak gain 3.79dBi (highest gain) were chosen for full testing.

#### IEEE 802.11 b ,802.11g ,802.11n HT20 mode (DTS Band)

The EUT had been tested under operating condition.

There are three channels have been tested as following:

IEEE 802.11b mode: 1Mbps long data rates (worst case) were chosen for full testing.

IEEE 802.11g mode: 6Mbps data rates (worst case) were chosen for full testing.

IEEE 802.11n HT20 mode: 6.5Mbps data rates (worst case) were chosen for full testing.

#### IEEE 802.11n HT40 mode (DTS Band)

The EUT had been tested under operating condition.

There are three channels have been tested as following:

IEEE 802.11n HT40 mode: 13.5Mbps data rates (worst case) were chosen for full testing.

The worst-case data rates are determined according to the description above, based on the investigations by measuring the PSD, peak power and average power across all the data rates, bandwidths, modulations and spatial stream modes.



## 4. TEST METHODOLOGY

The tests documented in this report were performed in accordance with ANSI C63.4 and FCC CFR 47 15.207, 15.209 and 15.247 and KDB 558074..

## 5. FACILITIES AND ACCREDITATIONS

### 5.1 FACILITIES

All measurement facilities used to collect the measurement data are located at No.8, Jiucengling, Xinhua Dist., Tainan City 712, Taiwan (R.O.C.)

The sites are constructed in conformance with the requirements of ANSI C63.7:1992, ANSI C63.4: 2003 and CISPR Publication 22.

### 5.2 EQUIPMENT

Radiated emissions are measured with one or more of the following types of linearly polarized antennas: tuned dipole, biconical, log periodic, bi-log, and/or ridged waveguide, horn. Spectrum analyzers with preselectors and quasi-peak detectors are used to perform radiated measurements.

Conducted emissions are measured with Line Impedance Stabilization Networks and EMI Test Receivers.

Calibrated wideband preamplifiers, coaxial cables, and coaxial attenuators are also used for making measurements.

All receiving equipment conforms to CISPR Publication 16-1, "Radio Interference Measuring Apparatus and Measurement Methods."

The test facilities used to perform radiated and conducted emissions tests are accredited by Taiwan Accreditation Foundation for the specific scope of accreditation under Lab Code: 1109 to perform Electromagnetic Interference tests according to FCC PART 15 AND CISPR 22 requirements. 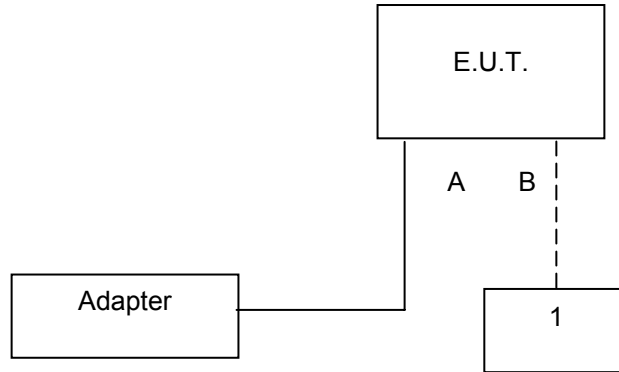

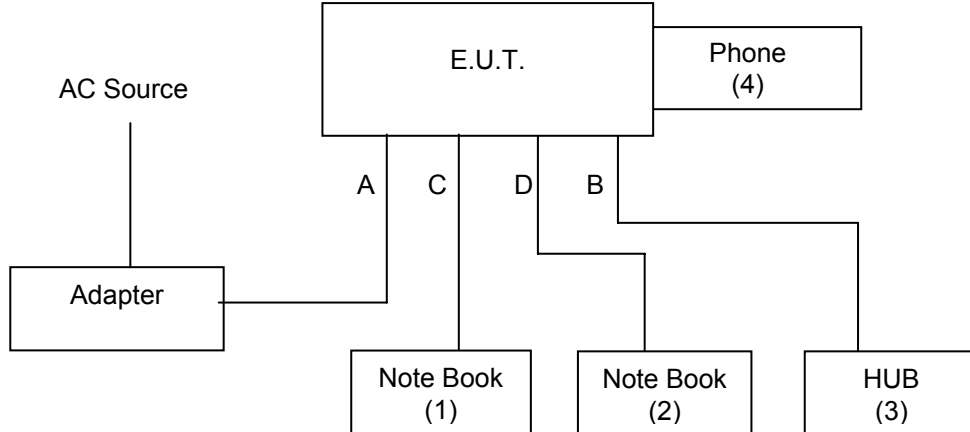

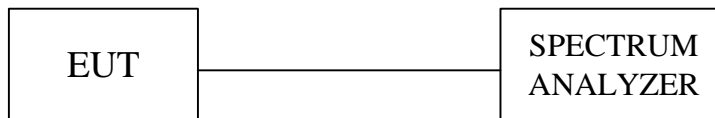

#### TEST PROCEDURE

The transmitter output was connected to a spectrum analyzer. The bandwidth of the fundamental frequency was measured by spectrum analyzer with 100 KHz RBW and 100 KHz VBW. The 6dB bandwidth is defined as the total spectrum the power of which is higher than peak power minus 6dB.

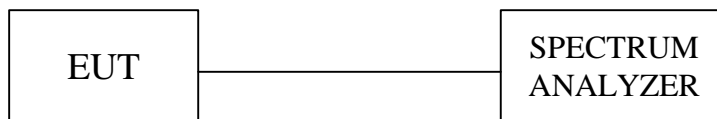
§ 15.247(b) (4) Except as shown in paragraphs (c) of this section , if transmitting antennas of directional gain greater than 6 dBi are used the peak output power from the intentional radiator shall be reduced below the stated values in paragraphs (b)(1) or (b)(2), and (b)(3) of this section , as appropriate, by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

## **TEST PROCEDURE**

The tests were performed in accordance with KDB 558074 5.2.1.2 and 5.2.2.1.

### **5.2.1.2 Measurement Procedure PK2:**

- 1.This procedure provides an integrated measurement alternative when the maximum available RBW < EBW.
- 2.Set the RBW = 1 MHz.
- 3.Set the VBW = 3 MHz.
- 4.Set the span to a value that is 5-30 % greater than the EBW.
- 5.Detector = peak.
- 6.Sweep time = auto couple.
- 7.Trace mode = max hold.
- 8.Allow trace to fully stabilize.
- 9.Use the spectrum analyzer's integrated band power measurement function with band limits set equal to the EBW band edges(for some analyzers, this may require a manual override to ensure use of peak detector). If the spectrum analyzer does not have a band power function, sum the spectrum levels (in linear power units) at 1 MHz intervals extending across the EBW of the spectrum.

### **5.2.2.1 Measurement Procedure AVG1(power averaging over the EBW with slow sweep speed):**

- 1.Set the analyzer span to 5-30% greater than the EBW.
- 2.Set the RBW = 1 MHz.
- 3.Set the VBW  $\geq$  3 MHz.
- 4.Detector = power average (RMS).
- 5.Ensure that the number of measurement points in the sweep  $\geq$  2 x (span/RBW).
- 6.Manually set the sweep time to:  $\geq$ 10 x (number of measurement points in sweep) x (transmission symbol period).
- 7.Perform the measurement over a single sweep.
- 8.Use the spectrum analyzer's integrated band power measurement function with band limits set equal to the EBW band edges to determine the maximum conducted output power of the EUT over the EBW. Note: If the analyzer does not have a band power function, sum the spectral levels (in linear power units) at 1 MHz intervals extending across the entire EBW.

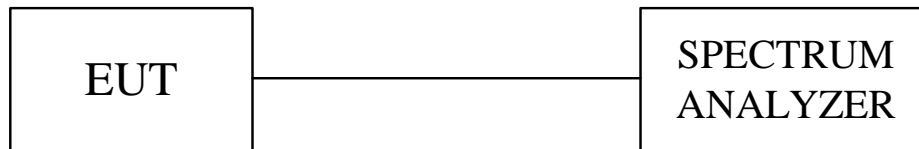
§ 15.247(d) In any 100 kHz bandwidth outside the frequency band in which the spread spectrum intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement. Attenuation below the general limits specified in § 15.209(a) is not required. The spectrum from 30 MHz to 26.5 GHz is investigated with the transmitter set to the lowest, middle, and highest channels in the 2.4 GHz band.

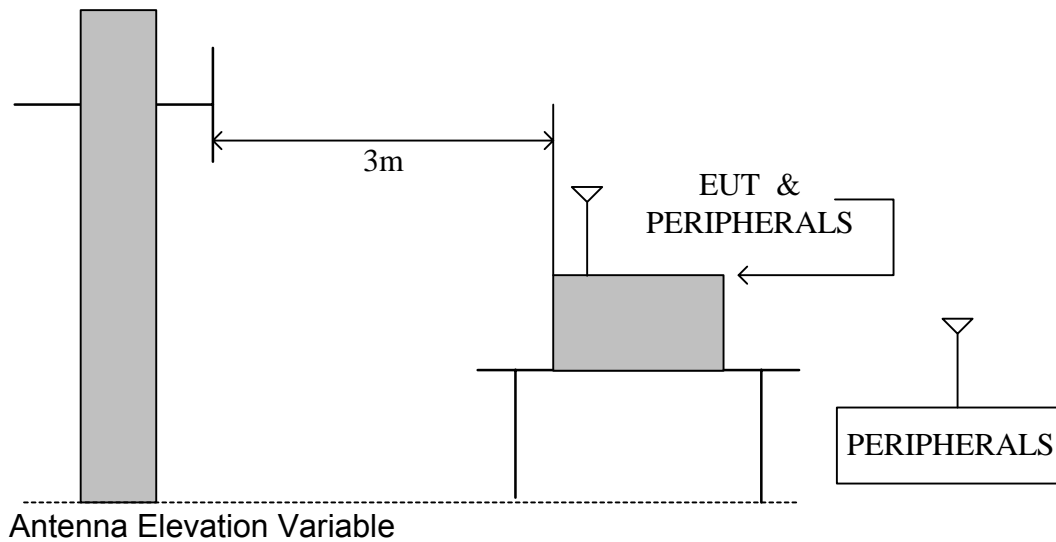


**TEST SETUP**

## **TEST PROCEDURE**

- a. The EUT was placed on the top of a rotating table 0.8 meters above the ground at a 10 meter open area test site. The table was rotated 360 degrees to determine the position of the highest radiation.
- b. While measuring the radiated emission below 1GHz, the EUT was set 3 or 10 meters away from the interference-receiving antenna, which was mounted on the top of a variable-height antenna tower. While measuring the radiated emission above 1GHz, the EUT was set 3 meters away from the interference-receiving antenna
- c. The antenna is a broadband antenna, and its height is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarization of the antenna are set to make the measurement.
- d. For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters and the table was turned from 0 degrees to 360 degrees to find the maximum reading.
- e. The test-receiver system was set to Peak Detect Function and Specified Bandwidth with Maximum Hold Mode.
- f. If the emission level of the EUT in peak mode was 10 dB lower than the limit specified, then testing could be stopped and the peak values of the EUT would be reported. Otherwise the emissions that did not have 10 dB margin would be re-tested one by one using peak, quasi-peak or average method as specified and then reported in a data sheet.
- g. The tests were performed in accordance with KDB 558074 5.4.

### **NOTE:**

1. The resolution bandwidth and video bandwidth of test receiver/spectrum analyzer is 120 KHz for Peak detection (PK) and Quasi-peak detection (QP) at frequency below 1GHz.

### 8.7 POWERLINE CONDUCTED EMISSIONS

#### LIMITS

§ 15.207 (a) Except as shown in paragraph (b) and (c) this section, for an intentional radiator that is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies within the band 150 kHz to 30 MHz shall not exceed the limits in the following table, as measured using a 50 μH/50 ohms line impedance stabilization network (LISN). Compliance with the provisions of this paragraph shall be based on the measurement of the radio frequency voltage between each power line and ground at the power terminal.

The lower limit applies at the boundary between the frequency ranges.

## **9. ANTENNA REQUIREMENT**

### **9.1 STANDARD APPLICABLE**
