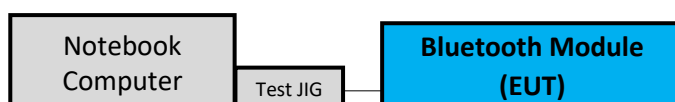

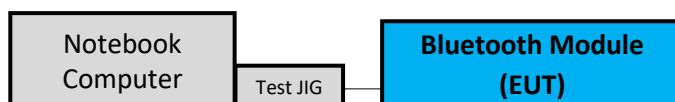

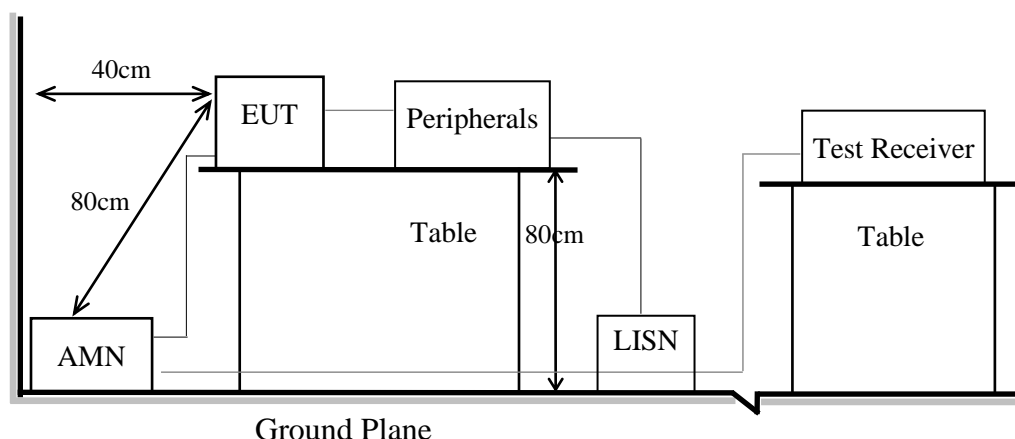

### 5.3. Test Procedure

- 5.3.1. To set up the EUT as indicated in ANSI C63.10. The EUT was placed on the table which has 80 cm height to the ground and 40 cm distance to the conducting wall.
- 5.3.2. Power supplier of the EUT was connected to the AC mains through an Artificial Mains Network (A.M.N.).
- 5.3.3. The AC power supplies to all peripheral devices must be provided through line impedance stabilization network (L.I.S.N.)
- 5.3.4. Checking frequency range from 150kHz to 30 MHz and record the emission which does not have 20 dB below limit.

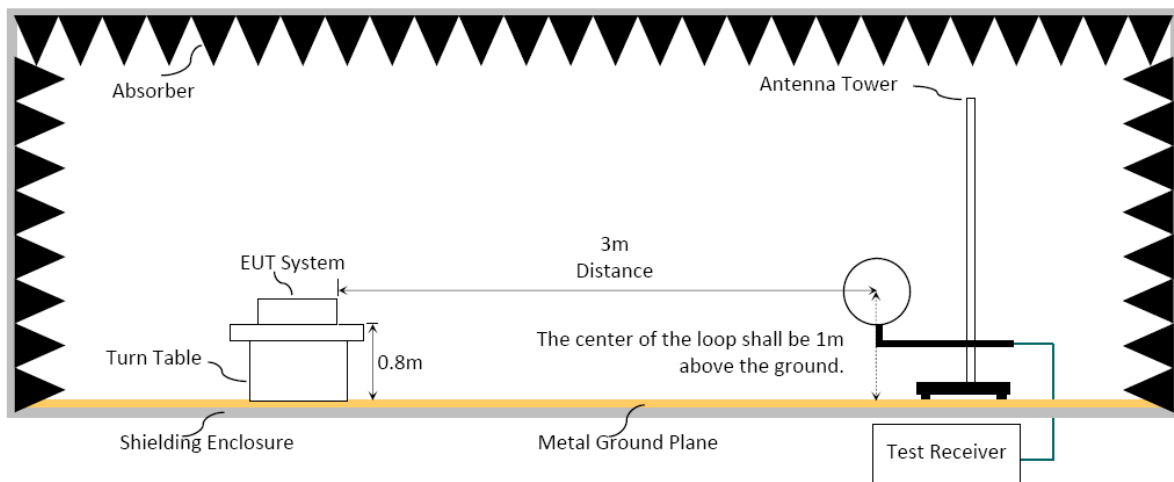

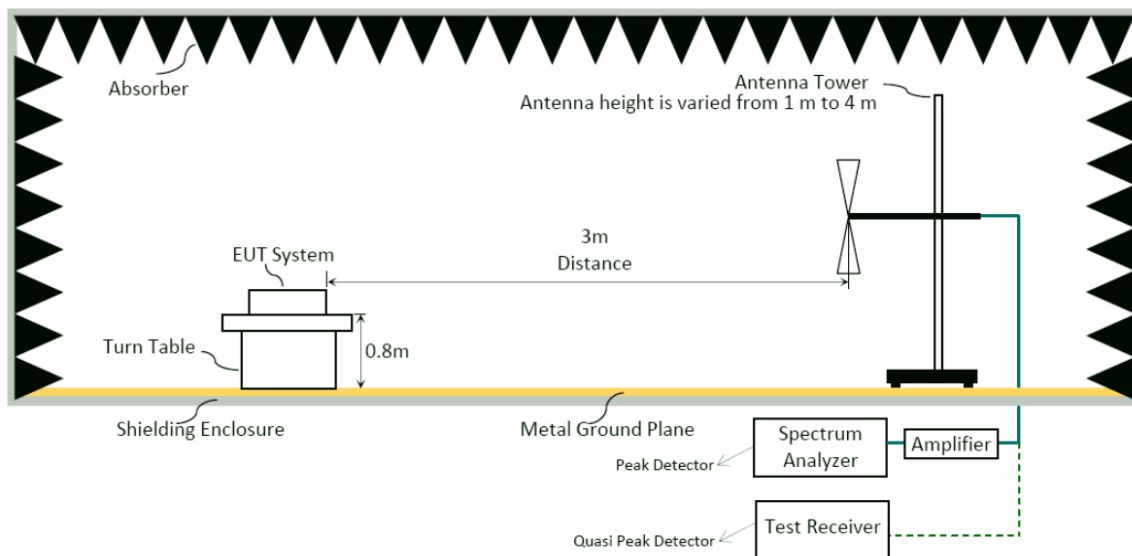
#### 6.1.1. Block Diagram of EUT

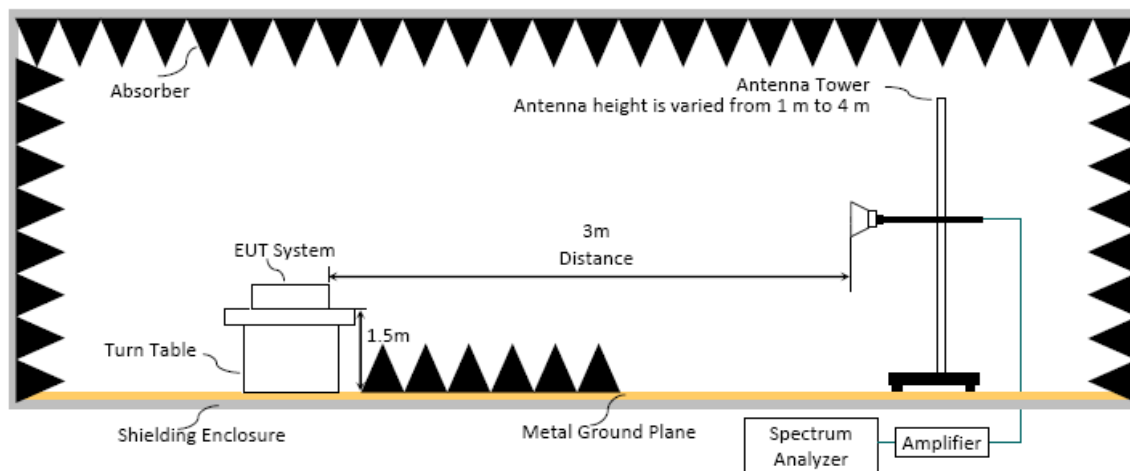
#### 6.1.2. Setup Diagram for 9kHz-30MHz

## 6.2. Radiated Emission Limits

In any 100kHz bandwidth outside the frequency band, the radio frequency power produced by the intentional radiator shall be at least 20dB below that in the 100kHz bandwidth within the band that contains the highest level. In addition, radiated emissions which fall in restricted bands, as defined in Section 15.205/RSS-Gen Section 8.10 table 6, must also comply with the radiated emission limits specified as below.

- (2) The tighter limit applies to the edge between two frequency bands.
- (3) Distance refers to the distance in meters between the measuring instrument antenna and the closed point of any part of the device or system.
- (4) Fundamental and emission fall within operation band are exempted from this section.
- (5) Pursuant to ANSI C63.10: 6.6.4.3, if the maximized peak measured value complies with the average limit, then it is unnecessary to perform an average measurement.

### 6.3. Test Procedure

#### Frequency Range 9kHz~30MHz:

The EUT setup on the turntable which has 0.8 m height to the ground. The turn table rotated 360 degrees and antenna fixed to 1 m to find the maximum emission level. In order to find the maximum emission, all of the interface cables were manipulated according to ANSI C63.10-2013 regulation.

- (1) RBW = 9kHz with peak and average detector.
- (2) Detector: average and peak (9kHz-490kHz)  
Q.P. (490kHz-30MHz)

#### Frequency Range 30MHz ~ 25GHz:

The EUT setup on the turn table which has 80cm (for 30-1000MHz) and 1.5m (for above 1GHz) height to the ground. The turn table rotated 360 degrees and antenna varied from 1 m to 4 m to find the maximum emission level. Both horizontal and vertical polarization are required. 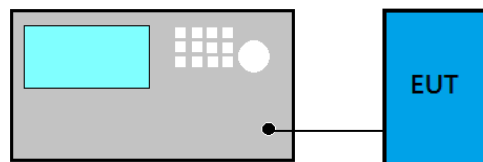

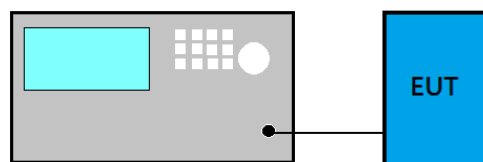

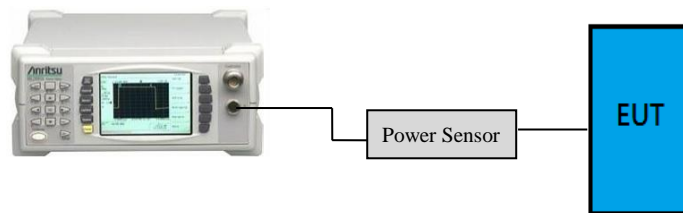

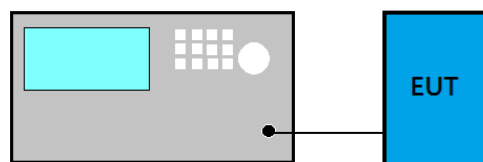

In any 100kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20dB below that in the 100kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, that the required attenuation shall be 30 dB instead of 20 dB.

Attenuation below the general limits specified in Section 15.209(a)/RSS-Gen Section 8.9 table 4 is not required. In addition, radiated emissions which fall in restricted bands, as defined in Section 15.205(a)/RSS-Gen Section 8.10 table 6., must also comply with the radiated emission limits specified in Section 15.209(a)/RSS-Gen Section 8.9 table 4 (See Section 15.205(c)).
