1. SAR test exclusion threshold

- The power density Pd (5th column) at a distance of 20 cm calculated from the friis transmission formula is far below the limit of 1 mW/cm².

Confirm the sum result of individual MPEs ratio is \leq 1.0;

Element + WLAN: $(1.188 / 997.7) + (0.028 624 / 1) = 0.030 \le 1.0$
