#### **GENERAL INFORMATION**

#### **Product Description for Equipment Under Test (EUT)**

The *DESA Specialty* product, *FCCID: BJ4-64WDB44TX or* the "EUT" as referred to in this report is a wireless door bell push button transmitter in a metal housing that can transmit to one or more different receivers. Two 3-volt CR-2032 lithium batteries power the transmitter circuit. This input power is internally regulated in each encoder IC T-99. The miniature dip switches control the coding for the T-99 encoder, allowing up to 128 different code possibilities for each button. The output of each encoder chip goes through the oscillator/modulator stage. A SAW Resonator circuit sets the frequency, which is 315M Hz. The encoded signal from either button is then sent through the "helical" antenna mounted on the PCB and the RF output is transmitted into the air.

#### **Mechanical Description**

The *DESA Specialty, LLC* product, *FCCID: BJ4-64WDB44TX* in this report is a Wireless Push Button which measures approximately 109.60mm L x 25.20mm W x 26.00mm H and weighs 26.20g. The EUT is designed to operate at 315 MHz frequency.

#### **Objective**

This report is prepared on behalf of *DESA Specialty*, *LLC* in accordance with Part 2, Subpart J, and Part 15, Subparts B and C of the Federal Communication Commissions rules.

The objective of the manufacturer is to determine compliance with FCC rules, Part 15.231 for radiated emission, 20dB Bandwidth, and Deactivation.

#### **Test Methodology**

All measurements contained in this report were conducted with ANSI C63.4 –2003, American National Standard for Methods of Measurement of Radio-Noise Emissions from Low-Voltage Electrical and Electronic Equipment in the range of 9 kHz to 40 GHz. All radiated and conducted emissions measurements were performed at BACL.

#### **Measurement Uncertainty**

All measurements involve certain levels of uncertainties, especially in field of EMC. The factors contributing to uncertainties are spectrum analyzer, cable loss, antenna factor calibration, antenna directivity, antenna factor variation with height, antenna phase center variation, antenna factor frequency interpolation, measurement distance variation, site imperfections, mismatch (average), and system repeatability.

Based on NIS 81, The Treatment of Uncertainty in EMC Measurements, the values range from  $\pm 2.0$  for Conducted Emissions tests and  $\pm 4.0$  dB for Radiated Emissions tests are the most accurate estimates pertaining to uncertainty of EMC measurements at BACL.

Detailed instrumentation measurement uncertainties can be found in BACL report QAP-018.

#### **Test Facility**

The Test site used by BACL to collect radiated and conducted emission measurement data is located at 1274 Anvilwood Ave, Sunnyvale, California, USA.

Test site at BACL has been fully described in reports submitted to the Federal Communication Commission (FCC) and Voluntary Control Council for Interference (VCCI). The details of these reports has been found to be in compliance with the requirements of Section 2.948 of the FCC Rules on February 11 and December 10, 1997 and Article 8 of the VCCI regulations on December 25, 1997. The facility also complies with the radiated and AC line conducted test site criteria set forth in ANSI C63.4-2003.

The Federal Communications Commission and Voluntary Control Council for Interference has the reports on file and is listed under FCC file 31040/SIT 1300F2 and VCCI Registration No.: C-1298 and R-1234. The test site has been approved by the FCC and VCCI for public use and is listed in the FCC Public Access Link (PAL) database.

Additionally, BACL is a National Institute of Standards and Technology (NIST) accredited laboratory, under the National Voluntary Laboratory Accredited Program (Lab Code 200167-0). The current scope of accreditations can be found at http://ts.nist.gov/ts/htdocs/210/214/scopes/2001670.htm







#### **Radiated Emissions EUT Setup**

The radiated emission tests were performed in the closed chamber 3-meter test site, using the setup in accordance with ANSI C63.4 - 2003. The specification used was the FCC Subpart C limits.

The spacing between the peripherals was 10 centimeters.

The EUT was placed on the center of the back edge on the test table.

#### **Spectrum Analyzer Setup**

According to FCC CFR 47, Section 15.33, the EUT was tested to 5GHz.

#### **Test Procedure**

Maximizing procedure was performed on the six (6) highest emissions to ensure EUT compliance is with all installation combinations.

According to §15.231, Intentional radiators operating under the provisions of this section shall demonstrate compliance with the limits on the field strength of emission, based on the average value of the measured emissions. As an alternative, compliance with the limits may be based on the use of measurement instrumentation with a CISPR quasi-peak detector.

#### **Corrected Amplitude & Margin Calculation**

The Corrected Amplitude is calculated by adding the Antenna Factor and Cable Factor, and subtracting the Amplifier Gain from the Amplitude reading. The basic equation is as follows:

Corrected Amplitude = Indicated Reading + Antenna Factor + Cable Factor - Amplifier Gain

The "Margin" column of the following data tables indicates the degree of compliance with the applicable limit. For example, a margin of -7dB means the emission is 7dB below the maximum limit. The equation for margin calculation is as follows:



#### **Corrected For Pulse Operation**

When the transmitter is activated (by button press), it will, in the worst case, transmit pulse position modulated (PPM) ASK data. Within any given 100ms window, the worst case total on time occurs is 17.56ms.




Figure a: The Pulse transmission pattern in 100ms sweep time. (Total of 8 wide pulses and 44 narrow pulses)


