FCC and ISED Information

Nintendo Switch and Nintendo Switch Lite Consoles

This device complies with Part 15 of the FCC Rules and ISED's RSS Standards. Operation is subject to the following two conditions: (1) This device may not cause harmful interference, and (2) this device must accept interference received, including interference that may cause undesired operation. Changes or modifications not expressly approved by the manufacturer could void the user's authority to operate this device.

In order to comply with FCC radio-frequency radiation exposure guidelines for an uncontrolled exposure, this device and its antenna must not be co-located or operating in conjunction with any other antenna or transmitter.

5150-5350 MHz band is restricted to indoor operation only.
