2. EUT DESCRIPTION

The EUT is a portable game machine with a Wireless 802.11 transceiver operating in the 2400-2483.5 MHz band with 13 channels.

The transmitter has a maximum peak conducted output power as follows:

The radio utilizes a Dipole Antenna, with a maximum gain of 2.09 dBi.

3. TEST METHODOLOGY

The tests documented in this report were performed in accordance with ANSI C63.4/2001, FCC CFR 47 Part 2 and FCC CFR 47 Part 15.

4. FACILITIES AND ACCREDITATION

The test sites and measurement facilities used to collect data are located at 561F Monterey Road, Morgan Hill, California, USA. The sites are constructed in conformance with the requirements of ANSI C63.4, ANSI C63.7 and CISPR Publication 22. All receiving equipment conforms to CISPR Publication 16-1, "Radio Interference Measuring Apparatus and Measurement Methods."

5. CALIBRATION AND UNCERTAINTY

5.1. MEASURING INSTRUMENT CALIBRATION

The measuring equipment utilized to perform the tests documented in this report has been calibrated in accordance with the manufacturer's recommendations, and is traceable to recognized national standards.

5.2. MEASUREMENT UNCERTAINTY

7.2. 99% BANDWIDTH







7.3. PEAK OUTPUT POWER

PEAK POWER LIMIT

§15.247 (b) The maximum peak output power of the intentional radiator shall not exceed the following:

\$15.247 (b) (3) For systems using digital modulation in the 902-928 MHz, 2400-2483.5 MHz , and 5725-5850 MHz bands: 1 watt.

§15.247 (b) (4) Except as shown in paragraphs (b)(4) (i), (ii) and (iii) of this section, if transmitting antennas of directional gain greater than 6 dBi are used the peak output power from the intentional radiator shall be reduced below the stated values in paragraphs (b)(1) or (b)(2) of this section, as appropriate, by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

§15.247 (b) (4) (i) Systems operating in the 2400–2483.5 MHz band that are used exclusively for fixed, point-to-point operations may employ transmitting antennas with directional gain greater than 6 dBi provided the maximum peak output power of the intentional radiator is reduced by 1 dB for every 3 dB that the directional gain of the antenna exceeds 6 dBi.

The transmitter output is connected to a spectrum analyzer and the analyzer's internal channel power integration function is used to integrate the power over a bandwidth greater than or equal to the 99% bandwidth.







§15.247 (d) For direct sequence systems, the peak power spectral density conducted from the intentional radiator to the antenna shall not be greater than 8 dBm in any 3 kHz band during any time interval of continuous transmission.

The transmitter output is connected to a spectrum analyzer, the maximum level in a 3 kHz bandwidth is measured with the spectrum analyzer using RBW = 3 kHz and VBW > 3 kHz, sweep time = span / 3 kHz, and video averaging is turned off. The PPSD is the highest level found across the emission in any 3 kHz band.







7.7. CONDUCTED SPURIOUS EMISSIONS

LIMITS

§15.247 (c) In any 100 kHz bandwidth outside the frequency band in which the spread spectrum intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement. Attenuation below the general limits specified in §15.209(a) is not required. In addition, radiated emissions, which fall in the restricted bands, as defined in §15.205(a), must also comply with the radiated emission limits specified in §15.209(a) (see §15.205(c)).


SPURIOUS EMISSIONS, LOW CHANNEL (802.11)







SPURIOUS EMISSIONS, MID CHANNEL (802.11)

Above 1000 MHz, compliance with the emission limits in Section 15.209 shall be demonstrated based on the average value of the measured emissions. TEST PROCEDURE

The EUT is placed on a non-conducting table 80 cm above the ground plane. The antenna to EUT distance is 3 meters. The EUT is configured in accordance with ANSI C63.4. The EUT is set to transmit in a continuous mode.

For measurements below 1 GHz the resolution bandwidth is set to 100 kHz for peak detection measurements or 120 kHz for quasi-peak detection measurements. Peak detection is used unless otherwise noted as quasi-peak.

For measurements above 1 GHz the resolution bandwidth is set to 1 MHz, then the video bandwidth is set to 1 MHz for peak measurements and 10 Hz for average measurements.

The spectrum from 30 MHz to 26 GHz is investigated with the transmitter set to the lowest, middle, and highest channels.


The frequency range of interest is monitored at a fixed antenna height and EUT azimuth. The EUT is rotated through 360 degrees to maximize emissions received. The antenna is scanned from 1 to 4 meters above the ground plane to further maximize the emission. Measurements are made with the antenna polarized in both the vertical and the horizontal positions.






RESTRICTED BANDEDGE (LOW CHANNEL, HORIZONTAL)







RESTRICTED BANDEDGE (LOW CHANNEL, VERTICAL)







RESTRICTED BANDEDGE (HIGH CHANNEL, HORIZONTAL)







WORST-CASE RADIATED EMISSIONS BELOW 1 GHz


SPURIOUS EMISSIONS 30 TO 1000 MHz (WORST-CASE CONFIGURATION, HORIZONTAL)

7.9. POWERLINE CONDUCTED EMISSIONS

LIMIT

 $\S15.207$ (a) Except as shown in paragraphs (b) and (c) of this section, for an intentional radiator that is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies within the band 150 kHz to 30 MHz shall not exceed the limits in the following table, as measured using a 50 μ H/50 ohms line impedance stabilization network (LISN). Compliance with the provisions of this paragraph shall be based on the measurement of the radio frequency voltage between each power line and ground at the power terminal.

The EUT is placed on a non-conducting table 40 cm from the vertical ground plane and 80 cm above the horizontal ground plane. The EUT is configured in accordance with ANSI C63.4.

The resolution bandwidth is set to 9 kHz for both peak detection and quasi-peak detection measurements. Peak detection is used unless otherwise noted as quasi-peak.

Line conducted data is recorded for both NEUTRAL and HOT lines.


