MS Prado,

We are puzzled by the dismissal of our application for Certification of Type Acceptance as detailed in our application of June 8, 2015.

For context, we want to explain the time gaps in our correspondence. In late August our CEO, and Applicant, Mr. Jim Yard, was suddenly taken ill and was hospitalized for over 6 weeks. Although his staff made every effort to monitor emails addressed to him there was a short period immediately following his medical event where emails were not received. That period included the date of your email of 9/2/2015. We are a small business with a small staff and were unable to cover every conceivable event during that period. Mr. Yard is now in the process of recovering, and although not yet returned to work, is addressing a few important issues such as this one. Having said all this we are not making excuses nor asking for relief on this basis. We are, however, requesting relief based entirely on the recorded facts pertaining to the subject application.

We believe that we have provided, in a timely manner, all of the information required under §2.1031-§2.1060 and Part 74, Subpart G. The FCC records of our application support our claim (a copy of the OET Exhibits Summary List for this application is attached) and our review of that supporting documentation confirms our belief that all required information was submitted in a timely manner.

We respectfully request that our application be granted on the basis of the documentation filed with that application. We understand that FCC policy is to dismiss an application where the applicant fails to submit all required exhibits. Our request, however, is based on the belief that all such exhibits have been in the hands of the FCC since our application was filed on June 8, 2015.

Short of granting our request, we ask that you provide specific guidance on the documentation/exhibits that do not meet the requirements of the above cited regulations or are missing in their entirety.

We appreciate your consideration of our request and await your response.
