| Method: The AMN placed 0,8 m from the boundary of the unit under test and bonded to a ground reference plane. This distance was between the closest points of the AMN and the EUT. All other units of the EUT and associated equipment were at least 0,8 m from the AMN. All power was connected to the system through Artificial Mains Network (AMN). Conducted voltage measurements on mains lines were made at the output of the AMN. The measuring port of the LISN for EUT was connected to spectrum analyzer. Using conducted emission test software, the emissions were scanned with peak detector mode. After scanning over the frequency range, suspected emissions were selected to perform final measurement. When performing final measurement, the receiver was used which has Quasi-Peak detector and CISPR Average detector. For (0.15 ~ 30) MHz frequency range, Quasi-Peak detector with 10 kHz RBW and 30 kHz VBW was used.
