## LABEL TEXT (GIFT BOX LABELS) FOR DH1-0008

### Contents

This document describes the information that shall be printed on the labels used for the marking of the Handset (OfficeT), Item number DH1-0008.

### Label and Text

The text on the labels shall be parallel to the long side.

Label 1 shall be placed on the left long side of the box and readable from the back to the front. Label 2 shall be placed on the top cover of the box and in the same readability as label 1

### Format

The format of the label is based on 1301 - SVF 930 114 Uen.

Where nothing else specified, Zebra printer Scaleable Smooth Font, "0" (CG Triumvirate Bold Condensed) is imposed. When needed, the text size is adjusted to fit the label.

When needed, the alignment is adjusted to fit the label.

### Content

#### Label 1

- On (2,21): Ascom Item number including R-state  
<Ascom Item number>RRR, Bold text, height 3 mm.
- On (2,17): FCC ID with surrounding border
- On (2,9): S/N number of the included handset in bar code, (only actual number). Bar code, height 7 mm, Code 128 symbology.
- On (2,5): "S/N nnnnnnnnnn", Text, height 2 mm.
- On (2,2): "Made by Ascom Tateco AB, China". Text, height 2 mm.
- On (38,9): IPEI number of the included handset in bar code, (only actual number). Bar code, height 7 mm, Code 128 symbology.
- On (38,5): "IPEI: nnnnnnnnnnnn", Text, height 2 mm.
- On (50,2): Year and week of packing. Text, height 2 mm.  
"yyy'W'ww", ("yyy"=year, "ww"=week).
- On (72,12): WEEE logo.
- On (72,2): Recycling logo.

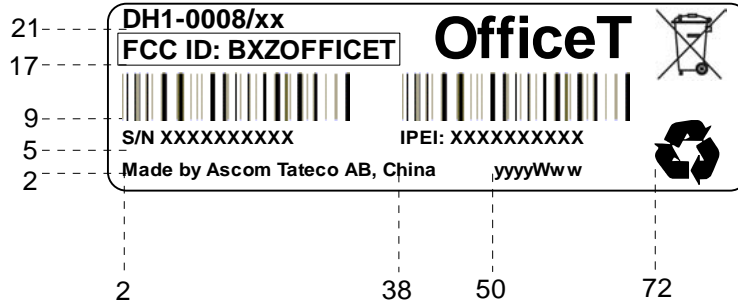
