All measurements were made as documented in test report UL LLC Document “13U14963 – FCC IC DTS WLAN Report – Model 1537” for operation in the 2.4 GHz and 5 GHz DTS bands.

Output power, Duty cycle and Antenna gain data is excerpted from the applicable test reports.

## 4. FACILITIES AND ACCREDITATION

## 5. MAXIMUM PERMISSIBLE RF EXPOSURE

### 5.1. FCC RULES

§1.1310 The criteria listed in Table 1 shall be used to evaluate the environmental impact of human exposure to radio-frequency (RF) radiation as specified in §1.1307(b), except in the case of portable devices which shall be evaluated according to the provisions of §2.1093 of this chapter.

NOTE 1 TO TABLE 1: Occupational/controlled limits apply in situations in which persons are exposed as a consequence of their employment provided those persons are fully aware of the potential for exposure and can exercise control over their exposure. Limits for occupational/controlled exposure also apply in situations when an individual is transient through a location where occupational/controlled limits apply provided he or she is made aware of the potential for exposure.

NOTE 2 TO TABLE 1: General population/uncontrolled exposures apply in situations in which the general public may be exposed, or in which persons that are exposed as a consequence of their employment may not be fully aware of the potential for exposure or can not exercise control over their exposure.

## 5.2. IC RULES

IC Safety Code 6, Section 2.2.1 (a) A person other than an RF and microwave exposed worker shall not be exposed to electromagnetic radiation in a frequency band listed in Column 1 of Table 5, if the field strength exceeds the value given in Column 2 or 3 of Table 5, when averaged spatially and over time, or if the power density exceeds the value given in Column 4 of Table 5, when averaged spatially and over time.

### **5.3. EQUATIONS**

#### **POWER DENSITY**

Power density is given by:

$$S = \text{EIRP} / (4 * \text{Pi} * \text{D}^2)$$

Where

S = Power density in mW/cm<sup>2</sup>  
EIRP = Equivalent Isotropic Radiated Power in mW  
D = Separation distance in cm

Power density in units of mW/cm<sup>2</sup> is converted to units of W/m<sup>2</sup> by multiplying by 10.

#### **DISTANCE**

Distance is given by:

$$D = \text{SQRT} (\text{EIRP} / (4 * \text{Pi} * S))$$

Where

D = Separation distance in cm  
EIRP = Equivalent Isotropic Radiated Power in mW  
S = Power density in mW/cm<sup>2</sup>

#### **SOURCE-BASED DUTY CYCLE**

Where applicable (for example, multi-slot cell phone applications) a duty cycle factor may be applied.

$$\text{Source-based time-averaged EIRP} = (\text{DC} / 100) * \text{EIRP}$$

Where

DC = Duty Cycle in %, as applicable  
EIRP = Equivalent Isotropic Radiated Power in W



## 5.4. LIMITS AND IC EXEMPTION

### FIXED LIMITS

For operation in the PCS band, the 2.4 GHz band and the 5 GHz bands:

From FCC §1.1310 Table 1 (B), the maximum value of  $S = 1.0 \text{ mW/cm}^2$

From IC Safety Code 6, Section 2.2 Table 5 Column 4,  $S = 10 \text{ W/m}^2$

### INDUSTRY CANADA EXEMPTION

RSS-102 Clause 2.5.2 RF exposure evaluation is required if the separation distance between the user and the device's radiating element is greater than 20 cm, except when the device operates as follows:

- below 1.5 GHz and the maximum e.i.r.p. of the device is equal to or less than 2.5 W;
- at or above 1.5 GHz and the maximum e.i.r.p. of the device is equal to or less than 5 W.

## 6. RF EXPOSURE RESULTS

In the table(s) below, Power and Gain are entered in units of dBm and dBi respectively and conversions to linear forms are used for the calculations.

**Note 1:** For distances < 5mm, a distance of 5mm is used to determine SAR exclusion. For distances < 50mm the calculation must yield a value <= 3.0 to exclude that position from body or head SAR and <=7.5 for Extremities

**Note 2:** Output power is the maximum rated power (including tune-up or manufacturing tolerances) and includes source-based averaging.

**Note 3:** If the antenna separation distance is > 50mm then the threshold power value is calculated.

**Note 4:** Formulas round separation distance to nearest mm and power to nearest mW before determining if SAR is excluded.
