# 5. STANDALONE SAR TEST EXCLUSION CONSIDERATIONS

## 5.1. FCC

SAR test exclusion in accordance with KDB 447498.

The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at test separation distances  $\leq$  50 mm are determined by:

[(max. power of channel, including tune-up tolerance, mW) / (min. test separation distance, mm)]·[ $\sqrt{f(GHz)}$ ]  $\leq$  3.0, for 1-g SAR and  $\leq$  7.5 for 10-g extremity SAR, where

- f<sub>(GHz)</sub> is the RF channel transmit frequency in GHz
- Power and distance are rounded to the nearest mW and mm before calculation
- The result is rounded to one decimal place for comparison

The test exclusions are applicable only when the minimum test separation distance is  $\leq$  50 mm and for transmission frequencies between 100 MHz and 6 GHz. When the minimum test separation distance is < 5 mm, a distance of 5 mm is applied to determine SAR test exclusion.

#### Conclusion:

The computed value is < 7.5; therefore, EUT qualifies for Standalone SAR test exclusion.


For handheld devices the exemption limit is multiplied by 2.5.

Power used to determine exemption is the higher of the maximum declared conducted average power or EIRP.

The minimum antenna to user distance that will be encountered in normal use is 10mm(See drawing at the end of this report). Using the exclusion criteria for 10mm this results in an exemption limit of 17.5mW at 2450 MHz and 15mW at 5800 MHz.

As the maximum output power is 3.1mW conducted at 2.4GHz and 6.5mW EIRP at 5GHz the EUT qualifies for SAR test exclusion.
