The tests documented in this report were performed in accordance with the DFS portion of FCC CFR 47 Part 2, FCC CFR 47 Part 15, FCC 06-96, FCC KDB 789033, KDB 905462 D02 and D03, ANSI C63.10-2013, RSS-247 Issue 1.

# 4. CALIBRATION AND UNCERTAINTY

# 4.1. MEASURING INSTRUMENT CALIBRATION

The measuring equipment utilized to perform the tests documented in this report has been calibrated in accordance with the manufacturer's recommendations, and is traceable to recognized national standards.

# 4.2. SAMPLE CALCULATION

Where relevant, the following sample calculation is provided:

Field Strength (dBuV/m) = Measured Voltage (dBuV) + Antenna Factor (dB/m) + Cable Loss (dB) – Preamp Gain (dB) 36.5 dBuV + 18.7 dB/m + 0.6 dB – 26.9 dB = 28.9 dBuV/m

#### **INDUSTRY CANADA**

IC RSS-247 is closely harmonized with FCC Part 15 DFS rules. The deviations are as follows:

**Note:** For the band 5600–5650 MHz, no operation is permitted.

Until further notice, devices subject to this annex shall not be capable of transmitting in the band 5600-5650 MHz. This restriction is for the protection of Environment Canada weather radars operating in this band.

**Note:** Frequencies selected for statistical performance check (Section 7.8.4) should include several frequencies within the radar detection bandwidth and frequencies near the edge of the radar detection bandwidth. For 802.11 devices it is suggested to select frequencies in all 20 MHz channel blocks and a null frequency between the bonded 20 MHz channel blocks.

**Note 2:** Throughout these test procedures an additional 1 dB has been added to the amplitude of the test transmission waveforms to account for variations in measurement equipment. This will ensure that the test signal is at or above the detection threshold level to trigger a DFS response.

**Note 3:** E.I.R.P. is based on the highest antenna gain. For MIMO devices refer to KDB publication 662911 D01.

**Note 1:** Channel Move Time and the Channel Closing Transmission Time should be performed with Radar Type 0. The measurement timing begins at the end of the Radar Type 0 burst.

**Note 2:** The *Channel Closing Transmission Time* is comprised of 200 milliseconds starting at the beginning of the *Channel Move Time* plus any additional intermittent control signals required to facilitate a *Channel* move (an aggregate of 60 milliseconds) during the remainder of the 10 second period. The aggregate duration of control signals will not count quiet periods in between transmissions.

**Note 3:** During the *U-NII Detection Bandwidth* detection test, radar type 0 should be used. For each frequency step the minimum percentage of detection is 90 percent. Measurements are performed with no data traffic.



# **SYSTEM OVERVIEW**

The short pulse and long pulse signal generating system utilizes the NTIA software. The Vector Signal Generator has been validated by the NTIA. The hopping signal generating system utilizes the CCS simulated hopping method and system, which has been validated by the DoD, FCC and NTIA. The software selects waveform parameters from within the bounds of the signal type on a random basis using uniform distribution.

The short pulse types 1, 2, 3 and 4, and the long pulse type 5 parameters are randomized at run-time.

The hopping type 6 pulse parameters are fixed while the hopping sequence is based on the August 2005 NTIA Hopping Frequency List. The initial starting point randomized at run-time and each subsequent starting point is incremented by 475. Each frequency in the 100-length segment is compared to the boundaries of the EUT Detection Bandwidth and the software creates a hopping burst pattern in accordance with Section 7.4.1.3 Method #2 Simulated Frequency Hopping Radar Waveform Generating Subsystem of KDB 905462 D02. The frequency of the signal generator is incremented in 1 MHz steps from  $F_L$  to  $F_H$  for each successive trial. This incremental sequence is repeated as required to generate a minimum of 30 total trials and to maintain a uniform frequency distribution over the entire Detection Bandwidth.

The signal monitoring equipment consists of a spectrum analyzer. The aggregate ON time is calculated by multiplying the number of bins above a threshold during a particular observation period by the dwell time per bin, with the analyzer set to peak detection and max hold.

#### **SYSTEM CALIBRATION**

A 50-ohm load is connected in place of the spectrum analyzer, and the spectrum analyzer is connected to a horn antenna via a coaxial cable, with the reference level offset set to (horn antenna gain – coaxial cable loss). The signal generator is set to CW mode. The amplitude of the signal generator is adjusted to yield a level of –64 dBm as measured on the spectrum analyzer.

Without changing any of the instrument settings, the spectrum analyzer is reconnected to the Common port of the Spectrum Analyzer Combiner/Divider. The Reference Level Offset of the spectrum analyzer is adjusted so that the displayed amplitude of the signal is –64 dBm.

The spectrum analyzer displays the level of the signal generator as received at the antenna ports of the Master Device. The interference detection threshold may be varied from the calibrated value of –64 dBm and the spectrum analyzer will still indicate the level as received by the Master Device.

#### **ADJUSTMENT OF DISPLAYED TRAFFIC LEVEL**

A link is established between the Master and Slave and the distance between the units is adjusted as needed to provide a suitable received level at the Master and Slave devices. The video test file is streamed to generate WLAN traffic. The monitoring antenna is adjusted so that the WLAN traffic level, as displayed on the spectrum analyzer, is at lower amplitude than the radar detection threshold.



#### 5.1.4. DESCRIPTION OF EUT

The EUT operates over the 5250-5350 MHz and 5470-5725 MHz ranges, excluding operation in the band 5600 to 5650 MHz.

The EUT is a Slave Device with without Radar Detection.

The highest power level within these bands is 8.41 dBm EIRP in the 5250-5350 MHz band and 8.50 dBm EIRP in the 5470-5725 MHz band.

The only antenna assembly utilized with the EUT has a minimum gain of 1.7 dBi in the 5250-5350 MHz band and 2.90 dBi in the 5470-5725 MHz band.

The rated output power of the Master unit is < 23dBm (EIRP). Therefore the required interference threshold level is -62 dBm. After correction for procedural adjustments, the required radiated threshold at the antenna port is -62 + 1 = -61 dBm.

The calibrated radiated DFS Detection Threshold level is set to –64 dBm. The tested level is lower than the required level hence it provides a margin to the limit.

The EUT uses one transmitter/receiver chain connected to an antenna to perform radiated tests.

WLAN traffic is generated by streaming the 5\_GHz\_Audio\_Test\_file.WAV over a wireless connection at a data rate of 6.5 Mbps from the Master to the Slave using an embedded application resident on the Master Device.

TPC is not required since the maximum EIRP is less than 500 mW (27 dBm).

The EUT utilizes the 802.11a/n architecture. One nominal channel bandwidth, 20 MHz, is implemented.

The software installed in the EUT is R74.

The DFS software installed in the Master Device is revision 1.0.0.0.

### MANUFACTURER'S STATEMENT REGARDING UNIFORM CHANNEL SPREADING

This is not applicable to Slave devices.

# OVERVIEW OF MASTER DEVICE WITH RESPECT TO §15.407 (h) REQUIREMENTS

The Master Device is a Microsoft Xbox One Game Console, FCC ID: C3K1525. The minimum antenna gain for the Master Device is 4.7 dBi.

The rated output power of the Master unit is < 23dBm (EIRP). Therefore the required interference threshold level is -62 dBm. After correction for procedural adjustments, the required radiated threshold at the antenna port is -62 + 1 = -61 dBm.

The calibrated radiated DFS Detection Threshold level is set to –64 dBm. The tested level is lower than the required level hence it provides a margin to the limit.






#### **RADAR WAVEFORM**

The delta marker is set at the end of the last WLAN transmission following the radar pulse. This delta is the channel move time.

The aggregate channel closing transmission time is calculated as follows:

Aggregate Transmission Time = (Number of analyzer bins showing transmission) \* (dwell time per bin)


The observation period over which the aggregate time is calculated begins at (Reference Marker + 200 msec) and ends no earlier than (Reference Marker + 10 sec).



# **MOVE TIME**




# **CHANNEL CLOSING TIME**
