

















**Fig.4 EUT Top side to flat phantom**




**Fig.5 EUT Bottom side to flat phantom**






**Fig.11 EUT Back side to flat phantom**




Fig.13 Front view of EUT




Fig.15 Antenna position of EUT




Fig.16 Antenna position of EUT
