









Photograph of the tissue simulant fluid liquid depth (Body)












Fig.3 EUT Back side to flat phantom






Fig.5 EUT Bottom side to flat phantom






Fig.8 EUT Back side to flat phantom




Fig.15 Antenna position of EUT




Fig.16 Antenna position of EUT
