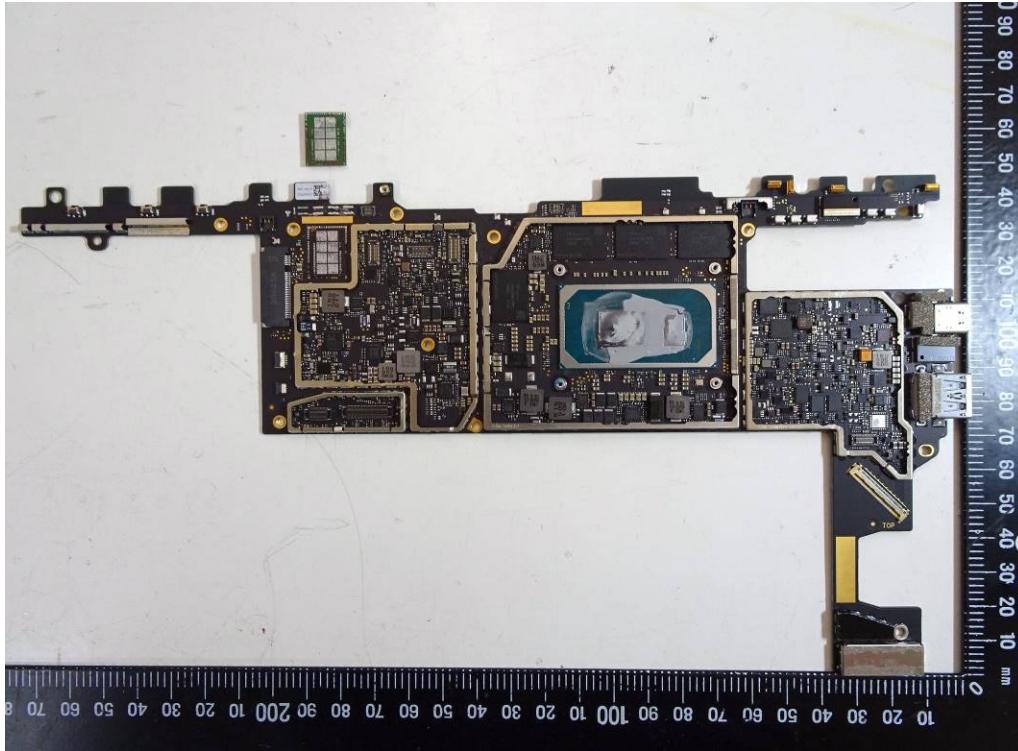

Internal View of EUT-3



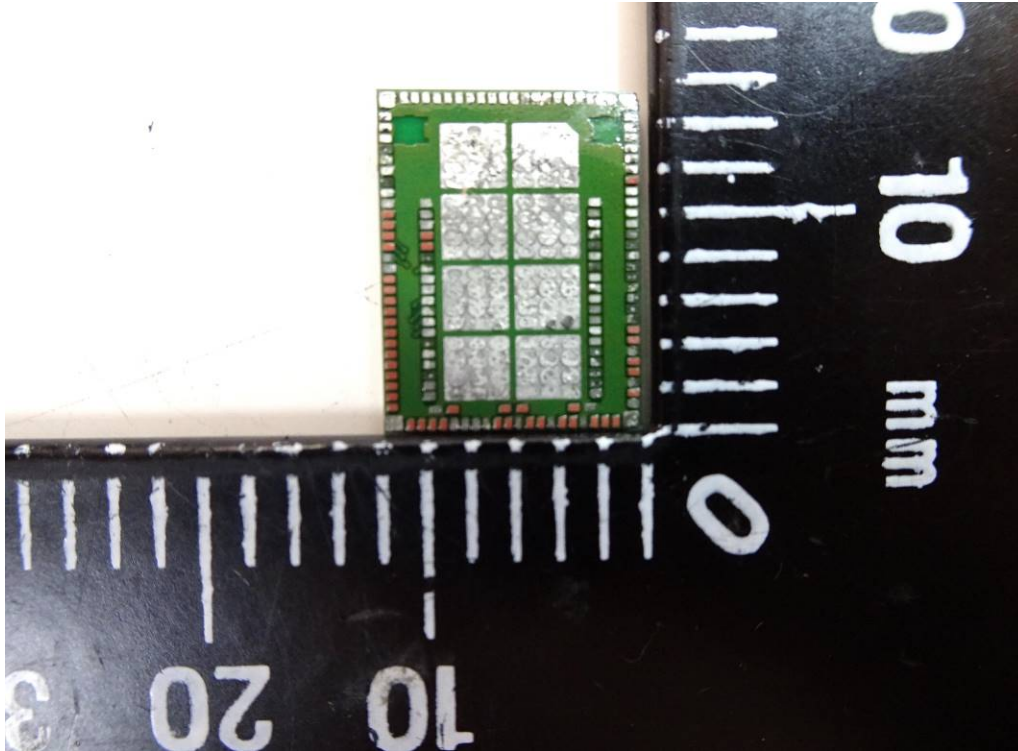

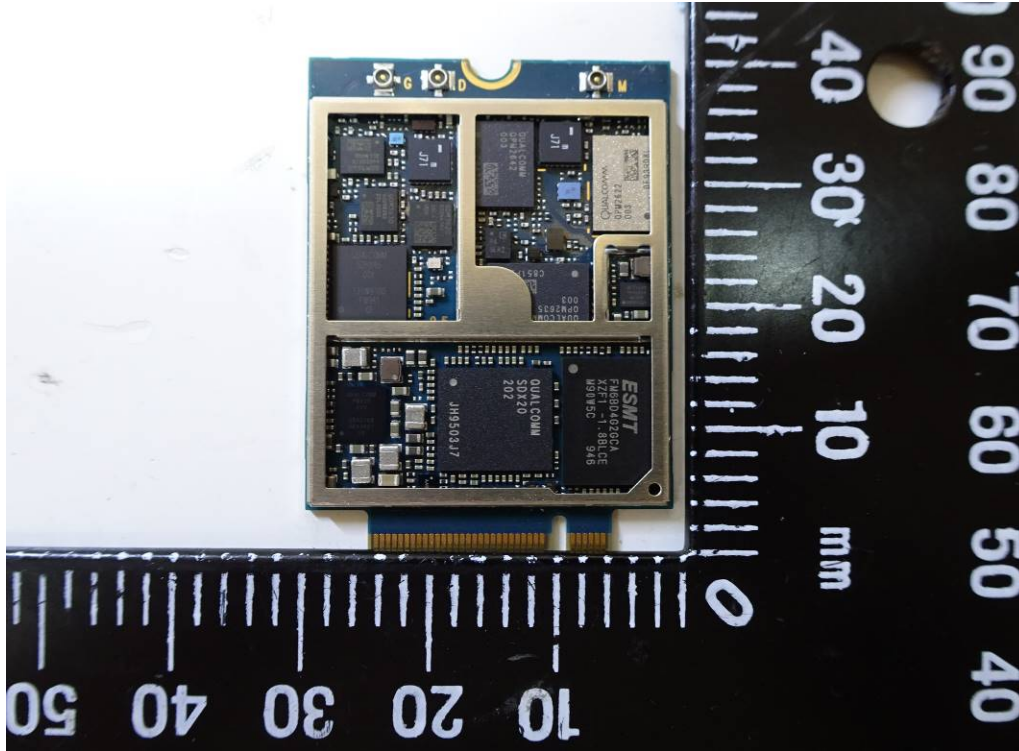
