






Plot 7-371. Radiated Lower Band Edge Plot SISO ANT1 (Average – UNII Band 1)



Plot 7-372. Radiated Lower Band Edge Plot SISO ANT1 (Peak – UNII Band 1)








Plot 7-375. Radiated Lower Band Edge Plot SISO ANT1 (Average – UNII Band 2C)

Plot 7-377. Radiated Upper Band Edge Plot SISO ANT1 (Peak – UNII Band 3)





Plot 7-376. Radiated Lower Band Edge Plot SISO ANT1 (Peak – UNII Band 2C)











Plot 7-378. Radiated Lower Band Edge Plot SISO ANT1 (Average – UNII Band 1)










Plot 7-379. Radiated Lower Band Edge Plot SISO ANT1 (Peak – UNII Band 1)






Plot 7-382. Radiated Lower Band Edge Plot SISO ANT1 (Average – UNII Band 2C)








Plot 7-385. Radiated Lower Band Edge Plot SISO ANT1 (Average – UNII Band 1)










Plot 7-386. Radiated Lower Band Edge Plot SISO ANT1 (Peak – UNII Band 1)




Plot 7-388. Radiated Upper Band Edge Plot SISO ANT1 (Peak – UNII Band 2A)






Plot 7-389. Radiated Lower Band Edge Plot SISO ANT1 (Average – UNII Band 2C)




Plot 7-392. Radiated Lower Band Edge Plot SISO ANT1 (Average – UNII Band 1)










Plot 7-393. Radiated Lower Band Edge Plot SISO ANT1 (Peak – UNII Band 1)




Plot 7-395. Radiated Upper Band Edge Plot SISO ANT1 (Peak – UNII Band 2A)



Plot 7-396. Radiated Lower Band Edge Plot SISO ANT1 (Average – UNII Band 2C)





Plot 7-397. Radiated Lower Band Edge Plot SISO ANT1 (Peak – UNII Band 2C)









Plot 7-398. Radiated Lower Band Edge Plot SISO ANT2 (Average – UNII Band 1)










Plot 7-399. Radiated Lower Band Edge Plot SISO ANT2 (Peak – UNII Band 1)






Plot 7-402. Radiated Lower Band Edge Plot SISO ANT2 (Average – UNII Band 2C)

Plot 7-404. Radiated Upper Band Edge Plot SISO ANT2 (Peak – UNII Band 3)








Plot 7-405. Radiated Lower Band Edge Plot SISO ANT2 (Average – UNII Band 1)










Plot 7-406. Radiated Lower Band Edge Plot SISO ANT2 (Peak – UNII Band 1)






Plot 7-409. Radiated Lower Band Edge Plot SISO ANT2 (Average – UNII Band 2C)

Plot 7-411. Radiated Upper Band Edge Plot SISO ANT2 (Peak – UNII Band 3)












Plot 7-412. Radiated Lower Band Edge Plot SISO ANT2 (Average – UNII Band 1)










Plot 7-413. Radiated Lower Band Edge Plot SISO ANT2 (Peak – UNII Band 1)




Plot 7-415. Radiated Upper Band Edge Plot SISO ANT2 (Peak – UNII Band 2A)






Plot 7-416. Radiated Lower Band Edge Plot SISO ANT2 (Average – UNII Band 2C)




Plot 7-419. Radiated Lower Band Edge Plot SISO ANT2 (Average – UNII Band 1)










Plot 7-420. Radiated Lower Band Edge Plot SISO ANT2 (Peak – UNII Band 1)




Plot 7-422. Radiated Upper Band Edge Plot SISO ANT2 (Peak – UNII Band 2A)



Plot 7-423. Radiated Lower Band Edge Plot SISO ANT2 (Average – UNII Band 2C)











Plot 7-425. Radiated Lower Band Edge Plot MIMO (Average – UNII Band 1)






Plot 7-429. Radiated Lower Band Edge Plot MIMO (Average – UNII Band 2C)



Plot 7-432. Radiated Lower Band Edge Plot MIMO (Average – UNII Band 1)










Plot 7-433. Radiated Lower Band Edge Plot MIMO (Peak – UNII Band 1)






Plot 7-436. Radiated Lower Band Edge Plot MIMO (Average – UNII Band 2C)

Plot 7-438. Radiated Upper Band Edge Plot MIMO (Peak - UNII Band 3)




Plot 7-437. Radiated Lower Band Edge Plot MIMO (Peak – UNII Band 2C)





#### 7.6.15 MIMO Radiated Band Edge Measurements (80MHz BW) §15.407(b.1)(b.2) §15.205 §15.209






Plot 7-439. Radiated Lower Band Edge Plot MIMO (Average – UNII Band 1)









Plot 7-440. Radiated Lower Band Edge Plot MIMO (Peak – UNII Band 1)




Plot 7-442. Radiated Upper Band Edge Plot MIMO (Peak – UNII Band 2A)




Plot 7-445. Radiated Upper Band Edge Plot MIMO (Peak – UNII Band 3)









Plot 7-446. Radiated Lower Band Edge Plot MIMO (Average – UNII Band 1)






Plot 7-448. Radiated Upper Band Edge Plot MIMO (Average – UNII Band 2A)












Plot 7-452. Radiated Spurious Plot below 1GHz MIMO (802.11a – U2C Ch. 120)







Figure 7-8. Test Instrument & Measurement Setup




Plot 7-454. Line Conducted Plot with 802.11a UNII Band 1 (L1)




#### Plot 7-455. Line Conducted Plot with 802.11a UNII Band 1 (N)


Plot 7-456. Line Conducted Plot with 802.11a UNII Band 2A (L1)




#### Plot 7-457. Line Conducted Plot with 802.11a UNII Band 2A (N)


Plot 7-458. Line Conducted Plot with 802.11a UNII Band 2C (L1)




Plot 7-459. Line Conducted Plot with 802.11a UNII Band 2C (N)
