








Plot 7-1048. Radiated Upper Band Edge Plot MIMO (Average – UNII Band 8)






Plot 7-1050. Radiated Upper Band Edge Plot MIMO (Average – UNII Band 8)



7.8 Radiated Spurious Emissions Measurements – Below 1GHz §15.209

Test Overview and Limit

All out of band radiated spurious emissions are measured with a spectrum analyzer connected to a receive antenna while the EUT is operating at its maximum duty cycle, at maximum power, and at the appropriate frequencies. All data rates and modes were investigated for radiated spurious emissions. Only the radiated emissions of the configuration that produced the worst case emissions are reported in this section.

All out of band emissions appearing in a restricted band as specified in Section 15.205 of the Title 47 CFRmust not exceed the limits shown in Table 7-150 per Section 15.209.

Test Settings

Quasi-Peak Field Strength Measurements

- 1. Analyzer center frequency was set to the frequency of the radiated spurious emission of interest
- 2. RBW = 120kHz (for emissions from 30MHz 1GHz)
- 3. Detector = quasi-peak
- 4. Sweep time = auto couple
- 5. Trace mode = max hold
- 6. Trace was allowed to stabilize






Figure 7-7. Radiated Test Setup < 30MHz


Test Notes

- 1. All emissions lying in restricted bands specified in §15.205 are below the limit shown in Table 7-150.
- 2. The broadband receive antenna is manipulated through vertical and horizontal polarizations during the tests. The EUT is manipulated through three orthogonal planes.
- 3. This unit was tested with its standard battery.
- 4. The spectrum is investigated using a peak detector and final measurements are recorded using CISPR quasi peak detector. The worst-case emissions are reported however emissions whose levels were not within 20dB of the respective limits were not reported.
- 5. Emissions were measured at a 3 meter test distance.
- 6. Emissions are investigated while operating on the center channel of the mode, band, and modulation that produced the worst case results during the transmitter spurious emissions testing.
- 7. No spurious emissions were detected within 20dB of the limit below 30MHz.
- 8. The results recorded using the broadband antenna is known to correlate with the results obtained by using a tuned dipole with an acceptable degree of accuracy. The VSWR for the measurement antenna was found to be less than 2:1.
- The wide spectrum spurious emissions plots shown on the following pages are used only for the purpose of emission identification. There were no emissions detected in the 30MHz – 1GHz frequency range, as shown in the subsequent plots.
