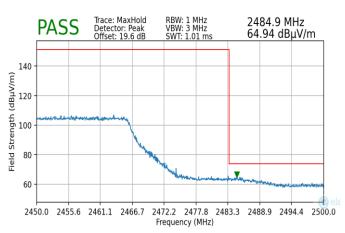

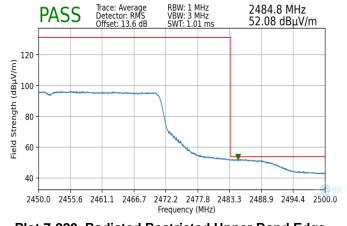

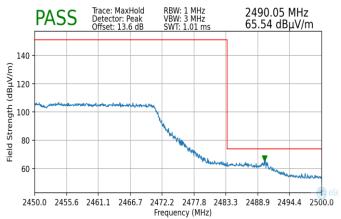

Plot 7-220. Radiated Restricted Upper Band Edge Measurement MIMO (Average)



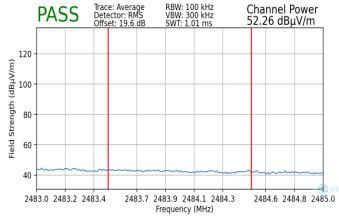
Plot 7-221. Radiated Restricted Upper Band Edge Measurement MIMO (Peak)

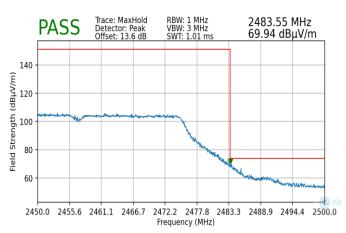

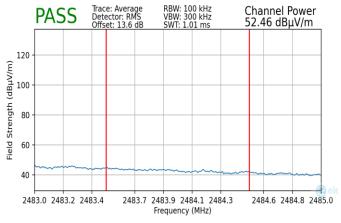
Plot 7-222. Radiated Restricted Upper Band Edge Measurement MIMO (Average)

7.8 Line-Conducted Test Data

Test Overview and Limit

All AC line conducted spurious emissions are measured with a receiver connected to a grounded LISN while the EUT is operating at its maximum duty cycle, at maximum power, and at the appropriate frequencies. All data rates and modes were investigated for conducted spurious emissions. Only the conducted emissions of the configuration that produced the worst case emissions are reported in this section.

All conducted emissions must not exceed the limits shown in the table below per §15.207 and RSS-Gen (8.8).

The EUT and measurement equipment were set up as shown in the diagram below.

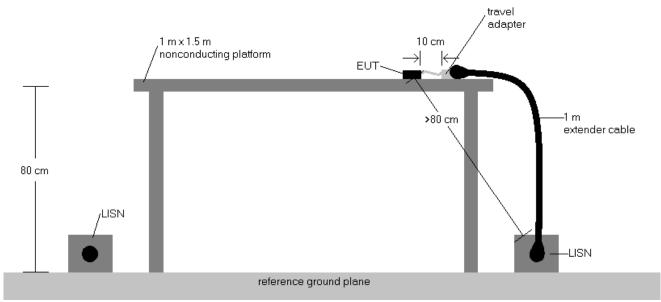


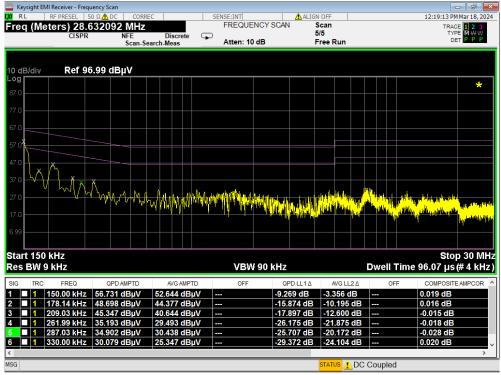
Figure 7-9. Test Instrument & Measurement Setup

Test Notes

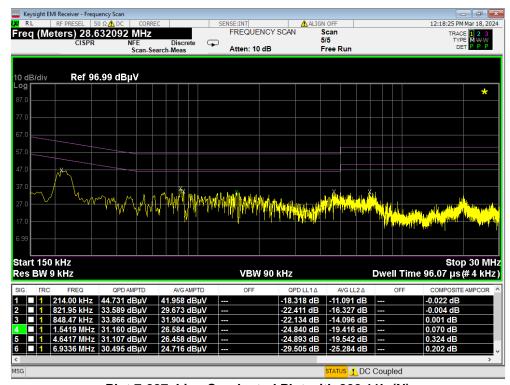
- All modes of operation were investigated and the worst-case emissions are reported using mid channel.
