4. FACILITIES AND ACCREDITATION

The test sites and measurement facilities used to collect data are located at 47173 and 47658 Kato Road, Fremont, California, USA.

5. DEVICE UNDER TEST

The EUT is an Rear Derailleu with BLE and AIREA Radios, BLE operating in the frequency range of 2402 to 2480MHz and AIREA operating in the frequency range of 2405 to 2475MHz.

6. MAXIMUM OUTPUT POWER

The maximum output power of the device is declared as the following:

BLE = Power: 7dBm; Antenna Gain: 0 dBi AIREA = Power: 7dBm; Antenna Gain: 0 dBi

The antenna(s) gain and type, as provided by the manufacturer' are as follows:

The radio utilizes a trace on ceramic chip antenna.

7. STANDALONE SAR TEST EXCLUSION CONSIDERATIONS

7.1. **FCC**

SAR test exclusion in accordance with KDB 447498 D01.

The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at test separation distances ≤ 50 mm are determined by:

 $I(max, power of channel, including tune-up tolerance, mW) / (min. test separation distance, mm)] \cdot [\sqrt{f(GHz)}] \le 3.0$, for 1-g SAR and ≤ 7.5 for 10-g extremity SAR, where

- f_(GHz) is the RF channel transmit frequency in GHz
- Power and distance are rounded to the nearest mW and mm before calculation
- The result is rounded to one decimal place for comparison

This test exclusion is applicable only when the minimum test separation distance is ≤ 50 mm and for transmission frequencies between 100 MHz and 6 GHz. When the minimum test separation distance is < 5 mm, a distance of 5 mm is applied to determine SAR test exclusion.

Conclusion:

The device operates with a maximum Duty Cycle of 100%. The Calculated Threshold with duty cycle applied is ≤3 for1-g SAR and ≤7 for10-g extremity SAR; therefore, this device qualifies for Standalone SAR test exclusion.
