Subject: **TCB Services for a Class 2 Permissive Change on FCC ID: CASTBA-H0**

We wish to achieve the following outcomes by way of a Class 2 Permissive Change (Elite Quote EEE-21235C2PC) in the order shown below.

1. Claim an improved frequency stability of  $\pm 0.5\text{ppm}$  for the Base Station Transceiver [Old =  $\pm 1.0\text{ppm}$ ] (Reference Test Report 1834-D)
2. Add extra digital emission designators to original Grant of Authorisation (Test Report 1834-D).

3. Add FCC Rule Part 74, 95A to the Grant of Authorisation
4. Add a 5W Power Amplifier to the Grant of Authorisation (Test Report 1834-E)
5. Obtain an additional FCC ID: **CASTBAH0A** under CFR47 Part 2.933 Change of Equipment Identification.

2.933 (a) This is an application for equipment authorisation for an additional FCC ID, for which equipment authorisation has already been issued.. The Base Station Transceiver will continue to be marketed under it's original FCC ID: CASTBA-H0.

2.933 (b) Under the provisions of 2.1043, the variations in construction do not affect the characteristics required to be reported to the Commission.

1. The original identification used on the equipment prior to the change in identification is CASTBA-H0.
2. The date of the original Grant of Equipment Authorisation is 07/03/2004.
