Subject: **2.933 Change In Identification Of Equipment – CASTMAD1A / CASTBBD1A**

2.933 (a) This is an application for equipment authorisation for a new configuration (Base Station) of this Mobile Transceiver equipment, for which equipment authorisation has already been issued.. The Mobile Transceiver will continue to be marketed under it's original FCC ID: CASTMAD1A.

2.933 (b) Under the provisions of 2.1043, the variations in construction do not affect the characteristics required to be reported to the Commission.

1. The original identification used on the equipment prior to the change in identification is CASTMAD1A.
2. The date of the original Grant of Equipment Authorisation is 3/10/2004.
3. The equipment bearing the modified identification differs from the original equipment in that, it is a metal case with two transceivers mounted inside, one has the transmitter section disabled and the other has the receiver section disabled, to allow duplex operation.
4. The test results for CASTMAD1A continue to be representative of, and applicable to, the equipment bearing the change in identification. Please refer to the attached Declaration of Equivalence.
5. Photographs required by 2.1033(b)(7) or 2.133(c)(12) showing the exterior appearance of this equipment, including the operating controls available to the user, and the identification label(s) are attached.

2.933 (c) The changes to the equipment fall within the purview of a permissive change as described in 2.1043 and therefore a complete submission is not required.
