


TRANSMITTER AUDIO FREQUENCY RESPONSE - PRE-EMPHASIS

- 2. For analogue measurements: The EUT was modulated by a 2500Hz tone at an input level 16dB above a level that produced 50% deviation. The input level was established at the frequency of maximum response of the audio modulating circuit.

 For Digital measurements: The EUT was modulated with an internally generated pseudo random bit sequence at the appropriate Baud rates.





Unmodulated 155.1000MHz Mask D 50W Pass RBW=100Hz VBW=1000Hz




Analogue Modulation 155.1000MHz Mask D 50W Pass






Analogue Modulation 155.1000MHz Mask D 10W Pass






Analogue Modulation 155.1000MHz Mask B 50W Pass






Analogue Modulation 155.1000MHz Mask B 10W Pass



Unmodulated 155.1000MHz Mask C 50W Pass RBW=300Hz VBW=3000Hz








Digital Modulation 155.1000MHz Mask C 10W Pass RBW=300Hz VBW=3000Hz



Unmodulated 155.1000MHz Mask C 50W Pass RBW=300Hz VBW=3000Hz



Unmodulated 155.1000MHz Mask D 10W Pass RBW=100Hz VBW=1000Hz






