Equipment Function and Testing Procedures

The EUT is a 902-928 MHz radio transmitter used to transmit alarm conditions for use in an alarm panel installation. The 1100Di and 1100 Xi Series Transceiver wireless transmitter is a wireless link used for transmitting alarm conditions in installation environments. The device signals the alarm panel or initiates a contact point based on operational conditions. The unit is marketed for use to incorporate a wireless link in an alarm system solution. Test software was installed in the test samples for testing purposes. The modified software allowed the transmitter to be set to transmit channels dependent on activation of a switch attached to the relay point contact. The unit operates from external DC battery power only and has no other power options available. For testing purposes a battery, supplied by the manufacturer, was used to power the EUT during testing. The printed circuit board (PCB) offers two configuration options, permanently mounted PCB antenna or antenna etched on PCB. The same circuit board is used in wither configuration. The internally etched antenna option is disabled when the permanently mounted PCB antenna is installed during production. Both options utilize permanently connected antenna system with no provision for user replacement. The unit has provision to connect to external auxiliary equipment through a relay point contact.

Equipment and Cable Configurations

Conducted Emission Test Procedure

The unit operates solely from direct current battery power and has no provision to connect to utility power system. Therefore, no AC line conducted emissions testing was performed or required.

Radiated Emission Test Procedure

Testing for the unintentional radiated emissions was performed as defined in section 13.1.4 of ANSI C63.4. The EUT was placed on a rotating 1 x 1.5-meter wooden platform, 0.8 meters above the ground plane at a distance of 3 meters from the FSM antenna. EMI energy was maximized by equipment placement, raising and lowering the FSM antenna, changing the antenna polarization, and by rotating the turntable. Each emission was maximized before data was taken using a spectrum analyzer. Refer to photographs in the exhibits for EUT placement.

Subpart B – Unintentional Radiators

Radiated EMI

The EUT was arranged in a typical equipment configuration and operated through all of its various modes. Preliminary testing was performed in a screen room with the EUT positioned 1 Radiated emissions measurements were performed to identify the meter from the FSM. frequencies, which produced the highest emissions. Plots were made of the frequency spectrum from 30 MHz to 10,000 MHz for the preliminary testing. Refer to figures one through five showing plots of the radiated emissions spectrum taken in a screen room (Printed Circuit Board etched antenna) configuration. Refer to figures six through ten showing plots of the radiated emissions spectrum taken in a screen room (permanently attached antenna) configuration. The highest radiated emission was then re-maximized at the OATS location before final radiated emissions measurements were performed. Final data was taken with the EUT located at the OATS at a distance of 3 meters between the EUT and the receiving antenna. The frequency spectrum from 30 MHz to 10,000 MHz was searched for radiated emissions. Measured emission levels were maximized by EUT placement on the table, rotating the turntable through 360 degrees, varying the antenna height between 1 and 4 meters above the ground plane and changing antenna position between horizontal and vertical polarization. Antennas used were Broadband Biconical from 30 to 200 MHz, Biconilog from 30 to 1000 MHz, Log Periodic from 200 MHz to 5 GHz and or, pyramidal horns and mixers from 4 GHz to 10 GHz, notch filters and appropriate amplifiers were utilized.






Figure one General Radiated Emissions (PCB Antenna).

Figure three General Radiated Emissions (PCB Antenna).




Figure four General Radiated Emissions (PCB Antenna).




Figure six General Radiated Emissions (Mounted Antenna).




Figure seven General Radiated Emissions (Mounted Antenna).




Figure eight General Radiated Emissions (Mounted Antenna).



Summary of Results for Conducted Emissions

The unit operates solely from direct current battery power and has no provision to connect to utility power system. Therefore, no AC line conducted emissions testing was performed or required. The conducted emissions for the EUT meet the requirements for CISPR 22, CFR47, and Industry Canada requirements.

Summary of Results for Radiated Emissions

The radiated emissions for the EUT meet the requirements for CISPR 22, CFR47, and Industry Canada requirements. The EUT had at least a 21.8 dB minimum margin below the limit. Other emissions were present with amplitudes at least 20 dB below the limit.

Statement of Modifications and Deviations

No modifications to the EUT were required for the unit to meet the CISPR 22, CFR47, and Industry Canada requirements. There were no deviations or exceptions to the specifications.

15.205 Restricted Bands of Operation

Spurious emissions falling in the restricted frequency bands of operation were measured at a distance of three meters at the OATS. The EUT utilizes frequency, determining circuitry, which generates harmonics falling in the restricted bands. Emissions were checked at the OATS, using appropriate antennas or pyramidal horns, amplification stages, and a spectrum analyzer. No other significant emission was observed which fell into the restricted bands of operation.

Summary of Results for Radiated Emissions in Restricted Bands

The radiated emissions for the EUT meet the requirements for FCC Part 15C Intentional Radiators. The EUT had a 24.7 dB minimum margin below the limits. Both average and peak amplitudes were checked for compliance with the regulations. No other emissions where found in the restricted frequency bands. Other emissions were present with amplitudes at least 20 dB below the FCC Limits.

15.209 Radiated Emissions Limits; General Requirements

Radiated EMI

The EUT was arranged in a typical equipment configuration and operated through all of its various modes. Preliminary testing was performed in a screen room with the EUT positioned 1 meter from the FSM. Radiated emissions measurements were performed to identify the frequencies, which produced the highest emissions. Emissions were checked in the screen room from 30 to 12,000 MHz and plots were made of the frequency spectrum from 30 MHz to 12,000 MHz for the preliminary testing. The highest radiated emission was then re-maximized at this location before final radiated emissions measurements were performed. Final data was taken with the EUT located at the open area test site at a distance of 3 meters between the EUT and the receiving antenna. The frequency spectrum from 30 MHz to 12,000 MHz was searched for radiated emissions. Measured emission levels were maximized by EUT placement on the table, rotating the turntable through 360 degrees, varying the antenna height between 1 and 4 meters above the ground plane and changing antenna polarization between horizontal and vertical. Antennas used were Broadband Biconical from 30 MHz to 200 MHz, Biconilog from 30 MHz to 1000 MHz, Log Periodic from 200 MHz to 5 GHz, and/or Pyramidal Horns from 4 GHz to 12 GHz.

Summary of Results for Radiated Emissions

The radiated emissions for the EUT meet the requirements for CFR47 Part 15C, and Industry Canada requirements. The EUT had at least a 21.8 dB minimum margin below the limit. Other emissions were present with amplitudes at least 20 dB below the limit.

15.247 Operation in the Band 902-928 MHz

The power output was measured on an Open Area Test Site at a 3 meters distance. The EUT was placed on a wooden turntable 0.8 meters above the ground plane and at a distance of 3 meters from the FSM antenna. The peak and quasi-peak amplitude of the carrier frequency was measured using a spectrum analyzer. The peak and average amplitude of the spurious emissions were measured using a spectrum analyzer then data was recorded from the analyzer display. Refer to figures thirteen through twenty-one for plots of the spectrum analyzer display demonstrating compliance to the specifications. The EUT is a frequency hopping spread spectrum intentional radiator utilizing at least 50 hopping channels. The 20-dB bandwidth of 93 kHz complies with the requirement of less than 250 kHz wide and utilizing at least 50 hopping frequencies. The average time of occupancy on any frequency shall not be greater than 0.4 seconds within a twenty-second-time period. Figure 18 shows the dwell time of occupancy of 31 mS. The pseudo random lookup table moves through the 53 channels taking a calculated 1.75 seconds (53 x 31 mS = 1.643 S). The table will repeat after completion of one full cycle thus allowing the channel to be occupied 12.173 times in any twenty second period (20/1.75). This allows a channel to be occupied a maximum of 377 mS in any twenty second time interval. Information showing compliance for time of channel occupancy and hopping sequence are

displayed below.

The maximum peak output power of the unit was measured at the OATS at a distance of three meters. The amplitudes of each emission and spurious emission were measured at a distance of 3 meters from the FSM antenna at the OATS. The amplitude of each emission was maximized by varying the FSM antenna height, polarization, and by rotating the turntable. A Biconilog Antenna was used for measuring emissions from 30 to 1000 MHz, Log Periodic Antenna for 200 to 5000 MHz, and Pyramidal Horn Antennas from 4 GHz to 10 GHz. Emissions were measured in $dB\mu V/m$ at three-meters. The band edges are protected due to the frequency of operation of the EUT. For multiple systems to coexist properly, each system within range of another is assigned a unique number between 1 and 52. That number is multiplied by the hop sequence is modified by multiplying each hop number by a system number (1-52) and using that value modulo 61 as the hop number. For example, rather than hopping 0,1,2,3,4, a system with a system number of 3 would use hop sequence 0,3,6,9,12..., which would lead to the channel sequence 0, 27, 6, 1, 44... This allows up to 52 systems to coexist because of the unique hopping sequence of each. The amplitude of each measured emission was maximized by varying the FSM antenna height, polarization, and by rotating the turntable. A Biconilog Antenna was used for measuring emissions from 30 to 1000 MHz, a Log Periodic Antenna for 200 to 5000 MHz, and Pyramidal Horn Antennas from 4 GHz to 25 GHz. Emissions were measured in dBµV/m @ 3 meters. The power output was measured at the open area test site at a three-meter distance. Data was taken per Paragraph 2.1046(a), 15.247 and RSS-210. The 902 and 928 MHz band edges are protected due to the 903 – 927 MHz channels used for frequency of operation. 




Figure eleven Power at Low, middle and high channels (PCB Antenna)






Figure fourteen Frequencies of operation (Mounted Antenna)




Figure fifteen Occupied Bandwidth low frequency




Figure sixteen Occupied Bandwidth middle frequency





Figure eighteen Dwell Time on channel




Figure twenty one higher frequency band edge.




Figure twenty two, Channel Occupancy over 20-second period.
