RSS-102 § 2.5.2 Exemption Limits for Routine Evaluation - RF Exposure Evaluation.

RF exposure evaluation is required if the separation distance between the user and/or bystander and the device's radiating element is greater than 20 cm, except when the device operates as follows:

The maximum output from Exhibit 5-1 is measured as 21.52 dBm.

The duty cycle from Exhibit 3 is 18.656%, or 7.29 dB

The max antenna gain of the antenna is 4.4 dBi

The max time-averaged EIRP per 2.0 above is $1.31 \times 10^{-2} \times 2475^{0.6834}$ (W) = 2.732W = 2732 mW.
