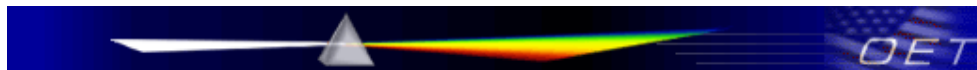


Tim,

As per our conversation:

- (1) There is no request for confidentiality for any of our exhibits.
- (2) This device does not have any form supervisory capability.
- (3) There are no different size/length transmissions sent during installation, or at any other time. Nor is there any way to make a transmission that will exceed 5 seconds, during installation, or at any other time. The only transmission we send is that which we described in our EXHIBIT 3-1 with the accompanying timing diagram in EXHIBIT 3-2. Only the 'bit pattern' of the data word changes to denote: "alarm" , "control" , or "confirmation".
- (4) I did not receive a letter from the FCC yet, but; see the second page of this letter: our test site No. ((156835)) still shows up on the 731 page (?). It did not show up from the test site search link on the OET page - but that page also refers to "test sites available to the general public" - which we are not, our site is certified for our own use only and not for the general public.
