In the frequency range from 100 MHz to 1500 MHz, exposure limits for field strength and power density are also generally based on guidelines recommended by the American National Standards Institute (ANSI) in Section 4.1 of "IEEE Standard for Safety Levels with Respect to Human Exposure to Radio Frequency Electromagnetic Fields, 3 kHz to 300 GHz,"

RSS-102 § 2.5.2 Exemption Limits for Routine Evaluation - RF Exposure Evaluation.

RF exposure evaluation is required if the separation distance between the user and/or bystander and the device's radiating element is greater than 20 cm, except when the device operates as follows:

• at or above 300 MHz and below 6 GHz and the source-based, time-averaged maximum e.i.r.p. of the device is equal to or less than 1.31 x  $10^{-2} f^{0.6834}$  W (adjusted for tune-up tolerance), where f is in MHz;

In these cases, the information contained in the RF exposure technical brief may be limited to information that demonstrates how the e.i.r.p. was derived.

#### 3.0 UUT POWER OUTPUT AND ANTENNA GAIN

The maximum fundamental field strength from Exhibit 5-2 is measured as 18.92 dBm.

The duty cycle from Exhibit 3 is 6.98%, or 23.12 dB

The max antenna gain between the two antennas is 4.0 dBi

The max time-averaged EIRP per 2.0 above is  $1.31 \times 10^{-2} \times 2405^{0.6834}$  (W) = 2.679W = 2679 mW.

The power density at 20cm corresponding to 2679 mW EIRP is N/(4 x  $\pi$  x d<sup>2</sup>) or 2679/(4\* $\pi$ \*20<sup>2</sup>) = **0.533 mW/CM**<sup>2</sup>
