1 General Information

1.1 Product Description for Equipment Under Test (EUT)

This test and measurement report was prepared on behalf of *Communications Specialists, Inc.* and their product, model: CSTXR.1, *FCC ID*: CFXTXR-2 or the "EUT" as referred to in this report. The EUT is an Ankle/Wrist Homing Transmitter operating in 433.5 MHz and the 217-220 MHz & 216-217 MHz frequency bands.

1.2 Mechanical Description

The "EUT" measures 25mm (L) x 25mm (W) x 5mm (H), and weighs approximately 5g.

The data gathered are from production sample. Serial number R1611033-1 assigned by BACL.

1.3 Objective

This report is prepared on behalf of *Communications Specialists, Inc.* in accordance with Part 2, Subpart J and Part 95, Subpart G of the Federal Communication Commission's rules.

1.5 Test Methodology

All measurements contained in this report were conducted with TIA-603-D.

1.6 Measurement Uncertainty

All measurements involve certain levels of uncertainties, especially in the field of EMC. The factors contributing to uncertainties are spectrum analyzer, cable loss, antenna factor calibration, antenna directivity, antenna factor variation with height, antenna phase center variation, antenna factor frequency interpolation, measurement distance variation, site imperfections, mismatch (average), and system repeatability.

Based on CISPR16-4-2:2011, The Treatment of Uncertainty in EMC Measurements, the values ranging from ± 2.0 dB for Conducted Emissions tests and ± 4.0 dB for Radiated Emissions tests are the most accurate estimates pertaining to uncertainty of EMC measurements at BACL Corp.

1.7 Test Facility Registrations

4.1 Applicable Standards

4.2 Test Results

Refer to the 4.3.1 Standalone SAR test exclusion considerations in 447498 D01 General RF Exposure Guidance V06.

[(max. power of channel, including tune-up tolerance, mW) / (min. test separation distance, mm)] \cdot [$\sqrt{f(GHz)}$] =[6.79mW/5mm] \cdot [$\sqrt{0.2169875}$] =0.63 \leq 7.5 for 10-g extremity SAR.

Since the results for the highest output power is (are) less than the SAR exclusion value, SAR testing was exempt.

5 FCC §2.1046 & §95.639 - RF Output Power

5.1 Applicable Standard

According to FCC §95.639(e), the maximum transmitter output power authorized for LPRS stations is 100 mW.

5.2 Test Procedure

The transmitter was place onto a Styrofoam block. The unit was normally transmitting with a 50 ohm terminator connected to the antenna terminal.

The measurement antenna was placed at a distance of 3 meters from the EUT. During the tests, the antenna height and polarization as well as EUT azimuth were varied in order to identify the maximum level of fundamental emissions from the EUT.

After the fundamental emissions were found, the EUT was removed and replaced by a substituting antenna. A signal generator was connected to the substituting antenna by a non-radiating cable. The absolute levels of the spurious emissions were measured by the substitution.







6 FCC §2.1049, §95.633 & §95.635 - Occupied Bandwidth & Emission Mask

6.1 Applicable Standard

According to FCC §95.633(d) (2), for transmitters in the LPRS, the channel bandwidth for standard band frequencies is 25 kHz.

According to FCC §95.635(c)(1), for transmitters designed to operate in the LPRS, emissions for LPRS transmitters operating on standard band channels (25 kHz) shall be attenuated below the unmodulated carrier in accordance with the following:

- (i) Emissions 12.5 kHz to 22.5 kHz away from the channel center frequency: at least 30 dB; and
- (ii) Emissions more than 22.5 kHz away from the channel center frequency: at least 43 + 10log(carrier power in watts) dB.

6.2 Test Procedure

The EUT is connected to the spectrum analyzer. The EUT transmits a CW signal with no modulation and FSK modulation.





Emission Bandwidth


216.0125 MHz, Modulation: N0N



216.9625 MHz, Modulation: N0N




216.9875 MHz, Modulation: FSK




Emission Mask



7 FCC §2.1055 & §95.629 - Frequency Stability

7.1 Applicable Standard

FCC §2.1055, §95.629 (b) (2), LPRS transmitters operating on narrowband channels must be maintained within a frequency stability of 50 parts per million.

7.2 Test Procedure

Frequency Stability vs. Temperature: The equipment under test was connected to an external DC power supply and the RF output was connected to the Spectrum Analyzer via feed-through attenuators. The EUT was placed inside the temperature chamber. The DC leads and RF output cable exited the chamber through an opening made for the purpose.

After the temperature stabilized for approximately 20 minutes, the frequency output was recorded from the Spectrum Analyzer.

Frequency Stability vs. Voltage: For hand carried, battery powered equipment, reduce primary supply voltage to the battery operating end point which shall be specified by the manufacturer.

8 FCC §2.1053 & §95.635 - Field Strength of Spurious Radiation

8.1 Applicable Standard

According to FCC §95.635(c)(1), emissions for LPRS transmitters operating on standard band channels (25 kHz) shall be attenuated below the unmodulated carrier in accordance with the following:

- (i) Emissions 12.5 kHz to 22.5 kHz away from the channel center frequency: at least 30 dB; and
- (ii) Emissions more than 22.5 kHz away from the channel center frequency: at least 43 + 10log(carrier power in watts) dB.

8.2 Test Procedure

The transmitter was place onto a Styrofoam block. The unit was normally transmitting with a 50 ohm terminator connected to the antenna terminal.

The measurement antenna was placed at a distance of 3 meters from the EUT. During the tests, the antenna height and polarization as well as EUT azimuth were varied in order to identify the maximum level of emissions from the EUT.

Emissions were investigated up to the tenth harmonic of the fundamental frequency.

After the emissions were found, the EUT was removed and replaced by a substituting antenna. A signal generator was connected to the substituting antenna by a non-radiating cable. The absolute levels of the spurious emissions were measured by the substitution.
