2.3 Traceability

Diagram of Measurement Configuration for Radiation Test

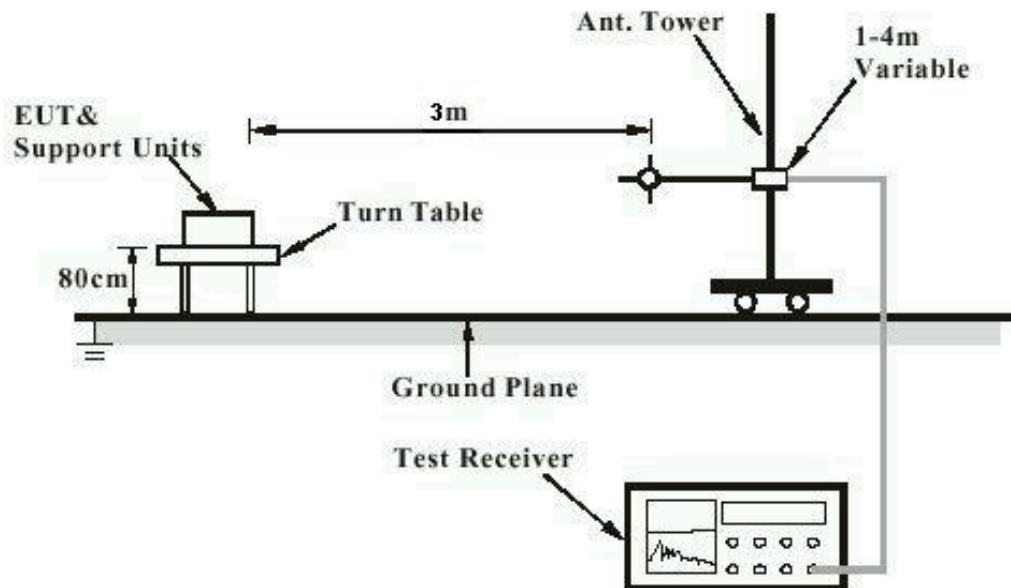
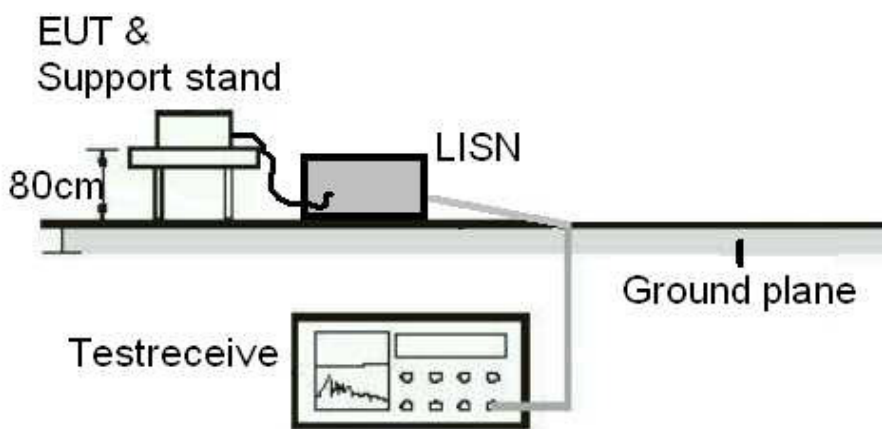


Diagram of Measurement Equipment Configuration for Mains Conduction Measurement (if applicable)

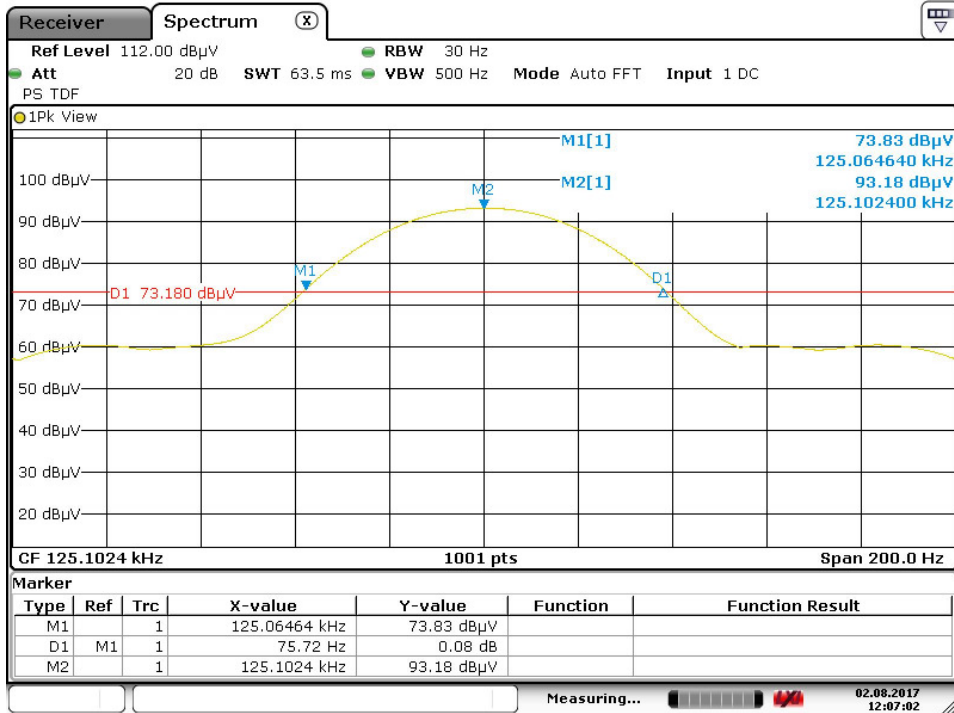

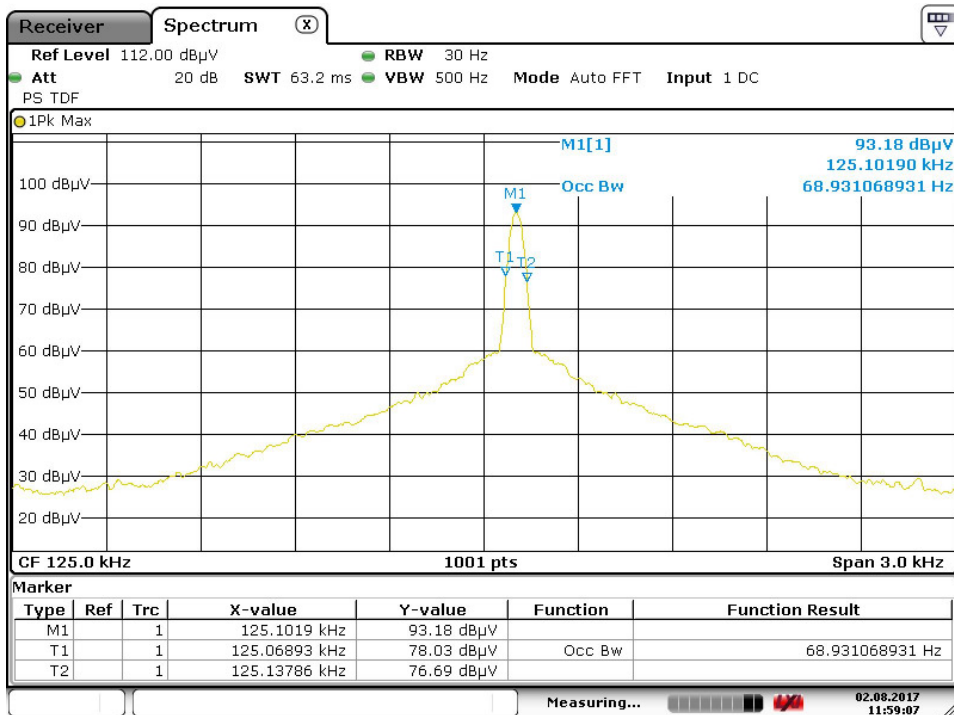

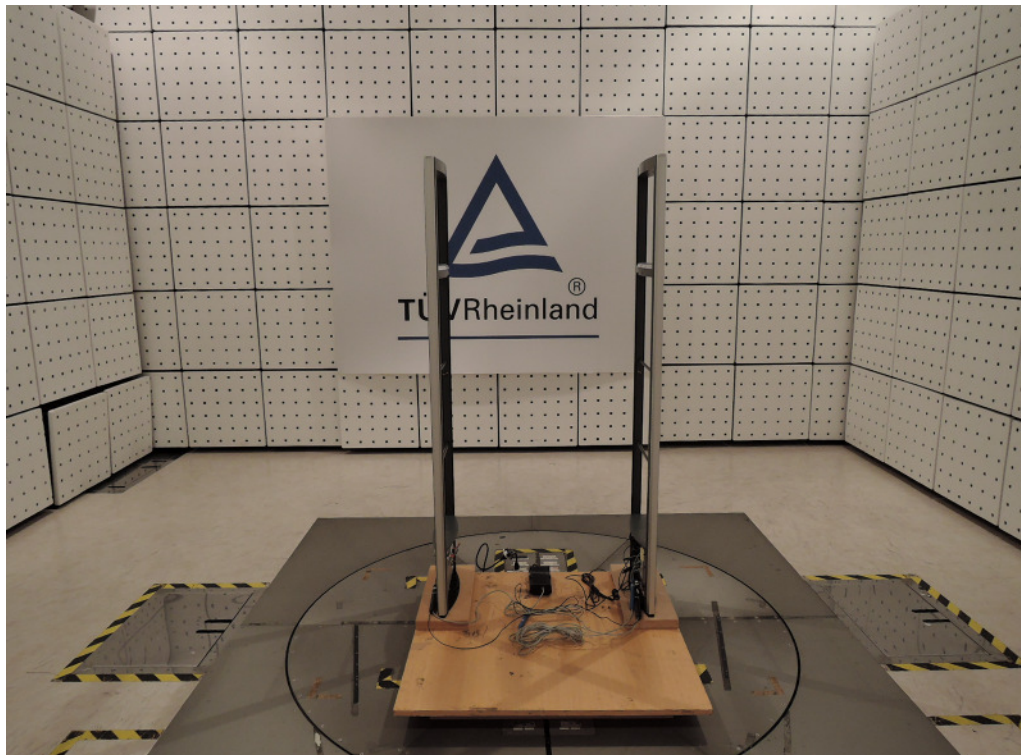

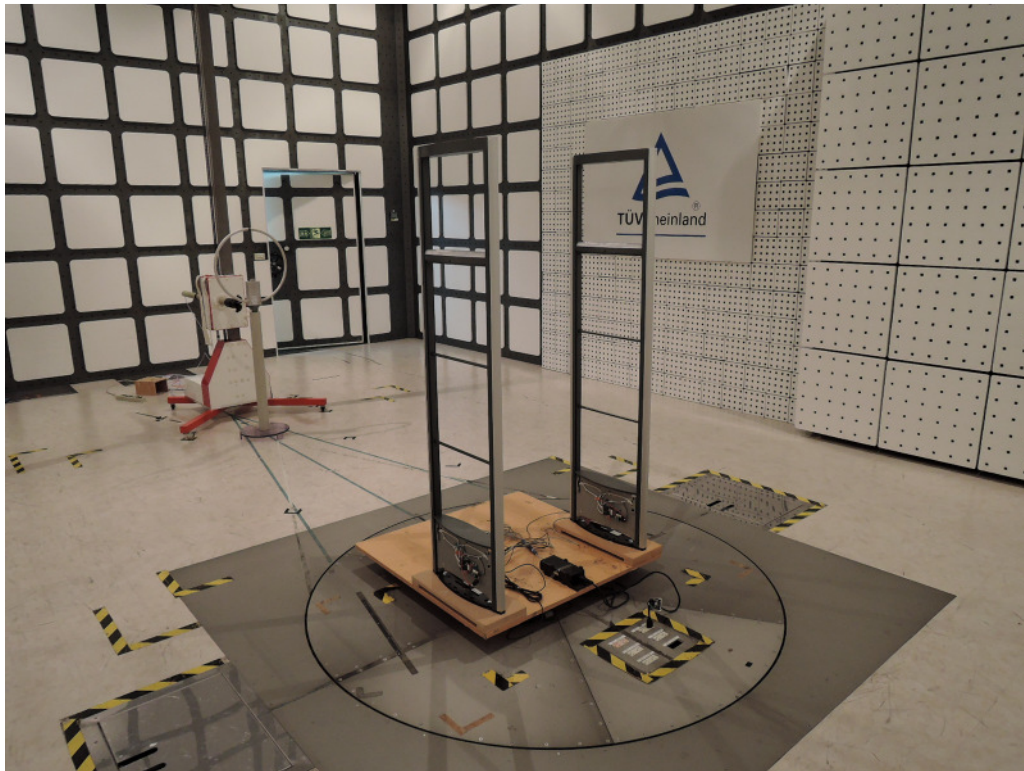

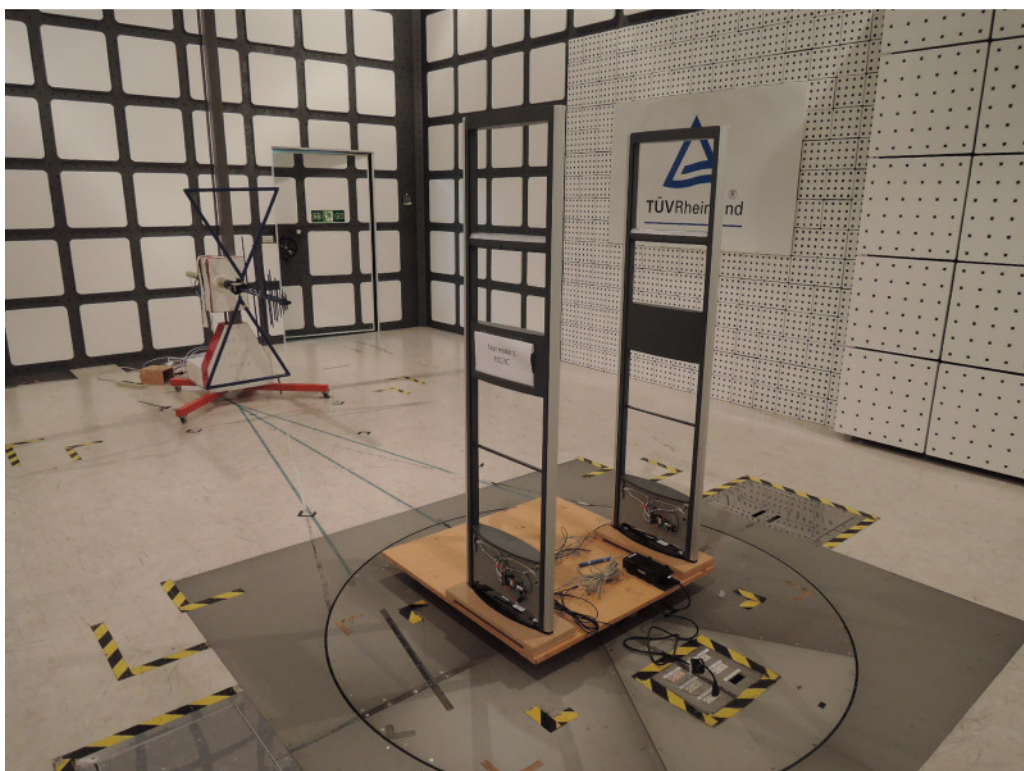
Photograph 1: Set-up for Radiated Emissions TX (Front View)

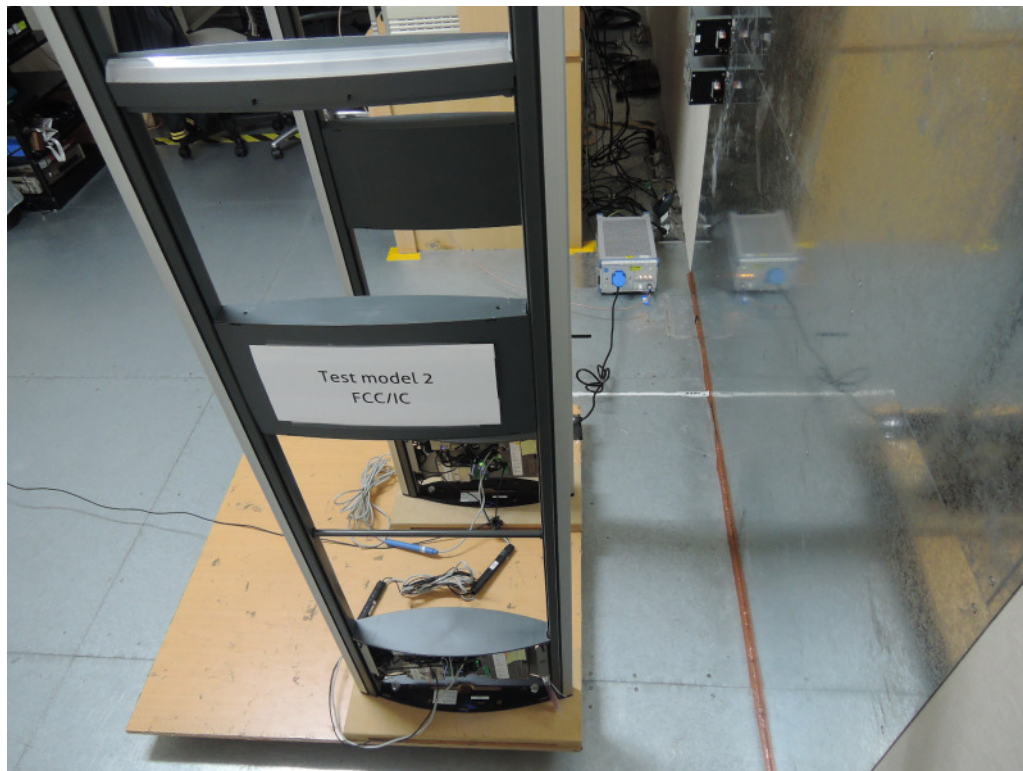


Photograph 3: Set-up for Radiated Emissions (Back View 2)
