We, N.V. Nederlandsche Apparatenfabriek "Nedap", declare that the antenna BPL-DA200x200S has the same properties as the antenna BPL-DA380x280S as mentioned in the test report 14-09091401.fcc01_Rev02_NEDAP_SMARTDEACTIVATOR CGSSMARTDEC.pdf apart from the dimensions. See also attached pictures in Annex 1.

The antenna BPL-DA200x200S is smaller being 158 by 158 mm while the BPL-DA380x280S has dimensions 296 by 195 mm, meaning the last mentioned and measured antenna will radiate more than the smaller one.

The measurements of the BPL-DA380x280S show 31.4 dB lower result (8.6 dB μ V/m with a limit of 40 dB μ V/m at 30 meters) on the intentional frequency.

The measurement of the BPL-DA380x280S show a 14.9 dB lower result (28.6 dB μ V/m with a limit of 43.5 dB μ V/m at 3 meters)

I thereby wish to request whether you can authorize us to apply this antenna with our SMART DEAC system with FCC ID: CGDSMARTDEAC since the BPL-DA200x200S is a much smaller one thus will radiate at a lower level.
