## Functions:

### ★ TO SPEAK:

In (ON) position, press and hold the (PUSH TO TALK) button. Then speak into Walkie Talkie to transmit voice.

### MORSE CODE:

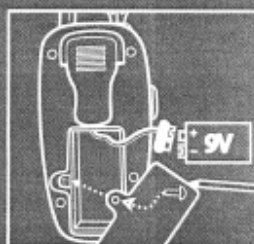
★ In (ON) position, press and hold (PUSH TO TALK) button. Then press (MORSE CODE) button to transmit message.

### ON/OFF/VOLUME:

★ Turn counter clockwise for (ON) position.  
★ Turn clockwise to turn (OFF).  
In (ON) position, adjust the volume level by turning up.

## BATTERY REPLACEMENT

REPLACEMENT OF BATTERIES  
MUST BE DONE BY ADULT.



This toy takes 2 x "9V" type batteries  
(not included).

Nonrechargeable batteries are not to be recharged.  
Rechargeable batteries are to be removed from the toy before being charged.  
Rechargeable batteries are only to be charged under adult supervision.  
Different types of batteries or new and used batteries are not to be mixed.  
Batteries are to be inserted with the correct polarity.  
Exhausted batteries are to be removed from the toy.  
The supply terminals are not to be short-circuited.

Please keep this packaging since it contains important information.

To replace batteries, unscrew cover using a Phillips screwdriver. Note polarity of batteries, remove and replace with new batteries.
