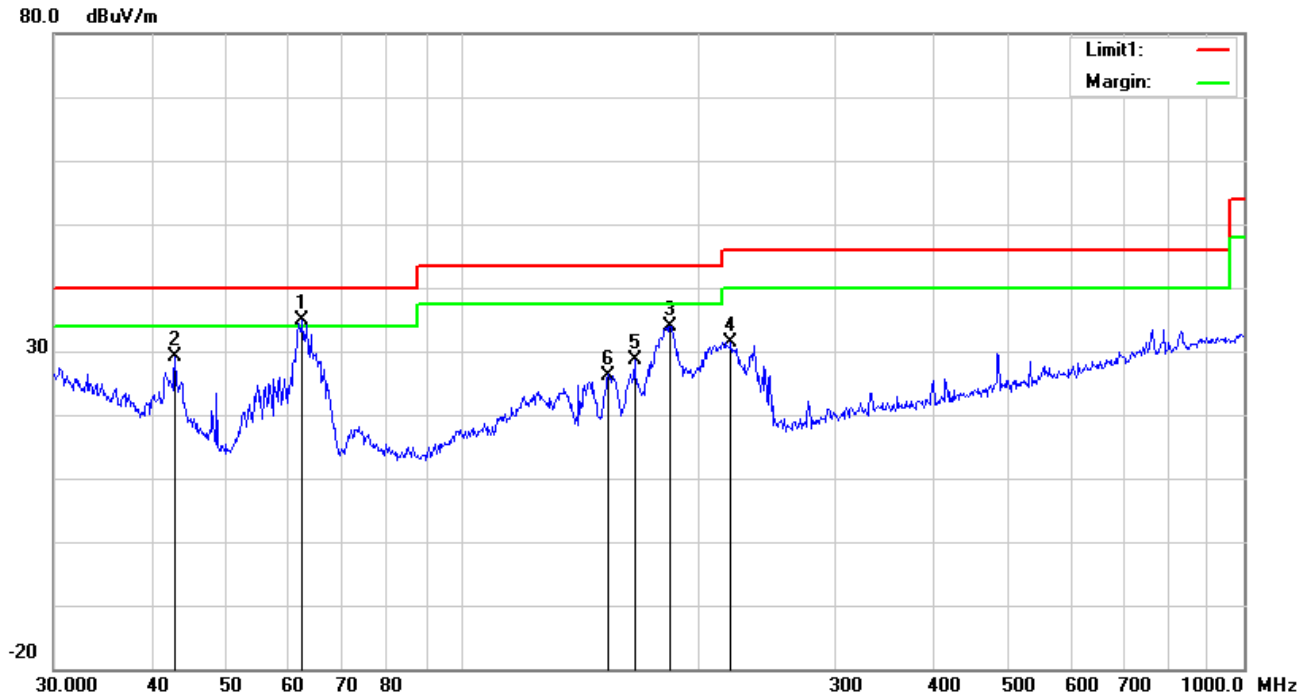

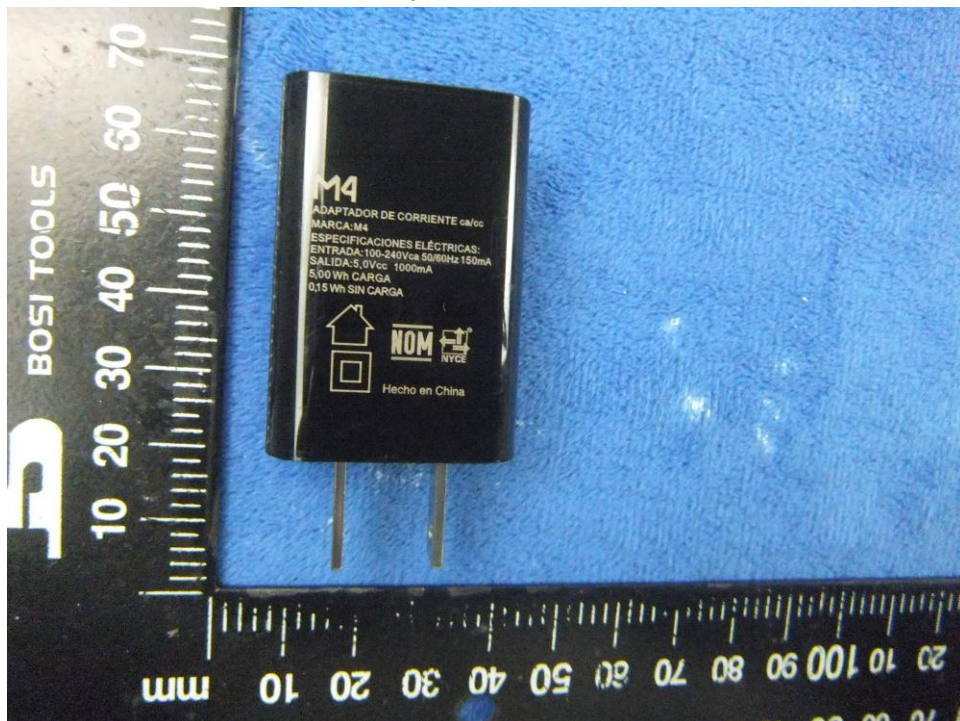

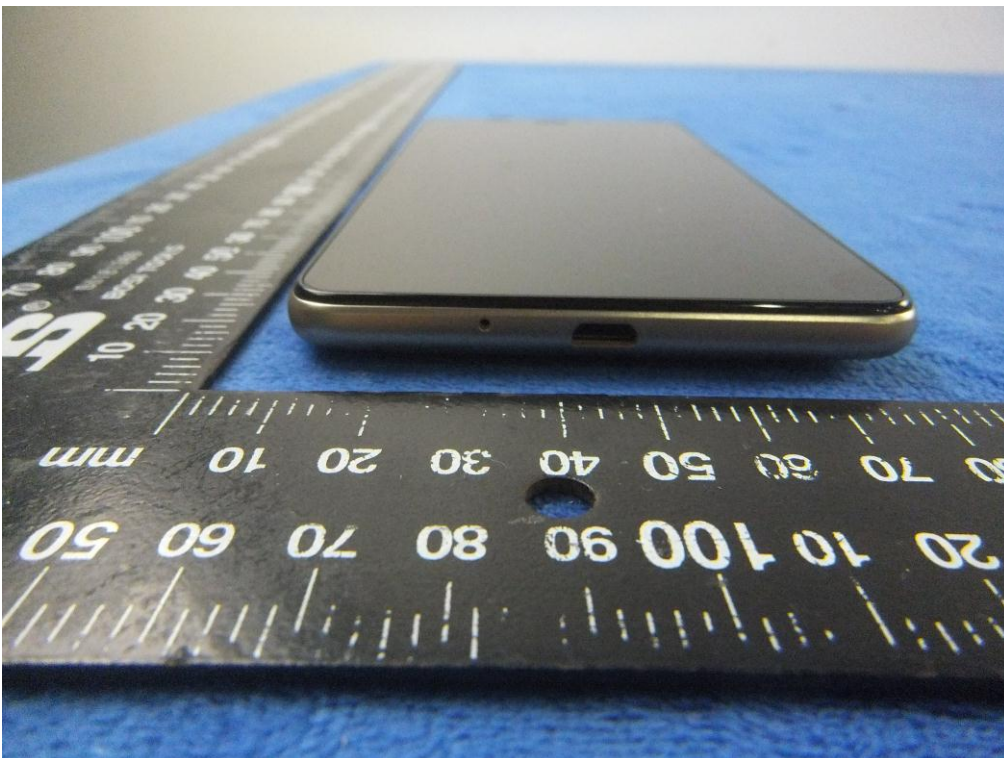

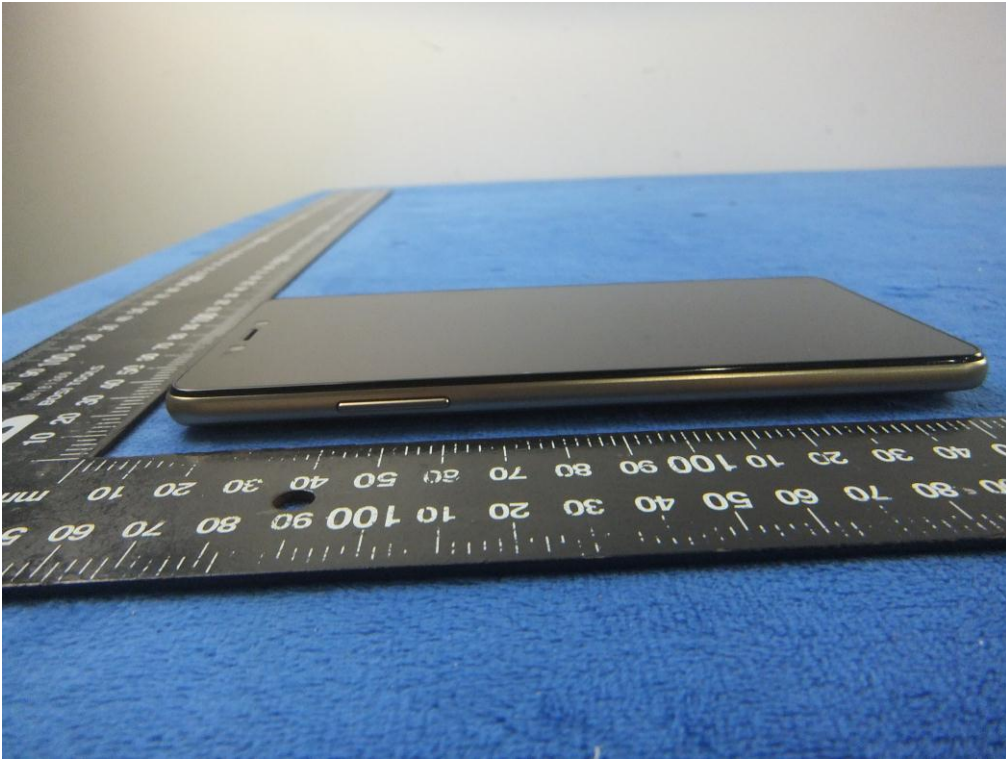

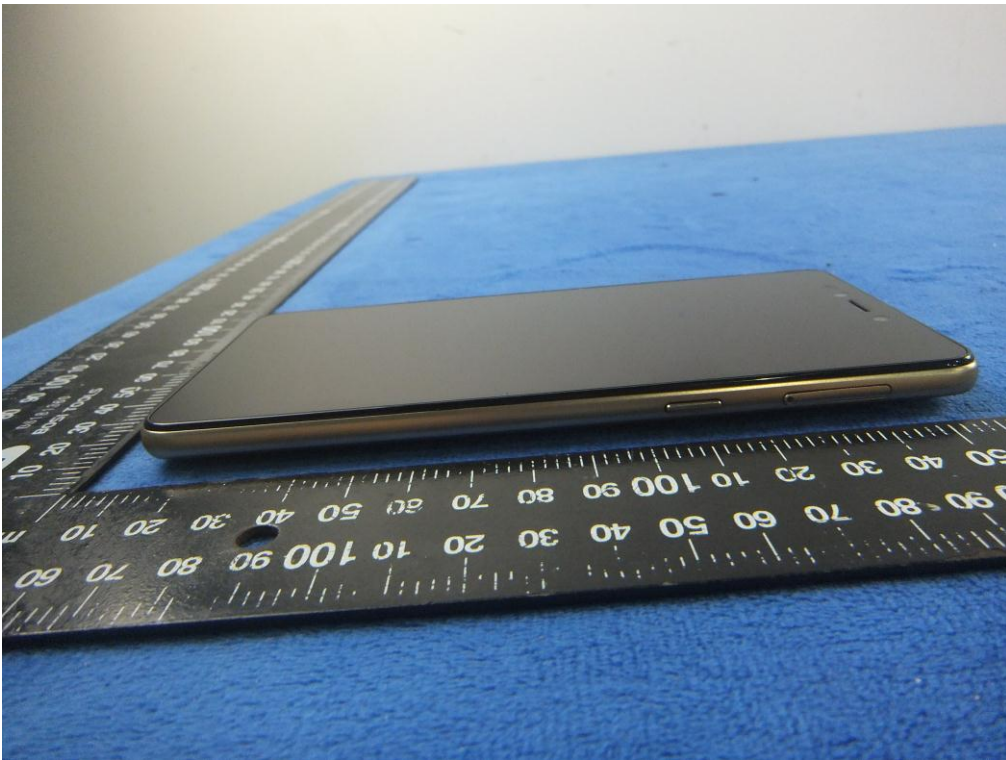

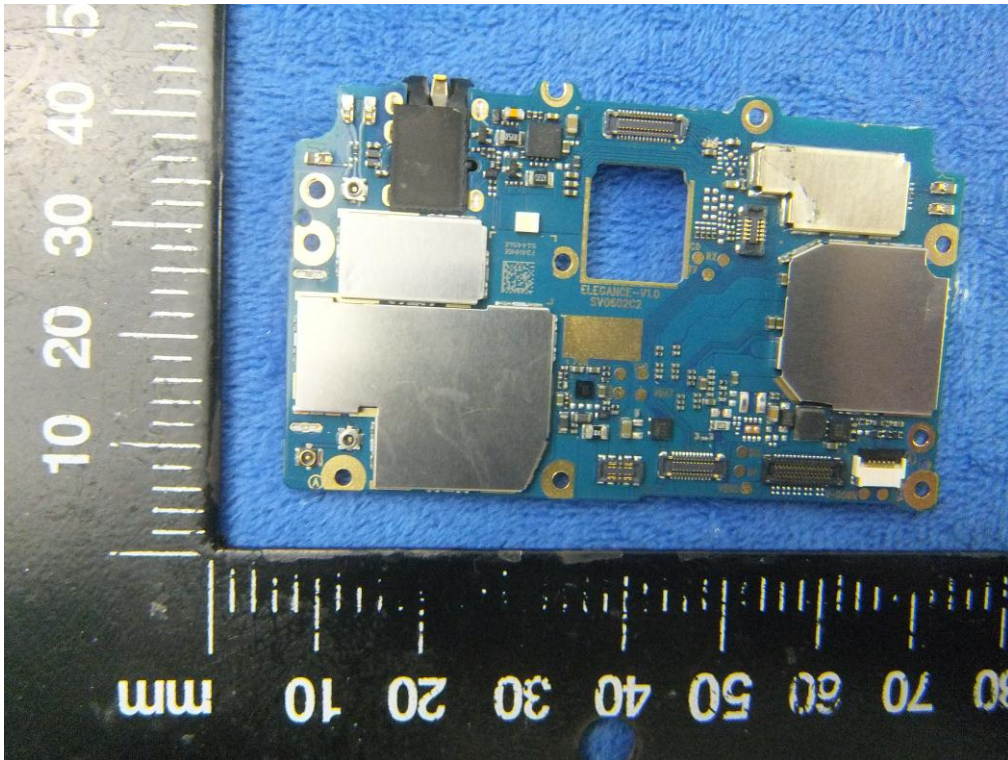

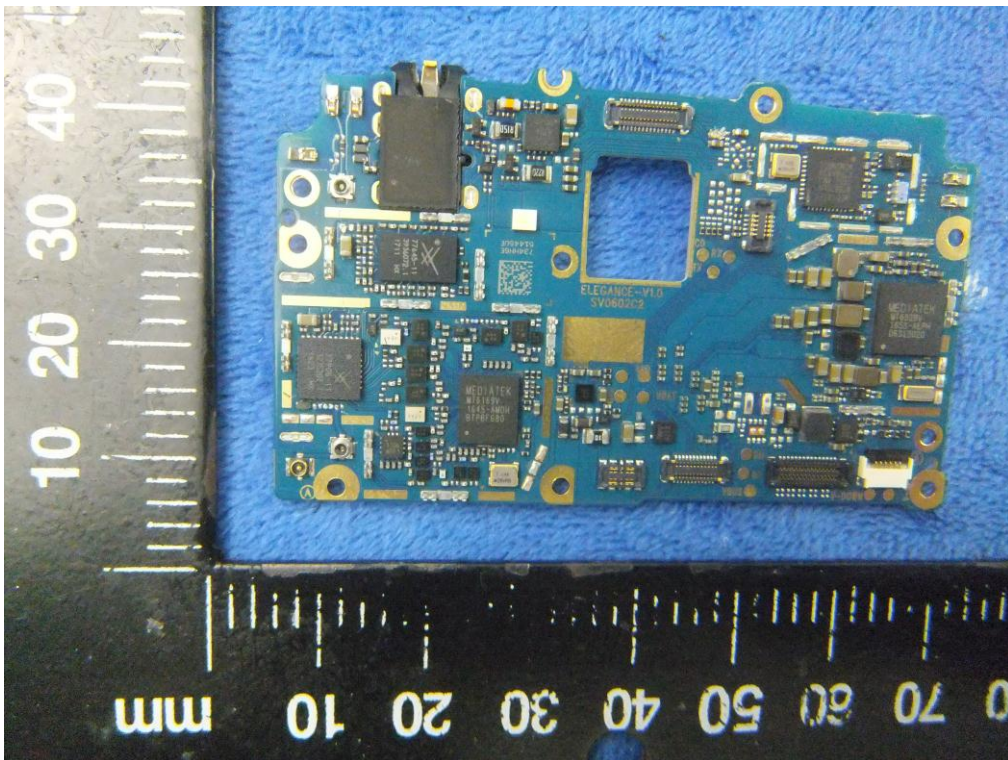

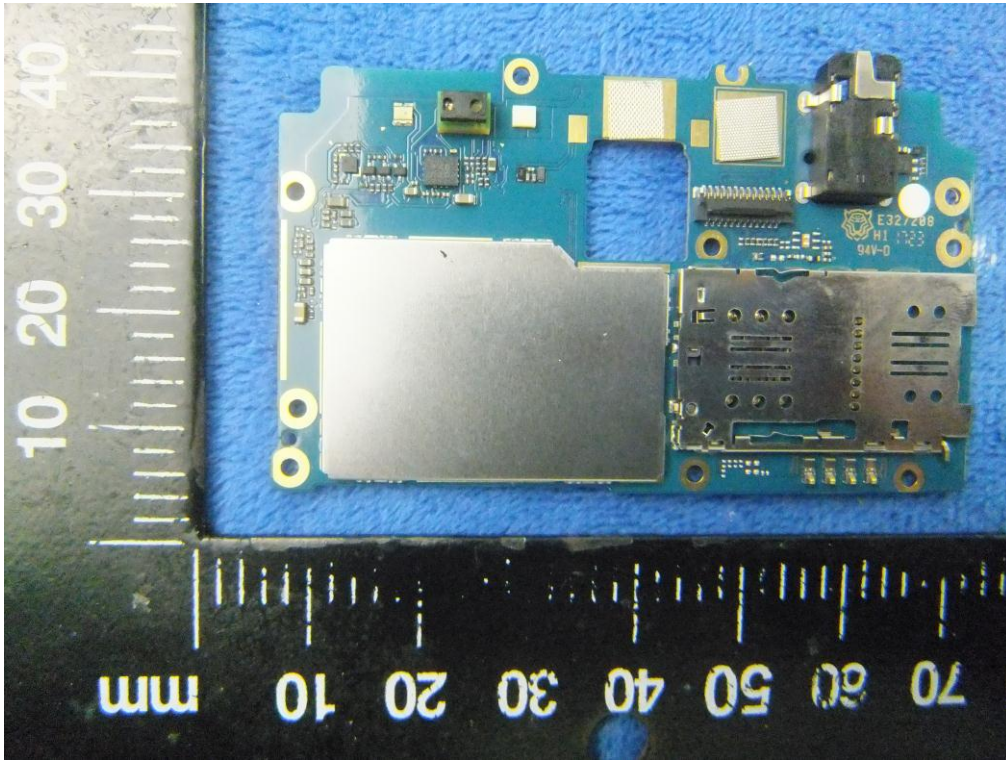
Mainboard with Shielding - Front View



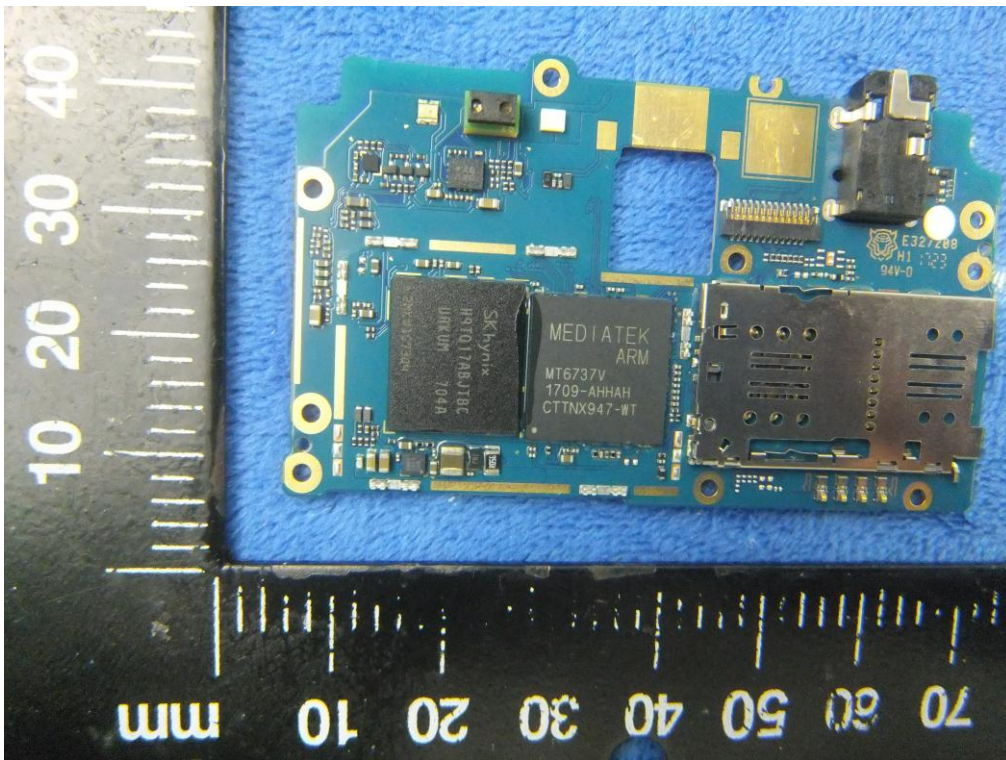
Mainboard without Shielding - Front View

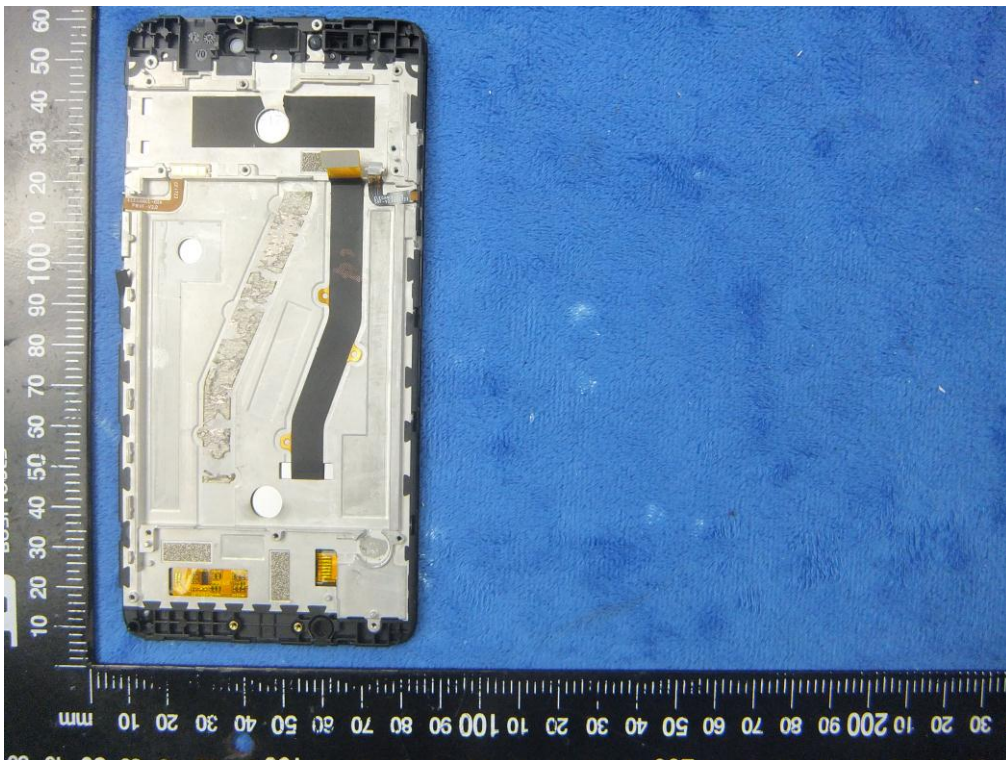

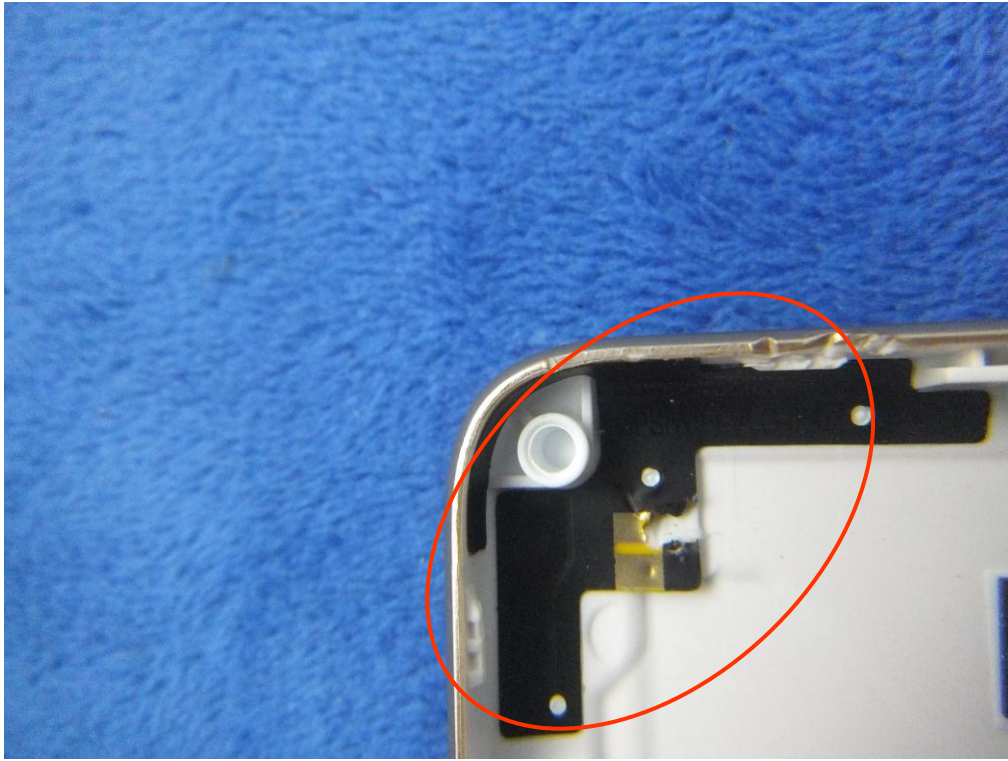

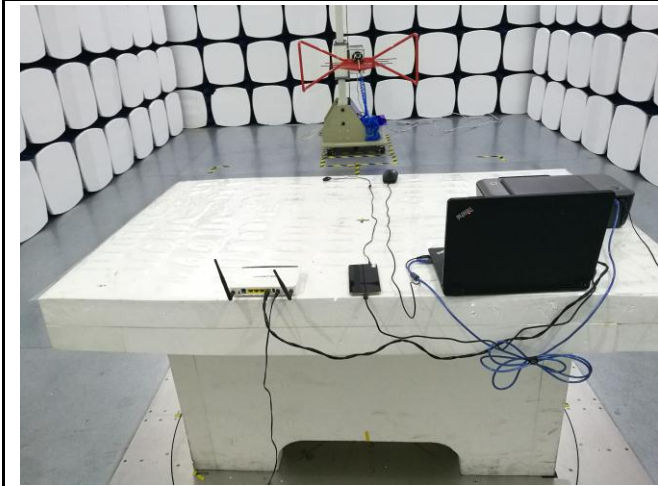

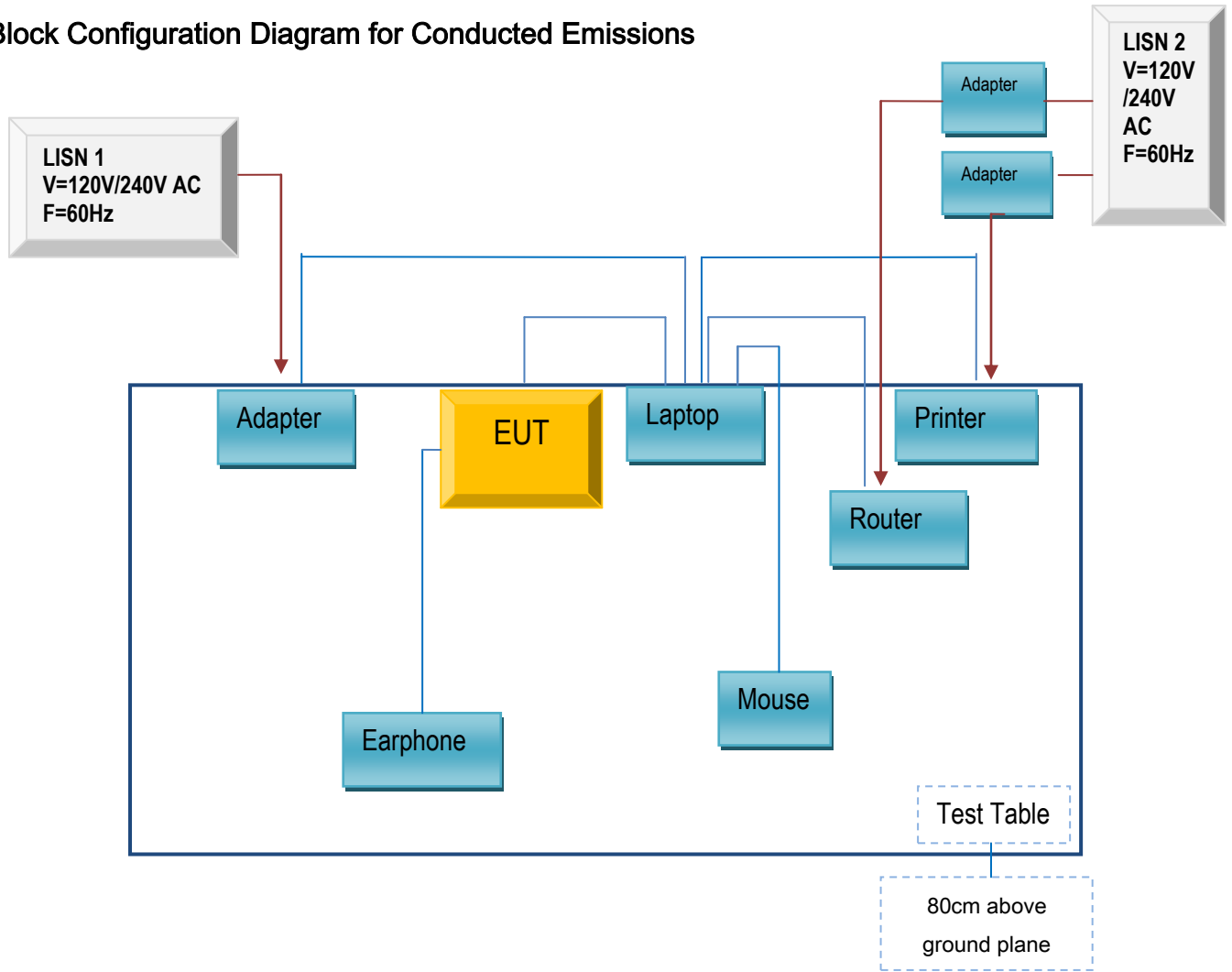

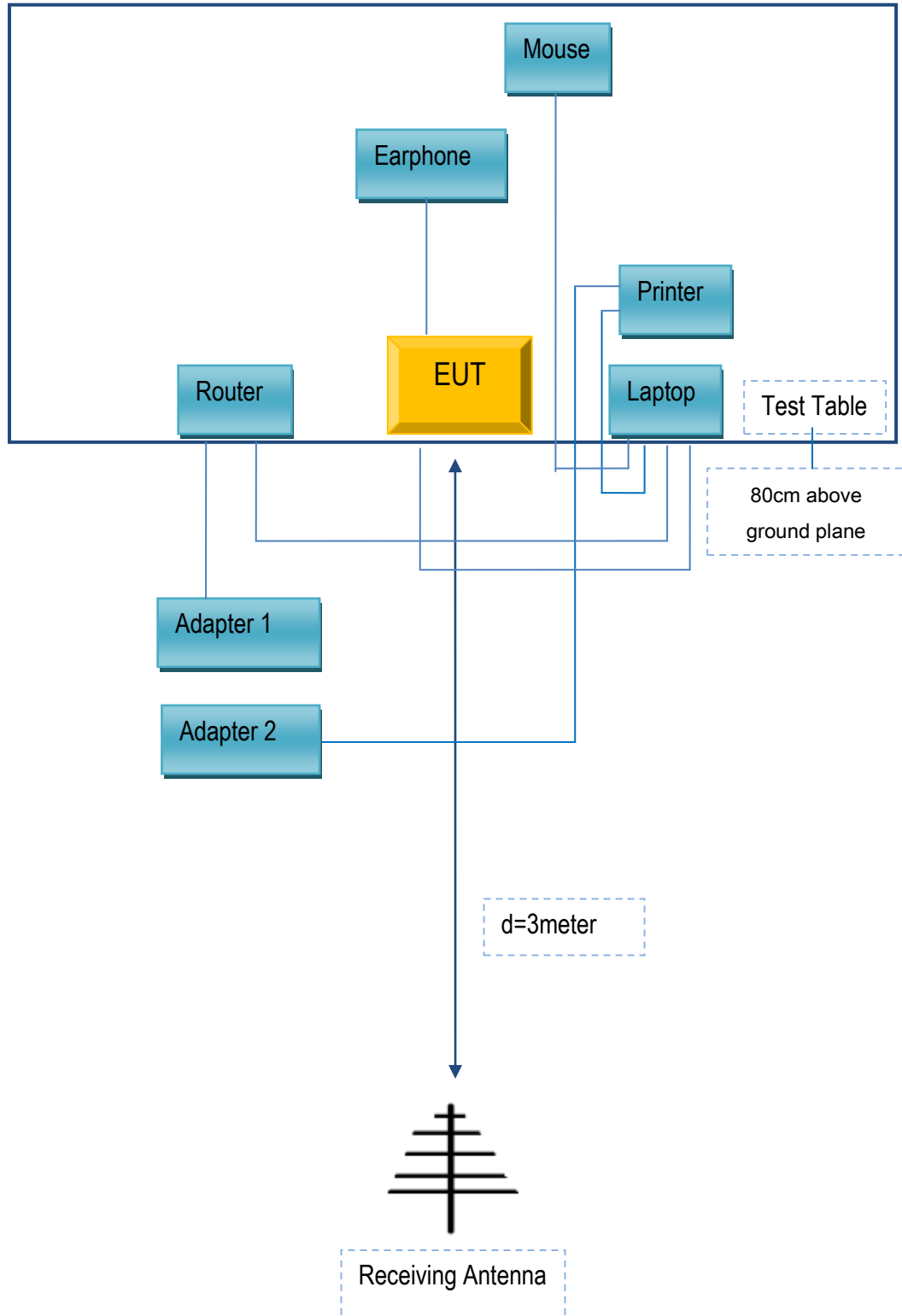
