E(V/m) = SQRT (30 \* P \* G) / d

 $Pd(W/m^2) = E^2 / 377$ 

 $S = EIRP / (4 * Pi * D^2v)$ 

Where:

 $S = Power density, in mW/cm^2$ 

EIRP = Equivalent Isotropic Radiated Power, in mW

D = Separation distance in cm

Power density is converted from units of  $\underline{MW/cm^2}$  to units of  $\underline{W/m^2}$  by multiplying by 10.

#### DISTANCE

$$D = SQRT (EIRP / (4 * Pi * S))$$

D = Separation distance in cm

EIRP = Equivalent Isotropic Radiated Power, in mW

S = Power density in mW/cm^2
