

SPOTTERRF NON-TRANSFER AND END USER LICENSE AGREEMENT

Rights Summary

1. License to use SpotterRF for tracking of moving targets and sending location data of said moving targets to other systems.
2. Warranty for 1 year from receiving the SpotterRF for hardware and software defects. Additional warranty and support options can be purchased.
3. Support for 1 year from receiving the SpotterRF including firmware upgrades and phone and email technical support.

Restrictions Summary

1. EXPORT RESTRICTIONS. U.S. State Department regulations and rules expressly prohibit you from releasing to a foreign national within the U.S. or exporting to a foreign country by any means, including resale, lease or transfer, designated SpotterRF models—Military Models Mxxxx series—unless you have obtained the State Department's express written approval or license to do so, before any release or exportation. You may export other designated SpotterRF models —Commercial Models Cxxxx series—as long as you comply with U.S. Commerce Department regulations and rules that have classified this model is as an EAR99 device. When exporting this EAR99-classified product, you must follow and comply with all terms and conditions the Commerce Department has established for exporting this product.
2. No attempting to open case of the SpotterRF. No attempting to reverse engineer any of the software or hardware comprising the SpotterRF.
3. No warranty on units were the case is breached or struck by lightning

IMPORTANT- READ CAREFULLY: This End-User License Agreement ("EULA") is a legal agreement between you (either an individual or a single entity) and SpotterRF for the SpotterRF hardware and/or software that accompanies this EULA, which includes software embedded in the device (Firmware) and may include associated media, printed materials, "online" or electronic documentation. **YOU AGREE TO BE BOUND BY THE TERMS OF THIS EULA BY INSTALLING, COPYING, OR OTHERWISE USING THE SOFTWARE OR HARDWARE. IF YOU DO NOT AGREE, DO NOT INSTALL, COPY, OR USE THE SpotterRF HARDWARE OR SOFTWARE.**

1. **GRANT OF LICENSE.** SpotterRF grants you the following rights provided that you comply with all terms and conditions of this EULA:
 1. Installation and use. You may install and use the SpotterRF on any ground vehicle or platform that is attached to the ground.
 2. Tracking data generated by the SpotterRF may be displayed or distributed to any user or individual not restricted by U.S. Government regulations.
2. **RESERVATION OF RIGHTS AND OWNERSHIP.** SpotterRF reserves all rights not expressly granted to you in this EULA. The Software and Hardware of the SpotterRF is protected by copyright and other intellectual property laws and treaties. SpotterRF owns the title, copyright, and other intellectual property rights in the Software and Hardware of the SpotterRF. The Software of the SpotterRF is licensed, not sold.
3. **LIMITATIONS ON REVERSE ENGINEERING, DECOMPILE, AND DISASSEMBLY.** You may not reverse engineer, decompile, or disassemble the Hardware or Software of the unit.

4. **ADDITIONAL SOFTWARE.** This EULA applies to updates, supplements and add-on components of the Software/Hardware that SpotterRF may provide to you or make available to you after the date you obtain your initial copy of the Software/Hardware, unless SpotterRF provides other terms along with the update, supplement or add-on component.
5. **UPGRADES.** To use Software identified as an upgrade, you must first be licensed for the software identified by SpotterRF as eligible for the upgrade.
6. **NOT FOR RESALE.** The SpotterRF sensor is identified as "Not For Resale" or "NFR," and may not be sold or otherwise transferred to another user, individual or entity, or used for any purpose other than demonstration, test or evaluation without express written consent by SpotterRF and the U.S Department of Defense as necessary
7. **EXPORT RESTRICTIONS.** U.S. State Department regulations and rules expressly prohibit the releasing to a foreign national within the U.S. or exporting to a foreign country by any means, including resale, lease or transfer, items controlled by the International Traffic in Arms Regulations (ITAR), without the State Department's express written approval or license to do so, before any release or exportation. The U.S. State Department designates specified SpotterRF models—Military Models Mxxxx series—as ITAR-restricted items. Consequently, you may not release all or any part— hardware or software—of these SpotterRF products to a foreign national within the U.S. or export them to a foreign country unless you have obtained the State Department's express written approval or license to do so beforehand. 9. **LIMITED WARRANTY FOR SOFTWARE/HARDWARE.** SpotterRF warrants that the Software/Hardware will perform substantially in accordance with its specifications for a period of one year from the date of receipt. **AS TO ANY DEFECTS DISCOVERED AFTER THE ONE YEAR PERIOD, THERE IS NO WARRANTY OR CONDITION OF ANY KIND UNLESS EXPRESS WRITTEN CONSENT IS GIVEN BY SpotterRF. LIMITATION ON REMEDIES; NO CONSEQUENTIAL OR OTHER DAMAGES.** Your exclusive remedy for any breach of this Limited Warranty is as set forth below. Except for any refund elected by SpotterRF, **YOU ARE NOT ENTITLED TO ANY DAMAGES, INCLUDING BUT NOT LIMITED TO CONSEQUENTIAL DAMAGES,** if the Software/Hardware does not meet SpotterRF's Limited Warranty, and, to the maximum extent allowed by applicable law, even if any remedy fails of its essential purpose. The terms of Section 11 ("Exclusion of Incidental, Consequential and Certain Other Damages") are also incorporated into this Limited Warranty. This Limited Warranty gives you specific legal rights. Any replacement unit will be warranted for the remainder of the original warranty period or thirty (30) days, whichever is

longer, and SpotterRF will use commercially reasonable efforts to provide your remedy within a commercially reasonable time of your compliance with SpotterRF's warranty remedy procedures.

Except for the Limited Warranty and to the maximum extent permitted by applicable law, SpotterRF and its suppliers provide the SpotterRF and support services (if any) AS IS AND WITH ALL FAULTS, and hereby disclaim all other warranties and conditions, whether express, implied or statutory, including, but not limited to, any (if any) implied warranties, duties or conditions of merchantability, of fitness for a particular purpose, of reliability or availability, of accuracy or completeness of responses, of results, of workmanlike effort, of lack of viruses, and of lack of negligence, all with regard to the SpotterRF, and the provision of or failure to provide support or other services, information, software, and related content through the SpotterRF or otherwise arising out of the use of the SpotterRF. ALSO, THERE IS NO WARRANTY OR CONDITION OF TITLE, QUIET ENJOYMENT, QUIET POSSESSION, CORRESPONDENCE TO DESCRIPTION OR NON-INFRINGEMENT WITH REGARD TO THE SpotterRF.

13. **ENTIRE AGREEMENT; SEVERABILITY.** This EULA (including any addendum or amendment to this EULA which is included with the Software) is the entire agreement between you and SpotterRF relating to the SpotterRF and the support services (if any) and they supersede all prior or contemporaneous oral or written communications, proposals and representations with respect to the SpotterRF or any other subject matter covered by this EULA. Extended warranty and support packages purchased by the user will extend this agreement as specified in the terms of the extended warranty and support agreement. If any provision of this EULA is held to be void, invalid, unenforceable or illegal, the other provisions shall continue in full force and effect.

14. END-USER CERTIFICATION. By purchasing and accepting delivery of this product, I the end user agree as follows:

1. We certify that we are the end-user of the purchased SpotterRF product.
2. ITAR-Restricted Product. If we have purchased a SpotterRF model—Military Models Mxxxx series—we acknowledge and agree that this product is an ITAR-restricted item, subject to ITAR and attendant rules. We also agree not to release all or any part—hardware or software—of this purchased product to a foreign national within the U.S. or export it to a foreign country by any means, including resale, lease or transfer, without the U.S. State Department’s express written approval or license to do so. If we make a State Department application for authorization to export this ITAR-restricted product, we agree to complete and submit a form DSP-83 as a part of our application.
3. EAR99 Product. If we have purchased a SpotterRF model—Commercial Models Cxxxx series—we acknowledge and agree that this product is an EAR99 device, subject to U.S. Commerce Department’s EAR and attendant rules. We also agree not to export this purchased product to a foreign country, except in compliance with EAR and attendant rules that specify the terms and conditions for exporting this product.
