





2.2. Limit

2.2.1. Radiated emission limits; general requirements.

According to § 15.209(a), except as provided elsewhere in this Subpart, the emissions from an intentional radiator shall not exceed the field strength levels specified in the following table:

However, operation within these frequency bands is permitted under other sections of this part, e.g., § 15.231 and § 15.241.

2.2.2. Periodic operation in the band 40.66-40.70 № and above 70 №

Where F is the frequency in Mb, the formulas for calculating the maximum permitted fundamental field strengths are as follows: for the band 130-174 Mb, μ V/m at 3 meters = 56.81818(F) - 6136.3636; for the band 260-470 Mb, μ V/m at 3 meters = 41.6667(F) - 7083.3333. The maximum permitted unwanted emission level is 20 dB below the maximum permitted fundamental level.

2.3. Test Procedures

Radiated emissions from the EUT were measured according to the dictates of ANSI C63.10:2013

2.3.1. Test Procedures for emission below 30 Mb

- a. The EUT was placed on the top of a rotating table 0.8 meters above the ground at a 3 meter anechoic chamber test site. The table was rotated 360 degrees to determine the position of the highest radiation.
- b. Then antenna is a loop antenna is fixed at one meter above the ground to determine the maximum value of the field strength. Both parallel and perpendicular of the antenna are set to make the measurement.
- c. For each suspected emission, the EUT was arranged to its worst case and then the table was turned from 0 degrees to 360 degrees to find the maximum reading.
- d. The test-receiver system was set to Peak Detect Function and Specified Bandwidth with Maximum Hold Mode.

2.3.2. Test Procedures for emission from 30 Mb to 1 000 Mb

- a. The EUT was placed on the top of a rotating table 0.8 meters above the ground at a 3 meter anechoic chamber test site. The table was rotated 360 degrees to determine the position of the highest radiation.
- b. During performing radiated emission below 1 %, the EUT was set 3 meters away from the interference receiving antenna, which was mounted on the top of a variable-height antenna tower. During performing radiated emission above 1 %, the EUT was set 3 meter away from the interference-receiving antenna.
- c. The antenna is a broadband antenna, and its height is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement.
- d. For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters and the table was turned from 0 degrees to 360 degrees to find the maximum reading.
- e. The test-receiver system was set to Peak Detect Function and Specified Bandwidth with Maximum Hold Mode.
- f. If the emission level of the EUT in peak mode was 10 $\,\mathrm{dB}$ lower than the limit specified, then testing could be stopped and the peak values of the EUT would be reported. Otherwise the emissions that did not have 10 $\,\mathrm{dB}$ margin would be re-tested one by one using peak, quasi-peak or average method as specified and then reported in a data sheet.

2.3.3. Test Procedures for emission above 1 @

- a. The EUT was placed on the top of a rotating table 1.5 meters above the ground at a 3 meter anechoic chamber test site. The table was rotated 360 degrees to determine the position of the highest radiation.
- b. The resolution bandwidth and video bandwidth of test receiver/spectrum analyzer is 1 \pm for Peak detection at frequency above 1 \pm .
- c. The resolution bandwidth of test receiver/spectrum analyzer is 1 $\,\text{Mz}$ and the video bandwidth is 10 $\,\text{Hz}$ for Average detection (AV) at frequency above 1 $\,\text{GHz}$.





Scanning plots below 30 Mb







3. Bandwidth of Operation Frequency

3.1. Test Setup



3.2. **Limit**

According to § 15.231(c), the bandwidth of the emission shall be no wider than 0.25 % of the center frequency for devices operating above 70 $\,\text{Mb}$ and below 900 $\,\text{Mb}$. For devices operating above 900 $\,\text{Mb}$, the emission shall be no wider than 0.5 % of the center frequency. Bandwidth is determined at the points 20 $\,\text{dB}$ down from the modulated carrier.

3.3. Test Procedure

- 1. The transmitter output is connected to the spectrum analyzer.
- 2. The bandwidth of the fundamental frequency was measured with the spectrum analyzer using RBW = 10 $\,\mathrm{kHz}$, VBW = 10 $\,\mathrm{kHz}$ and Span = 1 $\,\mathrm{MHz}$.
- 3. The bandwidth of fundamental frequency was measured and recorded.





- 2. The bandwidth of the fundamental frequency was measured with the spectrum analyzer using RBW = 1 ME, VBW = 1 ME, Span = 0 E, Sweep Time = 10 sec.
- 3. The bandwidth of fundamental frequency was measured and recorded.






