Therefore, a KDB inquiry was filed to exempt a related device from Noise figure measurements, and was accepted by the FCC in KDB inquiry 925403. Furthermore, since the device will never handle multiple signals, another KDB inquiry was filed to exempt a related device from Out-Of-Block Intermodulation testing which was also accepted by the FCC in KDB inquiry 885618. Testing reflects these exemptions.

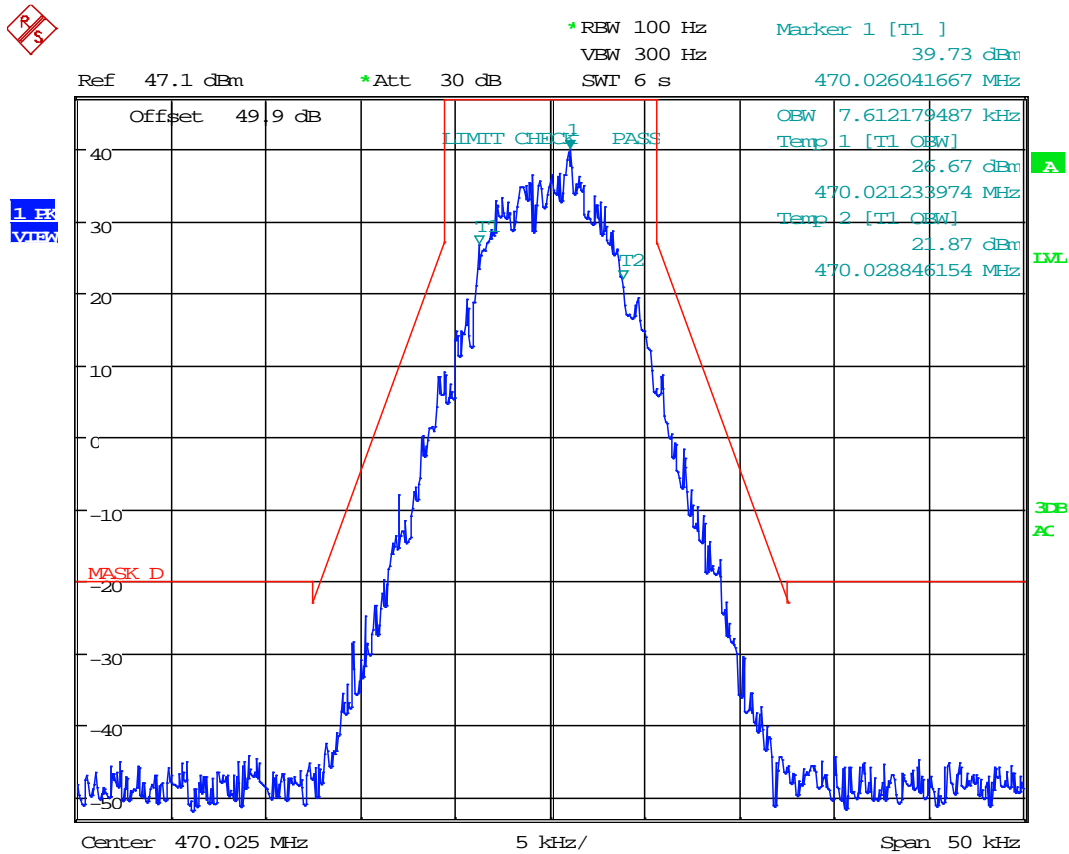

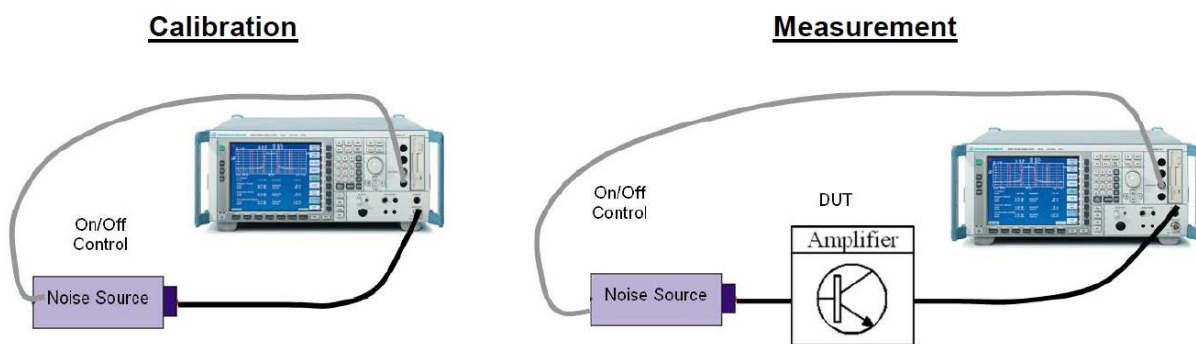

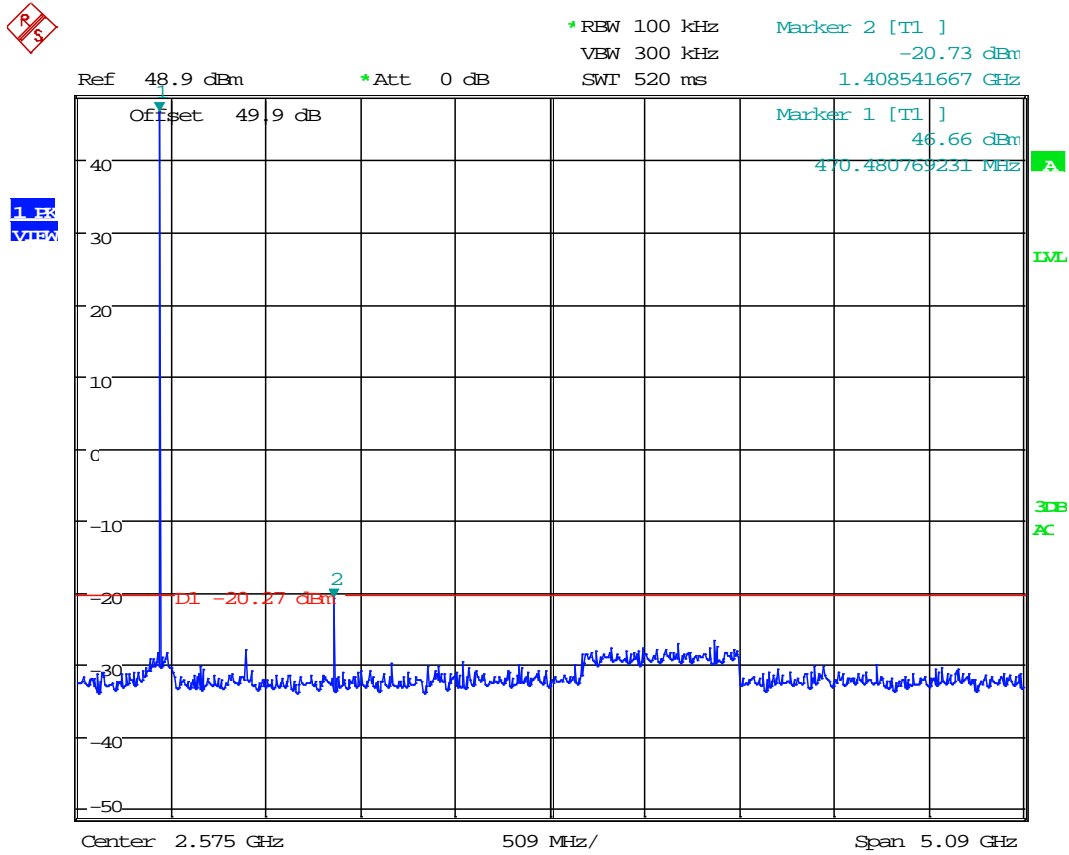
