> you can not rely on customer to maintain the compliance to the applicable  
> law. The device bearing this FCC ID can only be sold in USA when the use

> any channels beyond 11 channels is disabled. Please provide technical  
> description to describe how the applicant will prevent the user to operate  
> this device beyond 11 channel.

> Question #2: The RF exposure warning statement in the user manual does not

> address FCC colocated transmitter restriction. Suggest text can be: "The  
> antenna(s) used for this transmitter must be installed to provide a  
> separation distance of at least 20 cm from all persons and must not be  
> co-located or operating in conjunction with any other antenna or  
> transmitter. " Please provide revised user manual.  
>  
> Question #3: Please provide MPE estimate to address RF exposure  
compliance.  
>  
> Question #4: The FCC ID label format does not clearly indicate the FCC ID.  
> Please resubmit FCC ID label format.  
>
