Dear S.s. Liou,

I have completed a review of the product. The application is nearly complete except for a few items as described below.

1. The user manual must have RF exposure information. The following statement, which was in the manual of an earlier Tecom filing, FCCID: D6XAW4038 would also be acceptable for this product. "IMPORTANT NOTE: To comply with the FCC RF exposure compliance requirements, no change to the antenna or the device is permitted. . Any change to the antenna or the device could result in the device exceeding the RF exposure requirements and void user's authority to operate the device. The antenna used for this transmitter must be installed to provide a separation distance of at least 20cm from all persons and must not be co-located or operating in conjunction with any other antenna or transmitter."
2. The FCCID label on the product must have the following statement "This device complies with Part 15 of the FCC Rules. Operation is subject to the following two conditions: (1) This device may not cause harmful interference, and (2) This device must accept any interference received, including interference that may cause undesired operation."
3. The schematic shows provision for two antennas. The photos and test results show only one antenna. although the circuit board does have provision for connection of another antenna. Please provide a statement that the product will be marketed as tested with only one antenna and that there will be no provision for attachment of additional or alternate antennas.
4. Please provide an MPE evaluation exhibit similar to the exhibit provided with Tecom filing FCCID: D6XAW4038 earlier this year.
