9. The installation manual submitted is written for an end user, not an OEM integrator. The modular approval does not allow an end user to install the device unless it is equipped with a BIOS lock. Please submit the Installation Manual that will be furnished to the OEM or System Integrator.

10. The filing does not contain a sample of the label to be affixed to the outside of the end use product. Please provide a sample of a label that the OEM or System Integrator would place on the outside of the end use product. This label must include the following wording, "Contains FCC ID D6XWL5011S" in order to address Item 6 in your Modular Approval Letter. This sample label may be included in the installation manual, in the Exhibit-D-ID_Label document, or as a separate document.

11. The installation manual submitted does not contain OEM integrator instructions for labeling. Please include instructions to the OEM integrator regarding the applicable labeling requirements from FCC Rules Part 2.925 and Part 15.19.

12. The installation manual submitted contains FCC information that would be appropriate for an end user manual, rather than instructions to the OEM or System Integrator regarding the required FCC information. Please clarify that the FCC information included in the installation manual is a recommended sample of the FCC information that the OEM or System Integrator must furnish to the end user.

13. The installation manual submitted contains the following statement as part of the FCC information: "This device is design for embedded system

application not for general notebook PC use." This statement is appropriate for the instructions to the OEM integrator but is not suitable as part of the regulatory information to the end user. Please remove this statement from the recommended sample FCC information that you provide to the OEM integrator.
