## 1 General Description

#### 1.1 Product Description for Equipment Under Test (EUT)

This test and measurement report has been compiled on behalf of *Lectrosonics*, *Inc.* and their product model: *SSM-B1*, *FCC ID: DBZSSMB1A*, which henceforth is referred to as the EUT (Equipment Under Test). The EUT is a wireless microphone transmitter. The EUT operates in the frequency range: 537.6 to 607.95 MHz.

#### 1.2 Mechanical Description of EUT

The SSM-B1 (EUT) measures approximately 5.84 cm (L) x 3.80 cm (W) x 1.42 cm (H) and weighs approximately 0.065 kg with rechargeable battery.

The data gathered are from a typical production sample provided by the Lectrosonics, Inc. with serial number: 2971

#### 1.3 Objective

The following type approved report is prepared on behalf of *Lectrosonics, Inc.* in accordance with Part 74, Subparts H of the Federal Communications Commission rules.

The objective is to determine compliance with Part 74 of the FCC Rules, limits for RF output power, Modulation characteristics, Emission bandwidth, Field strength of spurious radiation and Frequency stability for license-exempt, low-power radio apparatus operating in the television bands.

#### 1.5 Test Methodology

All measurements contained in this report were conducted in accordance with ANSI/TIA-603-E-2016, FCC KDB 971168 D01 Power Meas License Digital Systems v03r01, and EN 300 422-1 v1.4.2 Electromagnetic compatibility and Radio Spectrum Matters; Wireless microphones in the 25MHz to 3GHz frequency range.

#### **1.6** Measurement Uncertainty

All measurements involve certain levels of uncertainties, especially in the field of EMC. The factors contributing to uncertainties are spectrum analyzer, cable loss, antenna factor calibration, antenna directivity, antenna factor variation with height, antenna phase center variation, antenna factor frequency interpolation, measurement distance variation, site imperfections, mismatch (average), and system repeatability.

Based on CISPR16-4-2:2011, The Treatment of Uncertainty in EMC Measurements, the values ranging from  $\pm 2.0$  dB for Conducted Emissions tests and  $\pm 4.0$  dB for Radiated Emissions tests are the most accurate estimates pertaining to uncertainty of EMC measurements at BACL Corp.

#### 1.7 Test Facility Registrations

BACLs test facilities that are used to perform Radiated and Conducted Emissions tests are currently recognized by the Federal Communications Commission as Accredited with NIST Designation Number US1129.






SSM-B1 537.6 MHz 50 mW Output Power




SSM-B1 572.775 MHz 50 mW Output Power




#### SSM-B1 607.95 MHz 50 mW Output Power




SSM-B1 537.6 MHz 25 mW Output Power





#### SSM-B1 50 mW OBW





#### SSM-B1 25 mW OBW





#### SSM-B1 50 mW Reference Level





#### SSM-B1 50 mW Emission Mask









A period of time sufficient to stabilize all of the components of the oscillator circuit at each temperature level shall be allowed prior to frequency measurement. The short term transient effects on the frequency of the transmitter due to keying (except for broadcast transmitters) and any heating element cycling normally occurring at each ambient temperature level also shall be shown. Only the portion or portions of the transmitter containing the frequency determining and stabilizing circuitry need be subjected to the temperature variation test.
- (d) The frequency stability shall be measured with variation of primary supply voltage as follows:
- (2) For hand carried, battery powered equipment, reduce primary supply voltage to the battery operating end point which shall be specified by the manufacturer.



- i) The values recorded in steps g) and h) are the modulation limiting.






