

The EUT was in loopback-mode and was controlled with the CMD65, the modulation pattern was set to Pseudo-Random bit sequence to simulate normal speech.

8.4 Radiated Emission Test


Test Set-up 4:

The radiated measurements are performed in vertical and horizontal plane in the frequency range from 9 kHz to 20 GHz in semi-anechoic chambers. The EUT is positioned on a non-conductive support with a height of 0.80 m above a conductive ground plane that covers the whole chamber. The receiving antennas are conform with specifications ANSI C63.2-1987 clause 15 and ANSI C63.4-2003 clause 4.1.5. These antennas can be moved over the height range between 1.0 m and 4.0 m in order to search for maximum field strength emitted from EUT. The measurement distances between EUT and receiving antennas are indicated in the test setups for the various frequency ranges. For each measurement, the EUT is rotated in all three axes until the maximum field strength is received. The wanted and unwanted emissions are received by spectrum analyzers where the detector modes and resolution bandwidths over various frequency ranges are set according to requirement ANSI C63-4-2003 clause 4.2. Antennas are conform with ANSI C63.2-1996 item 15.






This test setup is used for all Monitoring and Time and Spectrum Access Procedure tests. The path loss from the signal generator to the EUT is measured with a power meter before the testing is started.

A clock signal is used to synchronize the Interference Generator to the start of the DECT frame, this signal always comes from the base station. If the EUT is a DECT Portable Part (i.e. a handset) the clock signal will come from the Companion Device.





Conducted Peak Output Power




Lower Channel




Middle Channel



Radiated Peak Output Power






Emission Bandwidth B, Lower Channel














Histogram of Carrier Frequency Stability


Receiver Spurious Emissions, Conducted, 100 kHz - 1 GHz





