2. Measurement Result:

Lower than the low threshold 60/f = (63.03 mW), this was measured at 951.875 MHz. d<2.5 cm general population category.

The SAR measurement is not necessary.

To determine the worst case level to be use for the RF exposure statement, when possible we will make RF conducted at the antenna terminal measurements and EIRP measurements. The higher of the two measurements will be used. If using the RF conducted method, the antenna gain is added.
