# 6 Description of the test setup

Typically, the calibrations of the test apparatus are commissioned to and performed by an accredited calibration laboratory. The calibration intervals are determined in accordance with the DIN EN ISO/IEC 17025. In addition to the external calibrations, the laboratory executes comparison measurements with other calibrated test systems or effective verifications. Weekly chamber inspections and range calibrations are performed. Where possible, RF generating and signaling equipment as well as measuring receivers and analyzers are connected to an external high-precision 10 MHz reference (GPS-based or rubidium frequency standard).







Plot 2: 470.1 MHz, peak (unmodulated carrier)






Plot 3: 514.0 MHz, average (modulated carrier)

Plot 4: 514.0 MHz, peak (unmodulated carrier)






Plot 5: 558.0 MHz, average (modulated carrier)





Plot 2: 514.0 MHz







Plot 1: 470.1 MHz, spurious emissions, 25 MHz – 12.75 GHz




Plot 2: 514.0 MHz, spurious emissions, 25 MHz – 12.75 GHz




Plot 3: 558.0 MHz, spurious emissions, 25 MHz – 12.75 GHz


Plot 1: 470.1 MHz, spectrum mask




Plot 2: 514.0 MHz, spectrum mask





Plot 1: 558.0 MHz, spurious emissions, 25 MHz – 12.75 GHz




Plot 2: 583.0 MHz, spurious emissions, 25 MHz – 12.75 GHz





Plot 1: Unmodulated carrier reference (with pilot-tone), 470.1 MHz




Plot 2: Modulated carrier with the weighted noise source, 470.1 MHz





Plot 3: Unmodulated carrier reference (with pilot-tone), 514.0 MHz




Plot 4: Modulated carrier with the weighted noise source, 514.0 MHz





Plot 6: Modulated carrier with the weighted noise source, 558.0 MHz





Plot 1: Unmodulated carrier reference (with pilot-tone), 558.0 MHz




Plot 2: Modulated carrier with the weighted noise source, 558.0 MHz





Plot 3: Unmodulated carrier reference (with pilot-tone), 583.0 MHz




Plot 4: Modulated carrier with the weighted noise source, 583.0 MHz







Plot 3: 558.0 MHz, max hold with frequency variation from 50 Hz to 15 kHz

Plot 1: 558.0 MHz, max hold with frequency variation from 50 Hz to 15 kHz






Plot 2: 583.0 MHz, max hold with frequency variation from 50 Hz to 15 kHz
