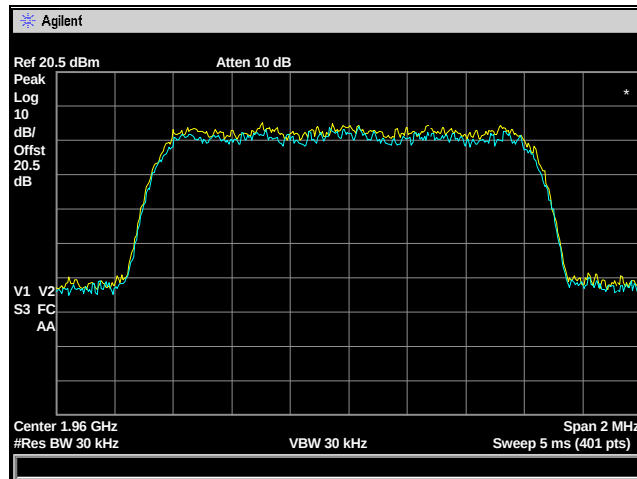


Figure 1: Occupied Bandwidth - CDMA Mid Channel

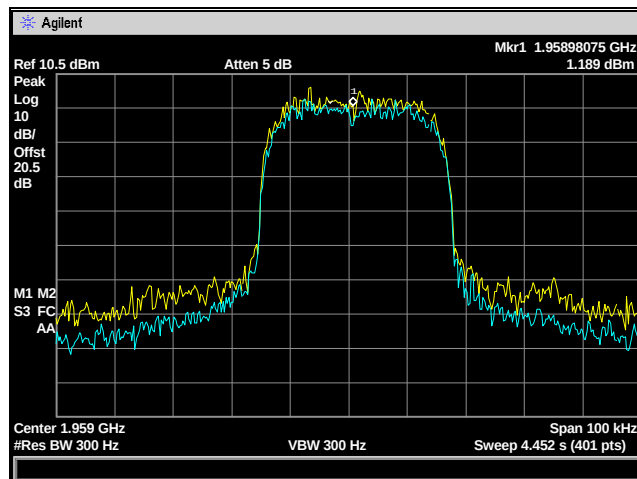


Figure 2: Occupied Bandwidth - TDMA Mid Channel

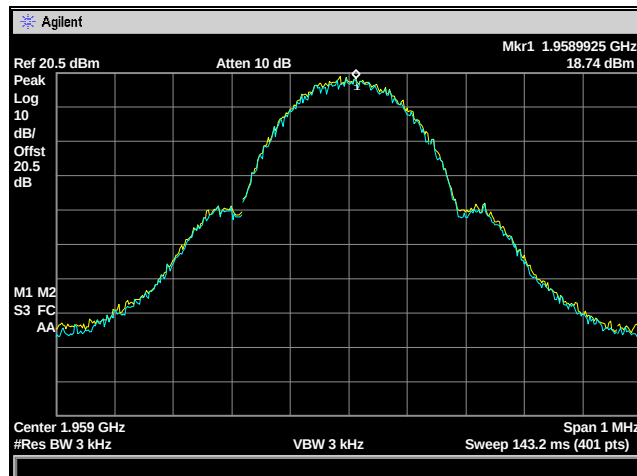


Figure 3: Occupied Bandwidth - GSM Mid Channel

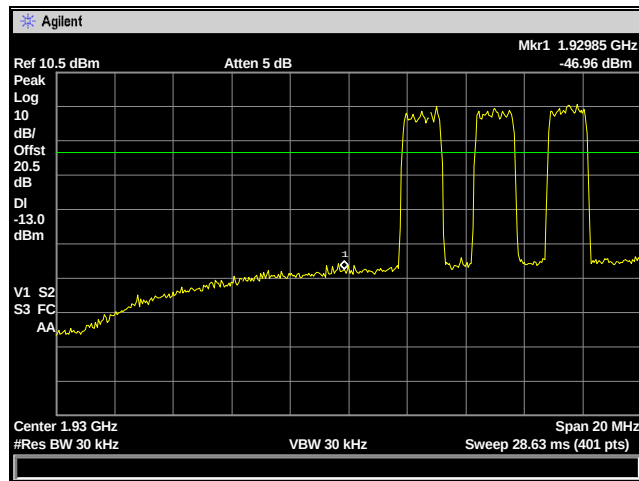


Figure 4: Spurious Emissions - CDMA Low Channel – In Band

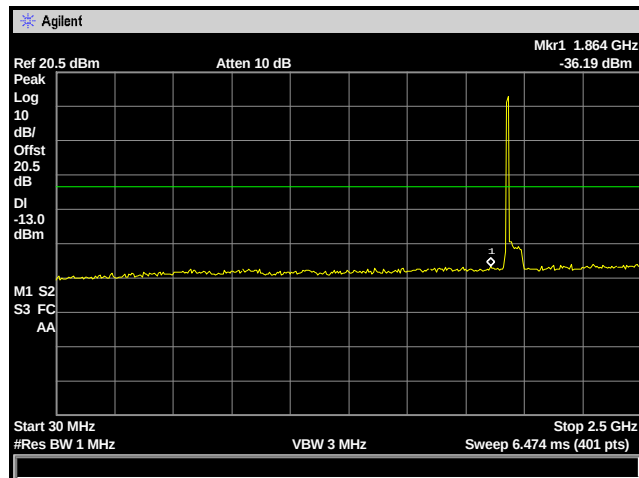


Figure 5: Spurious Emissions - CDMA Low Channel – 30 MHz to 2.5 GHz

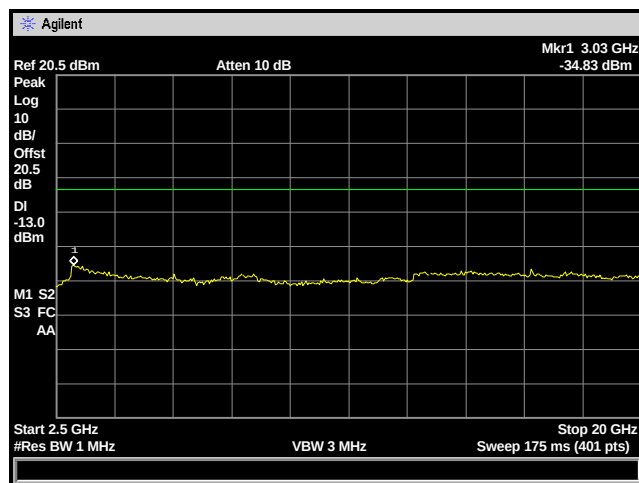


Figure 6: Spurious Emissions - CDMA Low Channel – 2.5 to 20 GHz

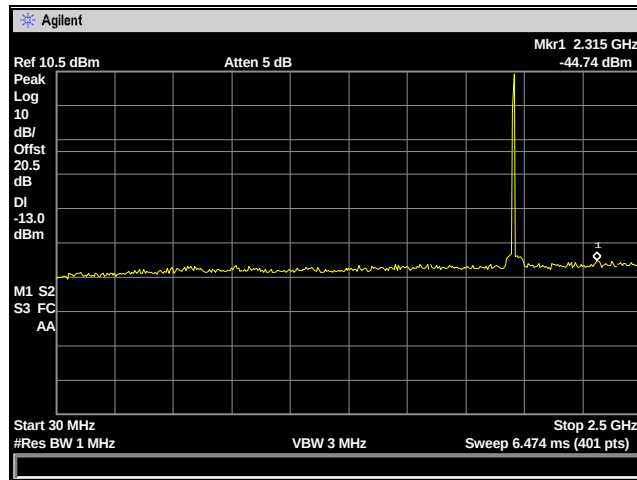


Figure 7: Spurious Emissions - CDMA Mid Channel – 30 MHz to 2.5 GHz

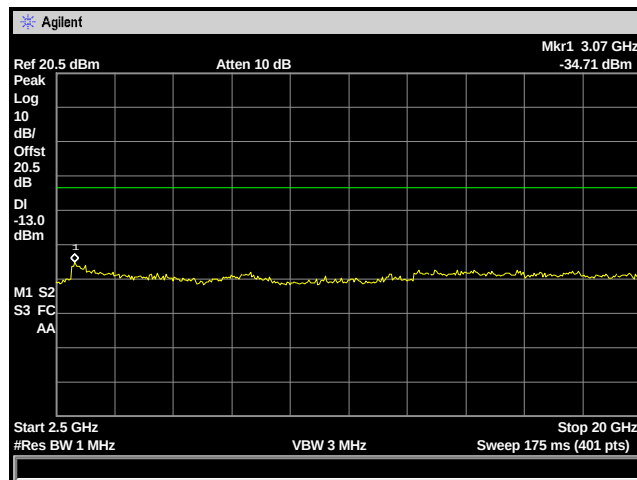


Figure 8: Spurious Emissions - CDMA Mid Channel – 2.5 to 20 GHz

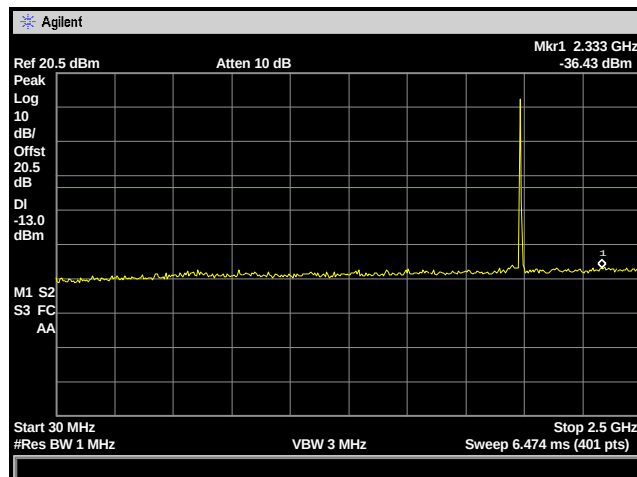


Figure 9: Spurious Emissions - CDMA High Channel – 30 MHz to 2.5 GHz

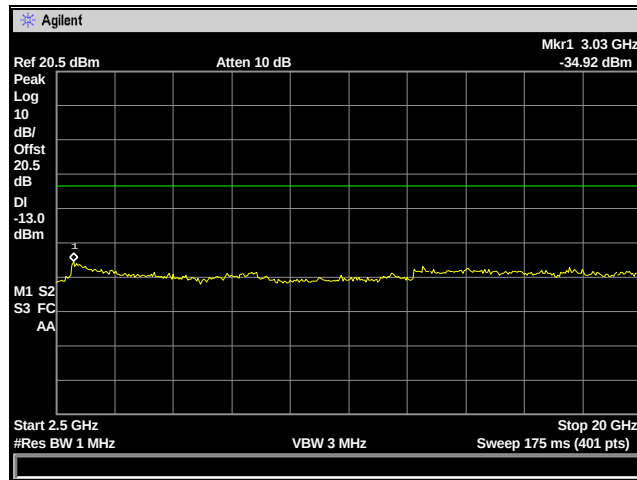


Figure 10: Spurious Emissions - CDMA High Channel – 2.5 to 20 GHz

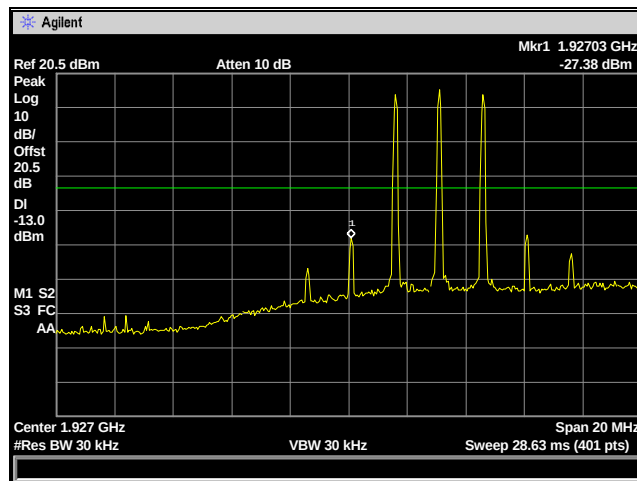


Figure 11: Spurious Emissions - TDMA Low Channel – In Band

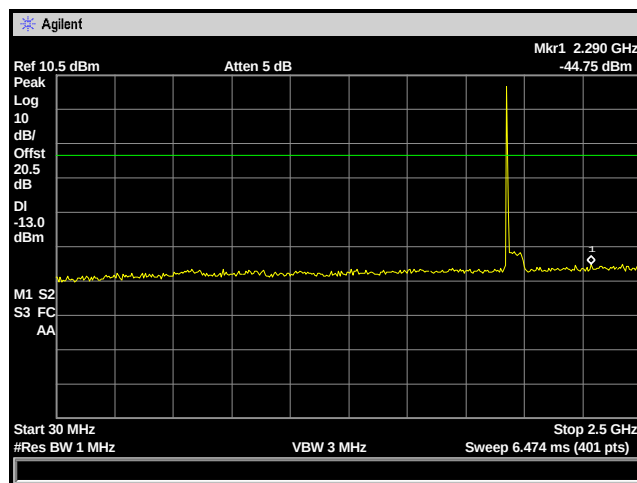


Figure 12: Spurious Emissions - TDMA Low Channel – 30 MHz to 2.5 GHz

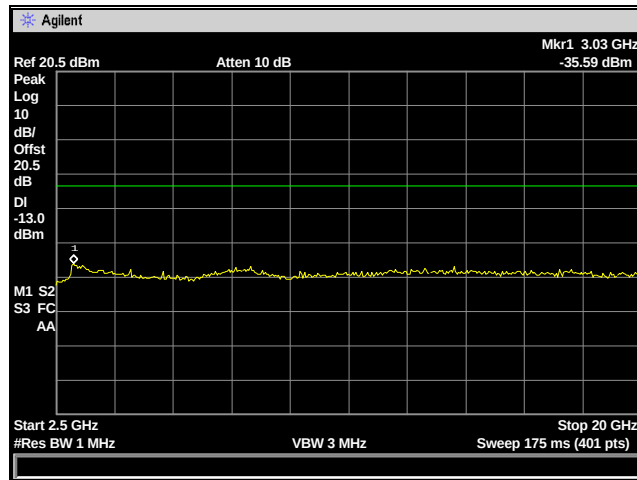


Figure 13: Spurious Emissions - TDMA Low Channel – 2.5 to 20 GHz

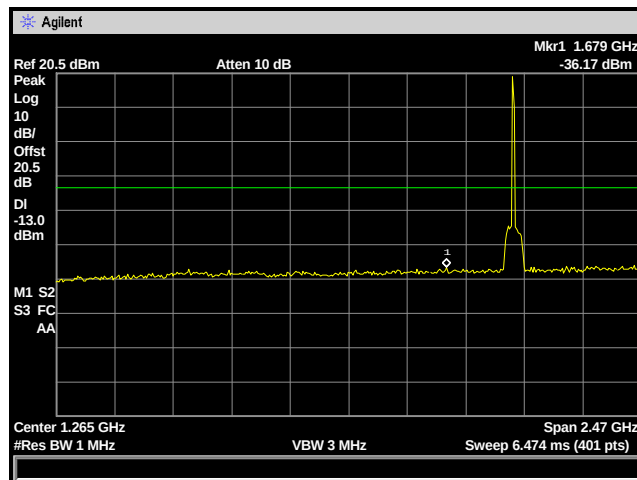


Figure 14: Spurious Emissions - TDMA Mid Channel – 30 MHz to 2.5 GHz

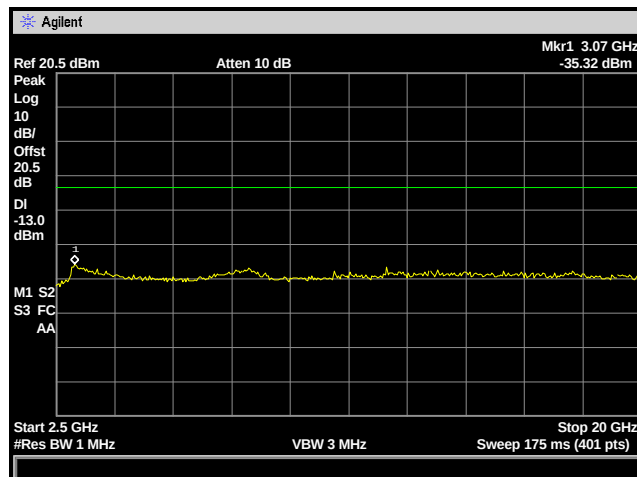


Figure 15: Spurious Emissions - TDMA Mid Channel – 2.5 to 20 GHz

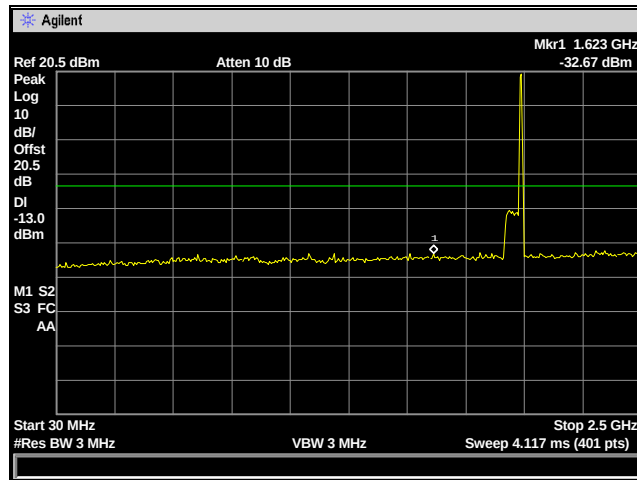


Figure 16: Spurious Emissions - TDMA High Channel – 30 MHz to 2.5 GHz

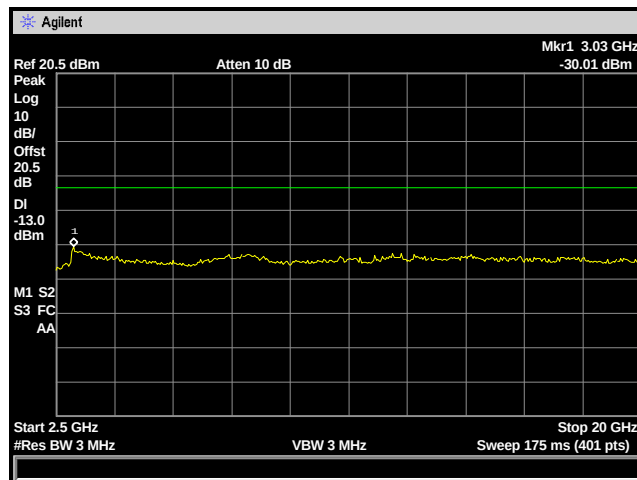


Figure 17: Spurious Emissions - TDMA High Channel – 2.5 to 20 GHz

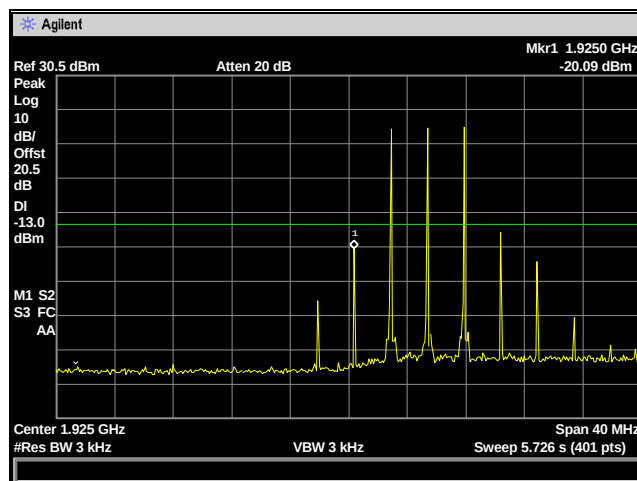


Figure 18: Spurious Emissions – CW Low Channel – In Band

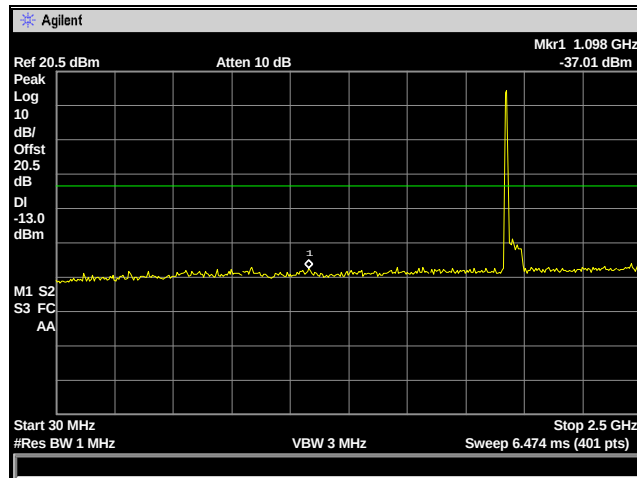


Figure 19: Spurious Emissions – CW Low Channel – 30 MHz to 2.5 GHz

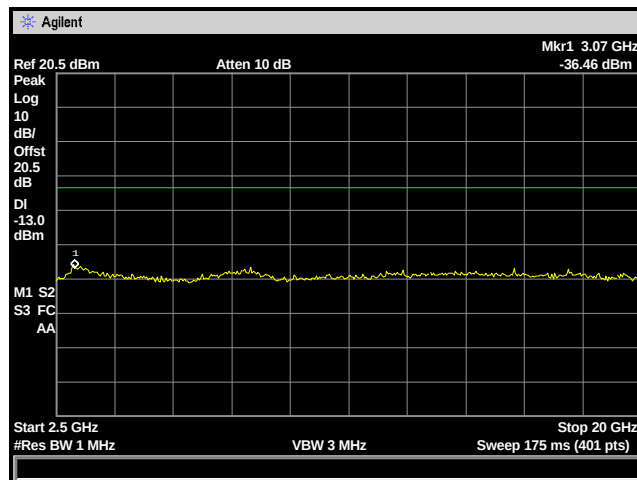


Figure 20: Spurious Emissions – CW Low Channel – 2.5 to 20 GHz

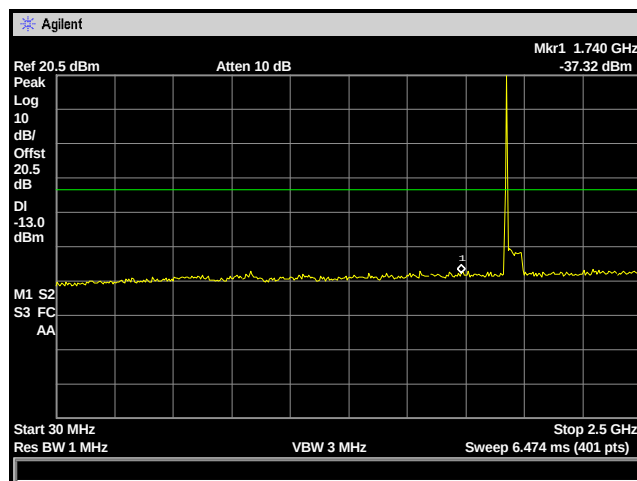


Figure 21: Spurious Emissions - GSM Low Channel – 30 MHz to 2.5 GHz

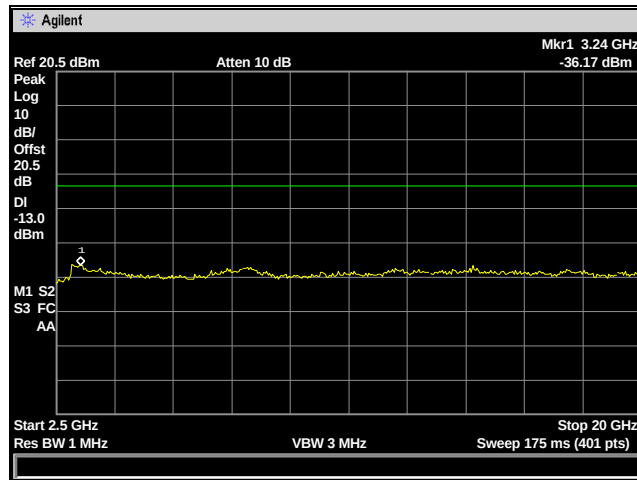


Figure 22: Spurious Emissions - GSM Low Channel – 2.5 to 20 GHz

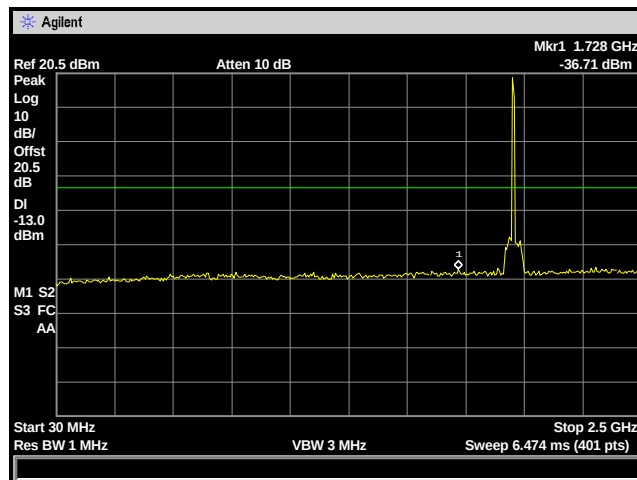


Figure 23: Spurious Emissions - GSM Mid Channel – 30 MHz to 2.5 GHz

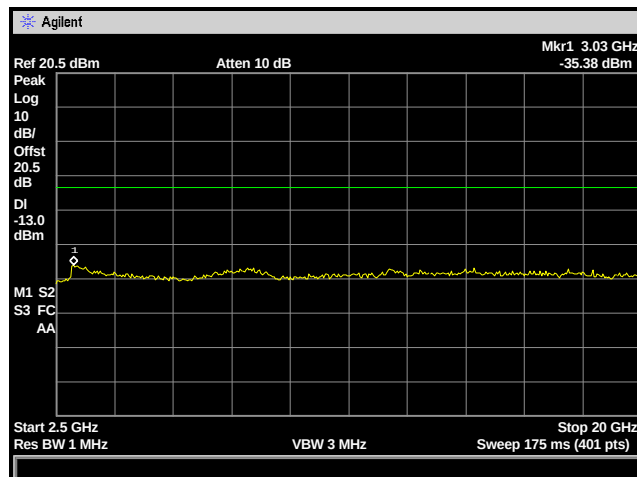


Figure 24: Spurious Emissions - GSM Mid Channel – 2.5 to 20 GHz

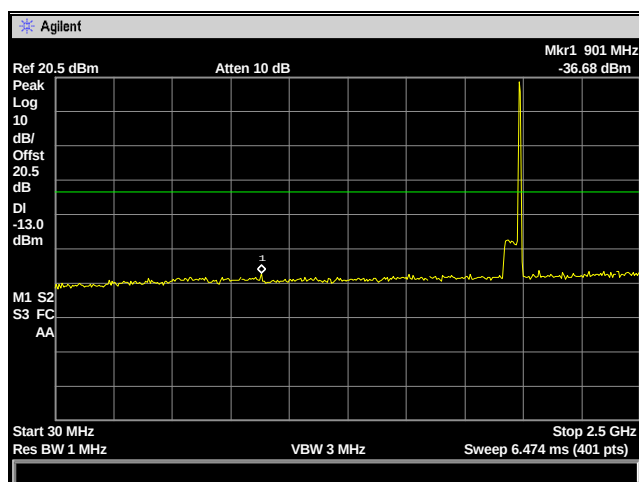


Figure 25: Spurious Emissions - GSM High Channel – 30 MHz to 2.5 GHz

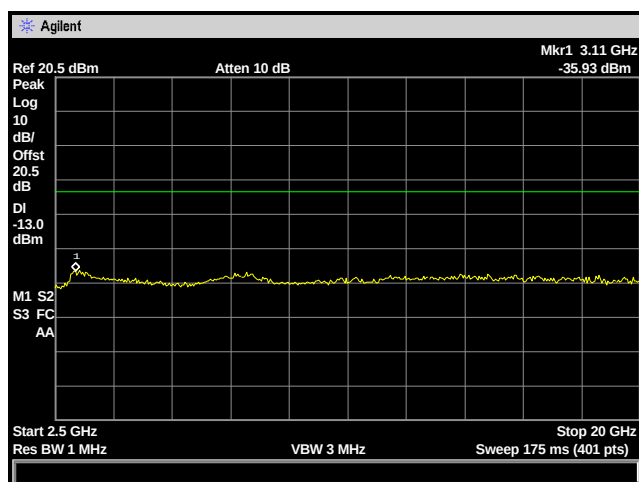


Figure 26: Spurious Emissions - GSM High Channel – 2.5 to 20 GHz

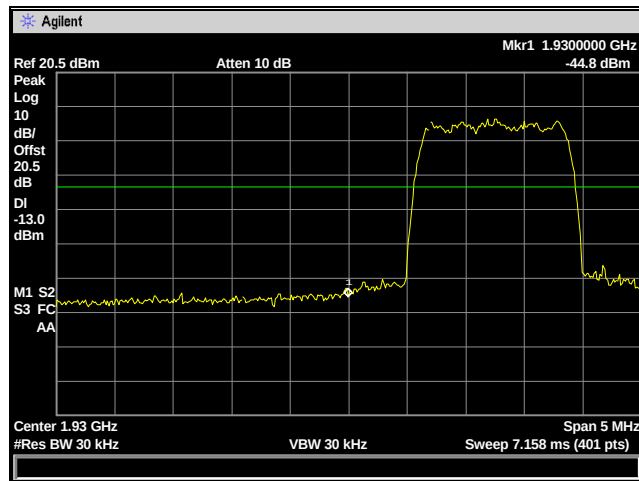


Figure 27: Band-Edge CDMA Low Channel

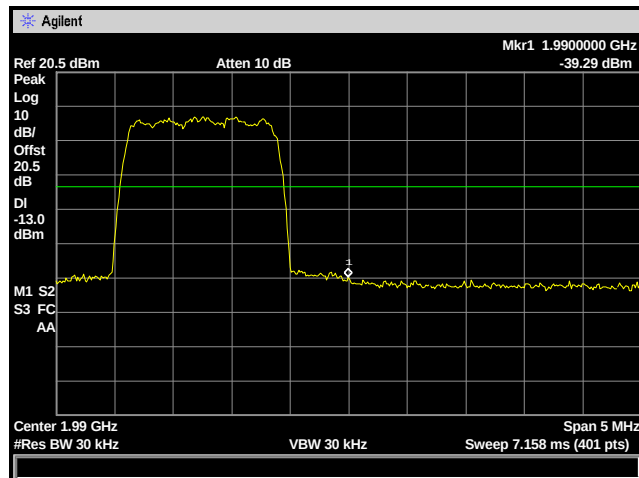


Figure 28: Band-Edge CDMA High Channel

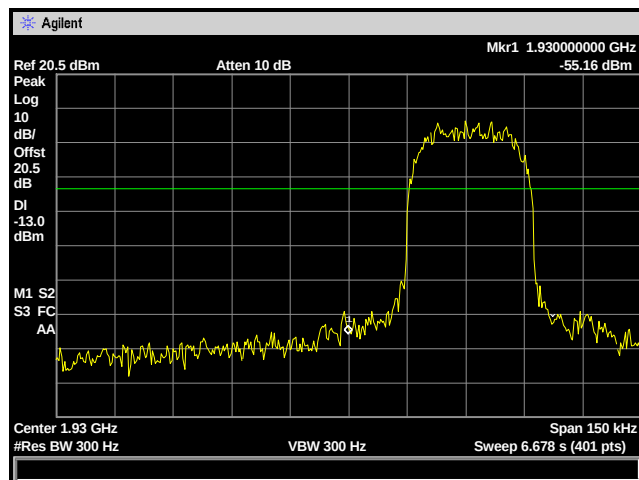


Figure 29: Band-Edge TDMA Low Channel

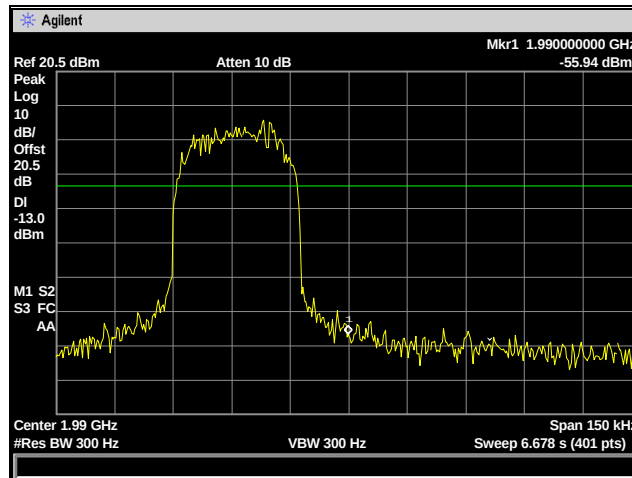


Figure 30: Band-Edge TDMA High Channel

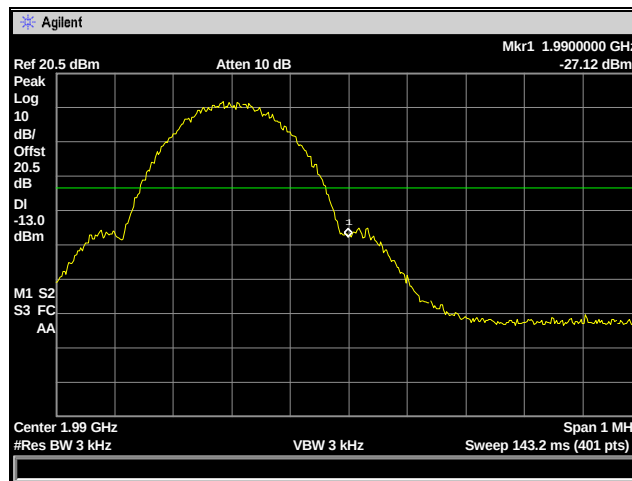


Figure 31: Band-Edge GSM Low Channel

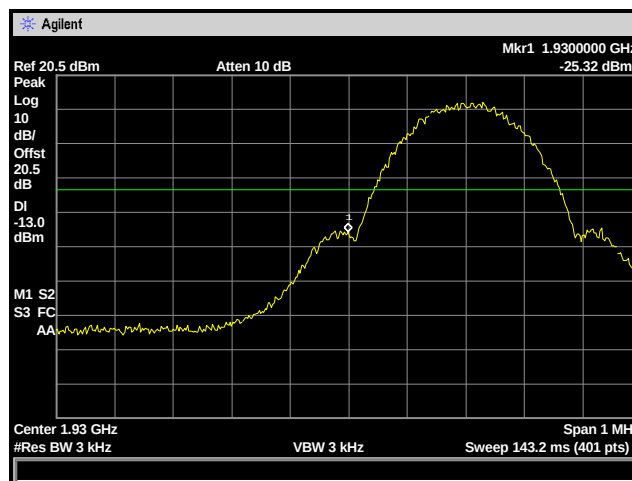


Figure 32: Band-Edge GSM High Channel
